When she refused, they tied her legs and hands with scarfs, poured kerosene on her and set her ablaze.

The perpetrators wanted to make it look like a suicide. But their plan failed as Nusrat was rescued after they fled the scene.

With 80 percent burns, she was admitted to the burn unit of Dhaka Medical College Hospital.

People in different parts of the country took to the streets, seeking exemplary punishment to the killers.

Prime Minister Sheikh Hasina had asked the law enforcement agencies to take prompt steps to bring the perpetrators to book.

On September 30, the tribunal set yesterday for delivering its judgment after 61 days of proceedings -- a considerably short period for completing trial in such cases.

Around 250 law enforcers were deployed in and around the court vesterday.

A large number of people gathered on the court premises since morning. But the court allowed only the lawyers, journalists and victim's family members inside the building.

All the accused were brought to the court in a prison van around 11:00am. The judge started reading out the judgement at 11:05am and finished within 13 minutes.

Some of the convicts looked arrogant and a few others shouted at the judge while he was delivering the verdict

Later, some of them broke into tears while being taken to jail in a prison van

The convicts will get the chance to file appeal with the High Court within seven days. And if they are not happy with the HC verdict, they will have scope to lodge appeal with the Supreme Court.

new business less expensive with the reduction of registration and name clearance fees and removal of the certifying fee for digital certificates.

In Dhaka, obtaining an electrical connection was made more efficient as the city invested in digitisation and human capital.

And yet, a business still needs to complete nine procedures, the most not only in the region, but also globally. Only two other economies in the world require nine steps to obtain a connection.

Bangladesh also reduced the amount of the security deposit required for a new connection this year.

Access to credit information was improved thanks to expanded coverage by the credit information bureau. This reform delivered Bangladesh's most significant improvement, as it climbed 42 notches to 119 in the ranking for this category.

Minimal progress was seen in case of property registration and getting construction permits.

As many as 16 procedures must be overcome to start construction, which take up to 281 days. In South Asia, the average number of procedures is 14.6 and the median duration is 149.7 days. In case of property registration, 8 steps must be completed, which takes a staggering 264 days, leaving

Transferring a property title in Bangladesh takes on average 271 days, almost six times longer than the global average of 47 days, according to the WB study.

Nusrat murder verdict hailed

Expressing satisfaction over the verdict in Feni madrasa student Nusrat Jahan Rafi murder case, different rights bodies, political parties, and sociocultural organisations yesterday urged the authorities concerned to quickly execute the verdict.

In a press statement, National Human Rights Commission Chairman Nasima Begum demanded early implementation of the verdict.

"Such a verdict is a warning for those who conduct violence against women,' she said.

Road Transport and Bridges Minister Obaidul Quader said the government was satisfied at the verdict as the trial of the case was completed at an "incredible speed".

Oikya Nap President Pankaj Bhattacharya and General Secretary Asadullah Tarek, in a press release, said such a swift announcement of verdict is a good illustration of establishing rule of law in the country.

They also demanded early execution of the verdict.

Sammilita Samajik Andolon (SSA), a platform against communalism and militancy, issued a press statement saying this verdict reflects the sincerity of authorities concerned to prevent violence against women and it will bring satisfaction to the countrymen.

BNP Secretary General Mirza Fakhrul Islam Alamgir, however, expressed anger over the verdict as the police officials were exempted from charges in this case.

"It proves that this government are dependent on police," he told journalists at Hazrat Shahjalal International Airport following his return from Australia.

had been identified.

"[No one] has been identified, but the process is on. We asked the Facebook authorities how the post was circulated on Facebook after the ID was hacked. But they have yet to give us any clear idea," the home boss said.

Earlier, police and government officials said they had identified two people and taken them into custody.

In this regard, the minister said, "Both of them have told us that they were not involved in the hacking. That is why we approached Facebook to be sure [of their involvement].

"Facebook hasn't provided us specific details, but they have given us some idea. We are looking into those."

Anjuman Kamal, assistant inspector general of Lawful Interception Unit (LIC) of Police Headquarters, told The Daily Star yesterday that they were working with Facebook authorities and would need some more information regarding the Bhola incident.

Meanwhile, a Bhola court granted a three-day remand each to five people in two separate cases filed with Borhanuddin police station. One was a murder case and the other was filed under the Digital Security Act.

Biplob Chandra Baidya -- the man whose Facebook ID was allegedly hacked -- Rafsan Islam Sharif and Md Imon were placed on three-day remand over the case filed under the Digital Security Act for spreading hate speech hurting religious sentiments.

Biplob was arrested on October 19, after he had filed a GD stating that his ID was hacked and hate speech was being spread through it. Sharif was arrested from Patuakhali, while Imon from Borhanuddin the same day.

Police arrested Sharif after he made a phone call to Biplob from Patuakhali and demanded Tk 2,000 for returning his Facebook account. Imon was arrested as he had sold the SIM card, registered under another name, to Sharif which was used to make the call.

Earlier on Sunday, police claimed that they had "arrested the hackers", Rafsan Islam Sharif, along with Imon. The investigators now think that

Sharif may not be the hacker, as he police in Bhola and the officer-in-charge did not have the technical knowledge to hack an account.

The two arrested in the murder case -- Arif and Sajib -- were picked up from different places in the district on Wednesday night, said the inspector (investigation) of Borhanuddin police station, and also the investigation officer.

Police arrested the duo after they were identified from footages of the protest on Sunday.

SLAMIC FRONTS CALL OFF PROGRAMMES

The Bhola district administration refused to give permission for holding any outdoor events today, resulting in two Islamic parties postponing their agitation programmes.

Earlier, Sharbadalia Muslim Oikya Parishad and Islami Adolon Bangladesh had announced holding separate programmes protesting the death of four people killed in Sunday's clash with police during the protest rally over hate speech spread through Facebook.

They announced the agitation after their six-point charter was not met within the 72-hour ultimatum they had given.

The Oikya Parishad had planned a special prayer session after the Jumma prayers at Bhola Government High School ground, while the Islami Adolon had chalked out an agitation programme and special prayer sessions at all of the 930 mosques in Bhola Sadar upazila.

Mizanur Rahman, the joint convener of the parishad, announced the postponement around 9:00pm after a meeting of the platform's highups. Mizanur said they had delayed the programmes after they were not given the permission to hold those.

Similarly, Islami Andolon, also withdrew their agitation programmes and special prayers.

Sirajul Islam, Islami Adolon Bangladesh, Bhola North unit president, told this newspaper, "We are withdrawing our programme as we could not secure the permission for it."

Sharbadaliya Muslim Oikva Parishad placed a six-point demand at a press conference at Bhola Press Club around noon on Monday.

Their demands included immediate withdrawal of the superintendent of meeting, told The Daily Star.

Access to capital can be termed as another barrier (29.17 percent) for sectors to flourish as they cannot expand beyond a certain level.

Other obstacles such as weak institution and corruption, unskilled labour and lack of technology also have a negative impact on the market environment

In terms of reforms, 45.99 percent of the survey respondents called for an inclusive financial system. The highest expectation is for low interest rates or easy terms and conditions for loans.

Wells also said the government estimates host communities in Cox's Bazar are outnumbered by Rohingyas two to one, and that these communities have endured economic disruptions, ecological damage, and uncertainty about their own future just as the Rohingya face uncertainty about theirs.
