### 39 found dead in Essex lorry were Chinese

Say UK police AFP, Grays

British police said yesterday that 39 people found dead in a truck near London were all believed to be Chinese nationals, in a case that has triggered national outrage over the people trafficking business.

Emergency workers discovered the bodies early Wednesday inside the refrigerated container of a truck parked in an industrial area east of London, shortly after it had arrived on a ferry from Belgium.

Police are conducting the country's largest murder probe in more than a decade into what Prime Minister Boris Johnson described as an "unimaginable tragedy".

The local police force, who have arrested the truck's driver, said in a statement that eight of the dead were women and 31 were men.

"All are believed to be Chinese nationals," Essex Police said.

China's foreign ministry said its embassy staff in London were heading to the scene "to verify this situation".

An embassy spokesperson said Chinese authorities had read the reports with a "heavy heart" and were in close contact with police "to seek clarification and confirmation".

The deaths echoed the discovery of 58 Chinese immigrants hidden in a Dutch truck in the English port of Dover in 2000. Only two people had survived

'SUBSTANTIAL OPERATION' With the help of immigration officials and the National Crime Agency (NCA), Essex Police are leading the biggest murder probe in Britain since the 2005 London terror attacks that killed 52 people.

The force confirmed officers had searched three properties in Northern Ireland overnight in connection with the investigation.

The addresses are believed to be linked to the arrested truck driver, a 25-year-old man from the province.

Police said a coroner would try to establish the cause of death of the 39 victims, before investigators then attempt to identify each individual.

Officials moved the truck Wednesday to a "secure location" at nearby Tilbury docks, "to give the utmost dignity to those within the trailer as we prepare for a coroner's post-mortem examination", Essex

Police said. ROUTE FROM ZEEBRUGGE The container section came by ferry from the Belgian port of Zeebrugge into Purfleet on the River Thames estuary -- a crossing that takes nine to

12 hours. The vessel docked there at around 12:30 am Wednesday (2330 GMT Tuesday) and the truck left the port area about half an hour later.

Police were called to the Waterglade Industrial Park in nearby

Grays at around 1:40 am. Prosecutors in Belgium have launched their own probe and confirmed yesterday the container had on Tuesday passed through Zeebrugge, one of the world's busiest ports for cargo on trucks.

"It is not yet clear when the victims were placed in the container and whether this happened in Belgium," the federal prosecutor's office said.

It added that its investigation "will focus on the organisers of and all other parties involved" and be carried out in close cooperation with Britain.

Essex Police revealed the tractor unit of the truck entered Britain on Sunday on a ferry from Dublin to the Welsh port of Holyhead.

They had earlier said they believed the tractor originated in Northern Ireland.

The vehicle had licence plates issued in Bulgaria after it was registered there in 2017 by an Irish citizen, according to Prime Minister Boyko Borisov.

He said the unit had not entered Bulgarian territory since and there was "no connection with us".

In another incident Wednesday, police in Kent in southeast England said they had discovered nine people stowed away inside another truck, after stopping the vehicle on a motorway.

After precautionary medical checks, they were passed to immigration officials.

# China detains journo who covered HK protests: sources

A Chinese journalist who covered democracy protests in Hong Kong has been detained after returning to the mainland, sources with direct knowledge of the situation told AFP yesterday.

Huang Xueqin, who became known for her support of the #MeToo movement against sexual harassment in China last year, had travelled to Hong Kong this

She had written at least two reports about the protests that have plunged the semi-autonomous city into crisis for nearly five months.

When Huang returned to the mainland, authorities in the southeastern city of Guangzhou summoned her to a meeting and confiscated her travel documents, the sources said.

Then, Huang was told she could go and collect her documents on October

Instead, the sources said she was arrested under the charge of "making trouble and picking quarrels" -- a vague accusation often levelled against critics of the mainland government.

The detention centre in Guangzhou referred questions to city police, who did not immediately respond to a request for comment. Huang's lawyer and friend, Wan

Miaoyan, declined to comment on the

FROM PAGE 20 Like humans, marmosets raise their offspring with the help of the entire group, which could be another reason why they need "language skills", according to scientists from the

University of Zurich. Senior author Dr Judith Burkart told The Independent: "It's rather like what you in England call accents. All the calls are high pitched so for the human ear it's hard to hear these differences but using acoustic analysis we could locate these calls to distinct

"The ear of the marmoset is much more in tune to these calls so the differences are clearly audible to

Scientists already knew marmoset calls varied from one region to the next but they didn't know why. They thought it could be caused by genetic differences, environmental factors or learnt through social learning.

To answer this, they analysed the calls of common marmosets - which normally travel around in groups of between three and 15 individuals before and after they moved to a new colony. They looked at captive marmosets

in three colonies in Spain, Italy and Switzerland. Each group did not have direct contact with the new group but they still adapted their calls in as little as a few weeks. "We could clearly show that the

dialects of common marmosets are learned socially," said the first author of the study, Yvonne Zurcher, from the University of Zurich. "If their dialects were genetically determined, moving to a new place wouldn't cause any change in calls.

The changes can't be explained

by differences in the environment either," she said. Marmoset males remain in their group until they are adults at which point they leave to find breeding females. One of their defining social behaviours is their cooperative breeding and infant care systems with siblings and offspring caring for

young ones. Dr Burkart said: "It's like with humans – when you move to a new

place you accommodate new accents. Next researchers want to look at how accents change when monkeys
