# Malta brings smile to growers in Rangamati

Malta growers in Rangamati district are happy with good yield and fair price of the delicious juicy fruit this year.

The hill district sees gradual rise in Malta cultivation as the fruit grown there is very tasty and usually of large size.

Each fruit weighs around 250 grams and one kg of it is now selling for Tk 80 to Tk

100 in local markets. Ananta Chakma made a Malta orchard at his home yard in Chowdhury Chara village

under Naniarchar upazila of Rangamati. Visiting the spot a few days ago, this correspondent saw Ananta and his wife Madhumita taking care to Malta trees at their orchard.

Tree branches were seen bowing down with the weight of hanging ripe Malta.

"In 2014, I made an orchard on 2.5 acres of land where I planted 300 Malta, 200 guava and 200 orange trees," said Ananta Chakma.

"For the first time, I started selling fruit Rangamati, officials said. from my 100 Malta trees in 2016. I sold the next two years. This year the fruit is selling well and I think I will get over Tk 1 lakh, he said. PHOTO: STAR

Hemo Kumar Chakma from Bodhipur village under Rangamati Sadar upazila also gained success in Malta cultivation.

Seeing their success, several others have become interested in cultivating Malta at different villages.

Sugata Chakma, 40, a fruit trader, said he usually collects Malta from Rangamati and sells it in Chattogram and Dhaka.

"Our customers show great interest for seasonal fruits from hill areas as we always try to sell pure organic fruits. Fruits grown in hill areas are often of high quality," he added.

Officials at the Department of Agricultural Extension (DAE) in Rangamati said they introduced cultivation of Barivariety of Malta under a pilot project in Chattogram Hill Tracts in 2014. Later farming of Bari-2 Malta started in the hill region. Both saw success.

Last year, the DAE distributed about 30,000 Malta plants among the farmers in

A court here yesterday sentenced a drug peddler to 10 years' imprisonment.

The convict is Md Rubel, 30, of Natunbazar area in Patuakhali town. He was tried in absentia.

Special Sessions Judge Abu Naser Md Jahangir Alom also fined him Tk 10,000. In default, he is to suffer another 10 months in jail.

According to the prosecution, a team of Rab-8 arrested Rubel with 35 Yaba tablets from the area on April 6 in 2016 and handed him over to police.

A Rab member then filed a case with Sadar Police Station in this regard.

Rubel was later released on bail and went into

same year. After examining witnesses and evidences, the judge found Rubel guilty and pronounced the

## Hanging bodies of woman, youth found in Saltha and Bhanga upazilas in Faridpur

Police recovered hanging bodies of an elderly woman and a youth in Saltha and Bhanga upazilas in Faridpur yesterday.

The deceased in Saltha was Nurjahan Begum, 65, wife of Kanchan Mia of Nowpara village.

"Nurjahan quarrelled with her husband over a family issue on Wednesday evening. After taking supper, they went to sleep but locals found Nurjahan's hanging body beside their house on Thursday morning," Muhammad Ali Jinnah, officer-in-charge of Saltha Police Station, quoted locals as saying.

On information, police recovered the body and sent it to Faridpur Medical College Hospital for autopsy, he said, adding that an unnatural death case was filed with Saltha Police Station.

Police recovered hanging body of a youth from Mohesdi Boromuckurni village under Bhanga upazila around 2:00pm yesterday. The deceased was Shahin Sheikh, 25, son of Hafiz

Sheikh of the village. According to locals, Shahin was addicted to gambling

and he borrowed money from his friends.

As he could not return the money, he was suffering from depression, they said.

"On information, police recovered the body that was hanging from a mango tree beside their house and sent it to Faridpur Medical College Hospital for autopsy," said Kazi Saidur Rahman, officer-in-charge of Bhanga Police Station.

An unnatural death case was filed with the police station, he added.

## Kids attend classes in abandoned bldg for 8 years

Children are attending classes in an abandoned primary school building of Nagarkanda upazila in the district for eight years amid risk of accident, thanks to the authorities' negligence to the

Biva Hawlader, headmaster of Hiyaboldi Government Primary School, said the school was established in 1985 and the building was built in 1994.

The upazila primary education department declared the building abandoned in 2011, she said.


"We have another building nearby. Built in 2003-2004 fiscal year, it comprises two classrooms and a teachers' room," said the headmaster.

They were compelled to use a room of that abandoned building as the two classrooms are not sufficient to accommodate 162

students, added Biva. During a recent visit to the school building, this correspondent found that plaster of most part of the roof has already fallen, exposing rusty iron rods. Cracks have also

developed in the roof. Yunus Mia, an assistant teacher of the school, said plaster fell off the ceiling three months ago. However, none sustained injuries in the accident as all the students were out of the room at that time.
