He saw death so close

A survivor of the Mediterranean tragedy in May narrates how manpower brokers treated fortune seekers in Libya, and the horrific experiences of his trip to Europe

It is called "body contract" under which you do not need to pay a dime before reaching your destination. But as soon as you are there, your family members have to make the payment.

Billal Ahmed was assured by his travel agent that he would safely make it to Italy. "There would be no risk at all," the agent had said.

Billal along with 15 others were rescued in the Mediterranean in May after a boat carrying 86 people to Italy from Libya capsized off the

Tunisian coast. As many as 71 people, including Billal's three nephews, died on that perilous journey.

A resident of Mohidpur village in Sylhet's Fenchuganj upazila, Billal, 31, is the youngest among nine siblings and has not married yet. He dropped out of school after class five.

He was doing well with fish farming and paddy cultivation until a devastating flash flood hit him hard in 2017.

"I could not earn anything that year. So, I thought, I should try my luck aboard. I was looking for an opportunity," he told this correspondent at his village home recently.

In September 2018, he met Enamul Haque at a wedding party of one of his relatives at a nearby village.

Enamul told him that he had a travel agency in Sylhet and sent many people to Europe. And Billal would have to pay him Tk 9 lakh once he SEE PAGE 2 COL 3

Two Boeing 777 Leased from Egypt Air Biman returns last one after huge loss

Biman has finally got rid of the last of its two leased Boeing 777-200ER airplanes that have been causing the national flag carrier to incur huge losses for several years.

Leased from Egypt Air in 2014 for five years with stringent conditions that went against Biman's interests, the extended range planes remained grounded since 2017 due to engine defects. One was returned to Egypt

Air in July and the other on Tuesday.

Biman had to pay Tk 56 crore to Egypt Air for breaching the terms of lease, Tk 600 crore for lease, Tk 310 crore for leasing four engines, around Tk 250 crore to United Airlines for repairs, and around Tk 7 crore to Vietnam Airlines Engineering Company for using its Bay, officials added.

Voluntary return of Rohingyas to Myanmar only solution

PM tells NAM leaders; Rouhani, Mahathir assure Bangladesh of help in resolving the refugee crisis

UNB, Baku, Azerbaijan

Calling upon the world community to address the Rohingya crisis, Prime Minister Sheikh Hasina yesterday said voluntary return of the Rohingyas to their homes in safety, security and dignity was the only solution to the crisis.

The crisis not only destabilises Bangladesh but also territories beyond the country, she said at the plenary session of the 18th Summit of the Non-Aligned Movement (NAM) in Baku.

"We're currently hosting over 1.1 million Rohingyas. It has the potential to destabilise our country and beyond. We're constrained to seek support of the international community in resolving the crisis. Voluntary return of the Rohingyas to their homes in the Rakhine State in safety, security and dignity is the only solution to the crisis," said Hasina.

The session titled "Upholding the Bandung Principles to ensure concerted and adequate response to the challenges of contemporary world" was held at Baku Congress



Centre.

Hasina said the Rohingya crisis is a political one deeply rooted in Myanmar. "Thus, its solution has to be found inside Myanmar.

Despite the socio-economic successes, Bangladesh is currently dealing with two challenges --Rohingya crisis and adverse impacts of climate change, she said.

Meanwhile, during meetings with Hasina at Baku Congress Centre, Iranian President Hassan Rouhani and Malaysian PM Mahathir Mohamad assured her of help in resolving the

Rohingya crisis.

About impacts of the climate change, Hasina at the plenary session said although Bangladesh has little responsibility for global warming, it is suffering heavily from its devastating impacts.

'The international response to climate change, particularly that of developed countries, must, therefore, fully respect the UN Framework Convention on Climate Change," she said.

The PM said Bangladesh has been making unprecedented socioeconomic progress. "Our GDP growth has now reached 8.13 percent. We're making continuous efforts in strengthening democracy and justice by empowering people, especially women.

She pointed out that Bangladesh's successes in poverty reduction, healthcare, primarv women's empowerment, gender equality and gender parity in education have been widely acclaimed by the international community.

Hasina said Bangladesh is a country
