Earlier, Local Government Division removed ward-9 councillor AKM Mominul Haque Sayeed from his post on October 17, allegedly for his absence in board meetings and travelling abroad without permission from the ministry.
Sayeed is also the joint secretary of Dhaka City South Jubo League, youth front of ruling Awami League. He is allegedly involved in casino business.
The name of Sayeed came to light after the drive against casino business started in Dhaka.
Sayeed allegedly used to run an illegal casino at Wanderer's Club in the capital. He fled the country following a crackdown on the illegal casino business.
The councillor was found guilty under Section 13 (1) of the Local Government

(City Corporation) Act 2009, and suspended under the Section 13 (2), the order says.
According to the order, Sayeed was absent in 13 meetings out of 18 of DSCC and currently, he is abroad without the permission of the local government, rural development and cooperatives ministry.
However, 35 councillors who were also absent in board meetings of both the city corporations of Dhaka are still holding their posts. As per rules, councillors of two city corporations have to attend the board meetings.
According to article 13 of the Local Government Act (City Corporation Act) 2009, if mayors or councillors remain absent at three consecutive monthly meetings without any appropriate reason, they will be removed from their position.

The latest draft also excluded definitions of some critical concepts like poisonous elements in air, approved fuel, risky effluents, bad odour and pollution control machine, she said.
Saber Hossain Chowdhury, chairman of standing committee on the Ministry of Environment, Forest and Climate Change, said people have to be familiarised with the proposed clean air law.
Its language has to be unambiguous, he added.
Ziaul Huq, director of DoE, underscored the need for an air quality control authority

and empowerment of the department.
The clean air law has to have adequate provisions for easily exactable financial penalty on the polluters, opined Zakir Hossain Khan, senior programme manager of TIB.
Dr AKM Rafique Ahammed, director general of Department of Environment, said they have a plan to draw detailed provisions in the rules after the law is enacted.
Lawmakers Md Zafar Alam from Mymensingh, and Md Rezaul Karim Bablu from Bogura, among others, also spoke at the event.

corruption case later the same year, though her party claims both cases are politically motivated.
The BNP chief has been receiving treatment at Bangabandhu Sheikh Mujib Medical University (BSMMU) since April 1 this year.
BNP has been claiming that the health condition of their party chief has deteriorated alarmingly and called upon party men to take to the streets to demand her release.
Khaleda Zia's elder sister Selima Islam on Friday met her at BSMMU and told reporters that the family members want to take her (Khaleda) abroad on bail as she urgently needs better treatment.
"Khaleda Zia was in better condition when she was taken to BSMMU for treatment. But now she cannot even get up from bed or walk on her own," he said, adding that Khaleda Zia will not receive proper treatment at BSMMU.
Earlier on October 1, BNP lawmakers including Harunur Rashid, Ukil Abdus Sattar and Aminul Islam met Khaleda Zia at BSMMU and expressed their party chief's willingness to go abroad for better treatment if she gets bail.

BEATING MAN TO DEATH

SI among 2 remanded

A Chattogram court yesterday placed a suspended sub-inspector (SI) of police and his brother-in-law on two-day remand, in a case filed over beating a ship-breaking yard worker to death over allegation of cellphone theft last Monday in Sitakunda upazila of Chattogram.
The court of Additional Chief Judicial Magistrate Robiul Islam passed the remand order for SI Iqbal Parvej Raihan and his brother-in-law Mizan Uddin, after hearing a seven-day remand prayer from Sitakunda Police Station, said Court Inspector Subrata Banarjee.
Ejahar Mia (26), son of Mofizur Rahman was assaulted by the duo at Bhatiyari union of Sitakunda upazila on Monday night.
He later succumbed to his injuries on the way to the hospital after the accused released him.
Police later arrested Iqbal and his relative in this connection, and a case was lodged.
SI Iqbal had been recently transferred to Range Reserve Police of Chattogram district from Guimara Police Station of Khagrachari district. He was suspended after being arrested, said police sources.

The HC bench of Justice M Enayetur Rahim and Justice Md Mostafizur Rahman came up with the order and rule following a writ petition filed by Ain o Shalish Kendra (ASK) and Jaima's father Md Jamal Gazi.
Advocate Anisul Hasan, a lawyer for petitioners, told The Daily Star that Jaima got seriously wounded after the launch hit her on December 29, 2017. She was six years old at the time.
The authorities failed to take necessary steps to punish the perpetrators, he said, adding that Jaima is still undergoing treatment. The lawyer said Jaima's father, a rickshaw-puller, cannot afford her treatment expenses.
Jamal filed a criminal case with South Keraniganj Police Station in February 2018, but no action was taken in this regard, said Advocate Hasan. The accused reportedly threatened Jamal to withdraw the case, he added.
ASK and Jaima's father filed the petition on October 24 that year, seeking HC directives on authorities to give Tk 50 lakh to Jaima as compensation and treatment cost.
Deputy Attorney General Tushar Kanti Roy represented the state.

2,730 new non-government educational institutions from across the country under the MPO scheme, under which the government pays basic salary of teachers, as well as some monthly allowances from the public fund.
Prime Minister Sheikh Hasina revealed the names of the new institutions, that include 1,651 schools and colleges, 557 madrasas, and 522 technical and vocational institutions. The decision will take retrospective effect from July this year.
According to the new list, 439 are

junior secondary schools (Class VI-VIII), 995 secondary schools (VI-X), 68 higher secondary schools, 93 colleges (XI-XII), and 56 degree colleges (XIII-XV).
Among the madrasas are 357 Dakhlil, 128 Alim, 42 Fazil and 29 Kamil-level institutions.
In 2010, when the last inclusion to MPO was made, some 1,624 institutions were brought under the scheme.
Up till now, more than 4.5 lakh teachers and employees of 26,340 educational institutions have been enjoying MPO benefits.

In Faridpur, shopkeeper Sunil Roy, 70, was killed after a pick-up ran him over on Majkandi-Bhatiapara road in Boalmari upazila around 6am yesterday, said police, quoting locals.
The accident took place when Sunil was returning home by his bicycle, after attending a cremation of his relative.

The pick-up driver fled the scene with the vehicle.
Locals rushed critically injured Sunil to the upazila health complex where an on-duty doctor declared him dead, they added.
In Sirajganj, an unidentified man, aged about 40, was killed on the spot after a truck hit his bicycle at Hatikumrul roundabout in Ullapara upazila around 9pm on Saturday, said police.
