### 2,000 Georgia websites hit by cyber attacks

Some 2,000 websites in Georgia, including those of the president, courts, and media came under a massive cyber attack yesterday, officials and media said.

Georgian President Salome Zurabishvili's website was "attacked by hackers this afternoon," her spokeswoman told AFP.

"Law enforcement agencies are investigating the incident," Sopho Jajanashvili said.

Georgia's Interpress news agency said that the website for Georgia's general jurisdiction courts as well as websites of a number of government agencies, NGOs and media outlets were also hit by cyber attacks yesterday.

Up to 2,000 sites are believed to have been affected.

They displayed a photo of Georgia's exiled former president Mikheil Saakashvili with an inscription "I'll be back!" Interpress said.

Saakashvili lives in a self-imposed exile in Ukraine after his second term as president ended in 2013.

The age at which the average Chinese woman has her first child rose from 24.3 years in 2006 to 26.9 years in 2016, according to a report this year by the Economist Intelligence Unit.

While the two-child policy has had a smaller effect on China's birth count than expected, it has prompted more older women to consider having second children.

Around 51 percent of newborns in 2017 were second children, compared to around 40 percent in 2016, the Economist Intelligence Unit report

Other women in their 60s and 70s have given birth in recent years, though generally after having fertility treatment.

The China Daily reported in December 2016 that a 64-year-old woman gave birth to a baby boy by Caesarean section after IVF treatment in the country's northeast Jilin

# CSE, IT graduates getting more jobs

Islamic University of Technology graduates' job placement rate was the highest at 92.4 percent, closely followed by the Buet at 91.1 percent. BRAC University had 87.1 percent and East West University 83.8 percent.

The CSE graduates from Jashore University of Science and Technology had the lowest job placement rate of 57.6 percent, which was said to have been a result of its geographical location.

The other universities surveyed are Ahsanullah University of Science and Technology, Daffodil International University, Jahangirnagar University and University of Dhaka.

Professor Dr M Kaykobad of the CSE department of Buet, said, based on his own assumption, it was true that graduates of these subjects were getting more jobs, adding, that many Buet students would eventually go abroad for higher studies.

"So, if any local organisation conducted the study, it would be more consistent," he said.

### LOW WAGES, OPPORTUNITIES ABROAD

The graduates of IUT had the highest mean salary of Tk 51,938 followed by the Buet, and Dhaka University, with ranges for both above Tk 40,000.

Overall, 89.5 percent of the employed graduates were in the private sector, 6.2 percent in the government sector, 2.9 percent in nongovernment organisations. Another 1.5 percent were self-employed.

On average, graduates who work be regularly updated. in the education sector received the highest starting monthly salary at Tk 40,237, followed by those who worked curriculum in the software industry at Tk 39,772, financial and insurance activities at Tk 38,986 and IT consultancy at Tk

For those not in jobs (22.9%), around half were active job seekers. Many of them were unemployed because of unsatisfactory working conditions, such as low wages

But the average monthly wage among CSE/IIT graduates (Tk 38,780) was higher than the overall university average (Tk 30,000); one view is that job seekers have high salary expectations after graduating from CSE/IIT programmes.

Around half of the graduates also chose not to look for jobs and continue their education instead. The majority of respondents were graduates of bachelor's programs, and some continued on to a master's degree or other specialised training.

Interestingly, regardless of job placement status, 60% of graduates expressed an interest furthering their education or develop their career

## EU grants Brexit delay

Johnson will respond to the EU's delay offer once he has reviewed the details, his spokesman said yesterday.

senior EU diplomats confirmed that the written procedure period agreed was 24 hours, effective from the time London accepts the offer of a Brexit delay from October 31 to January 31.

Britain's departure has already been delayed twice -- from March 29 and April 12 -- after Johnson's predecessor, Theresa May, failed three times to get her deal ratified by parliament.

With British politics still paralysed over carrying out Brexit 3-1/2 years after a 52%-48% referendum vote in favour of leaving the EU, Johnson is demanding parliament approve an election on December 12 in return for more time to adopt his deal.

But he needs the support of twothirds, or 434, of the 650 lawmakers for a new election. A House of Commons vote was due later yesterday.

'FLEXTENSION'

The EU, forged from the ruins of World War Two as a way to prevent another devastating conflict in Europe, is fatigued by Britain's Brexit crisis but keen not to be held responsible for an economically tumultuous "no-deal" rupture.

President Emmanuel French Macron had been the main hurdle to an extension, arguing there had to be a good reason for a delay and that the British needed to break their own political deadlock. But a source close to Macron said the prospect of an election in Britain had strengthened

The source stressed that the third Brexit delay would come with conditions, including a refusal to renegotiate the divorce agreement and giving a green light to other EU countries to meet without Britain to discuss the bloc's future.

An EU diplomat said the hope was that the British would use the postponement wisely. Even though the United Kingdom is set to leave, it will have a legal obligation to nominate a new commissioner for the EU's powerful executive body. The latest delay plan envisages that
