A young man was beaten to death in the capital's Hajaribagh last night allegedly for protesting the sexual harassment of his friend.

The dead, Ariful Islam Sajal, 22, was a second-year student of Mohammadpur Government College.

Locals said Ariful and his friend Sanjida Akter were in Rayerbazar Dhal area around 8:45pm when two men hurled abusive words at Sanjida.

Hajaribagh police Officer-in-Charge Ikram Ali Miah said one of the men slapped Ariful when he protested

"Later, the men came back with eight to 10 others who attacked Ariful. He was taken to a local hospital and later shifted to Dhaka Medical College Hospital as his condition deteriorated," Ikram said.

Locals said that Ariful was attacked with bamboo sticks.

He said Ariful died in DMCH around 9:15pm, adding that his body was sent to the hospital morgue for

"We are trying to arrest the culprits," Ikram said.

Ten 'unlawfully killed' in Indonesia election riots

people, including several teenagers, were killed in Indonesia's post-election riots, the human rights commission said yesterday, as it accused police of beating up protesters.

In its final report on the May riots, the agency Komnas HAM said four victims were underage and most had been shot in the capital Jakarta and demonstrations in Kalimantan, Indonesia's section of Borneo island.

Indonesia's rights commission called on police to find the perpetrators, who it suspected were "actors trained, organised and professional in using guns". It did not elaborate.

"This is a tragedy," commissioner Beka Ulung Hapsara told AFP.

"These are unlawful killings -- or killings that took place outside legal mechanisms -- and that violates the criminal code," he added.

It is just 'eyewash'

Although the October 30 attack took place in broad daylight, following announcements from two rallies organised by two Islamist groups --Touhidi Janata and Ahle Sunnat Wal Jamaat, police are yet to arrest the top leaders of those organisations.

The attack was triggered by an anti-religious Facebook post from the account of one Rasraj Das, 27.

Rasraj, a fisherman, was freed in January 2017 as police found evidence that his Facebook account was hacked or faked by someone else before the anti-religious posts were uploaded

In the last three years, however, law enforcement agencies failed to track who actually uploaded the anti-religious post and what was the

INVESTIGATIONS 'ON'

Locals said that frequent changes of investigation officers for five cases has made it difficult to make any headway and submit the charge sheets.

On October 30, Kajal Jyoti Dutta filed a case over vandalism and attacks on Hindu houses and temples.

"Since then, five investigation officers have investigated the case but no progress has been made. I am really worried about the future of the case I filed," said Kajal.

Nasirnagar police Inspector Kabir Hossain is now investigating two cases -- one filed by Kajal and another by Rasraj's brother Dayamoy Das over vandalism of their house at Harinber.

Kabir was the second investigation officer for the case filed with attacks in

"The accused are unidentified as the plaintiffs cannot identify them. We need to investigate the matter analysing video footage, which is time consuming. But we are trying our best to submit a report as soon as possible," he told this newspaper.

Nasirnagar police Sub-Inspector Kawser Hossain is investigating three cases filed by police, and he is the first investigation officer for a case filed over the arson attack in Nasirnagar Paschimpara and Nasirnagar Banikpara areas.

But he is the second investigation officer for a case filed over the arson attack in Nasirnagar Chengapara.

"We are in the final stage of investigation," said Kawser. He, however, did not give a reason for the

November 19, 2016 Anjan Kumar Deb filed a case over an arson attack on his house. So far, three investigation officers investigated the

Sub Inspector Abu Taher, the current investigation officer, could not be reached for comments.

Brahmanbaria's Detective Branch of police is investigating a case filed against Rasraj Das.

Additional Superintendent of Police in Brahmanbaria Alamgir Hossain said they were monitoring the investigation in all the cases.

"We will submit the reports one after another as soon as all the investigations are in the last stage.

"As there are many accused, it is taking time to submit the investigation reports. Moreover, we will need to submit accurate evidence to court so it is taking some time," Alamgir said.

Rana Dasgupta said, "As all accused are on bail, all witnesses should be protected. We will also need a minorities protection act in this

A culture of impunity and delay in trial were among the central reasons why violence against minorities are taking place, he said.

In the enquiry, the ACC found Anis has a seven-storey building worth Tk 2.63 crore in the capital's Mohammadpur, a 1,400sqft flat worth Tk 1.54 crore; another flat worth Tk 60 lakh in Dhanmondi, a shop worth Tk 28.7 lakh at Multiplan Centre, a 1,300sqft flat worth TK 32.15 lakh; another 820sqft flat worth Tk 18.15 lakh in Swamibagh, 24.5 decimal of land worth Tk 1.38 lakh in Gopalganj's Muksudpur, a filling station on 80 decimal of land worth Tk 7 lakh in Gopalganj, and four decimal of land worth Tk 9.68 lakh in Keraniganj.

His total immovable properties are worth Tk 5.74 crore.

Besides, Anis has several investments. He has invested Tk 85.5 lakh in Arafin Enterprise Company, Tk 36 lakh in Ma Filling Station, and Tk 3 lakh in prize bond. He has a car worth Tk 11.25 lakh.

Anis's income tax files, media reports, and secret information, it was found that Anis actually does not have any legal source of income. It is primarily proved that he amassed the moveable and immovable properties from casinos," reads the FIR.

It said the enquiry would continue investigators found primary evidence that Anis bought 12 flats at Eastern Housing in Shantinagar, a flat in Jigatola and a poultry farm and a hatchery on around 100 bigha of land in Gopalganj. He also accumulated properties around Dhaka worth Tk 200 crore illegally.

Sources said his relatives were collecting rent from his flats and shops. His wife Sumi has a four-storey

building on 3,400sqft land worth Tk 1.26 crore in the capital's Shukrabad. She has other immovable properties worth Tk 56.65 lakh.

On October 23, the anti-graft body requested the Special Branch of Police to impose travel ban on both the accused and 20 other people as part of its investigation into their involvement in illegal casinos and accumulation of wealth from unknown sources of

Shakib banned for 2 years

January 2018. The third was made during the Indian Premier League later the same year, in relations to the April 26 match between Sunrisers Hyderabad and Kings XI Punjab.

A visibly downcast Shakib visited the Bangladesh Cricket Board's (BCB's) headquarters at the Sher-e-Bangla National Stadium in Mirpur last night and held a press conference alongside BCB President Nazmul Hassan regarding the ban.

"I am obviously extremely sad to have been banned from the game I love, but I completely accept my sanction for not reporting the approaches," Shakib told the media. "The ICC ACU is reliant on players to play a central part in the fight against corruption and I didn't do my duty in this instance. "I will cooperate with ICC and

be involved in the Anti-Corruption Unit's (ACU) education session so that promising young cricketers do not commit the same mistake in the future. The way that [I have been supported by] cricket fans, the people of Bangladesh, the BCB and the government during my good and bad times, I wish that your support will always remain. If I have that support, I will be able to return to cricket very soon and be able to fulfill my duties stronger than before and with

In the reasoned decision, it was revealed that during a period of several months of communication with Aggarwal, the bookie asked Shakib for inside information on the tri-series and team lineup information ahead of the IPL match. Aggarwal had also talked about bitcoin payments and wanted to know about Shakib's 'dollar accounts'. During this conversation Shakib, who had reported an offer of money to underperform during an ODI series against Ireland at home in 2008, had told Aggarwal that he wanted to meet

Shakib did not report any of these instances, and when contacted by the ICC's ACU on January 23 and August 27 this year, said that he thought that Aggarwal was a bit 'dodgy' and that, 'following their conversations, he had the feeling that Aggarwal was a bookie'.

Shakib's prompt and voluntary admission of his breaches, cooperation with the anti-corruption unit (ACU), previous good disciplinary record and the fact that his offences did not affect the outcome of the relevant matches were seen as mitigating factors. On the other hand, aggravating factors in the severity of his sanction was that, despite being an experienced player and a captain, he failed to report the approaches despite

Aggarwal's intentions being clear over several conversations. "While the BCB is shocked and

extremely disappointed that an experienced player like Shakib had failed to report a corrupt approach on three occasions, at the same time we are pleased that he has cooperated fully with the ICC ACU and has pledged his commitment to its education programme," BCB President Hassan said after Shakib finished speaking. "We hope he will come back as a better and wiser cricketer and serve Bangladesh for many more years when his sanction will be over. During the suspension the BCB will continue to support his efforts at returning to cricket."
Shakib had previously been banned

by the BCB for six months in 2014 for sciplinary reasons.

Sĥakib, who made his international debut in August 2006, is widely acknowledged to be the best cricketer Bangladesh has produced and played a starring role in the 2019 World Cup. He has also been at the top of the all-rounders' ranking regularly since

More recently, he played a leading role in a three-day players' strike which ended with the BCB agreeing to nine of the players' 11-point demand.

But when BCB officials yesterday said that they were waiting for an ICC circular before announcing a fresh team for the India series, it was evident that a sanction against Shakib was coming. And it came crashing to disturb an otherwise healthy Bangladesh cricket

Shakib is solely to be blamed for putting the country's cricket in such an embarrassing situation. The ICC rightly said: "Shakib has attended many education sessions and knows his obligations under the Code. He should have reported each of these approaches.

Over the years Shakib has decided to live on his terms. He has often been criticised for his off-field 'can't care less attitude'. He has served a sixmonth ban from the BCB before but seems to have learnt little along the way. It is inexplicable how a player, who considered disgraced former Bangladesh captain Mohammed Ashraful an evil influence in Bangladesh cricket, committed an offence he could have easily avoided with a little

Unfortunately, he did not act in the manner in which he has been serving Bangladesh cricket on the field for the last 13-odd years. His wilful disregard for the law put Bangladesh cricket in deep trouble at a time when Bangladesh cricket is in transition.

The BCB planned a fresh journey with Shakib at the helm after the World Cup. Unfortunately, he will not be around for at least one year provided that he avoids the suspended one-year

It can be a good lesson for the rest of the team, but it remains to be seen if they can rise from the ashes.

Whoever corrupt getting caught

the anti-corruption drive was underway, the premier said her dictionary did not contain the word "fear". "I wouldn't have started the drive

against corruption if I was afraid... I am not a person to be scared of anything. Hasina said her political background and commitment prompted her to

launch the campaign. Asked if the corrupts beyond the political arena would also be brought to justice, she said suspects were not

being arrested based on any criteria. Regarding the ICC's possible ban on Bangladesh all-rounder Shakib Al Hasan, the PM said the BCB would remain beside Shakib and extend all

He even didn't inform the ICC [International Cricket Council] of it. He should have informed the ICC instantly and he committed a mistake. If ICC takes any step, there is nothing much we can do," she added.

About the recent strike by cricketers, Hasina said that "chapter" has already been closed and the problem did not exist now.

"There are a very few countries who support their players the way we support ours," the PM said, adding that the cricketers could have informed the BCB about their demands before calling for a sudden strike. ONION CRISIS

Responding to a question about the soaring onion prices, the PM said the crisis was temporary and there was nothing to be worried about.

Talking about some recent countries of the world and the killers are taking advantage of it."

The PM hoped that the government would be able to bring back the rest of the killers like it did in the cases of Bazlul Huda and Mohiuddin, who were deported from Thailand and the USA respectively and later executed.

NAM NOT A 'DEAD HORSE'

Speaking about the NAM, the premier said the forum is not a "dead horse" and it is still active. She said Bangladesh still has the ability to hold the summit of the 120-nation grouping.

"After coming to power in 2001, the BNP had cancelled Bangladesh's decision to organise the summit in Dhaka, calling the forum a 'dead horse'. But the reality is that the NAM is not a 'dead horse', it's still active and running."

In a written speech, the PM said the participation of the Bangladesh delegation in the 18th NAM Summit in Baku of Azerbaijan has further strengthened the country's position in the international arena.

She said the role of the NAM in establishing global peace, ensuring overall development and implementation of the SDGs is undeniable.

"Especially, the NAM has a crucial role alongside the United Nations in resolving the Rohingya crisis. So I think the participation of the Bangladesh team in the NAM Summit held after the UN General Assembly has further consolidated Bangladesh's position in the global forum.

Hasina said in her speech at the NAM Summit, she highlighted the Rohingya crisis and climate change as the two major challenges for Bangladesh.

The PM also reiterated that voluntary return of the Rohingyas to their homeland in Rakhaine in safety, security and dignity is the only solution to the crisis.

Road Transport and Bridges Minister Obaidul Quader and State Minister for Foreign Affairs Shahriar Alam were present at the press conference.

Buet students vow to keep boycotting classes, tests

Says unive not doing enough to meet their demands

Buet students demanding justice for Abrar Fahad yesterday vowed not to return to classes or sit for exams until the authorities met their 10-point demand.

The students came up with the announcement at a press conference held in front of Buet Shaheed Minar. The protesting students alleged that

although the Buet authorities formed a probe body 10 days after Abrar's murder, there was no visible progress in the investigation.

Only two of their demands have so far been met, the students said.

"No one from the Buet authorities has contacted Abrar's family regarding compensation and bearing expenses of the case, though they had issued a notice stating that they would do so, said a spokesperson of the protesters.

"Had the Buet administration wanted, they could have easily met our demands in the last 13 days since some protest programmes were called off, the statement read.

The protesters threatened tough movement in coming days if the authorities failed to implement their

Antora Tithi, a batch-15 student of Mechanical engineering department said, "We know that we are lagging behind academically, but we cannot wait for someone from us to face the same fate of Abrar

"Let the administrative activities continue, we will not cooperate in academic activities," she added.

Contacted, Buet Directorate of Students' Welfare Prof Mizanur Rahman said, the investigation into the incident is going on and they are hoping to get the probe report by next week. "The probe committee has sought

for 10 more days to submit the report and the request was approved," he said. Asked about the allegation of not contacting Abrar's family, he said they were trying to "find a proper way" to contact the family. The agitating students on October

15, called off their protests that started on the day Abrar was killed, but declared they will not return to classes and exams until the authorities expel those involved in the killing on the basis of the charge sheet submitted by the law enforcers.

Abrar, a second-year students of Electrical and Electronic Engineering department, was beaten to death by a group of Chattra League men at the university's Sher-e-Bangla Hall between the night of October 6 and early hours

FR Tower Design Forgery

Charges pressed against five

Anti-Corruption Commission yesterday pressed charges against five people in a case filed over forgery in the design of FR Tower in the capital's

Banani area. Md Abu Bakar Siddique, assistant director of ACC, submitted the chargesheet in the case, in which the accused are Syed Md Hossain Imam Faruq, a lease holder of FR Tower; Liakat Ali Khan Mukul, chairman of Rupayan Housing Estate Ltd; Md Humayun Khadem, former chairman of Rajdhani Unnayan Kartripakkha; Md Saidur Rahman, former chief engineer of Rajuk, and Syed Makbul Ahmed, former

authorised officer of Rajuk. The FR Tower caught fire on March 28. The incident left 25 people dead

and 73 others injured. The ACC had filed two cases against 23 people for their alleged involvement in illegally extending Banani's FR Tower

beyond the permitted number of floors. During investigation, the anti-graft body found that the 23-storey FR Tower had narrow exit points and staircases, and no fire alarm, while the fire exits

were blocked. The building authorities had legally obtained permission for a 15-storey building but they illegally added another eight storeys over time.

English tourists seriously injured in Australia shark attack

An English tourist had his foot bitten off by a shark while another was bitten during the attack in the Whitsunday Islands near Australia's Great Barrier Reef yesterday, officials said.

In the latest in a string of shark attacks in the tourist area, a 28-yearold man's right foot was bitten off while a 22-year-old man suffered serious lacerations to his lower left leg, according to Mackay Base Hospital.

The pair were in a "serious but stable" condition in hospital after being airlifted from the resort town of Airlie Beach, an official told AFP. They had been on a boat tour of

the Whitsundays Islands when they were attacked while swimming in Hook Passage, according to the RACQ Central Queensland Rescue, which operated the helicopter flight.
