take to the streets again if needed.
Talking to journalists, DU VC Prof Akhtaruzzaman yesterday said the accommodation crisis at DU has existed for a long time, and long-term planning is needed to resolve the crisis.
Demanding abolition of "gono room" -- an unofficially-designated room in all dorms where 30-35 freshers are compelled to stay because they do not get seat allotments -- Tanbir on September 1 moved to a "gono room" of Kabi Jashim Uddin Hall.
On October 1, the Ducus member issued a 15-day ultimatum to the university administration to resolve the accommodation crisis on campus.
Tanbir, a former member of Chhatra League's central unit, also threatened to move in to the VC's residence if the authorities fail to take any effective measure by this time.
Meanwhile, the university authority in a provost committee meeting on October 10 decided that students will have to leave their dormitories within 15 days of completing their master's degree examinations.

two expelled local Awami League leaders, over the murder of madrasa student Nusrat in April, an incident that shocked the nation.
Mamunur Rashid, judge of the Women and Children Repression Prevention Tribunal in Feni, also fined the convicts Tk 1 lakh each and ordered the district magistrate to give the money to the victim's parents.
The accused burnt Nusrat by pouring kerosene on her in a planned way, and they deserve exemplary and harshest punishment, the judge said while delivering the judgment in a packed courtroom.
Sacked madrasa principal Siraj Ud Doula, the prime accused, was awarded capital punishment for giving the order to kill Nusrat while the others were given death penalty for plotting and committing the murder.
The convicts include two teachers and 11 students of the madrasa, and two expelled AL leaders, who were members of the madrasa governing body.
The 19-year-old lost her battle for life on April 10, four days after she was set afire. She was sexually harassed by the then principal Siraj on March 27. Her mother filed a case against Siraj, who was later arrested and sent to jail.

joint secretary, and was later elected member of the Indian Constituent Assembly. Nominated by the Jukta Front, Farmuzul contested in the election as an independent candidate and secured more than 80 percent votes to become member of Provincial Assembly in 1954.
He made a positive impact in the policy and decision-making process of the Assembly, and was declared minister designate only days before General Ayub Khan took over in 1958.
He suffered from chronic bronchial asthma for many years, and eventually died from a heart attack while in his sleep on October 30, 1962.

'Act instantly against rights violations'

President urges NHRC

UNB, Dhaka

President Abdul Hamid yesterday asked the National Human Rights Commission (NHRC) to take instant and effective steps against human rights violations.
He came up with the directive when a six-member NHRC delegation, led by its newly-appointed Chairman Nasima Begum, met him at Bangabhaban in the evening.
President's Press Secretary Joynal Abedin briefed reporters after the meeting.
"Take instant and effective measures if you see any act of human rights violation anywhere in the country," the president said addressing the NHRC delegation.
He also advised the commission to strengthen its overall activities at the grassroots level so that people can be aware of their rights, and get necessary help from the commission when necessary.
"Let the people of grassroots know the function of the National Human Rights Commission," Hamid said.
Noting that human rights are people's fundamental rights, he said the constitution of Bangladesh has given utmost priority to protecting human rights.
The president expressed hope that the newly-formed commission will play a very effective role in protecting people's rights.
NHRC Chairman Nasima apprised the President of future plans and different activities of the commission. Besides, she informed him about its ongoing campaign to establish human rights throughout the world. The NHRC delegation also sought President Hamid's all-out cooperation in this connection.
Secretaries concerned to Bangabhaban were also present at the meeting.
The NHRC is an independent statutory body formed under the National Human Rights Commission Act 2009, which serves as the major national human rights watchdog, monitoring implementation of state obligations to respect protection and the fulfillment of the rights of every citizen of society.

the parliamentary watchdog, presided over the meeting. Committee members Motahar Hossain, Nasir Uddin, Mahbubur Rahman, and top officials of three services, among others, were present. The committee recommended that the government relocate Rohingyas to Bhashan Char immediately.
Some 7,40,000 Rohingyas fled a military crackdown in Myanmar in August 2017 and crossed into Bangladesh, where 3,00,000 members of the persecuted Muslim community were already in camps.
Many Rohingya refugees said there had been mass rapes and murders in the

villages, and several reports said there are reasonable grounds to believe the atrocities amounted to "genocide".
The government, earlier on several occasions, said it is planning to relocate Rohingya refugees in Bhashan Char. The idea, however, has been met with criticism from different quarters.
In an interview with a German media outlet, Bangladesh's Foreign Minister AK Abdul Momen in late August said that the Bangladesh government wants the United Nations aid agencies to support its plan to relocate 1 lakh refugees to the island in the Bay of Bengal.

Only 7.7pc citizens aware

Speaking as chief guest at the inaugural session of the daylong programme, Deputy Speaker Fazle Rabbi Miah said access to information is a civic and democratic right of all citizens, and the government is committed to ensure it.
At the convention, the organisers unveiled a study report, titled "Right to Information Survey 2019", to show the status of RTI implementation in the country.
MJJ -- in association with Management and Resources Development Initiative (MRDI), OrgQuest Research Ltd, the World Bank and UK Aid -- conducted the study between January and March this year.
After surveying a total of 12,800 citizens across the country, the study found only 7.7 percent of them are aware of the law. The percentage was 23 in 2012.
It also surveyed 768 government officials in 64 districts, and found about two-third of them did not receive a single application from citizens using RTI Act since they were

designated for providing information services.
About lack of awareness on RTI, the study observed that people's access to information has increased after the use of ICT flourished which might be a cause behind it.
People are now able to get information from government websites and social media platforms, which also make them less interested to use RTI, the study said.
Nevertheless, of the people who used the act -- a total of 359 people -- about two-third received their desired information, mostly in time, it added.
Speaking as chief guest at the closing session, Planning Minister Abdul Mannan thanked the organisations for conducting the survey, saying it will help in implementation of the law.
Mercy Miyang Tembon, country director of World Bank, Bangladesh and Bhutan; and Martuza Ahmed, chief information commissioner, also spoke at the event, among others.
