Talking to reporters at his office yesterday, Mahbubey Alam said people of the country expect the case to be settled at the HC soon.

The documents of the murder case reached the HC on Tuesday as a death reference, for examining of the trial court verdict that sentenced 16 accused to death.

MODEL VILLAGES

Significant progress in 3 dists: minister

The cabinet committee on economic affairs yesterday gave retrospective approval of a project worth Tk 154 crore, to build model villages in Rangpur, Gopalganj and Bogura

district, said Finance Minister AHM Mustafa Kamal. Bangladesh Machine Tools Factory (BMTF) Ltd started construction work of three model villages with limited urban facilities to prevent decrease of agricultural land.

The decision came at a meeting held at the secretariat. BMTF, under management of Bangladesh Army, got approval for the work following the government's direct procurement method.

The Executive Committee of the National Economic Council on August 19, 2014 approved the Tk 424 crore "Palli Janapad" project, through which four-storey buildings would be constructed in each village.

The initial plan was to built such villages at seven sites. "There has been significant progress in the construction work [of "Palli Janapad]. So far, 80 percent work in Rangpur and Gopalganj, and 40 percent in Bogura have been completed," the finance minister said.

Initially, 272 flats in four categories would be constructed in seven villages. Allottees of each flat would pay 30 percent of the construction cost as down payment.

The rest would be paid in installments over 15 years, in addition to five percent simple interest on the amount. The model villages would have shops, dairy or poultry farms, solar panels, biogas facilities, ATM booths, mobile banking and playgrounds.

Protect bird nests at Rajshahi orchard: HC

The High Court yesterday directed authorities concerned not to destroy bird nests at a mango orchard in Khordo Bausha village of Bagha upazila in Rajshahi.

It also issued a rule seeking explanation as to why the

specific area should not be declared a sanctuary for birds. The bench of Justice M Enayetur Rahim and Justice Md Mostafizur Rahman passed the order, directing Rajshahi Deputy Commissioner and local Upazila Nirbahi Officer to submit a report within 40 days after inspecting whether the HC order can hamper the garden owner or leaser.

Supreme Court Lawyer Proggya Paromita Roy brought the matter to the notice of the High Court, reading out a report in Bangla daily Prothom Alo, titled "Orchard owner gives 15 days to evict birds".

The report said several thousands of Shamuk khol birds (Asian openbill stork) have built nests in 25 trees of the mango orchard, which have babies that haven't learned to fly yet. But the orchard owner wants to get rid of the birds, and threatened to do so in 15 days by destroying the nests

50 gold bars recovered from Biman plane

RMG workers stage demo for arrears

Workers of a readymade garments (RMG) factory in Savar yesterday demonstrated in front of their factory, demanding arrear salaries.

Around 700 workers of Trendy Outerware Ltd in Belma area started their demonstration around noon. Later, they held a rally blocking Bishmail-Zirabo road for one hour.

Demonstrators also tried to block Dhaka-Aricha highway but police intervened, reports our Savar correspondent.

The workers said factory authorities declared the factory shut on October 15 without paying salaries of the previous and current months. They said they have asked the authorities for the salaries multiple times already, but only received false promises.

'They said our salary would be paid on Wednesday [yesterday]. But we when got to the factory, we saw the gate was open but there was no one there," said Nargis Begum, a worker.

"After this, we began protesting and tried to block the Dhaka-Aricha Highway. Police assured us that our salary would be paid tomorrow [today]," she said.

"We are requesting factory authorities to be met. to pay workers' salaries by tomorrow [today]," Safiur Islam Sultan, Savar thana unit secretary of Bangladesh Readymade Garments Workers Federation told The

The workers will go for tougher movement if their demands are not met, the labour leader added.

Owners of the factory could not be reached for comments despite repeated phone calls.

Earlier on Sunday, the workers demonstrated in front of BGMEA building. They returned after getting assurance from BGMEA authorities that they would look into the matter.

CASE AGAINST EX-SONAGAZI OC

3 additional witnesses to be produced on Nov 4

COURT CORRESPONDENT A Dhaka court yesterday allowed the prosecution to produce

three additional witnesses before it, in a case filed against suspended Sonagazi OC Moazzem Hossain over filming Feni madrasa student Nusrat Jahan Rafi's statement and circulating the footage on social media without her consent.

The witnesses are: Nusrat's friends Nishat Sultana and Nasrin Sultana Furti, and PBI Sub-inspector Mohammad Abdullah Badi -- who prepared the forensic report of Nusrat.

Judge Ash Sams Joglul Hossain of Dhaka Cyber Tribunal passed the order after Public Prosecutor Nazrul Islam Shamim appealed to produce three more witnesses. Nishat and Nasrin went to Sonagazi Police Station with

Nusrat when Moazzem asked her indecent questions. They were not allowed to enter the OC's room. Earlier, the tribunal recorded statements of eight

prosecution witnesses, including complainant of the case. On April 15, Supreme Court lawyer Sayedul Haque Sumon filed the case against Moazzem. Nusrat was set on fire on April 6, after refusing to

withdraw a case she had filed against her madrasa principal Siraj Ud Doula for sexually harassing her. She died at Dhaka Medical College Hospital on April 10. Moazzem was withdrawn the same day, after Nusrat's

family alleged that he had not cooperated with them. A video of Moazzem asking Nusrat humiliating questions also went viral on social media, drawing widespread criticism.

No bar on lawmaker Harun's release

SC upholds HC bail order

The Supreme Court yesterday upheld a High Court order that granted bail to BNP lawmaker Harunur Rashid in a corruption case in which he was jailed for five years by a lower court.

A four-member bench of the Appellate Division headed by Chief Justice Syed Mahmud Hossain passed "no order" on a petition filed by Anti-Corruption Commission, seeking a stay on the HC order.

It means the order will remain in force, ACC lawyer Kurshid Alam Khan told The Daily Star. He also said there is no legal bar on Harun's release, following the SC order. On October 28, the HC granted six months' bail to Harun in the case, clearing the way for him to walk out of

jail. The HC also stayed a part of the lower court verdict that fined the Chapainawabganj-3 lawmaker Tk 50 lakh. The bench of Justice Md Shawkat Hossain passed the order, following an appeal filed by Harun challenging the

trial court verdict. A Dhaka court on October 21 sentenced Harun to five years' imprisonment and fined him Tk 50 lakh in the case filed over tax evasion while importing a luxury car. The tax was dodged by abusing the MP's duty-free car import facility, according to the case statement.

Advocate Khandker Mahbub Hossain and several pro-BNP lawyers appeared for Harun.
