In its report, the three-member probe body had said three officials at the Kathalbari Ferry Terminal in Madaripur may be blamed for delaying “Ferry Cumilla” that day -- Salam Hossain, Khokon Miah, and Firoz Alam, the report said.

That report has already been submitted to the HC, during a hearing of the same writ petition filed by Advocate Md Jahir Uddin Limon, chairman of rights organisation Legal Support and People’s Rights, seeking Tk 3 crore compensation for Titash’s family.

Titash, a student of Kalia Pilot Secondary School in Narail, was critically injured in a motorbike accident in the district on July 24.

A day later, doctors of a local hospital referred him to Dhaka Medical College Hospital for an emergency surgery.

The family was taking him to Dhaka in an

ambulance, which arrived at the Kathalbari Ferry Terminal around 8pm on July 25.

The ferry was already at the pontoon, but its gate was closed and it was not loading vehicles. Authorities said they were waiting for the arrival of Abdus Sabur Mondal, the head of Digital Service and Public Service Innovation Cluster and E-Service Implementation Specialist of the Access to Information (a2i) Programme at the Prime Minister’s Office. The ambulance was stuck on the pontoon and could not reverse or shift to another hospital because of the queue of vehicles in front of and behind it.

The ferry started loading vehicles at 10:20pm when authorities learned that Sabur Mondal was nearby. Around 11pm, he arrived and the ferry started moving. Titash died on the ferry, his family said.

from noon to 1pm for people from all walks of life to pay their last respects to the freedom fighter. The second janaza will be held at BNP’s Nayapalton headquarters after Zohr prayers; while a third one will be held at Dhaka South City Corporation building premises. Khoka’s body will then be taken to his Gopibagh house, following which a fourth namaz-e-janaza will be held at Dhupkhola ground after Asr prayers.

BNP joint secretary general Ruhul Kabir Rizvi said to mark the death of Khoka, black flags will be hoisted in party offices across the country, and party leaders and activists will wear black badges.

Meanwhile, DSCC declared a holiday today in honour of Khoka. All activities of the city corporation and its regional offices will remain closed on the day.

A janaza of Khoka was earlier held at Jamaica Muslim Center in New York, joined by a number of Bangladeshis.

Khoka breathed his last while undergoing treatment for cancer in New York earlier this week, after suffering from kidney cancer since 2014.

He is survived by his wife Ismat Ara, daughter Sarika Sadeque, sons Ishraque Hossain and Isfaq Hossain, and a host of relatives, followers and well-wishers.

attack, he asked why action against him was not taken.

“Will the state promote such [land] grabbers? Will AL turn into a party of grabbers?” -- asked the academician.

If AL does not want to turn into a party of occupiers, it will have to ensure justice for the killing of the Santal men by bringing all the accused, including the lawmaker, under trial immediately, Mesbah added.

He also demanded constitutional recognition of ethnic minority communities.

He further urged the industries minister to listen to the grievances of the community, who are suffering due to the attack and the eviction, and take necessary steps to ensure their safety and livelihood.

Speaking at the event, Rabindranath Soren, president of Jatiya Adivasi Parishad,

condemned dropping the names of 11 prime accused, including AL leader Azad, and policemen from the charge sheet of the case filed over the attack.

“...When will the deaf government listen to our grievances? When will the indigenous people get justice?” Rabindranath asked.

He demanded that authorities concerned cancel the “farical” charge sheet, press charges against the prime accused Azad and policemen, hand over the land to the rightful claimant, and withdraw the cases filed against them based on false allegations.

Shamsul Huda, executive director of Association for Land Reform and Development (ALRD); Sanjeeb Drong, general secretary of Bangladesh Adivasi Forum; and Ruhin Hossain Prince, a central leader of Communist Party of Bangladesh, also spoke at the programme.

Enamul Haque Arman, former vice-president of the same unit, in Cumilla after raiding a house near Indian border.

He came under the spotlight after Rab busted his illegal casino business at different sporting clubs in Dhaka. He was expelled from the Jubo League following his arrest.

Samrat was then brought to the capital, and the elite force conducted operations at various establishments where the former Jubo League leader either lived or carried out political and business activities.

Rab also took Samrat to his political office in Kakrail where he had been reportedly staying since the crackdown began on September 18.

Rab members at a press briefing said they had seized two torture devices, a pistol with five bullets, two hides of kangaroos, 1,160 pieces of yaba and 19 bottles of foreign liquor from there.

A Rab mobile court, led by Executive Magistrate Sarwoer Alam, sentenced Samrat to six months’ imprisonment for possessing wild animal hides and another six months for possessing illegal liquor.

Rab filed the two cases against him with Ramna Police Station the next day.

On September 24, the government imposed a travel ban on Samrat.

On October 13, Samrat’s mother Sayera Khatun Chowdhury said her son was implicated in the cases due to personal and political vengeance.

On October 15, Samrat was placed on a 10-day remand in connection with the two cases -- one for possessing arms and ammunitions and the other for possessing drugs -- at his office. After completion of his remand, he was sent to jail.
