## Locals deprived of services as councillors in jail

Though he was indifferent to attending city corporation's meetings, sacked Dhaka South City Corporation ward-9 councillor AKM Mominul Haque Sayeed rented a flat to use as his office, spending four times higher than the money allocated by the DSCC.

The DSCC gives a councillor Tk 8,000 a month to pay office rent, whereas Sayeed rented a flat at Tk 35,000 and made it his office in Arambagh. Sayeed's lavishness has put his

successor Sultan Miah in a fix as he cannot pay the additional rent from his pocket. As a result, people of the ward are being deprived of service. On October 27, the DSCC gave

Sultan, councillor of ward-8, the additional responsibility of Sayeed's "I need a citizen certificate for

opening a bank account, but no one is found at the councillor office [of ward-9]. I have been asked to come later," said Humayara on Monday.

People usually go to councillor offices for character, citizenship,

inheritance, and marriage certificates. Like DSCC ward-9, people of DSCC ward-39 and wards-32 and-33 of Dhaka North City Corporation are also not getting adequate services after three councillors were arrested. "I need an inheritance certificate,

but I'm not getting it as our councillor is arrested," said Akhtaruzzaman, a resident of KM Das lane, in front of the ward-39 councillor office at Rajdhani Super market in Tikatoli. Almost a month after the beginning of drive against illegal casino business,

the government removed Sayeed for

being "absent in general meetings and staying abroad without permission from the DSCC". Sayeed, who is reportedly in Singapore now, is also joint general secretary of Dhaka South Jubo League and the president of Arambagh Krira

Sangha. Visiting the councillor office on the second floor of a six-storey building in Arambagh around 11:30am on Monday, this correspondent found Sayeed's room locked.

# 11,000 illegal foreigners to be deported

Says liberation war affairs minister

The government has finally decided to deport around 11,000 foreigners staying illegally in Bangladesh without valid documents.

Liberation War Affairs Minister AKM Mozammel Haque disclosed the decision after a meeting of the cabinet committee on law and order at the secretariat yesterday.

"Intelligence agencies have identified the foreigners staying illegally. The problem is that they have no money to return home.... So we will request the government to allocate money so that we can send them back to their respective countries," he told journalists.

According to law enforcers, a large number of undocumented foreigners are from different African countries. Many foreiners are involved in crimes.

Jail sources said a total of 633 foreigners were behind bars till yesterday. Of them, 56 are serving jail terms while 500 facing trial. Besides, processes are underway to deport the rest of them as their jail terms have expired.

Talking to The Daily Star, an official at the headquarters of the Department of Prisons said no foreign mission in Dhaka has contacted the Bangladesh authorities to take back their nationals who served jail terms.

Law enforcers say many migrants enter Bangladesh as footballers, students, or businessmen, but they overstay their visas. They never try to

return home.

Even the Dhaka missions of some countries do not respond to communications from the Bangladeshi authorities concerned.

An official of the Detective Branch of the Dhaka Metropolitan Police said many foreigners destroy their passports immediately after their arrival in Bangladesh so that law enforcers cannot identify their nationalities.

He said they face problems in identifying the nationalities of illegal foreigners as many African countries do not have a mission in Dhaka.

The Security Control Organisation (SCO) of the Special Branch of police usually deals with the foreigners.

According to SCO officials, unlike other countries, Bangladesh has no mechanism to deal with illegal migrants. There is no fund for deporting those held by police.

"We don't have a deportation centre to detain illegal foreigners until confirming their identities and communicating with the authorities concerned abroad," said an SCO official, preferring anonymity.

SB officials said Bangladesh's law does not permit law enforcers to detain a foreign national without bringing formal charges against him. And that's why the law enforcers have no other option but to implicate him in cases over criminal activities or illegal stay in the country.



#### Acclaimed Bengali writer Nabanita Deb Sen no more

Award-winning poet, writer and acclaimed teacher Nabanita Deb Sen passed away in her south Kolkata residence last night prolonged illness. She was 81. A Sahitya Akademi



be best remembered for her feminist take on the Ramayana, which she has analysed from the perspective of Sita. Her book, Sitayan, was translated into many languages. Her parents, both poets, were

associated with Rabindranath Tagore and thus Nabanita often said she knew that "one of the signatures of growing up is to write poetry".

Her first collection of poems came out in 1959, the year she was married to economist Amartya Sen. The couple had two daughters and separated later.

She taught for many years in the Comparative Literature department of the Jadavpur University and was a

favourite among students. Truckbahone travelogue, McMahone [On a Truck Alone to

McMohan], provides an entertaining and delicate description of Tawang in Arunachal Pradesh. Nabanita, in her early twenties, hitchhiked up to Tawang in an Army truck to write the all-time bestseller of Bengali literature.

Lamenting her demise, writer Shirshendu Mukherjee said Nabanita had a "huge pool of material" which could not be used due to her ill health. "Besides losing a friend, I would say I will be missing her writings," Shirshendu said.

Chief Minister Mamata Banerjee said "her absence will be felt by her myriad students and well-wishers".

### 13-year-old rape victim caned at village arbitration

Alleged rapist yet to be held

A 13-year-old girl has been raped by a man and later caned by a village arbitration in Faridganj upazila of Chandpur, said police.

The victim's mother filed a case with Faridganj Police Station in connection with the rape and the torture on Monday.

According to the case statement, Faruk, 24, a day labourer by profession, picked up the girl on her way to school on October 30. He then boarded a cabin of a Dhaka-bound launch with the girl and raped her.

Faruk returned to Chandpur the next day and released the confined girl. On information, two members of the upazila's Balithuba union parishad -- Haris Miah and Mohsin Topadar -- called a social arbitration on Sunday in which they awarded the

girl with caning, the case statement said, adding that the locally influential duo also let Faruk escape. Both the union parishad members, Faruk and some other people, who were present during the village arbitration, were made accused in the case. Chandpur Senior Judicial

Magistrate Md Hasan Zaman took the case into cognisance and recorded the victim's statement. Abdur Rakib, officer-in-charge of

Faridganj Police Station, said they were trying to arrest the accused who were on the run as of 9:30pm yesterday.

# Mayeen Uddin Khan Badal

brother Manir Khan told The Daily Star. Badal was admitted to the hospital on October 18 as he was suffering from a heart disease, Manir said, adding that his body was being brought back to Dhaka yesterday.

Badal, hailing from Sarowatoli village of Boalkhali upazila in Chattogram, left behind his wife, three sons and a daughter.

He was the third among eight siblings, said Manir.

Badal was elected lawmaker thrice in

a row from Chattogram-8 constituency, beginning in 2008. Over the years, he made a reputation for himself as a great orator in the

House. Badal was vocal against corruption and lack of good governance, although

his party was a part of the government.

Expressing sorrow over his death, Awami League presidium member and former minister Mosharraf Hossain said Badal actively took part in the Liberation War from Chattogram city.

Dr Mahfuzur Rahman, chairman of Bangladesher Mukti Sangram O Muktijuddho Gobeshona Kendro Trust, said Badal was involved in the politics of Bangladesh Chhatra League in the 1960s, adding that he actively took part in the Liberation War as a guerrilla.

Badal joined JSD in the 1970s and was a central committee member of Bangladesher Samajtantrik Dal in the 1980s, said his brother Manir, adding, he joined Jatiya Samajtantrik Dal afterwards and was elected as an

executive president. Badal was born on February 21,

1952. Prime Minister Sheikh Hasina, Speaker Shirin Sharmin Chaudhury and members of different political parties expressed deep shock over

Badal's demise. Meanwhile, parliament yesterday unanimously adopted obituary references on a number of distinguished personalities, including Badal and former Dhaka City mayor and BNP

leader Sadeque Hossain Khoka. Participating in the obituary motion on the death of Badal, who is an Awami League MP, Hasina said his demise had created a vacuum in the country's

politics. "Badal always worked for the people

of his constituency. He contributed to different sectors, including politics. His death has created a big vacuum in the political arena of the country," she said.

Paying rich tribute to the veteran MP, Hasina said Badal played an active role in all democratic movements, including the liberation war and the anti-Ayub movement.

"I had the opportunity to work with him [Badal] in different movements in the streets," Hasina said, adding, "It's very unfortunate for us that we will not be able to hear his strong voice in parliament anymore."

Hasina, also leader of the House, prayed for the eternal peace of the departed soul and conveyed profound sympathy to the bereaved family.

Opposition leader in parliament Raushan Ershad, AL MPs Tofail Ahmed, Amir Hossain Amu, Mohammad Nasim, Abul Kalam Azad and Shajahan Khan, President of a faction of Jatiya Samajtantrik Dal Hasanul Haq Inu, Workers Party leader Rashed Khan Menon, Jatiya Party lawmaker Anisul Islam Mahmud and opposition chief whip Mashiur Rahman Ranga, among others, also participated in the obituary reterence.

Earlier, Speaker Shirin Sharmin Chaudhury moved the obituary references separately with brief resumes of those who died after prorogation of the fourth session of the 11th parliament on September 12. While moving the references, the
