Ahmed was the editor of a local publication of Sreemangal called Pubali Barta, and on August 3, 2002, his mutilated body was found on the rail tracks. He had gone missing two months before that. The case died along with the man—other than a 2002 post by Reporters Without Borders, there is no information available on who killed him and why.

Even those whose investigations were completed are having to wait for decades for justice. The trial of the murder of Saiful Alam Mukul, editor of the Jashore-based Daily Runner, has been going on for 21 years. He was killed by a handmade bomb thrown at him on the night of August 30, 1998. After over two decades, his family still hold press conferences demanding justice—the latest of which was held on his death anniversary this year. According to media reports, his brother Kabirul Alam Dipu addressed the reporters and said, "It would be better if I were not a brother of Mukul."

And who can forget Humayun Azad. The eminent writer's case is still unsolved 14 years on.

Most of them were district correspondents from outside of Dhaka, who were at the forefront of local drug wars and militant activities, but their cases remain unsolved. Almost all of them died in violent, pre-mediated murders. Between 2001 and 2004, four journalists in Khulna were murdered allegedly by terrorists of Purba Banglar Communist Party and its offshoots, but none of those cases saw the light of day. In fact, one of those cases—that of Sheikh Harunur Rashid who was shot point-blank at the chest—was dismissed in court, while another, that of Shukur Hossain, also shot, completed the trial without convicting anyone.

These trends bear bad news for the father of Ihsan Ibn Reza Fagun, a student journalist of Priyo.com, who was killed in May this year. His father, Kakon Reza, also a regular columnist in different newspapers, finds his faith faltering. "Fagun may have been killed for his reportage on a real estate company. We all know who the hit-man is but he is still out of reach," says Reza. Meanwhile, he writes about his son in newspapers, making sure that Fagun will not be forgotten, the way many have been.

Killed on Aug 3, 2002 - mutilated.
His mutilated body was found by police
on 3 August, more than two months after
he disappeared. Police have no leads in
the case.

Case status: Complete impunity

Manik Chandra Saha Ekushey Padak winner, Khulna-based

Killed on Jan 15, 2004 - bomb attack. Chargesheet was given the same year framing several members of Purba Banglar Communist Party.

Case status: 9 sentenced for life on Nov 30, 2016. It took 13 years.

Humayun Kabir Balu Editor of Daily Janmabhumi

Killed on June 27, 2004 - bomb attack. Judge made the observation that the charge sheet was very weak - "serious absence of necessary witnesses/proof."

Case status: All the accused were set free due to lack of evidence in 2008.

Humayun Azad Writer and Ekushey Padak winner

Killed on Aug 12, 2004 - hacked to death. Hacked to death for his critique of Islamist fundamentalist politics. 5 charged of whom 3 are on the run

Case status: Trial ongoing for 14 years. In 2014 the High Court had directed the lower court to dispose of the case within six months.

Kamal Hossain

Local correspondent for daily Ajker Kagoj

Killed on Aug 22, 2004 - abducted.

Abducted and brutally murdered by unknown assailants in the early morning in Manikcchari upazila of Khagrachhari.

He, was the general secretary of the Manikcchari Press Club

Case status: On March 21, 2005, The Chittagong Speedy tribunal sentenced one person to death and 11 other to life imprisonment. 14 others were aquitted.

Vice-president of Bangladesh Federal
Union of Journalists (BFUJ) and Exec

Killed on Oct 3, 2004 - decapitation.

At least nine investigation officers dealt with the case and the police submitted final reports in the sensational case four times but the family declined all of them alleging that actual culprits are not being charged. The case is with the

editor of Bogura-based Durjoy Bangla.

Case status: Charges yet to be framed.

Killed on Nov 17, 2005 - strangled.
Although colleagues were not aware of any specific threat against the reporter, they said that Das had written about sensitive topics such as the activities of Islamist militant groups, according to Media Watch

Case status: Five sentenced for life, four acquitted.
