# Weakened Bulbul crosses coast

Makes landfall in West Bengal, enters Bangladesh thru' Sundarbans; 21 lakh evacuated in 14 dists

Cyclone Bulbul lost strength and entered Bangladesh through the Sundarbans in Khulna around midnight yesterday, after making landfall at Sagar Island in the southern part of India's West Bengal.

The cyclone left at least five people injured in Bhola's Lalmohan upazila and Char Hardinge. Around 15 houses were damaged in the upazila, said fire service Mahmudur Hasan, divisional forest

officer in the Sundarbans (East), early today said the cyclone's eye crossed the Bangladesh coast with low tide in the Bay. The wind speed was between 100 and

120 km per hour at that time, according to the Met office. In a special bulletin around 11:00pm, the Met office had said "Bulbul" weakened into a "severe" cyclone from a "very severe" one and moved northeast at a speed of

about 8kph. It started crossing the West Bengal-Khulna coast near the Sundarbans around

9:00pm, according to the bulletin. The Met office also said the storm was

likely to pass through Cumilla and move

towards India's Tripura today. Since yesterday morning, the Bay had

been rough due to the cyclone. Many areas across the country, including the capital, experienced rain throughout the day.

At least 151 fishermen from Bhola, Barguna and Patuakhali, who had gone to the sea, were missing till last night. State Minister for Disaster Management

and Relief Md Enamur Rahman said around 21 lakh people were evacuated to more than 5,500 cyclone centres in 14 districts, including Satkhira, Bhola, Barguna, Patuakhali, Barishal, Pirojpur, Jhalakathi, Bagerhat and Khulna.

Ministry sources said more than 55,000 volunteers worked for the evacuation in the districts.

### No cyclone shelter in 8 coastal islands

15,000 exposed to cyclone Bulbul; 1,000 tourists stranded at hotels on St Martin's Island

No cyclone or safe shelter can be found in eight coastal islands under Patuakhali's Rangabali upazila, leaving some 15,000 people vulnerable to the natural calamity.

The islands are -- Char Kashem, Char Kalagachia, Char Kankuni, Char Maishor, Char Najir, Char Tojammel, Char Kawkhali and Char Lata.

The islands have no concrete structures either, meaning there is no place to seek refuge from cyclones, locals said.

"We have no safe shelter. We have to depend on Allah whenever any natural disaster hits our area," said Jannat Begum, 25, a resident of the remote Char Kasem.

"I was pregnant when Sidr had hit our area in 2007. At the time, our entire home was flooded. I saved myself by climbing a

if provocation is on Says PM about student-teacher

No funds for univs

protests on campuses

Prime Minister Sheikh Hasina yesterday said the government would stop providing funds to public universities if their teachers did not stop provocative activities to take their students down the wrong path in the name of movement.

"The government will stop all funding.... Why should the government provide funds?

These are autonomous institutions. Now you have to think what you will do," she said. The PM was addressing the 13th council of Jatiya Sramik League, an

associate body of the ruling Awami League, at the Suhrawardy Udyan in the capital. She said nobody would ever accept taking students down the wrong

path through provocation and uttering ugly words. "If it is done, then you will have to find your own funding, manage your own salaries, and bear your education costs yourself." Hasina, also the AL president, said the students of public universities

can pursue higher education as the government allocates funds for their universities through the University Grants Commission.

"No country in the world provides higher education at such a low cost .... It's true that autonomy is there [university]. But who is paying the money? It's the government." SEE PAGE 2 COL 3

#### It's based on law, not faith

Says Indian diplomat in Dhaka on SC verdict

The Indian Supreme Court's judgment that cleared the way for the construction of a Ram temple on the disputed land in Ayodhya is based on law, not on faith, said an Indian diplomat in Dhaka.

"This is a legal issue relating to a title suit concerning ownership of land, not faith," he told The Daily Star, following the landmark judgement yesterday.

The five-member bench of the Indian apex court gave the disputed Ayodhya land to Hindu entity Ramjanmabhumi Trust and ordered that an alternate 5-acre land, which lies in a prominent place in Ayodhya, be given

## Disputed land for temple, separate plot for mosque

Rules Indian SC in Ayodhya case; Modi appeals for peace, harmony; Muslim groups call for calm

India's Supreme Court finally put to rest the politically sensitive Ayodhya land dispute delivering a rather balanced verdict yesterday in the title suit.

In a landmark judgement, a five-judge bench headed by Chief Justice Ranjan Gogoi ruled that the disputed 2.77-acre land will be taken over by a government trust for the construction of a temple, while a suitable alternative plot of land measuring 5 acres at a prominent site in Ayodhya will be given to UP Sunni Central Wakf Board for a mosque.

The Indian Supreme Court has asked the Centre to set up the board of trustees within three months after which the disputed land will be handed over to the trust.

The ruling in the dispute between Hindu

and Muslim groups paves the way for the construction of a Hindu temple on the site, a proposal long supported by Prime Minister Narendra Modi's ruling Hindu-nationalist party.

Yesterday's judgment,

which is likely to be viewed as a win for Modi's Bharatiya Janata Party (BJP) and its backers, was criticised as unfair by a lawyer for the Muslim group involved in the case.

However, the group's leader said ultimately it would accept the verdict and called for peace between India's majority Hindus and Muslims, who constitute 14% of its 1.3 billion people.

In 1992, a Hindu mob destroyed the 16th-century Babri Mosque on the site, triggering riots in which about 2,000

### Tigers eye historic series win

The series tied 1-1, Bangladesh have the chance to make history with a win when they face India in the third and final T20I at Nagpur's Vidarbha Cricket Stadium today.



The Tigers clinched a historic first-ever T20I win against India in the first T20I following Mushfiqur Rahim's brilliance before India levelled the series with a win at Rajkot.

The Tigers arrived in Nagpur on November 8th and the T20I squad were yesterday joined by eight members of the Test team with captain Mominul Haque and Co. joining

the rest of the team at the Stadium in Vidarbha. With the series levelled 1-1, the third T20I will be like a final where the winner takes all.

However, Bangladesh's recent close defeats to India during the Nidahas Trophy and the Asia Cup finals might mean that India will have a slight mental edge going into this match.

The pitch will be a deciding factor in this game after the Delhi wicket provided some favours to Bangladesh's style of play while the Rajkot wicket afforded more options to India's strokeplay ability.

Bangladesh coach Russell Domingo was confident about his side's ability to play well and clinch the series and turn things around after the defeat at Rajkot.

"I am really proud of the way the boys have played thus far. In the second game we got ourselves into a good situation with the bat and then maybe made a few mistakes. We are confident that if we can play to our potential, we can push India and beat them on any day," Domingo said yesterday.
