# Limited tourism activities resume in Sundarbans

The Forest Department has decided to allow limited-scale tourism in the Sundarbans during November -- including a stop to all tourism activities between November 25 and 27 -- following cyclone Bulbul.

The decision was taken at a meeting between Tour Operators Association of Sundarbans (TOAS) and the Forest Department, at the conservator's office of Khulna yesterday.

Participants of the meeting also decided that tourists would not be allowed to enter Katka area, the part of the mangrove forest that is the most sensitive in terms of wildlife habitat.

Seven tourist vessels, which had already taken permission, were allowed to enter Sundarbans yesterday, a day after the Forest Department announced suspension of tourist access to the Sundarbans for assessment of the loss of

forest and animals. Md Moyeen Uddin Khan, conservator of forests in Khulna Circle, told The Daily Star that they will monitor whether tourism activities were going

on in a limited scale. "Considering the tourist season of Sundarbans, we took the decision," Moyeen said. "Tourists usually visit different tourist spots in the eastern part of the Sundarbans, which was not damaged during cyclone Bulbul,"

he also added. Some camps, wooden pontoons, jetties and walkways were damaged in the cyclone.

At least 20 percent trees of the western part of the Sundarbans are damaged, said an official, preferring not to be named. But almost half of those will grow back, the official added.

Around 900 employees of 63 camps under four range offices of the Forest Department started the work on Monday, to assess the trail of destruction left behind by the cyclone.

### ConviC ted by Mobile Courts 121 children released from correction centre

A hundred and 21 children -- who were convicted by mobile courts in various drives and kept at the Children Development Centre in Gazipur -- were released on Monday, in line with a High Court directive.

Of them, 11 children aged below 12 were exempted from the cases filed against them. The rest -- aged between 12 and 18 -- were released on six months' bail.

All the children were handed over to guardians around 9pm, said Ehiatuzzaman, superintendent of the centre.

Further decision on those released on bail will be taken following directives of the children's court, he added.

On October 31, an HC bench ordered authorities concerned of the government to release the children following a news report published on a national daily that said mobile courts have illegally jailed 121 children for six-month to one-year

The HC bench also issued a rule asking the authorities to explain why their conviction by the mobile court should not be declared illegal.

Masum, general secretary of Chattogram city's Lalkhan Bazar ward unit of AL, was arrested from Dhaka's Banani on August 4 in connection with the case. He was later granted bail by the High Court.

# Why no appellate tribunal yet: HC

The High Court yesterday wanted to know why the government has not formed the Land Survey Appellate Tribunal in 15 years, even after forming a law to this effect. According to the State Acquisition and Tenancy

(Amendment) Act, 2004, the government is supposed to form the appellate tribunal headed by a HC judge in order to hear and dispose of the appeals filed after the judgement and decree or order of the land survey tribunals.

Yesterday, the HC ordered the secretaries to the ministries of land and law to inform the reasons behind not forming the appellate tribunal in written within six weeks. The HC bench of Justice M Enayetur Rahim and Justice

Md Mostafizur Rahman came up with the order while hearing a writ petition filed by 59 people including Md Shah Alam from Chandpur, challenging a judgement by land survey tribunal in Chandpur. Petitioners' lawyer Advocate Md Rafiqul Islam Faruque

told The Daily Star that the tribunal on July 30 delivered a verdict in a land-related case, which went against his clients' favour. It ordered for giving two-decimal land of total

15-decimal in Shaisharchar area under Faridganj Police Station in Chandpur to the petitioners. Aggrieved, they filed the petition. Yesterday, the HC stayed the verdict given by the

tribunal for six months and also issued a rule asking the authorities concerned to explain why it should not be scrapped, he added.

### Bar associations must provide legal support to litigants

The High Court yesterday directed presidents and general secretaries of all bar associations across the country to provide legal assistance to justice seekers if they fail to engage any other lawyer to defend them.

The court ordered Bangladesh Bar Council, a statutory body regulating the country's lawyers, to monitor this issue.

The HC also summoned Kishoreganj's Senior Judicial Magistrate Md Rafiqul Rabbi to appear before the court on December 3 for continuing with the trial proceedings of an extortion case despite the HC staying it earlier.

The bench of Justice Obaidul Hassan

and Justice AKM Zahirul Huq came up with the order during the hearing of a bail petition filed by Md Atahar Ali and Sirajuddin, two accused in the aforemntioned case. Advocate Atiqur Rahman appeared

for the petitioners while Advocate MK Rahman stood for the lawyers. Deputy Attorney General Sarwar

Hossain Bappi represented the state.

### mindset towards ethnic minorities: speakers Staff CorrespOndent

Change discriminatory

Culture of impunity and non-cooperation of the administration in getting justice are major reasons behind violence against ethnic minority communities, particularly women, speakers said at a discussion yesterday.

They also urged the government and the administration to change their discriminatory mindset towards the minority communities if they "sincerely" want to ensure a safe, secure and dignified life for the disadvantaged groups.

Bangladesh Mahila Parishad (BMP), in association with Embassy of Sweden in Dhaka, organised the discussion on rights of indigenous women at BMP office in the capital. Speaking at the event, veteran politician Pankaj Bhattacharya said

the government talks about the rights of indigenous women, but those remain confined in words only, as the reality is different. "We didn't see a single example of justice for the violence -- including

rape and murder -- against indigenous women, particularly in Chattogram Hill Tracts," he said. A culture of impunity has been established in this country, he said. The state is not only prejudiced, but also unfriendly when it comes to women

and indigenous people, he alleged. "When a state doesn't even recognise the indigenous people constitutionally, protecting rights of indigenous women is a far cry," said

Pankaj, president of Oikya Nap. Falguni Tripura, coordinator of Bangladesh Indigenous Women Network (BIWN), said that indigenous women face three-dimensional violence -- as an indigenous person, as a woman and as an indigenous woman. To change their current state, she urged the government to empower them through ensuring their political participation and eradicating the ongoing culture of impunity.
