Two top US diplomats delivered gripping testimony Wednesday about Donald Trump's efforts to get Ukraine to investigate his potential 2020 rival Joe Biden, as the impeachment inquiry into the president shifted into a new phase of high-stakes televised

Taylor testified that he was told Trump cared more about the probe than he did about Ukraine.

The grey-haired former Army officer and veteran diplomat, who testified in a closed hearing last month, said he had since become aware of a telephone call between Trump and the US's EU ambassador Gordon Sondland, which a member of Taylor's staff overheard.

The staffer asked Sondland after the call what Trump thought about Ukraine and was told that "President Trump cared more about the investigations of Biden," Taylor said.

Freshman House Ocasio-Cortez, Alexandria outspoken Trump critic, said the new Taylor comment added "a layer of proximity" for the president.

Rohingya

141 top taxpayers honoured

Shahnaz Rahman, a director of Transcom Group and chairperson of Reliance Insurance Limited, was recognised as the highest taxpayer among women in Dhaka city.

Md Kamrul Hassan, executive director for finance at Transcom Group, received the award on behalf of Shahnaz Rahman and Transcraft Ltd.

Of the 141 awardees, 74 are individuals, 57 companies, and 10 organisations.

Speaking at the ceremony, the finance minister said: "You [top taxpayers] are good people. The economy has advanced because of your contribution."

He said there were four crore people in the country who fall

under the middle-income category, but many of them did not pay their taxes for various reasons, including a lack of courtesy from taxmen and encouragement from tax lawyers, and a lack of willingness to pay taxes.

Kamal said the NBR would take action if any taxpayer was harassed and dishonoured at the tax office.

Abul Hassan Mahmood Ali, chairman of the parliamentary standing committee on the finance ministry, said "Among those getting recognised, all are not our supporters. I see there are some...who fall into the category of our critics.'

Md Mashiur Rahman, economic affairs adviser to the prime minister, lauded the top taxpayers and said the recognition inspired people to do good.

NBR Chairman Md Mosharraf Hossain Bhuiyan said, "We are present here today to honour those who do the job of blood circulation for the development of the country. This is a matter of great pride."

Other top taxpayers in the journalist category include MA Malek, editor of the Dainik Azadi in Chattogram, Shykh Seraj, director and head of news of Channel i, and Monjurul Ahsan Bulbul, editor-in-chief and CEO of Ekushey Television.

Both editors of The Daily Star and the Prothom Alo, and the owning firms of the two dailies and their printer, started receiving the honour in their respective categories in 2015-16, when the NBR expanded the list of the awardees to include various

professions and areas.

Previously, it handed out tax cards in only two categories -- individuals and companies -- with 10 tax cards for each group.

The tax collector began recognising the top taxpayers with cards and crests in 2010-11 to improve tax compliance, and reduce tax evasion and avoidance in a country where just 1.33 percent of the population submitted income tax returns in the last fiscal year.

At the event, the NBR also honoured the highest and longest time taxpayers in Dhaka city and districts under the Dhaka division.

This year, the NBR named 374 highest taxpayers from districts and city corporations, and recognised 147 longest time taxpayers for 2018-19.

Train derails in Sirajganj, catches fire

Railway authorities, however, denied the allegation and said they would make comment on the issue only after conducting probes. Three probe committees were formed to investigate the accident.

Abdulla Al Mamun, divisional transportation officer of Bangladesh Railway's Paksey division, said, "Signals were completely fine and the accident did not happen due to wrong signals. There might be some other reason behind the train derailment."

Rail connection from Dhaka to northern districts and Dhaka to southern districts were interrupted for an indefinite period as the rail line was massively damaged due to the accident, he added.

"A rescue engine arrived around 5:00pm from Ishwardi and started working. We are trying to reestablish rail connection within the shortest possible time," he said. Talking to The Daily Star, some of

the passengers of the train shared their experiences. Raihan Hossain, a passenger of the train, told The Daily Star that airconditioned compartments of the

train were filled with smoke as soon

as the fire broke out.

"We were having suffocation. the truck was removed about an hour Some locals broke glasses of our compartment and rescued many," he said, adding, "People started running here and there after they were out of the train."

Another passenger of the train Liton Hossain said, "It was a horrific experience.'
