Name of Maruf Reza, a relative of former home minister Mahmudul Hasan, came to light when the trial court was recording statements of the witnesses. Then the lower court directed police to further

investigate into the case on May 23, 1991. Later, Maruf Reza filed a revision petition with the HC, challenging the lower court order for further investigation. On July 2, 1991, the HC stayed the

trial proceedings of the case and further probe. Reza, who had been arrested, was later exempted from the case. Mantoo, who had also been arrested in connection with the case, was released from jail on bail.
