Government Service Rule says he has to be suspended the day he files for bail.

According to documents obtained by The Daily Star, Shakil, instead of being suspended, was transferred to Raishahi on April 17, 2018, and just 13 days later, he was made the OC of Puthia Police Station.

The fact that Shakil served as OC of Puthia evading suspension came to the fore on September 16 when the High Court issued a ruling on a writ petition filed by Nigar Sultana, daughter of slain transport leader Nurul Islam.

In the petition filed on September 8, Nigar sought the court's directive on forming an enquiry committee to probe Shakil's tampering of the FIR filed in connection with the murder of her father.

She questioned why Shakil was not suspended as per the provisions of the Government Service Rule.

The HC ordered a judicial enquiry into the role of the OC and directed the authorities concerned to suspend him and initiate departmental proceedings against him.

It had asked authorities concerned as to why their inaction regarding the OC's "implication in criminal cases and involvement with corruption and other serious criminal offences" should not be deemed illegal.

The court might deliver an order today as the judicial probe report had been submitted.

Police eventually suspended Shakil on October 2 following the HC order with retrospective effect from January 9, 2018, the day he got bail.

This paper has a copy of the police

Following his suspension, locals opened up and alleged that Shakil, who has a lawmaker-brother, and his ally district AL Organising Secretary Ehsanul Haque Masud forged FIRs, indulged in corruption, and ran an extortion gang.

Nigar described most of the allegations against Shakil in her petition with the HC. NURUL MURDER

Nurul ran for the general secretary post of Puthia's Road Transport Workers' Union on April 24 this year. He lost to Abdur Rahman Patal, who was backed by his ally Masud.

Nurul then filed a civil suit with a Rajshahi court alleging that the election results were manipulated in favour of Patal.

On June 9, the court issued an injunction on the results.

Around 10:00am the following day when Nurul went to the union office with the court order, Masud, Patal, Golam Faruk, a former general secretary of the upazila AL who acted as an election commissioner, and others threatened him with dire consequences, according to the

Nurul went missing after the incident and on June 11 morning, his body was found near a brick kiln in Puthia. He had been bludgeoned to death and his genitals had been clubbed.

That afternoon, Nigar filed a murder case with Puthia Police Station. The case was eventually recorded at 11:30pm against Patal, Md Mithu, KM Shahin, Nurul Amin, Md Motin, and Abdur Rashid, according to documents.

Nigar in her writ said the FIR she had filed had eight named accused and Shakil had tried to persuade her to drop Masud and Golam Faruk.

She said Shakil made a fake FIR using her signature he had asked her to put on two blank sheets of paper. She said Shakil took the signatures saying those were required for the burial of Nurul and arrest of the accused.

The Detective Branch of Police was probing the case, but family members claimed that an attempt was made to divert the course of the investigation.

They said the office of the Rajshahi Superintendent of Police issued a press statement on June 19 saying that a 16-year-old boy confessed to killing Nurul for attempting to rape

The statement said the boy killed Nurul with a single blow.

Nurul's However, mentioned multiple injuries.

Nigar claimed that police had picked up the boy and kept him confined for four days to force him to make the false confessional statement.

The HC in its September 16, 2019, order had asked the Rajshahi SP to explain on what authority did "he disclosed confidential information of a confessional statement under 164". FIR MANIPULATION

On the night of June 6, 2018, Rocky Islam, 22, of Koipukuria in Puthia was fatally injured. He died half an hour after he was taken to Puthia

Health Complex, his family said. His body had marks of numerous injuries and his genitals had been clubbed.

Before his death, Rocky told his family members that Masud's cadres,

who were accused in a case for beating up his uncle Mohidul Islam in 2017, had attacked him.

Rocky's mother Rehana Begum filed a case with Puthia police accusing 14 people for the murder.

Three weeks later, she learnt that the FIR she filed was never recorded. Instead, police recorded an unnatural death case saying Rocky died by

On July 2, 2018, Rehana filed another case with a Rajshahi court accusing the same 14 people. And the case is now being investigated by the Police Bureau of Investigation. **EXTORTION**

A mob beat Md Tarek, 22, a rickshawvan puller on suspicion of trying to steal a rickshaw-van at Jhalmalia Bazar of Puthia and handed him over to the police on September 23, 2018, police said.

Tarek's mother Sanwara Begum alleged that Shakil had called them over to the police station and demanded Tk 60,000 for his release.

The family had said they would be able to pay only after they sell a piece of land they owned.

Sanwara told The Daily Star that Tarek hanged himself inside the police station after learning that the family was trying to sell the land to have him released.

She alleged that her son was kept in the ICU of Rajshahi Medical College Hospital for 22 days before being declared dead on October 15, 2018.

Police handed the body over without an autopsy, she said.

Locals claimed that soon after joining Puthia Police Station, Shakil in connivance with Masud patronised a gang of criminals, including some women, who entrapped well-off people and extorted them.

After Shakil was removed, police in early October arrested eight members

An audio clip allegedly of a female arrestee saying how the money went to Shakil and Masud went viral in social media.

THE SUSPENSION

Shakil's mother-in-law Aklima Begum had filed the criminal case against him for forgery, forceful eviction from her property, and attempted murder.

Aklima wrote to the Rajshahi Range deputy inspector general (DIG) of police that Shakil obtained bail in the case she filed. The DIG received the letter on September 26,

DIG also informed The Chapainawabganj police of the

Abu Bakar Siddique, one of the two lawyers dealing Nigar's writ petition, said there was hardly a way of suppressing the information of his bail. Either senior officials overlooked the matter while appointing him or he hid the information.

HC lawyer Jyotirmoy "Continuation of service said, by a suspended officer is simply impossible without political influence.'

SHAKIL'S SAY

Shakil told The Daily Star that he was not bothered about any of the allegations against him "since he was not involved".

He was involved in recording of the FIR and "I've done it properly," he said, adding that the recorded FIR carries the plaintiff's signature.

He claimed he did not take Nigar's signature on blank pieces of paper.

Shakil denied having any connections with Masud or having anything to do with the dropping of Masud and Faruk's names from the murder case.

He claimed that many of his senior officers, including the Rajshahi SP, knew about his bail.

RAJSHAHI SP

Rajshahi SP Md Shahidullah said Shakil served concealing information regarding his involvement in criminal

"We knew nothing. He [Shakil] continued serving hiding facts [of his involvement in criminal offence]," the SP said, adding that his office had no records of Shakil's taking leave to attend court hearings in this

connection. MASUD'S SAY

AL leader Ehsanul Haque Masud denied involvement in the murder of Nurul. He claimed that a vested quarter was trying to harm his image.

"Nurul's family members never accused me of the murder, until they went to the High Court," he said.

"They did not accuse me at the police station ... they could have done it before the court. But they had

"They only accused me in the writ petition over political enmity," he said.

LAWMAKER'S SAY

Talking to The Daily Star, Shakil's brother Shamil Uddin Ahmed Shimul, lawmaker of Chapainawabganj-1, said, "Being a police officer, he knew well where to grease to get away with the charges he was facing.
"I never lobbied for him and he

didn't contact me either.

"Whatever he did, he did with local political leaders beside him. He never contacted me and I never contacted him regarding these matters."

PM warns onion hoarders

Swechchhasebak League gets new leadership

Prime Minister Sheikh Hasina yesterday said the government wants to see whether there is any conspiracy behind the sudden hike in the price of onions in the country.

"Onion price is a problem right now...It is true that onion prices have surged in different countries, but I don't know why the price has soared abnormally in our country. We want to see if anyone is involved in this..." she

Hasina, also the chief of the ruling Awami League, said this while inaugurating the third national council of Awami Swechchhasebak League, an associate body of the ruling Awami League, at the Suhrawardy Udyan, reports the UNB.

Swechchhasebak League's councillors from across the country ined the inauguration of their new adership.

Meanwhile, Awami League General Secretary Obaidul Quader announced the names of the newly elected leaders of the central Swechchhasebak League and its Dhaka north and south units from the council session held at the Institute of Engineers, Bangladesh (IEB) in the afternoon.

Nirmal Ranjan Guha and Afzal Babu were named president and general secretary of Swechchhasebak League.

Nirmal was vice-president of the outgoing committee and is also the convener of the council preparatory committee, while Azfal was also vicepresident of the outgoing committee.

Ishak Miah and Anisur Rahman Naveem were named president and general secretary of the party's Dhaka north unit, while Kamrul Hasan Ripon

and Tarek Sayeed were named president and general secretary of its south unit. At the inauguration session, Sheikh Hasina said the government had taken initiatives to import onions in cargo

planes to bring down its price, reports "The planes carrying onions will land in the country either tomorrow [today]

or day after tomorrow [Monday]," she

It is natural that the production of a crop may increase or decrease due to weather, she said, adding that there might be some people who want to make a quick buck by raising the price through hoarding. "But they have to think about the fact that onions cannot preserved for a long time...they might rot."

The PM alleged that when the country is advancing and people are living in peace, vested interests are trying to confuse people by creating issues.

She said the onion price in India is also very high and it is currently being sold there at Tk 100. "But there's one state [in India] from where onion export is not allowed...The onion price in that state is lower.'

Hasina said the people of the country have to be aware of not bringing killers, corrupt people, and money-launderers

"Their return to power means the suffering of people, putting the country on the verge of destruction and resuming of militancy and terrorism, as they are involved in militancy and terrorism," she said.

Stressing the importance of maintaining the pace of advancement, Hasina said the government wants to eradicate drugs, terrorism and corruption, and the drive against these social menaces will continue.

"We have to ensure peace and security for the people of Bangladesh and if the peaceful atmosphere prevails in the country, it is possible to develop the country..." she said.

The PM went on to ask why one has to earn money through corruption and theft. "The people of the country won't tolerate living a lavish life and showing off with the money earned through terrorist acts, extortion, corruption and dishonesty.

She said the government has been implementing massive programmes to ensure development and the welfare of the country and its people in such a way that no one is left behind.

Criticising BNP founder Ziaur Rahman and Khaleda Zia, the PM said Zia started the politics of killing and destroyed the spirit of the Liberation established while Khaleda terrorism and militancy in the country.

They also rewarded killers of the Father of The Nation and war criminals by making them ministers, members of parliament and giving them blood spattered national flags, she said.

Hasina called upon leaders and workers of the Swechhashebok League to work with the mentality of serving people and strengthen the organisation

3 deals likely to be signed UNB, Dhaka

Prime Minister Sheikh Hasina left Dhaka yesterday for a four-day official visit to the United Arab Emirates (UAE)

to attend the Dubai Air Show 2019. Hasina will attend the air show on Sunday at the invitation of Vice-President and Prime Minister of the UAE Sheikh Mohammed bin Rashid Al Maktoum.

An Emirates flight carrying the PM and her entourage departed from Hazrat Shahjalal International Airport at 6:45pm.

The flight is scheduled to land at Dubai International Airport at 10:10pm (local time).

Bangladesh Ambassador to the UAE Muhammad Imran will receive the PM at the airport.

During her visit, Hasina will stay at Shangri-La Hotel in Abu Dhabi.

On Sunday, she will join the opening ceremony of the Dubai Air Show 2019 at Dubai Al Maktoum International Airport (also known as Dubai World Central) at 10:00am. She will later enjoy the flying display at 2:00pm (local time).

The PM will attend a dinner to be hosted by the Bangladesh ambassador to the UAE in her honour at 7:30pm on the same day.

During her visit to the UAE, three bilateral cooperation documents are expected to be signed, said Foreign Minister Dr AK Abdul Momen.

One of the instruments is on the bilateral cooperation between Bangladesh Investment Development Authority and Emirates Development Authority, one on the bilateral cooperation between Bangladesh Economic Zone Authority and Emirates Economic Zone Authority and a protocol on the allotment of a land plot for the Bangladesh Embassy in Abu Dhabi.

Hasina is also expected to have a meeting with the big investor groups and business leaders in the UAE.

She is expected to inaugurate a NID registration programme for nonresident Bangladeshis living in the UAE at the Bangladesh Embassy in Abu Dhabi, said the Foreign Minister.

Journalist found dead in his Banasree home

Police last night recovered the body of a journalist from his rented home in the capital's Banasree.

The dead was identified as Mansur Ali, 33, a sub-editor of the online news portal Bangla Tribune, Officer-in-Charge (OC) of Khilgaon police station Mashiure Rahman, told this newspaper. On information, police went there

and recovered the body after breaking 8:30pm, he said. Mansur, who shared the home

with two flatmates, was staying alone yesterday, the OC said. Mashiure said police were yet to confirm the reason behind the death.

The body was sent to the Dhaka Medical College morgue for autopsy, he added. Nuruzzaman Labu, a senior reporter at Bangla Tribune, said Mansur left for home at 12:15am yesterday and was

supposed to attend office at 4:00pm. As he did not come to the office, nis colleagues looked for him. Around 6:00pm, one of Mansur's flatmates, Manajit Mitra, reached home and found it locked from the inside, Labu said.

When Mansur did not respond, Manajit informed the house-owner, who informed police, he added. Mansur, hailing from Fenchuganj
