Selim also said they will be with BNP and the 20-party alliance.  
Abdul Karim Abbasi said Oli is only concerned about his own interests.  
"Oli Ahmed has made LDP his property. We do not accept his committee," he said.  
On October 26, 2006, Oli left BNP and formed LDP with the then Bikalpa Dhara Bangladesh President Dr AQM Badruddoza Chowdhury.  
However, B Chowdhury quit LDP within a year and revived Bikalpa Dhara following a conflict with Oli.  
Hours after the press conference of the newly-formed coordination committee, Oli Ahmed said LDP is registered with his name.  
"I founded LDP and have been carrying out the duty of the president for the last 12 years. Those who were dropped from the committee are like my brothers and sons. I won't say anything against them. There are a number of political parties and one more can emerge," he said at a press conference at Jatiya Press Club.  
Regarding Jatiya Muktimoncho, Oli said the platform does not believe in politics of vengeance. "We will forge national unity to give democracy and the spirit of the Liberation War an institutional form," he added.

at the hospital.  
Speaking at the event, Gonoshasthaya Kendra founder Dr Zafrullah Chowdhury said around 45,000 people develop kidney failure in the country every year.  
He said they are providing global standard dialysis at cheaper cost in their hospital. Kidney transplantation is a better alternative to dialysis, he added.  
Prof Mostafi mentioned around 18 percent people in the country have been suffering from kidney-related diseases, but many have no idea about it.  
He said over 40,000 people develop kidney failure every year but only 10 percent of them can take dialysis due to lack of affordability. Gonoshasthaya hospital is supporting people by providing them with free dialysis or at low cost.  
Prof Mostafi said they are also going to introduce kidney transplant facilities in the hospital from next year. It is important to amend the related law in this regard, he added.

said, "Since 2001, Nipah virus has been prevalent in 31 south-western and north-western districts, during December and March."  
IEDCR recorded 217 deaths (69 percent) out of 313 Nipah virus cases so far.  
"Some bats carry Nipah virus and could contaminate raw date juice at night. So, consuming boiled juice or molasses is safe," Dr Sharmin said.  
Infected people initially develop symptoms including fever, headaches, myalgia (muscle pain), vomiting and sore throat. It could progress to coma within 24 to 48 hours.  
There is no specific treatment for Nipah virus infection. Intensive supportive care is recommended to treat severe respiratory and neurologic complications.
