# No headway in probe

FB 'hackers', masterminds behind attack on police yet to be identified

One month into the attacks on law enforcers, houses of Hindus and a temple in Bhola's Borhanuddin upazila, police are yet to identify the masterminds behind those or the "hackers" who broke into the Facebook page of Biplob Chandra Baidya.

Many members of the religious minority community were still reeling from shock. They demanded prompt trial and punishment of the perpetrators. On October 20, a group of religious bigots, from a rally

organised to protest anti-religious messages spread from the hacked Facebook account, attacked police. The incident left four people dead and at least 100 injured. Immediately after the clashes, religious zealots vandalised 12 Hindu houses and a temple in the upazila.

Bhola police, with the help of the Police Headquarters (PHQ) in Dhaka, are carrying out an investigation to identify the "hackers". A PHQ official, involved in the investigation, said their

probe was in the final stages.

"We are hopeful of identifying the 'hackers'," he told The Daily Star yesterday wishing anonymity.

## jail term for Mir Nasir, son

The High Court yesterday upheld a lower court verdict that sentenced former BNP state minister for civil aviation Mir Mohammad Nasiruddin to 13 years and his son Mir Mohammad Helaluddin to three years in a corruption case.

The court also ordered them to surrender before the trial court within three months after the trial court receives the certified copy of its verdict.

The HC bench of Justice AKM Abdul Hakim and Justice Fatema Najib delivered the judgment after it held appeals hearing for around 40 days.

The bench dismissed the appeals seeking acquittal of the charges brought against the two.

M Asaduzzaman, lawyer for Nasir and Helal, told The Daily Star that on receiving the HC verdict's certified copy, his clients would move appeals before the Supreme Court's Appellate Division challenging the HC judgment and for their acquittal of the charges after they surrender before the trial

### US backs Israel on settlements

Palestinians slam Trump admin's policy shift; UN rights office says settlements in West Bank unlawful

The United States on Monday effectively backed Israel's right to build Jewish settlements in the occupied West Bank by abandoning its fourdecade-old position that they were "inconsistent with international law," a stance that may make Israeli-Palestinian peace even more elusive.

The announcement by Secretary of State Mike Pompeo was a victory for Israeli Prime Minister Benjamin Netanyahu, who is struggling to remain in power after two inconclusive Israeli elections this year, and a defeat for the Palestinians.

It appeared to deliver a new blow to Trump's efforts to resolve the Israeli-Palestinian conflict through a peace plan that has been in the works for more than two years but has drawn widespread skepticism even before Hossain, 35, Shaon, 25 and its release. Pompeo said US statements about the settlements on the West Bank,

which Israel captured in 1967, had been inconsistent, saying Democratic President Jimmy Carter found they were not consistent with international law and Republican President Ronald Reagan said he did not view them as inherently illegal.

"The establishment of Israeli civilian settlements is not, per se, inconsistent with international law," Pompeo told reporters at the State Department, reversing a formal legal position taken by the United States under Carter in 1978.

His announcement drew praise from Netanyahu, who said it "rights a historical wrong," and condemnation from Palestinian negotiator Saeb Erekat, who said Washington was threatening "to replace international SEE PAGE 10 COL 2

# 100 still holed up at HK univ

Desperate anti-govt protesters search for escape routes after two days of clashes with police

Anti-government protesters holed up in a Hong Kong university were frantically searching for escape routes yesterday after two days of clashes with police and dramatic

breakouts by rope and motorcycle. About 100 protesters were trapped in the Polytechnic University a day after students, some tired and fearful of police storming the campus, tried again and again to flee, only to be beaten back by police firing rubber bullets, water cannon and tear gas.

Some 280 injured were taken to hospital yesterday, the

Hospital Authority said. "I just want to leave. I feel very tired," said Thomas, 20, a student at another university who has been on the campus since the siege began. "I didn't throw Molotovs. I was here to support the protest. I don't see anything wrong with it so I wanted to support the students."

He then walked slowly, with about 10 others, towards the police who body-searched and arrested him. He had the phone numbers of lawyers written on his right forearm.

Police have made about 1,100 arrests in the past 24 hours on charges including rioting and possession of offensive weapons, they said. The total since June is more than 5,000.

Hong Kong leader Carrie Lam said she hoped the standoff could be resolved and she had told police to handle it humanely. Lam spoke shortly after the Chinese-ruled city's new
