'Drug dealer' killed in 'gunfight'

A suspected drug peddler was killed in a "gunfight" with members of Rapid Action Battalion in Hazaribagh area of the capital early yesterday.

The dead -- Nadim Bahadur, 38 -- is a listed drug dealer and accused in nine cases, Rab claimed in a short message circulated to journalists.

Sajid Mia, deputy assistant director of Rab-2, told The Daily Star that one of their teams came across two men on a motorbike around 4:00am near Sikder Medical College Hospital in Hazaribagh.

As soon as the Rab team signalled the motorbike to stop, the duo opened fire on them, forcing the law enforcers to retaliate, he claimed.

At one point of the "gunfight", Nadim was shot and another unknown person managed to flee. Nadim was rushed to Dhaka Medical College Hospital (DMCH) where doctors declared him dead, the Rab official added.

Rab confirmed the identity of the dead from a national identity card found with him.

The elite force also claimed to have seized a motorcycle and recovered a pistol along with few bullets, 35 bottles of phensidyl, and 180 pieces of yaba.

The body was sent to DMCH morgue for autopsy.

Section-144 imposed in some areas of Tangail town

The local administration last night imposed a three-day ban on holding any public gathering in some areas of Tangail town after two Awami League factions called for programmes at the same spot.

Muhammad Shahidullah, additional district magistrate of Tangail, imposed the embargo under section-144 in and around Shaheed Smrity Pouro Udyan, Nirala Intersection, Old Bus Stand areas along with some other important streets in the town.

The temporary embargo was imposed after two groups of the ruling Awami League called for programmes at Shaheed Smrity Pouro Udyan at 3:00pm today, said officials seeking anonymity.

A group led by Amanur Rahman Rana, former AL lawmaker of Tangail-3, called for a programme marking the 16th death anniversary of his elder brother Aminur Rahman Khan Bappy, who was also a leader of the party and killed near his home.

On the same venue at the same time, a rival group under the banner of Nirjatito Awami Paribar, along with local CNG-run auto-rickshaw workers and diesel-run three-wheeler workers, called for a programme demanding justice for freedom fighter Faruk Ahmed, whose body was found near his College Para house in the town on January 18, 2013.

Additional policemen were deployed in the town.

Bioethics. Advocates like Smith want to change the genetic makeup of embryos to prevent the transmission

of gene-related diseases. However, the practice is hugely

controversial due to fears that it could be used to create "designer babies" whose genes have been edited for non-therapeutic purposes.

In November 2018, Chinese scientist He Jiankui sparked outrage after announcing he had created the first genetically-modified babies in the world from embryos altered to make them resistant to HIV.

But Smith says their creation is ethically justifiable and would offer hope to parents at risk of transmitting serious genetic disease to their offspring, according to a statement.

From a "utilitarian standpoint' genetic modification is the "only conceivable way" to deal with multiple disease-associated genes in an embryo, according to Smith.

Aside from Palestinians, the US announcement, the latest in a series of moves by the Trump administration favouring Israel, drew immediate criticism from rights groups, Arab world, some US allies and politicians worldwide.

The UN and EU made clear that they continue to view Israeli settlement in the occupied Palestinian territories as illegal. The Arab League called the US move an "extremely adverse development."

Accusing the current Administration of legitimising the Israeli colonial settler agenda, Malki said the announcement "risks the demise of the international order and threatens to plunge the world into chaos and violence.

After a meeting of the Food Planning and Monitoring Committee, the ministry had said the list of growers would be scrutinised by the upazila procurement committees. In case the number of farmers

exceeds the procurement target, the growers would be chosen through lotteries, the food minister said at a briefing following the meeting on October 31. The government has also decided

to buy 3.5 lakh tonnes of parboiled rice, which would be procured at Tk 36 each kilogram.

The purchase quantity was the same last year.

Besides, 50,000 tonnes of unboiled rice would be bought at Tk 35 a kg, according to a ministry

Rice purchase from millers would begin on December 1 and continue till February 28, said the statement. PROCUREMENT IN DINAJPUR

Mahmudul Alam, deputy commissioner of Dinajpur, said the government bought 1,000kgs of Aman paddy from two farmers from the district's Biral and Nawabganj upazilas.

Mohammad Ashrafuzzaman, district food controller, said the district food office would buy 28,700 tonnes of Aman paddy from 13 upazilas of Dinajpur.

A farmer can sell maximum 500kgs of Aman paddy, he said, reports our Dinajpur correspondent.
