Two Khulna courts sentenced eight people to life imprisonment in two murder cases yesterday.

Khulna Public Safety Disturbance Crime Prevention Tribunal and Khulna District and Sessions Judge Court announced the verdicts.

Judge Md Saifuzzaman Hero of the former court sentenced seven people to life terms for the murder of Abdul Ali Sheikh, a rickshaw-puller.

In the other case, judge Mashiur Rahman Chowdhury sentenced Aslam Sana to life imprisonment and fine of Tk 20,000 for murder of Shahin Bond, a fish farm owner from Dumuria.

According to the case statement, Aslam killed Shahin Bond in his farm at Bilpabla area of Dumuria on June 6, 2011.

## 1,000 illegal structures demolished in Savar

A team of Roads and Highways Department (RHD) have evicted some 1,000 illegal structures on both sides of the Dhaka-Aricha highway in Savar.

The drives took place from Genda area to Savar Bus Stand, ahead of the Victory Day, said Mohammad Mahbubur Rahman Faruki, executive magistrate and estate and law officer of RHD Dhaka.

The demolished structures included parts of 20 highrise buildings, said Arif, a surveyor of RHD, adding 10 acres of space owned by the government body were freed up. Materials including wood and abandoned vehicles parked on highway land were sold on auction, he added.

Meanwhile, a group of workers of Pakiza Dyeing and Printing Industries beside Dhaka-Aricha Highway blocked vehicular movement on the road, following an altercation with RHD authorities. The blockade was removed after law enforcers asked them to leave the spot, said Faruki, adding that they did not make any arrests.

Many people whose structures were demolished alleged that no prior notice was served to them before the drive, and termed he eviction "selective" and an "eyewash".

Refuting the allegation, Faruki said people were informed about the drive through loudspeakers, and the drives are being conducted on the basis of map made by surveyors.

The drive continued till 7pm at Savar Bus Stand area. Asked whether eviction would continue, executive magistrate Faruki said both sides of Dhaka-Aricha highway will be cleared of encroachment soon.

# Treatment hampered by intern doctor-nurse row

Treatment at Rangpur Medical College Hospital (RMCH) was badly hampered yesterday, as nurses and intern doctors declared work abstention in the morning, following an altercation between two members of the groups on Monday evening.

Leaving patients unattended, both groups demonstrated on hospital premises, demanding punishment for the other. They, however, withdrew their strike in the afternoon after holding a meeting with the hospital authorities.

According to hospital sources, Dr Ananya, an intern of the dental department, was tending to a patient at ward-27 on Monday evening along with nurse Nilufa Yasmin Urmi.

At one point, an ampule Urmi was holding broke and some water spilled on Ananya. As Ananya scolded her, Urmi allegedly became angry and misbehaved, which led to an argument.

Urmi, however, claimed that Ananya slapped her.

Senior doctors sat with them that night to solve the dispute, but to no

Yesterday morning, around 80 nurses besieged the department, demanding justice. On the other hand, intern doctors staged a protest in front of the director's office.

Both groups demonstrated till 1pm.

Around 2pm, acting director Dr Shahadat Hossain sat with them, but the meeting ended without any result, Dr Faridul Islam, director of the hospital, who is in Dhaka now told The Daily Star over phone. They, however, agreed to return to work.

Contacted, Forkan Ali, president of Nurses Association at the hospital, said another meeting will be held today over the incident.

# Three killed, 22 injured in Faridpur bus-truck collision

Four others killed in separate road crashes

Seven people were killed and at least 28 others injured in road accidents across four districts in the last two days, our correspondents report.

In Faridpur, three people were killed and 22 injured when a Madaripur-bound bus collided head-on with a Faridpur-bound truck in Purba Sodardi area under Bhanga upazila around 8:30am yesterday.

The deceased were identified as Sirazul Islam (54), Rezaul Karim (29), and Khobir Uddin Hawladar (58). Sirazul was the bus driver.

The injured were taken to Bhanga Upazila Health Complex and Faridpur Medical College Hospital, said Bhanga highway police.

Following the accident, the highway remained blocked for over an hour. Later, police brought the situation under control and seized both vehicles. In Rajbari, one died and two were injured when

a truck rammed a rickshaw-van in Tatulia bazar area under Baliakandi upazila around 3:30pm yesterday. Locals rushed Zakir Mondal (32), the rickshaw-

van puller, and one of the injured to Faridpur Medical College Hospital, Baliakandi police said quoting locals. Zakir died on the way.

The other injured was taken to Baliakandi

Upazila Health Complex.

Locals handed the bus driver over to police. In Netrakona, two motorcyclists were killed and four passengers were injured in a road accident in

Bori area of Barhatta upazila on Monday night. The deceased were identified as Pronoy Sarker (21) and Mizan Mia (23).

The accident occurred when a Netrakona-bound motorbike collided with another motorbike at Bori area around 8pm, injuring the bikers and passengers critically, said OC Badrul Alam Khan of Barhatta Police Station.

Mizan and Pronoy were taken to Barhatta Upazila Health Complex where they succumbed to their injuries.

The others were referred to Mymensingh Medical College Hospital, the OC added. A case was lodged in this regard.

In Kishoreganj, a motorcyclist was killed in a road accident in Rampur area under Hossainpur upazila on Monday afternoon.

The accident occurred when a sand-laden truck hit the motorbike from behind. The motorcyclist, Rana Mia (20), sustained critical injuries and was rushed to Kishoreganj General Hospital where the doctors declared him dead, said the OC of Hossainpur Police Station.

The truck driver fled the scene with the vehicle, the OC said, quoting locals.
