## Jute mill workers go on symbolic hunger strike

Workers of nine state-owned jute mills in the Khulna-Jashore industrial belt staged a symbolic hunger strike yesterday to press home their 11-point demand, including payment of due salary and implementation of a wage commission.

The protest began around 8:00am and the workers took up positions in front of the main gates of the jute mills. The strike ended at 4:00pm.

The government announced a wage board or jute mill workers on June, 2015, but it was yet to be implemented.

Over thirty-one thousand workers (permanent and on daily basis) have been working in the nine state-owned jute mills.

Their demonstration was part of their seven-day agitation programme, announced under the banner of the "State-owned Jute Mills Collective Bargaining Association (CBA) and Non-CBA Sangram Parishad" on November 17 in Dhaka.

of public-private ownership, payment of provident fund gratuity for retired workers, regularising weekly wages and implementing the wage board, and payment of outstanding bills. They also demanded that the government buy jute products for other sectors.


Workers of Daulatpur, Khalishpur, Crescent, Platinum and Star jute mills took part in hunger strike.

Workers of Alim and Eastern jute mills also went on hunger strike in Atra industrial area of the city. In Jashore, workers of Jashore Jute

Industry and Carpeting Jute Mills Ltd went on a hunger strike in Rajghat Khalilur Rahman, former president

of CBA of Platinum jute mill told The Daily Star that the workers would not stop the protest at any cost, because most were outraged as the national wage commission had not been implemented in five years. "This symbolic hunger strike is

part of the demonstration and will continue until the wage commission Their demands include cancelling is implemented", he added.

#### Brac employee murdered in Nilphamari

Police arrested two employees of a building material store yesterday morning on suspicion of hacking a Brac employee to death in Kazirhat area of Nilphamari town Tuesday afternoon. Police recovered the body of

Mahidul Islam, 45, of Naogaon's Manda upazila, from his rented room after locals noticed a stream of blood coming out of the door, said Subinspector Mintu Chhandra Banik of Nilphamari Sadar Police Station.

The arrestees, Moinul Islam, 25, and Faruk Hossain, 26, are also suspected of stealing Tk 8 lakh from the building material store by breaking into a locker, said Mintu who is investigating the case.

The suspects are being interrogated and the "investigators have made significant progress", he added.

Mahidul, who worked in the microcredit programme of Brac, used to live alone in a rented room behind the building material store.

His wife and children live in Rangpur's Taraganj, where she teaches in a school, police said.

Owner of the building material store, Isahaq Ali Shohag, 47, told this correspondent that he kept Tk 8 lakh inside the locker of his shop earlier that day and went home for lunch, closing the store.

He returned in the afternoon and found that "somebody broke into the store and stole the cash along with the computer and CCIV cameras".

Shohag and a few locals then went behind the store and found that the door of Mahidul's room was locked from outside and a steam of blood

was coming from under the door. Informed by locals, police officers went to the scene and broke into the room and found the body of the victim. They sent the body to a

hospital for autopsy. Ruhul Amin, additional superintendent of police in Nilphamari, said the Brac employee may have been killed after he

witnessed the robbery at the store. Mahidul's brother-in-law filed a

case later that day. A special police team along with Rab and CID officials is investigating

#### Psychiatric patient mysteriously dies in drug rehab

A CCTV footage of a privately owned drug rehabilitation centre in Mirpur upazila of Kushtia raised question over the death of a first-year Hons student with schizophrenia. The 19-year-old victim --

student of Rajshahi City College -- was sent to the drug rehabilitation centre -- Samarpan -- by his father Ezazul Azim Ripon where he died on Monday morning. Yesterday, a leaked CCTV

Kamruzzaman Imon, honours

footage of the drug rehabilitation centre showed a group of people indiscriminately beating Imon tiding his hands and legs a day before his death.

According to Ripon, he brought back his son to home from his college on November 12.

As his health condition was deteriorating, Imon was taken to Pabna Mental Hospital on Friday, he said.

"We could not admit Imon to the hospital as we could not submit the required documents for admission at that time. Doctors there asked me to return to the hospital with all the documents."

Later on November 19, Imon was admitted to Samarpan following family members' suggestion, he said.

"I came to know [on Monday] that Imon was admitted to Mirpur Upazila Health Complex following a cardiac arrest. I rushed there and found my son dead," he added.

On information, police detained three -- Abdul Matin, 57, owner of Samarpan, Habib Uddin Malitha, 52, supervisor of Samarpan, and Mintu Hossain, 26, who beat Imon up -- yesterday, said Abul Kalam, officer-in-charge of Mirpur Police Station.

The victim's father did not file any complaint in connection with Imon's death even after repeated requests, the OC said.

Asked, Ripon said he did not file any complaint as he would not get his son back.

Upazila Health Officer Selim Uddin Farazi, who examined Imon's body, said he found marks on the body that suggested that Imon was tortured before death.

"We will be able to share further detail after receiving autopsy report," he added.

The foreign minister told the meeting that they came to know about a particular incident of torture or harassment only after a victim informed the Bangladesh mission.

The foreign ministry also informed the JS body that it was planning to set up hotline numbers at different Bangladesh missions abroad and the numbers would be given to all female migrant workers. The workers would call the numbers if they faced any problem.

Officials told the meeting that some irregularities took place in sending female workers abroad, including sending job seekers aged below 14 and above 65 abroad.

They also said following communications from them, the Saudi authorities took actions against several Saudi nationals over torture of female Bangladeshi workers.

The parliamentary watchdog agreed with the foreign ministry officials that it would not be logical to bring back female workers as they send huge foreign remittances to home.

"According to statistics, a female worker sends home about 90 percent of her monthly income against 60 percent by a male worker. The

#### Amnesty warns of Egypt's 'parallel justice system'

International Amnesty warned yesterday that Egyptian President Abdel Fattah al-Sisi's government had built a "parallel justice system' to crack down on critics and dissent.

The London-based rights watchdog said the key tools of repression were the Supreme State Security Prosecution service, known as the SSSP, as well as counter-terrorism courts and special police forces. "In Sisi's Egypt, all critics of the

government are seen as potential terrorists," Amnesty's France director Katia Roux said at the launch of the 60-page report in Paris. In its report entitled "Permanent

State of Exception", Amnesty said it had observed a sharp rise in cases prosecuted by the SSSP -- from 529 in 2013 to 1,739 cases last year.

The prosecution -- which deals with activities deemed threats to state security -- regularly probes political dissidents and Islamist figures including from the outlawed Muslim
