N Korea fires two projectiles: Seoul

THANKSGIVING HOLIDAY IN US

North Korea fired two "unidentified projectiles" yesterday -- the Thanksgiving holiday in the US -- Seoul said, as nuclear talks between Pyongyang and Washington remain deadlocked.

The projectiles were fired eastwards from South

Hamgyong province and came down in the Sea of Japan, also known as the East Sea, South Korea's Joint Chiefs of Staff (JCS) said. They added that the launch, the latest in a series by Pyongyang, was carried out at 16:59 pm local time

(0859 GMT) -- or the early hours on the east coast of the United States, during one of the country's biggest annual holidays. It was also one day short of the two-year anniversary of the North's first test of its Hwasong-15 intercontinental

ballistic missile, which analysts say is capable of reaching the entire US mainland. Pyongyang is banned from firing ballistic missiles under UN Security Council resolutions, and Prime Minister

Shinzo Abe said that yesterday's launch was the latest in a series of violations. "North Korea's repeated launches of ballistic missiles are a serious defiance to not only our country but also the international community," he told reporters in Tokyo.

Yesterday's launch came after Pyongyang fired what it called a "super-large multiple rocket launcher" system last month, and the JCS said the latest devices were presumed to be of a similar type.

They flew 380 kilometres and reached a maximum altitude of 97 kilometres, the JCS added.

BJP's arrogance rejected Says Mamata after her party's by-polls victory

Trinamool Congress won all the three seats in the byelections to three assembly seats in West Bengal yesterday. Trinamool supremo and Bengal chief minister Mamata Banerjee described it as a victory of the people and added that it was also a victory for development.

"The BJP's arrogance has cost them," she said.

The Chief Minister, who has been fighting to retain her grip on Bengal with an aggressive BJP chipping away at her strongholds, said the BJP's constant talk of the NRC or National Register for Citizens to weed out illegal migrants had cost it.

"So much arrogance and pride is not good. The BJP is too arrogant and proud. Sometimes they are saying NRC, sometimes they are saying

they will evict people and then give citizenship rights, Mamata Banerjee said to a TV channel. "This result's message is clear, people are saying goodbye

to BJP. BJP should go back," she said. The by-polls were held on Monday in Kharagpur Sadar,

Karimpur and Kaliaganj assembly constituencies. In all three, the Trinamool and the BJP were locked in a tough fight.

The Karimpur seat was vacated by Mahua Moitra when

she contested and won the parliamentary election in May. There was a huge outcry when the BJP's Karimpur

candidate, Jay Prakash Majumdar, was heckled, assaulted and kicked into bushes by the side of the road by Trinamool supporters during polling. Trinamool's Bimalendu Sinha Roy humbled his nearest rival Majumder by 23,650 votes. But more significant is the Trinamool's victory in Kaliagani

and Kharagpur Sadar, where the party has never won before. spectacular Today's victory in the Assembly bypolls proves that the people of Bengal are with

us... For the first time in 22 years, since the formation of Trinamool Congress, we have won the Kaliaganj and Kharagpur Assembly seats," Banerjee wrote on Twitter.

Kaliaganj had always been a Congress domain. The seat fell

vacant after MLA Pramatha Nath Ray died earlier this year. In early leads, the BJP's Kamal Chandra Sarkar was ahead But the Trinamool candidate, Tapan Deb Singha, overtook him and won by a narrow margin of over 2,000 votes.

The Kharagpur Sadar victory is also sweet for the Trinamool as BJP's Bengal chief Dilip Ghosh was an MLA from the seat and he had swept the Kharagpur parliamentary seat. This was a Congress stronghold before the BJP's rise.

Pak SC grants army chief six more months in power

Imran Khan welcomes court's decision

Pakistan's Supreme Court gave the country's army chief a reprieve yesterday, allowing him to hold on to power for at least six more months after a days-long legal battle posed unprecedented questions about the nucleararmed nation's most powerful institution.

General Qamar Javed Bajwa has served three years in his role, arguably the highest authority in the country,

and in August Prime Minister Imran Khan asked him to extend his tenure and serve another three. The request is not

unusual. The Pakistani military has long played

an outsized role in national life, ruling the country for roughly half its 72-year history, while many army chiefs have gone well beyond their mandated term.

This time, however, the Supreme Court has raised questions about the legality of the decision, in an unexpected move that has shocked the South Asian nation long accustomed to seeing the military get its way.

Yesterday, hours ahead of the midnight deadline for Bajwa's term to expire, the court said it was granting him a conditional extension of six months, giving parliament time to clarify the constitutional guidelines under which an army chief's tenure could be prolonged.

"Considering that the (army chief) is responsible for the command, discipline, training, administration, organisation and

preparedness for war of the army ... we, while exercising restraint, find it appropriate to leave the matter to the parliament," Chief Justice Asif Saeed Khosa told the court.

Khan celebrated the

court's decision.

"Today must be a great disappointment to those who expected the country to be destabilised by a clash of institutions," the prime minister tweeted moments after the ruling.

Envoy's 'GOOD LUCK' to Myanmar was a mistake

Says Israel on Rohingya genocide case

The Israeli ambassador was mistaken to have sent a "GOOD LUCK" message to Myanmar ahead of World Court hearings on accusations the state committed genocide against Rohingya Muslims, Israel's foreign ministry said yesterday.

Israel's Haaretz newspaper reported that the ambassador to Myanmar wished authorities good luck in tweets that have since been deleted ahead of the hearings next month at the International Court of Justice (ICJ) in The Hague.

"The ambassador's tweet was a mistake and was immediately amended," the foreign ministry said in a statement.

"Israel forthrightly condemns the atrocities perpetrated against the Rohingya in the Rakhine region. Israel voted, a week ago, in favour of a U.N. resolution stability. condemning the atrocities."

More than 730,000 Rohingya Muslims have fled to neighbouring Bangladesh since a 2017 crackdown by Myanmar's military, which U.N. investigators say was carried out with "genocidal intent". Buddhist majority Myanmar denies accusations of genocide.

Myanmar's de facto leader, State Counsellor Aung San Suu Kyi, will lead a delegation to defend against accusations brought at the ICJ by Gambia, which has the backing of the Organisation of Islamic Cooperation.

Ronen Gilor, Israel's ambassador to

Myanmar, had tweeted "Encouragement for a good verdict and good luck!" in one post, Haaretz reported with a screengrab of the since deleted tweet.

Another tweet said: "State Counsellor going to respond for Myanmar in the ICJ! GOOD LUCK!"

Western countries have widely condemned Myanmar's actions in Rakhine state while China has offered support for what it terms Myanmar's efforts to preserve domestic

Myanmar is facing a wave of international pressure from courts across the world, and other cases involve individual criminal responsibility.

Foreigners' Tribunals creating 'havoc' in Assam: Amnesty

Amnesty has accused Indian authorities and courts of lack of oversight on the functioning of Foreigners Tribunals' courts that have been accused of creating "havoc" in the northeastern state of Assam, where nearly two million people were excluded from a citizenship list

in August. "For the last 15 years, Foreigners' Tribunals have wreaked havoc in Assam by arbitrarily denying people their citizenship. They have not been held accountable by the courts, the Government of India and the Government of Assam," Amnesty International India said on Wednesday in a report

titled Designed to Exclude. The report alleges that the Foreigners' Tribunals, quasi-judicial courts that decide the citizenship of people, are "riddled with bias" and work in "arbitrary ways".

"Holding governments accountable for the human rights abuses they commit has always been difficult. However, in this case, it is the judiciary that has aided the government institutions and Foreigners' Tribunals in committing abuses with impunity," said Aakar Patel, Head of Amnesty International India, in a statement.

On August 31, the National Register of Citizens (NRC) - a Supreme Court-monitored bureaucratic citizenship exercise - excluded 1.9 million people from its final citizenship list in Assam.

> have criticised the NRC for anomalies and procedural flaws, with many cases where genuine Indian citizens, including former government officials, were excluded.

Those excluded from the NRC list have been given 120 days to appeal in the Foreigners' Tribunals. They can file cases in the High Court and the Supreme Court for redress.

An analysis of the affidavit filed by the Government of Assam in the Gauhati High Court, according to Amnesty International India, shows that on an average, a Foreigners' Tribunals member who declared people were foreigners in fewer than 10 percent of their disposed cases, stood the risk of being axed.

India extends ban on Ulfa

The Indian government yesterday said it had extended the ban on "insurgent outfit" United Liberation Front of Asom (ULFA) for five years for "continuing subversive activities, including killings, kidnapping and extortions".

The home ministry said in a notification that the ULFA had been indulging in various illegal and violent activities intended to disrupt the sovereignty and territorial integrity of India in furtherance of its objective of liberating Assam.

"Now therefore, in exercise of the powers conferred by sub-section (1) of section 3 of the Unlawful Activities (Prevention) Act, 1967 (37 of 1967), the central government hereby declares the United Liberation Front of Asom (ULFA) along with all its factions, wings and front organizations as an unlawful association," it said.

A Home Ministry official said the ban had been extended for five years.

ULFA was set up in April 1979 and the group was first banned in 1990. Since then, the Indian government has been extending the ban imposed on it from time to time.

A faction of the ULFA is currently involved in peace talks with an interlocutor of the central government, while another faction, led by its military chief Paresh Baruah, has been engaged in subversive activities.

After ULFA Chairman Arabinda Rajkhowa expressed willingness to begin peace talks with the Indian government in November, 2004, the dialogue began in October 2005.

On November 6, 2009, ULFA's "foreign secretary" Sashadhar Choudhury and "finance secretary" Chitraban Hazarika surrendered before the BSF near Agartala and on December 4, 2009, Rajkhowa and "Deputy commander-in-chief" Raju Baruah, along with family members, surrendered to Indian authorities along India-Bangladesh border in Meghalaya.

GANDHI KILLER REMARK BJP MP sacked from defence panel

Cracking the whip on MP Pragya Thakur over her remarks on Nathuram Godse in Lok Sabha, the BJP yesterday barred her from attending its parliamentary party meeting in the ongoing Parliament session and removed her from the consultative committee on

defence. BJP working president J P Nadda announced the disciplinary action against her and condemned the Hindutva controversial leader's remarks in a bid to defuse the political crisis triggered by her remarks in the Lok Sabha on Wednesday.

Nadda also said that Thakur will be removed from the consultative committee on defence, to which she was recently appointed.

"The statement given by MP Pragya Thakur is condemnable. BJP never supports such statement and we do not support this ideology. We have decided that Thakur will not attend meetings of BJP parliamentary party during the session," he told reporters.

Thakur created a controversy on Wednesday with her remark in the Lower House during DMK member A Raja's narration of a statement by Nathuram Godse before a court on why he killed Mahatma Gandhi.

However, after opposition members protested against Thakur's remarks, Lok Sabha Speaker Om Birla said only the DMK leader's speech during the discussion on the Special Protection Group (Amendment) Bill will go on record.

Opposition parties attacked the government, particularly Prime Minister Narendra Modi, alleging that the PM's "inaction" against her proves his latent support to "Godse's sinister thought".
