# Cheating in recruitment tests with spy gadgets

DB arrests seven with earphones, transmitters

With a tiny wireless earphone inserted in his ear and an electronic transmitter attached to his arm with an elastic band, Rasel Ali sat for a recruitment test of a state-owned bank at Adarsha High School in Mirpur on Friday, when the detective branch (DB) of police detained him.

Taking him in custody, police conducted multiple drives on Friday and Saturday and arrested six members of a question-leaking gang from Kafrul and Lalbagh areas, said Masudur Rahman, deputy commissioner (media) of Dhaka Metropolitan Police in a press briefing at the DMP media centre vesterday.

The arrestees were allegedly involved in helping candidates of recruitment tests of various government and private jobs cheat in the exam through electronic devices, he

Six members of this gang are still on the run, Masudur told the press conference.

DB police also seized 12 such electronic transmitters, 16 micro-earphones, 15 cell phones, 25 SIM cards and four books used for solving question papers of different

The arrestees are: Rasel Ali (29), Mahmudul Hasan Azad (36), Md Nahid (25), Ruhul Amin (25), Khalekur Rahman Titu (29), Ahmed Zubair Saimon (26), and Md Ibrahim (24).

Among them, Azad -- dubbed the master planner of the racket, has been working a

government job after being recommended as a non-cadre officer in the 36th BCS exam, Masudur said, adding that they were enquiring about the profiles of the other

A case was filed under public examinations act and digital security act with Kafrul Police Station on Saturday against the arrestees and six others, he said, adding that drives are on to arrest the other accused.

The arrestees were produced before a Dhaka court with a 10-day remand prayer.

The court granted two-day remand for each. Sources said Azad and Nahid are chargesheeted accused in a case over a question paper leak incident of Dhaka University on October 20, 2017

On June 23, the charge-sheet was submitted against 125 people including five masterminds of the gang. Most of them are now on bail.

Of the ringleaders, Ebrahim Molla (35), was also accused in the latest case, as the arrestees named him to be involved with the racket. Ebrahim is on bail in the previous case.

Ebrahim, who came from a modest background owned a six-storey building in Khulna city and a duplex in Narail town. On November 3, a Dhaka court ordered to confiscate the two houses.

The latest arrestees were involved in leaking questions of Janata Bank's recruitment test on Friday, said Ashrafullah,

### Dhaka to get 64 parking spots temporarily: DTCA

Amid an acute crisis of parking space in the city, Dhaka Transport Coordination Authority (DTCA) has approved 64 parking spots on a

The approval was given yesterday at DTCA's 13th board meeting, held at Nagar Bhaban of Dhaka South City Corporation (DSCC) and presided over by Road Transport and Bridges Minister Obaidul Quader.

The decision comes fifteen days into the enforcement of Road Transport Act-2018, according to which, no vehicle is allowed to park or load and offload goods or pick up and drop off passengers at any place not designated for the purpose.

Violators would be fined Tk 5,000.

However, only a handful of commercial buildings in the city have parking spaces. For buses, there are no designated parking space or terminal in the capital. Therefore, many vehicles remain parked on roads, causing congestion.

At yesterday's meeting, a decision was also taken to shift all inter-district bus terminals of Dhaka city upon ensuring alternative places outside Dhaka. Quader said the drive against illegal easy-bikes, battery-run rickshaws and non-motorised vehicles have lost momentum amid worsening dengue

At DTCA's 12th meeting on June 19, a special committee led by Dhaka South City Corporation (DSCC) Mayor Sayeed Khokon was formed to remove illegal vehicles from the streets and free footpaths from grabbers within two months.

But the move did not bring expected results.

The proposition of taking class came from the students' end. I was compelled to give class at the stairs as the department did not allow me to use classrooms. The students seemed to appreciate the class. If they want, I'll continue taking classes," Rushad told The Daily Star.

The assistant professor said he will continue the sit-in in front of the department chairperson's room until the latter reinstates him.

## Daycare approach an effective alternative to hospitalisation

severe childhood Management pneumonia by daycare approach is an alternative to hospitalisation, and can reduce the treatment cost by half, scientists of icddr,b at a seminar said vesterday.

Based on a clinical trial, they also said that some 80 to 90 percent children with severe pneumonia -- malnourished or not -- can be treated under this approach in the existing healthcare system in the country, and is as effective as the World Health Organization (WHO) prescribed mechanism.

Moderated by Prof George Fuchs of University of Kentucky in USA, experts from home and abroad and policymakers attended the seminar at the Sasakawa Auditorium of icddr,b in Dhaka.

According to WHO, pneumonia is the single largest infectious cause of death in children worldwide -- killing some 8,08,694 children under the age of five in

This disease, a result of acute respiratory infection caused by a number of agents -including viruses, bacteria and fungi -- can be prevented with simple interventions and treated with low-cost, low-tech medication and care.

However, lack of timely access to treatment intensifies the risk and causes death of "one child every 39 seconds globally", Unicef estimates.

and Abdullah Al Roman (22). A Rab team arrested them along with some "extremism provoking" books and leaflets when they gathered in Nikunja area around 9:40pm on Saturday, Mizanur Rahman Bhuiyan, an assistant director of

Rab's legal and media wing, said. According to Rab, the arrestees during preliminary interrogation admitted that they were active members of the banned group and did not support the democratic

system. "The accused wanted to establish Islamic law in the country and for this, they justified killing people whom they

#### EVICTION NOTICE TO ASK

#### HC issues status quo for three months

The High Court yesterday directed the authorities concerned to maintain a status quo for three months on the possession of the office of Ain O Salish Kendra (ASK), a leading rights organisation, at Dhaka's Lalmatia.

It also imposed the status quo on the Rajuk mobile court order that fined ASK Tk two lakh and asked the organisation to leave its Lalmatia office in two months.

At the same time, the HC issued a rule asking the authorities concerned to explain in four weeks why the Rajuk mobile court order should not declared illegal.

The bench of Justice M Enayetur Rahim and Justice Md Mostafizur Rahman passed the order and issued the rule following a writ petition filed by ASK, challenging the legality of the mobile court's order.

There is no legal bar to ASK running its office at Lalmatia following the HC order, ASK lawyer ZI Khan Panna told reporters.
