## to death in Jashore

An activist of Bangladesh Chhatra League (BCL) has allegedly been stabbed to death by rivals in Jashore Sadar upazila.

Jony Rahman, 20, son of Sirajul Islam of the upazila, was an executive committee member of Narendrapur Union unit of Chhatra

Quoting locals, police said the deceased had disputes with other leaders including unit president GM Sabuj Hassan and general secretary Shahin Alam, over the purchase of sand from a pond in the area.

On Monday around 9:00pm, the activists of the rival BCL factions attacked him in Taropara Amtola area and stabbed him, said Officerin-Charge (OC) Moniruzzaman of Kotwali Model Police Station.

Nahid died on the spot, the OC said, adding that the body was sent to Jashore General Hospital morgue for autopsy.

"Police are investigating the matter. Whoever involved in the killing will be arrested," he

### BCL man stabbed | Trump to face 2 formal charges

Nadler, in a solemn and deeply serious moment for the nation, was joined by House Speaker Nancy Pelosi in the US Capitol to lay out the charges facing

Trump-- who will be only the third US president to be impeached if the full House of Representatives backs the charges--responded to the announcement of impeachment charges by calling the accusations "ridiculous."

He also renewed his familiar claim on Twitter that he is the victim of a "WITCH HUNT!"

The president is alleged to have wielded the power of the presidency for personal and political gain by pressuring Ukraine to interfere in the 2020 US election.

His accusers say he conditioned vital military aid and a much-sought White House meeting on Kiev announcing it

would investigate Democratic former vice president Joe Biden, who is the frontrunner to challenge Trump in the 2020 election.

He also pressed his Ukrainian counterpart Volodymyr Zelensky to probe a debunked Kremlin conspiracy theory that it was Kiev, and not Moscow, that interfered in the 2016 US election.

The charges also focus on Trump's efforts to block Congress from fully investigating his actions -- which Democrats see as a violation of its constitutional right to conduct oversight of the executive branch.

"The evidence of the president's misconduct is overwhelming and uncontested," said House Intelligence Committee chairman Adam Schiff, who oversaw weeks of public hearings in which witnesses including Trump administration officials and US diplomats testified about the pressure

"To do nothing would make ourselves complicit in the president's abuse of his high office," Schiff said, adding that Trump's "misconduct goes to the heart of whether we can conduct a free and fair election in 2020."

Trump, who has long assailed the Democrats for pursuing impeachment, maintained his fighting posture early yesterday, tweeting that the effort to oust him as "sheer Political Madness!"

Democrats on Monday laid out their case for ouster with a nearly 10hour public hearing in which they declared Trump a "clear and present danger" to national security.

It is widely understood that Democrats were debating whether to unveil a third article of impeachment -- obstruction of justice -- against Trump, but concluded it would be better to keep the charges narrowly focused on Trump's Ukraine pressure

## Cut down on foreign trips

# 12 acres of Meghna leased out illegally

Says NRCC

The district administration in Munshiganj violated law leasing out a 12-acre foreshore and floodplains of the Meghna in Char Betagi, said National River Conservation Commission Chairman Muzibur Rahman Howlader.

"The way Munshiganj district administration leased out vast expanse of the river foreshore and floodplains is unlawful and it has gone against the tenet of saving this arterial river," he told this correspondent yesterday.

Mentioning that the district administration resorted irregularities while leasing out the Khas land, he said, "They [district administration] first leased out the Khas land to landless people and then retracted it to give it to a wealthy

This very method is illegal because the character of an area recorded as river in the Cadastral Survey records cannot be altered and handed over to private parties, he added.

Members of National River Conservation Commission (NRCC), including its chairman, visited Char Betagi to inspect the fresh earth filling into the river on Monday.

A day before their visit, The Daily Star published a report on how this piece of unregistered land was leased out to privately owned Anlima Petroleum Limited.

The report also mentioned how the company started filling up the foreshore and floodplains to reclaim highland for establishing its petroleum refinery.

Talking to The Daily Star yesterday, NRCC Chairman Muzibur also said his commission instructed the deputy commissioner of Munshiganj to immediately stop the ongoing work, cancel the lease and resolve the issue within a week.

The commission has also ordered the authorities to restore the original character of the river area by excavating the already filled up site, he added.

The deputy commissioner of 11, 201 Munshiganj will have to immediately the US.

revoke the lease in accordance with section 149/4 of the State Acquisition and Tenancy Act, he said.

According to the NRCC official, they examined other incidents of such river grabbing in Gazaria upazila of Munshiganj and Sonargaon upazila of Narayanganj during their latest

The district commissioners of the two districts were also directed to prepare a list of river grabbers and take legal actions against them, he

Muzibur also held the inaction of Bangladesh Inland Water Transport Authority, Bangladesh Development Board, Department of Environment and the two district administrations responsible for such condition of the Meghna and its tributaries.

Meanwhile, Moniruzzaman Talukdar, deputy commissioner of Munshigani district, said they halted the earth filling work on the day The Daily Star published its report.

They were now looking into the process of revoking the lease and retracting the river area, he further

"My predecessor leased out the river foreshore and floodplains. It is a constraint to me. I will seek opinion of the land ministry in this case," he

added. administration initiated leasing out the yet-to-be identified land, he said, 'It is embarrassing for me to either defend or contradict with this. I was not directly involved in this process."

# MTB employee

Both the accounts were maintained under the bank's "privilege banking" scheme, which was under the supervision of Jahid.

On the same day, Ferdousi applied for issuing a cheque book against the new account. The cheque book was issued and shown given to the client on October 25, 2016. However, the client never received the book, reads the First Information Report (FIR) of the case.

Later another chedue book w issued in April 2017. The ACC found that the book was issued upon a fake request from the client.

However, this time Ferdousi received the cheque book. She authorised one Ishtiaq Hossain Talukdar, who collected the book on her behalf,

according to the case statement. On August 23 that year, another application was filed with the MTB branch, seeking another cheque book. It was issued two days later. Signatures of the client in both the requisition slip and collection register were found to be fake.

On March 28 last year, another request was made for issuing a cheque book. This time, Jahid, also then assistant vice president of the bank, prepared a fake authorisation letter which said Ferdousi authorised him to collect the cheque on her behalf.

The client's signature in the authorisation letter was fake, the graft watchdog found.

Each cheque book contains 25 pages. Ferdousi used only 14 pages of a cheque book to withdraw about Tk

"After verification by experts, it was found that the signatures in the 14 cheques were hers," said the case

statement. However, Ferdousi's signature was forged in the rest of the 60

cheques which were used by Jahid for withdrawing about Tk 4.97 crore.

Of the amount, Jahid deposited Tk 2.24 crore in his wife's account in another private bank.

As transaction information is sent to clients through SMS, Jahid changed Ferdousi's mobile phone number in the bank's client database with his own number within 25 days of opening of

To do so, the banker prepared a fake omi for changi mobile phone number.

The ACC verified the changed number with a mobile phone operator and found that the NID number used

for its registration belonged to Jahid. Contacted, MTB Managing Director and CEO Syed Mahbubur Rahman yesterday said they were conducting an investigation into the incident and action would be taken if anyone was
