

# Nippon Foundation to donate \$2m for Rohingya education

Nippon Foundation, a Japanese non-profit organisation, is going to donate around USD 2 million (about Tk 17 crore) to Brac towards its education programme for Rohingya children in Cox's Bazar.

The organisations made the announcement at a press conference held at Brac Centre Inn in the capital yesterday, according to a press release.

About the outcome of the initiative, the press release also said the grant will help build about 50 two-storey moveable steel structures -- to be used as learning centres for about 8,000 Rohingya children.

The aid will also help build about 100 pre-primary learning centres for the host community children in Cox's Bazar, it added.

Top officials of both organisations -- including Nippon Foundation Chairman Yohei Sasakawa and Brac Executive Director Asif Saleh -- and representatives from the Japanese embassy in Dhaka were present at the event.

Founded in 1962, the Nippon Foundation works with communities in the fields of social safety, youth, culture, poverty, and saving the oceans, among others.

# Transfers in land ministry to be based on lottery: minister

Land Minister Saifuzzaman Chowdhury yesterday said transfer and posting of land service officials will be on the basis of lottery, according to a press release.

He said they took the decision to ensure transparency and accountability in ministry activities and prevent lobbying and corruption.

The minister was speaking at an event, organised to launch the lottery system at the secretariat. In the first phase, 548 newly-promoted land officials will be brought under the system.

"We want to do it so that there will be unquestionable transparency in the process of posting, transferring and other official activities," said Saifuzzaman.

# Court summons Bonya for statement on Dec 30

A Dhaka court yesterday summoned Rafida Ahmed Bonya and five other prosecution witnesses to appear before it for statements on December 30, in the case filed over the murder of writer-blogger Avijit Roy.

Judge Md Majibur Rahman of the Anti-Terrorism Special Tribunal of Dhaka passed the order during yesterday's hearing.

Eight out of 34 prosecution witnesses, including Avijit's father Ajoy Roy who passed away on December 9, have given their depositions before the tribunal so far in the case.

"Bonya is the most important witness in the case," Assistant Public Prosecutor Golam Sharuar Khan told The Daily Star.

During yesterday's hearing, prosecution witness Saiful Kabir told the court that Assistant Commissioner Fazlur Rahman of Detective Branch (DB) seized two cell phones and SIM cards in front of him on March 2, 2015 during investigation.

"On March 3 that year, investigation officer Fazlur Rahman seized three CPUs as evidence in the case," said Saiful, a constable of DB (south division).

"Constable Bashir Uddin, who was also a witness while seizing the case evidence, died in 2017," Saiful added.

The judge recorded Saiful's statements after the defence lawyers cross-examined him.

Four accused -- Mozammel Hossain Saymon, Abu Siddiq Sohel, Arafat Rahman Siam and Shafiu Rahman Farabi -- were produced before the tribunal during yesterday's hearing. Two other accused -- Sayed Mohammad Ziaul Haque alias Maj (sacked) Zia and Akram Hossain Abir -- are still on the run.

in abducting, torturing and killing nine non-combatant freedom fighters.

According to the charges, Sattar along with the Pakistani army and Razakars attacked Talaimari village under Boalia Police Station and detained freedom fighters from their homes.

They were taken to the army camp at the hall and tortured. The nine were killed on November 4, 1971, it added.

# SCOPE FOR EXTENSIVE PROBE

The tribunal said Pakistan occupation army did not just station at Shamsuzzoha Hall in 1971, they transformed it into a "concentration camp", and had recurrently killed countless civilians after bringing them there.

"Targeting civilians would not have been possible without active assistance, contribution and collaboration of Bangalee traitors belonging to Razakar Bahini and pro-Pakistan political parties," it said.

The tribunal said they got a portrayal of the army camp set up at the hall from an

article titled, "Honouring a Rare Sacrifice", published in The Daily Star on March 31, 2011.

"Around mid-April, a huge force of the Pakistani army entered the city. Most of the campus residents left the area as the Pakistani army established their base at the university halls. The army turned Shaheed Shamsuzzoha Hall into a 'concentration camp' and 'repression centre'. After torturing them, the barbarians killed the students, the intellectuals and able-bodied males at the mass graveyard behind Zoha Hall," the verdict mentioned, citing the report of the English daily.

"We fail to comprehend why the investigation agency did not care to concentrate on other countless events, which resulted in killing of thousands of civilians, after keeping them confined to the army camp..." it added.

The tribunal said more extensive investigation can help comprehend what extent of barbaric atrocities were carried out at the army camp at Zoha Hall during the Liberation War.

"We are yet to learn who owned the motorcycles," he said.

The incidents took place amid law enforcers' strict security measures taken in and around Supreme Court area ahead of BNP leader Khaleda Zia's bail hearing today.

Police sources said security has been beefed up, and they will strengthen their vigilance today centring the hearing.

On November 14, Khaleda Zia filed the appeal with the Supreme Court, challenging the High Court order that rejected her bail petition in the Zia Charitable Trust corruption case.

Pro-BNP lawyers on December 5 created chaos at the SC during the hearing of Khaleda's bail appeal -- forcing the chief justice and five other judges to leave the courtroom.

On that day, Attorney General Mahbubey Alam prayed to the court to adjourn the hearing till December 12. He told the court that BSMU authorities were yet to prepare the medical reports on Khaleda's condition, and they needed one more week to carry out various tests.

On October 29 last year, Dhaka Special Judge's Court-5 convicted Khaleda in the case and sentenced her to seven years' imprisonment in her absence. The Anti-Corruption Commission had filed the case with Tejgaon Police Station on August 8, 2011.

The BNP chief landed in jail on February 8 last year after the same court awarded her five years' imprisonment in Zia Orphanage Trust graft case.

The HC on October 30 enhanced her jail term to 10 years in the case, dismissing her appeal.

leader Md Asaduzzaman Asad spoke about the country's present rights situation.

It is a matter of regret that even after 49 years of independence, people are being victims of extrajudicial killing and forced disappearance, he said. "A suffocating situation is prevailing in the country where people are being deprived of their rights," he added.

Fakhrul alleged that the government has created a myth surrounding its development projects to fool people. "Only development cannot resolve people's sufferings. If there is no democracy, no development can be sustainable."

The BNP leader urged all to unite to restore democracy. Party's standing committee member Amir Khasru Mahmud Chowdhury said as the government is not accountable to anyone, they do not care about the country's human rights condition.

"Absence of democracy is the root cause of all problems. Democracy must be restored to come out of this situation," he added.

He also claimed that all the autocratic regimes had created a sense of fear to stay in power and the incumbent government is not an exception.

Among others, former Dhaka University teacher Mahbub Ullah and Gonoshasthaya Kendra founder Dr Zafrullah Chowdhury spoke at the seminar, participated by delegates from the US, the UK, Russia, India, European Union and other countries.

During an open discussion, Shah Faisal Kakar, acting high commissioner of Pakistan to Bangladesh, took the floor and raised the issue of Jammu and Kashmir. He demanded that a UN inquiry commission must be established to look into the human rights situation there. Fakhrul asked Kakar several times to end the speech and at one stage, stopped him abruptly.

He also said the ministry will take an initiative soon to involve Bangladeshi diaspora living across the globe in the country's development.

"There should be a diaspora policy," he said.

In India and China, diaspora communities are now investing billions of dollars and contributing to the development of their respective country of origin directly, the minister said.

Such investment by Bangladeshi diaspora communities is not yet noticeable, he added.

Secretary to the Expatriates Welfare Ministry, Salim Reza, said they will have to give a subsidy of about Tk 35 crore annually for the insurance -- taking into consideration 7,00,000 migrant workers going for overseas employment on an average each year.

At present, a deceased migrant worker's family gets Tk 3 lakh from the government as compensation. The insurance money will be added to that amount, he said.

Senior Secretary Ashadul Islam of Financial Institutions Division, Expatriates Welfare Ministry's Additional Secretary Ahmed Munirur Saleheen and JBC Chairperson Shelina Afroza, among others, addressed the ceremony.
