The students, however, said the number of sick students would be more than 70. They alleged that the food was

sub-standard, blaming authorities' negligence for the incident.

Ganosamhati protests Citizenship (Amendment) Act

Martyred tea workers' families given ownership of land

Tarapur Tea Garden in Sylhet witnessed mass killings by Pakistani occupation army on April 18, 1971, during which 39 tea worker families were affected.

After 48 long years, the families are finally getting ownership of the land they have lived on for generations. Tea workers have been deprived of the right to own land for over a century, and this initiative of handing over land ownership to them is a milestone, said Faruque Mahmud Chowdhury, president of rights organisation Sushasoner Jonno Nagorik's Sylhet chapter.

On Victory Day, three families of martyred tea workers received papers finalising their land ownership. On April 18 this year, 20 families got the papers.

The tea garden, now an endowed property, is looked after by Pankaj Kumar Gupta, who lost five family members in 1971.

Pankaj handed over the documents to the martyrs' descendants. "My father, uncle, and brothers were killed before my eyes. My life was spared as I was a child. These workers' families are like me; I can feel their pain," he said.

"Other martyrs' families will get land ownership soon, as I believe they deserve this honour for the sacrifice they had to make for the country," added Pankaj.

A rickshaw-puller killed a fellow worker -- hitting him in the head with a brick -following a row in Narayanganj's Fatullah area early yesterday.

The deceased was identified as Suruj Miah (57) from Mymensingh.

Police arrested the accused rickshawpuller Abdul Gani (56), also from Mymensingh, said Mizanur Rahman, inspector (investigation) of Fatullah Model Police Station.

Inspector Mizanur said that five rickshaw-pullers were staying in a single room at Khilmarket area. Around 5am yesterday, Abdul Gani locked into an altercation with Suruj Miah over sleeping in the bed, he said.

Abdul hit Suruj with a brick -- leaving him critically injured.

Others sharing the room took Suruj to Narayanganj General Hospital. He was later shifted to Dhaka Medical College Hospital (DMCH).

"Doctors at DMCH declared Suruj dead yesterday noon," said the inspector. Police have arrested the accused.

Govt doesn't care about the underprivileged

Says Sultana Kamal

Noted rights activist Sultana Kamal yesterday urged the government to enact the proposed Anti-discrimination Act immediately to ensure equal rights for all citizens and end discrimination towards marginalised communities like Dalit.

She claimed that the government is keeping it pending, as they do not care about those people anymore.

Sultana, chairperson of Transparency International Bangladesh (TIB) made the remarks at a press conference held at Dhaka Reporters' Unity. National Advocacy Platform, in association with Centre for Social Activism and HEKS/EPER, organised the event to launch a report on

the rights situation of Dalits and ethnic minority groups living in the plain lands. Citing the report findings, Sultana, also convener of the Advocacy Platform, said the rights situation of these communities has been worsening gradually, as violence against them is frequent nowadays.

Most of the violent incidents they face centre land. Considering the current situation, formulation of a separate land commission for the ethnic groups and enactment of the anti-discrimination act have become absolutely necessary, she added.

The rights activist also alleged that the government could easily pass acts that tend to "snatch people's rights", but the acts that are necessary for the well-being of the masses remain pending for approval for years. SEE PAGE 4 COL 1

Railways minister seeks Japan's help

Railways Minister Nurul Islam Sujan yesterday sought assistance from Japan to build a new bridge to replace the century-old Hardinge Bridge in Pabna.


The minister made the request when the Japanese High Commissioner in Dhaka Ito Naoki met him at Sujan's office in the capital's Railway Bhaban.

"It is a very old structure, and we have to change it. We discussed several major structures with which Japan can assist, and then the minister mentioned Hardinge Bridge," Railways Secretary Mofazzel Hossain told The Daily Star last night.

The two also discussed the proposed Bangabandhu Rail Bridge over Jamuna River, Multi-modal Transport Hub centring Kamalapur Railway Station and Metro Rail projects, he said.

Japan is funding the under-construction Mass Rapid Transit-6 -- popularly known as metro rail -- and is expected to invest in the Bangabandhu Rail Bridge and Kamalapur Multi-modal Transport Hub.

The Hardinge Bridge, which has already recorded 100 years of use and counting, is one of many structures built by the British during their rule. The bridge shares a significant history of Bangladesh, and specifically, of Pabna.

BIMAN EMBEZZLEMENT CASE

2 officials granted bail

A Dhaka court yesterday granted ad-interim bail to two officials of Biman Bangladesh Airlines in a case filed over embezzling more than Tk 118 crore through misuse of

The accused are: Mohammad Ali Ahsan, former general manager (cargo), and Iftekhar Hossain Chowdhury, former manager (export) of cargo department.

Judge KM Emrul Kayesh of the Senior Special Judge's Court of Dhaka passed the order after their lawyer Syed Rezaur Rahman moved a petition seeking bail for his clients in the case.

The order came after a four-day long hearing. The bail will be valid till January 7, the next scheduled date of the case, said the judge in his order. During yesterday's hearing, Rezaur Rahman told the

court that his clients were not involved in the incident, as the two went on retirement in 2016 and 2017, before the embezzlement happened.

Meanwhile, Public Prosecutor Mahmud Hossain Jahangir opposed the defence pleas saying that the two officials could not avoid responsibility as other accused persons were under their supervision.

Foreigners without Work Permit

how many foreign nationals are working and running businesses in Bangladesh without valid work permits, how many are holding proper work permits and how much tax they have paid to Bangladesh government.

In response to a writ petition, the court ordered Bangladesh Investment Development Authorities (Bida), NGO Affairs Bureau and Bangladesh Export Processing Zone (Bepza) to submit separate reports to the HC in 60 days.

It also issued a rule asking authorities concerned why their inaction in enforcing requirement of work permit for foreign nationals should not be declared illegal.
