In Chennai, Dravida Munnetra Kazagham (DMK) and its allies yesterday took out a protest rally against the amendment act and seeking its withdrawal.

In Bengaluru, thousands of people from Muslim community yesterday staged a "Peace Rally" against CAA and NRC. Waving the national flag and holding placards, the protesters raised slogans demanding withdrawal of CAA.

A division bench of the court, in an interim direction, asked the state government to suspend all such advertisements till it gives a final order Joint Action Committee of Bengaluru, on the issue. The next hearing in the

The High Court direction by a division bench of Chief Justice T B N Radhakrishnan and Justice Radhakrishnan came on six pleas that were filed against state government advertisements which allegedly claimed that CAA and NRC will not be implemented in the state.

Mamata Banerjee has been highly critical of the amended act passed by parliament and proposed countrywide NRC and undertook street marches vowing not to allow their implementation in the state.

The CAA seeks to give citizenship to "persecuted" non-Muslim refugees from Afghanistan, Pakistan and Bangladesh who have taken shelter in India till 2014.

The bench has been hearing petitions on issues like state's campaign against the CAA in various forms of media, "breakdown" of law and order situation and damage to railway property.

The bench also asked the railways to give a detailed report on what action it has taken to prevent loss of public property and the monetary amount of damage caused during the violent protests against CAA, NRC.

In Kolkata's Jadavpur University, student owing allegiance to Leftist outfits yesterday showed black flags to West Bengal Governor Jagdeep Dhankar and surrounded his car for about half an hour protesting his views in support of CAA and NRC.

of them were routine transfers. Some of them were transferred for their inefficiency and some for serving more than five years at the same units.

The transfer list also includes 32 inspectors (investigation) and 31 inspectors (operation), 26 traffic inspectors, around 150 subinspectors, and some 1,100 assistant sub-inspectors.

The reshuffle started after Shafiqul Islam took charge as the DMP commissioner on September 13.

Shafiqul instructed officials concerned to create profiles of every officer in the DMP.

There had long been dissatisfaction among many police officers as a group of inspectors, blessed by some influential political leaders and police high-ups, were influencing the postings of OCs at different DMP

Several police officials, wishing anonymity, said police stations illegally collect a huge amount of money every day from hawkers and drug dealers.

Many OCs, who have recently been transferred, used to get a large cut, they added.

In three orders issued since October 1, the DMP commissioner transferred OCs of 16 police stations

#### and brought in some new faces. The transferred OCs were sent to

units where making illegal money is hardly possible, they said.

"There were some powerful officers who thought they could never be touched. Now they are getting a message that they would not be able to retain their posts without discharging their duties with transparency," city police chief Shafiqul said.

The commissioner said he had considered officers' capability and reputation before appointing them as OCs.

Under the DMP, there are 50 police stations, each having an average of 50 officers.

"The good ones are being chosen for the OC posts and we are doing it transparently. There is no lobbying and nothing is exchanged," he added. Joint Commissioner headquarters) of DMP Sha Migan Shafiur Rahman said, "We are taking tough measures to ensure better

services to city dwellers. In February last year, the then DMP deputy commissioner of Tejgaon division Biplob Kumar Sarkar at a quarterly crime conference said, "An ÔC has to pay a bribe of Tk 30 lakh to Tk 1.5 crore for his posting. A subinspector needs to pay lakhs of taka for his transfer."

He then suggested that senior police officials must stop taking bribes for postings of OCs and SIs.

The DMP has around 34,000 members. Of them, 643 are inspectors, 2,600 are SIs, and 3,982 are ASIs.

This find was made in Cairo, about 40 miles south of Albany. Previously, scientists thought a fossilised forest in Gilboa, New York, was the earliest, but the one in Cairo is two or three million years older and dramatically different.

A person from the New York State Museum was the first to spot the large, root-like structures in the bottom of the quarry.

Christopher Berry, study coauthor and a paleobotanist at Cardiff University in the United Kingdom, told CNN he was a bit sceptical the first time he visited the site. He thought a modern tree might have grown into the rock and been removed.

Upon closer inspection of the soil profile, researchers quickly confirmed they were looking at the footprint of something much, much older.

"The scale of the root systems were really striking," said William Stein, lead author and emeritus professor of biological sciences at Binghamton University, located about two hours west of Cairo.

The team carefully swept away layer upon layer of dirt, meticulously mapping the extraordinary find.

The team hypothesises a catastrophic flood killed most of the trees in the forest and preserved the root system as fossils. They even found fish fossils near the largest trees

and Telecommunications Minister Mustafa Jabbar said Grameenphone has sent a legal notice to President Hamid through a legal agency in Singapore seeking arbitration with the Bangladesh Telecommunication Regulatory Commission (BTRC) over its dues.

Lund said, "It's Telenor Group's position that we believe the disputed audit should be solved through dialogue, and that an amicable and transparent solution should be reached between the authorities of Bangladesh and Grameenphone.

"It remains our hope that this can be solved without international arbitration. It's an agreement establishing the terms and conditions for private investment by nationals and companies of one state in another state."

The statement said, "Bangladesh has around 30 bilateral investment treaties. The procedures adhered to by Telenor are agreed in the treaty, and Telenor is following due process.

"The process itself is governed by the treaty, and includes a period of six months for discussions after initial invitation letter, before any further steps towards international arbitration can be taken."
