building on it. The building was rented out to Pirojpur Rural Electricity Cooperative.

Awal, who was MP from Pirojpur-1 between 2014 and 2018, also illegally grabbed a government land near Swarupkathi upazila bungalow and built another modern bungalow there.

In Pirojpur town, Awal grabbed about 44 decimals of land and erected a boundary wall to keep it in his possession, ACC sources said.

3 ILLEGAL GAS CONNECTIONS SHUT IN MIRPUR
Meanwhile, ACC yesterday led a drive in Mirpur and shut down illegal gas connections.

Three dying factories had been using a booster to pump in gas from household connections, that apparently deprived at least 63 families of Benarashipalli of Mirpur from gas facilities, said a press release from the anti-graft watchdog.

The factories had been using about 1,326 cubic feet of gas illegally, the monthly charge for which would be Tk 1.5 lakh, the release added.

A resident yesterday lodged a complaint through the ACC hotline 106, which sent a team to the spot.

The team, led by ACC's Assistant Director Shahriar Jamil, found the allegation to be true.

The team sealed four illegal risers and seized 26 burners of the factories.

Titas Metro Dhaka Sales Division-6 manager Shahidur Rahman said an ACC team informed them. Later, they accompanied the ACC team.

"It's difficult to find illegal connections unless neighbours complain," he said, adding they will fine the factories' owners Tk 10 lakh.

Jatiya Party will start giving out nomination forms from today among interested mayoral and councillor candidates for Dhaka north and south city polls.

Forms can be collected from the party president's Banani office from December 23-27.

All prospective JP leaders will have to submit the filled-out forms by December 27, the party said in a press release.

Interview of the prospective candidates will be held on December 29 at the party chairperson's office while the list of candidates will be declared on December

30, said the release.

In the meantime, JP chairperson and deputy leader of the opposition GM Quader yesterday at a programme in the capital said JP will consider it if Awami League (AL) gives them any proposal to participate in the polls under an alliance.

AL will start distributing nomination papers among the party's prospective candidates today.

The polls to Dhaka North City Corporation (DNCC) and Dhaka South City Corporation (DSCC) will be held on January 30 next year.

Chief Election Commissioner (CEC) KM Nurul Huda announced the election schedule at a press conference held at Nirbachan Bhaban in the capital's Agargaon following the EC's 57th commission meeting on Sunday.

As per the schedule, the last date for nomination paper submission is December 31; nomination paper scrutiny will be held on January 2, and the deadline for candidature withdrawal is January 9.

Station-Jamalpur-Tarakandi route. Four intercity trains now operate on Dhaka-Jamalpur route but all of those go to Jamalapur via Mymensingh, according to BR.

So, travel time from Dhaka to Jamalpur will reduce once the new train is introduced, said a railway official.

While visiting Jamalpur in early October, the railways minister declared that a new train would be launched on Dhaka-Jamalpur route soon.

This year, BR introduced four trains on different routes. It launched "Banalata Express", a nonstop intercity train service, on Dhaka-Rajshahi route in April. Later, the train service was extended up to Chapainawabganj.

A month later, a semi-nonstop intercity train service -- "Panchagarh Express" -- was launched between Dhaka and Panchagarh. "Benapole Express" was launched in July on Dhaka-Benapole route while "Kurigram Express" on Dhaka-Kurigram route was launched in October.

Gao's friend Zhang Shu Hong filed a murder case with Banani Police Station against unnamed accused on December 12.

A Dhaka court placed Rauf and Enamul on four-day remand each, a day after they were arrested from Banani on December 17 in connection with the murder.

Gao used to supply stones and other construction material to the Padma bridge and Payra port projects.

Eminent citizens condemn

The signatories to the statement include Advocate Sultana Kamal, Hameeda Hossain, Khushi Kabir, Justice Nizamul Haque Nasim, Advocate Rana Dasgupta, Dr Iftekharuzzaman, Shaheen Anam, Ziauddin Tarique Ali, Advocate ZI Khan Panna, Barrister Sara Hossain, Sheepa Hafiza, Shamsul Huda, Dr Meghna Guhathakurta, Saleh Ahmed and Shirin Huq, among others.

Condemning the attack, rights organisations Bangladesh Mahila Parishad and Ain o Salish Kendra (ASK) also demanded punishment of the attackers, belonging to Muktijuddho Moncho and Chhatra League.

"This attack is against the establishment of democracy and good governance," the Mahila Parishad statement said.

Meanwhile, Amnesty International's South Asia Campaigner Saad Hammadi wrote on Twitter: "Repeated violence at the universities committed by supporters of the ruling party on students undermines discipline, rule of law and most importantly the right to peacefully exercise freedom of expression."

Universities are formative stages where students should have the freedom

to learn and contest ideologies. Such demonstration of power by supporters of ruling party is damaging for the academic environment and integrity of the institutions, he added.

"The attack on Nur, Farabi and others is deeply troubling, as it happens three months into the killing of Buett student Abrar Fahad. It appears that the perpetrators are confident about getting away with such violence. The authorities have a responsibility to prove otherwise," reads the tweet.

Meanwhile, Dhaka University Teachers' Association (Duta) yesterday also protested and condemned the attack on Nur and his aides.

In a statement, it demanded to ensure proper treatment of the injured, and urged Nur to be "more responsible" in his work or statements.

The teachers' body also requested university authorities to take tough steps if any outsider's involvement is found in the attack.

They held Muktijuddho Moncho activists responsible for the attack, but did not mention Chhatra League's involvement in the incident.
