Smugglers of zero line

How smuggled bikes from India flood B'baria, nearby dists

MOHAMMAD JAMIL KHAN and MASUK HRIDOY, back from Kasba

It's a house right on the zero line.

Transnational syndicates have turned its kitchen into a storeroom of smuggled motorcycles. They also use it for assembling bikes, bringing in parts like tanks, wheels, headlights and seats from across the border.

A section of unscrupulous police officials and even some Border Guard Bangladesh men allegedly have links to the syndicates.

The Daily Star came to know about the house during an independent investigation into trafficking through Kasba border in Brahmanbaria.

On October 9, these correspondents, aided by a local police informant, travelled around 54km by road and rail from Brahmanbaria town to Kollapathar area in Kasba upazila. Then it was one-km walk to the border.

Around 10:30am, the informant called a person named Md Momen Miah, living in one of the houses built on the zero line, almost touching the Indian fence.

Momen, who was using a Bangladeshi SIM, was told that two customers have come to buy a bike.


Getting a positive signal, the source then took these correspondents near the house after ten minutes' walk along a trail through dense bushes. There were no border guards around.

zero line, Momen said he had a brand new TVS Apache RTR bike in his kitchen and it costs Tk 1.20 lakh though its authorised price in Bangladesh is Tk 1.60 lakh.

Talking about the illegal trade to The Daily Star near the

As these correspondents showed an interest to buy it, he asked them to meet his aide Monir, who was also known to the police informant.

Talking to this paper in Kasba Bazar, Monir said they have to pay border guards on both sides around Tk 2,000 to Tk 5,000 for every bike. "Police officials also get almost

'Stunned by DU VC's biased role'

Parents, civil society members say in memo;

A number of civil society members and parents of several Dhaka University students yesterday submitted a memorandum to the DU Vice Chancellor Prof Md Akhtaruzzaman criticising him for his alleged support to the controversial activities of Chhatra League.

"We are stunned by the biased role of the VC," the memorandum reads.

They also accused the VC of supporting the attackers of Ducsu Vice President Nurul Haque Nur on Sunday and alleged that the university administration did not take any measures to quell the situation.

In response, the VC assured them that legal action would be taken against the perpetrators.

It's BCL men in garb of Moncho

Muktijuddho Moncho, which hit the headlines for attacking Ducsu VP Nurul Haque Nur and Chhatra Dal activists in the last couple of months, has current and former Chhatra League leaders at its helm.

The Moncho claims to be comprised of children of freedom fighters. It was formed in October last year to counter quota reform demonstrations and initiate protests for the reinstatement of 30 percent freedom fighters' quota in government jobs.

Before the formation, Dhaka University's sociology professor AKM Jamal Uddin was made the convenor of the platform's nine-member convening committee. Asibur Rahman, son of Awami League leader and the then shipping minister Shajahan Khan, was made member secretary.

Prof Jamal was elected as a member of the DU senate from the Awami leaguebacked Blue Panel. He was the president of DU Kabi Jasimuddin Hall BCL between 1992 and 1994, and international affairs secretary of BCL central executive committee between 1994 and 1998.

The convening committee made Aminul Islam Bulbul the president and Al Mamun the general secretary of the Moncho's central unit.

Bulbul is a former organising secretary

of Shaheed Sergeant Zahurul Haque Hall BCL. He later became a vice-president of the pro-AL student body's central unit.

He is accused in an attempted murder case filed with Gopalganj Police Station on May 3 in 2010 for allegedly hacking one Sheikh Kuddus with a machete, show the case documents.

The Moncho leader was relieved of his post at the central committee after he sought his removal in writing, said BCL sources.

Al Mamun is still the deputy programme and planning affairs secretary of the BCL central unit. Besides, he is a former deputy liberation affairs secretary of the same unit. He also held posts at the Chhatra League unit in the university's Sir A F Rahman Hall, said BCL and Moncho

General Secretary of the Moncho's Dhaka Metropolitan North unit Sohel Miah is a vice-president of the Dhaka Metropolitan North unit BCL.

Moncho leaders Hasanur Rahman Hasu is the deputy social service affairs secretary of BCL central unit, Sonnet Mahmud is a former joint general secretary of Sir A F Rahman Hall BCL, Rabby Hasan Shawon is a member of Dhaka College BCL and Al Amin Masum a former activist of Dhaka University BCL. These four are also joint convenors of the platform.

The other joint convener, Afrina Tuli,

Coveted promotions only to be short-lived

7 promoted to senior secretary; one of them to serve just for a day, another for a few days

Raisul Alam Mondal, secretary at the fisheries and livestock ministry, will serve as a senior secretary just for a day.

Strange as it may sound, but that is what

a government gazette notification says. The public administration ministry issued the notification on Monday night, stating that Raisul was promoted to one of

the most-coveted administrative posts. The order said his promotion will take effect on December 30. Interestingly, Raisul will go on post retirement leave (PRL) the

following day. Public Administration Ministry Secretary Faiz Ahmed, who also got promoted that night, will have a few more days to serve.

Faiz was elevated to the rank of senior secretary. But his promotion order came into effect immediately.

Like Raisul, he is going on PRL on the last day of the year. The ministry was quick to change his designation as senior

secretary on its website. Five more secretary-level officials were promoted to senior secretaries that night. They are Md Anwar Hossain, secretary at the

science and technology ministry; Mofazzel

Hossain, secretary at the railways ministry;

Shahin Ahamed Choudhury, member at the Planning Commission; Sajjadul Hassan, secretary at the Prime Minister's Office; and Mohibul Haque, secretary at the civil aviation and tourism ministry.

The promotion orders of all but three --Raisul, Faiz and Anwar -- will take effect on December 31. Mohibul will go on PRL on January 5,

Sajjadul on January 10, Mofazzel on May 4, and Shahin on June 1 next year. Anwar's PRL starts on June 30, 2021.

A number of former bureaucrats say this will result in a significant rise in the top officials' post-retirement benefits though they will not have much time to serve.

M Hafiz Uddin Khan, a former bureaucrat, said, "Giving promotion just days before their retirement was nothing but a move to provide them with more financial benefits.

"They will get the benefits from the taxpayers' money but will not serve the country and the people for long.

MINISTERS IN AL COMMITTEE

Presidium asks Hasina to decide

The newly-constituted Awami League presidium, the highest policy-making body of the party, yesterday left it to AL President Sheikh Hasina to decide whether seven ministers would be included in the 81-member central executive committee.

The seven, among the 12 ministers who were in the previous committee, do not feature in the partially-formed Awami League Central Working Committee, which was announced during the AL's triannual council held between December 20-21.

Party insiders, at the time, said they viewed the move as an effort to separate the party from the government, although four ministers were selected in the central committee.

Presidium members yesterday discussed the issue of the seven minister's at their first meeting held at the Gono Bhaban in the capital yesterday night with Hasina in the chair, said sources.

The members gave Hasina the responsibility to take the decision in this regard.

The seven ministers of the were not named in the committee yet, are Housing and Public Works Minister SM Rezaul Karim, its former legal affairs secretary;

Commerce Minister Tipu Munshi, former finance secretary of the party; three former organising secretaries in the previous committee: State Minister for Shipping Khalid Mahmud Chowdhury, Deputy Minister for Water Resources AKM Enamul Haque Shamim and Deputy Minister for Education Mohibul Hasan Chowdhury; State Minister for Religious Affairs Sheikh Muhammad Abdullah, former religious affair secretary; and State Minister for Women and Children Affairs Fazilatun Nessa Indira, former women affairs secretary.

Four ministers -- Obaidul Quader, road transport and bridges minister; Adbur Razzaque, agriculture minister, Dipu Moni, education minister; and Hasan Mahmud, information minister -- were elected in the central executive committee.

Hasina was elected AL president for the ninth consecutive time, while Quader was elected her deputy for his second term.

After the meeting, Quader told reporters at Gono Bhaban gate that the full committee would be announced on Thursday.

Following the council, AL elected Hasina-led 47-member cabinet, who 42 office bearers in the 81-member central working committee, while names of the other 11 office bearers and 28 members are yet to

Meanwhile, DU students yesterday put forward a three-point demand.

"It is clear that the attack was a play jointly staged by the authorities and the Chhatra League.'

3 MONCHO LEADERS ON REMAND A Dhaka court yesterday placed three leaders of Muktijuddho Moncho on a three-day remand in connection with a case filed over attacking Nur on Sunday.

Al Mamun, general secretary of the platform's central unit, Yeasir Arafat Turjo, general secretary of its Dhaka University unit and Mehedi Hasan Shanto, office secretary of the platform's DU unit, were accused in a case filed with Shahbagh Police Station early yesterday.

Metropolitan Magistrate Md Moinul Islam passed the order after law enforcers produced Mamun, Turjo and Mehedi Hasan Shanto, office secretary of the Muktijuddho Moncho faction.

The three was put on remand a day after they were arrested at the capital's Shahbagh.

In another development, Nur yesterday filed a complaint with the Shahbagh Police Station accusing Chhatra League DU unit President Sanjit Chandra Das and General Secretary Saddam Hussain, 27, other BCL leaders and eight Moncho leaders for an "attempt to murder him".

Ducsu Social Service Affairs Mujahidul Islam Selim, Mahmudur Secretary Akhtar Hossen filed the complaint on behalf of Nur, said Abul Hasan, officer-in-charge of Shahbagh Police Station.

A wooden slope is set up on the border fence to push a bike onto Bangladesh side after the border is found secure.

We used to smuggle around eight to 10 bikes almost daily but the situation is tougher now after police arrested six of our members," he said.

This newspaper talked to some other sources, including syndicate members, and some locals who bought smuggled bikes, to get an insight into the illegal trade.

If any customer wants to get a licence number and registration, the smugglers handover the bike to another group working in Cumilla and Chunarughat in Habiganj, close to Brahmanbaria border.

This group removes the chassis number and replaces it with the number of an officially imported bike that was sold from an authorised shop. For this, they collect sale reports from showrooms.

For the entire process regarding the so-called licence and registration, the smugglers take additional Tk five to seven thousand. The customers would get some forged papers alongside a number.

On Indian side, the syndicates sometimes register a bike using a local's ID card -- known as Aadhar. Then a complaint is filed with a police station claiming that the bike was stolen, said a Bangladeshi youth, who is linked with the syndicate.

"They file the complaint so that they can get their bike back if it is seized by border guards, claiming it to be a lost property," he said, requesting not to be named.

Daily Star independently verify this claim.

Lt Col Iqbal Hossain, commanding officer of BGB-60 Battalion, told The Daily Star that most of the motorbikes that run in the district are smuggled

properly, there is an increasing tendency among youths to buy smuggled bikes, he observed.

"We often got information about the smuggled motorbikes but the smugglers kept those in the houses built on zero line. We have no authorisation to conduct drives there,' said the commanding officer.

"We often express our concerns to our counterparts at flag meetings.

for law Sources working enforcement agencies say syndicates mainly use Hakor, Badla, Madla and Bayek border points to smuggle in the bikes.

According to sources working for law enforcement agencies, one of the rackets is run by Wasim Miah of Ganganagar village and Hosen Miah of Ramchandrapur village in Cumilla. Shipon Miah of Gourangona area in Kasba is working closely with the duo.

Some other syndicate members in Brahmanbaria are Jahir Miah of Gopinathpur village, Billal Member of Dhojanagar, Rubel Mastar and Sadek Sarder of Nayanpur Bazar and Kamal Mia of Madla village.

Apart from police sources, local political leaders confirmed these names but none of the alleged were available smugglers

Md Lukman Hossain, officerin-charge of Kasba Police Station, said they were trying their best to identify the syndicate members. "We also warned police officials to work sincerely as stern action will be taken if anyone of them is found guilty."

Replying to a query, Lt Col Iqbal refused the allegation of BGB men being involved in smuggling. He said they always remain active and conduct drives whenever they found information.

THE ARREST

According to police, six people, including four Indian nationals, were arrested on May 11 after they entered

As the documents are not checked Bangladesh for a bike consignment. The arrestees were identified

as Amzad Hossain Shawon, 22, and Hasibul Hasan Anik, 19, of Bangladesh, and Sanjit Devnath, 23, Nirmolendu Chowdhury, 32, Sankar Sarkar, 31, and Bimol Das, 33, of

Police also recovered one pistol, two pipe guns, six magazines, two walkie-talkies with a charger, one reflective vest, three pairs of leg guards and one pair of hand gloves from

Abdul Karim, the then assistant superintendent of police (ASP) of Kasba circle, said the gang used walkie-talkies as mobile network didn't always work properly at the

ASP Karim, who got transferred to Khulna on October 27, in a statement had said Shawon was a professional smuggler accused in two cases including one for murder. The Indian nationals were also professional smugglers.

But, claimed a local source close to law enforcers, police submitted the charge sheet in a hurry on July 26, without explaining these details to save other syndicate members in Bangladesh.

ASP Karim refuted the claim. He told The Daily Star on October 10 that police did not find any other people's involvement, so they submitted the charge sheet against only the six. "We needed to submit the charge sheet within 60 working days as required by the law.

Sources said police arrested the six following a lead they got while investigating a murder that took place on Kasba border on February 26.

Mazharul Islam Tanim, 30, was killed because of internal feud of a smuggling racket, said Sub-Inspector Md Faruk, the investigation officer of the case. "We have found involvement of

nine people behind the killing and three are already in custody," he said.

Biman's 787 'Achin Pakhi' arrives

Biman's brand new Boeing 787-9 Dreamliner "Achin Pakhi" arrived in Dhaka from Seattle, USA, last night.

The aircraft, which left Boeing Everett Delivery Centre at 2:30pm (local time), landed at Hazrat Shahjalal International Airport around 8:19pm, said Tasnim Akhtar, public relations manager of Biman.

The Dreamliner was named by Prime Minister Sheikh Hasina.

Biman's first and second Dreamliners -- "Akash Beena" and "Hangsabalaka" -- arrived in August and December last year. The third one -- "Gaangchil" arrived in July, "Rajhansa" in September and "Sonar Tori" in December this year.

Hong Kong marks Christmas Eve with clashes and tear gas

Hong Kong marked Christmas Eve with tear gas and mall clashes yesterday night as battles between democracy activists and riot police swept through a major shopping district.

The evening's unrest was the most sustained in what has otherwise been a few weeks of comparative calm for a city upended by more than six months of violent protests.

Thousands of black-clad protesters -some wearing Santa hats and reindeer antlers -- took to the streets of Tsim Sha Tsui, a usually bustling tourist district.

Clashes soon erupted with riot police firing multiple rounds of tear gas to disperse protesters throughout the evening, including outside the famous Peninsula Hotel. Police said a "large group of rioters"

had built barricades, damaged traffic lights and dug up bricks on the area's major thoroughfares. Meanwhile, flashmob rallies were

held in multiple malls across the financial hub, with protesters chanting anti-government slogans. In Harbour City, a luxury mall,

police used pepper spray and batons when a group of plainclothes officers were discovered and surrounded, an AFP reporter on the scene said.

The plainclothes officers made multiple arrests as the crowds threw objects and heckled them.

Riot police quickly arrived at the scene, one aiming a shotgun at protesters as shops quickly shuttered.

Flashmob rallies formed in at least four other locations on Tuesday night with riot police trying to disperse crowds shouting chants and heckling

Footage posted on social media from a mall in Yuen Long district showed a man barging into a police officer and leaping one storey delow in a bid to avoid arrest.

In a statement, police said officers were responding to reports protesters were vandalising shops in the mall and that the man who fell was taken to hospital in a conscious state and arrested for assault.

Former US adviser warns of 'imminent' N Korea risk

Former US national security adviser John Bolton on Monday sharply criticized President Donald Trump's North Korea policy, warning that the Asian country posed an "imminent"

threat. "The risk to US forces & our allies is imminent & more effective policy is required before NK has the technology to threaten the American homeland," tweeted Bolton, who was dismissed in September amid growing disagreements with Trump, particularly regarding his North Korea policy.

The erstwhile advisor, a longtime hawk on North Korea, was openly skeptical of the 2018 summit between Trump and North Korean leader Kim Jong Un, and encouraged the US president to be cautious.

The denuclearization process has been largely deadlocked since the collapse of a second summit in Hanoi at the start of this year. North Korea promised an ominous "Christmas gift" earlier this month if Washington does not give ground by the end of December.

In an interview with news site Axios published Monday, Bolton also said he thinks the Trump administration does not really intend to stop Pyongyang from becoming a legitimate nuclear power capable of firing missiles at other countries, otherwise "it would be pursuing a different course."

CHECKING VEHICLE OVERLOADING

Guidelines yet to be implemented

With overloading causing huge damages to roads and bridges, Roads and Highways Department (RHD) is not sure when it will be able to control axle load following approved guideline and international standards.

Speaking at a public hearing, RHD officials said the government in November 2017 increased the maximum weight limit for goodsladen vehicles for an "interim period" but they do not know when they will start following the original guideline.

overloading, officials including its Chief Engineer Mohammad Jawed Alam faced questions related to poor development project proposals (DPPs), dues of contractors and

RHD organised the hearing at its headquarters in Tejgaon as part of its implementation of National Integrity Strategy.

In May 2005, the then communication ministry (now road transport and bridges ministry) through a gazette notification had set a maximum permissible axle load limit for vehicles for the first

It fixed 13 to 15 tonnes for two axles, 22 to 25 tonnes for three axles, 25 to 33 tonnes for four axles and 35 to 38 tonnes for five axles, which were consistent with international standards.

In June 2012, the ministry prepared a guideline on Axle Load Control Centre.

In August 2016, the authorities of RHD, said the "interim decision"

tried to impose fines for overloading was taken following "consensus owners and workers damaged weighbridges in Manikganj and Chattogram on the very first day of their protest.

The government increased the maximum weight limit through a November 2017 order, which states that two-axle vehicle can carry maximum 22 tonnes, three-axle maximum 30 tonnes and four-axle maximum 40 tonnes.

Out of the three axle control centres, two are now in operation. Only five percent overloading can reduce road longevity by 18 percent, said an expert.

Yesterday, Md Amanullah, superintending engineer (administration and establishment)

under the guideline, but transport of all stakeholders" including transport leaders.

"It was decided that the rate would be reduced after further consultation and finally the guideline would be followed," he said, adding, "Although it [the decision] cannot be termed scientific, it was taken following discussion.

Asked when they will be able to follow the original guideline, Amanullah said a project has been taken to install 21 weighbridges on major highways to check overloading.

"Once those are set up within one and a half years, we hope the [road transport and bridges] ministry and other stakeholders will take the decision," he said.

5.5 lakh migrant workers deported in last 10 years

Hotline service for them formally launched

Nearly 5.5 lakh Bangladeshi migrant workers were deported from different countries in the last 10 years, Shariful Hasan, head of Brac Migration Programme, said at a workshop yesterday.

Almost all of these migrant workers had become undocumented in those countries and travel passes were required for their return, he added.

He said the data was prepared based on statistics maintained by Prabashi Kalyan Desk -- set up at airports by Wage Earners Welfare Board -- and other government agencies, as accurate data on returning migrant workers is not available.

Shariful said in most cases, migrant workers returned because their visas expired and due to lack of job opportunities, physical and mental abuse, not getting promised job, illness, employing companies shutting down or going bankrupt, and failing to adapt to new environment.

"If we want to make their reintegration in society sustainable, we have to focus on their mental health and the skills that they have accumulated," he said.

Brac Migration Programme and International Organization for Migration (IOM) Bangladesh held the workshop as part of a project called "Prottasha" at Brac Centre Inn in the capital.

Addressing the programme, IOM Bangladesh official Phineas Jasi said reintegration is an integral part of migration cycle and essential element for migrants returning to Bangladesh after years of absence from their families and society.

Ahmed Munirus Saleheen, additional secretary to Expatriates' Welfare Ministry, said the government with help from IOM Bangladesh is preparing a database on returning migrant workers.

It will enable the government to provide better services to the returnees, he said, adding that they now have data on migrant workers going abroad.

"We don't have information on how many of them returned," he added.

Under the "Prottasha" project, a hotline service for migrant workers was launched at the programme.

Migrant workers will be able to get information by dialing +08000102030 (toll free) and +09610102030 (long code) from 7am to 11pm every day.

The "Prottasha" project is led by the government. IOM Bangladesh is implementing it in partnership with Brac, funded by the European Union.

Indian govt trying to divert attention from economic crisis: Prof Serajul on NRC

The Citizenship Amendment Act (CAA) and the National Register of Citizens (NRC) are not just India's "internal issue" any more, and Bangladesh government should take a clear stance regarding them, speakers at a discussion said yesterday.

The developing "crisis" in India could badly affect Bangladesh like the Rohingya issue of Myanmar did. Considering this, Bangladesh should take precautionary measures, they said at the roundtable at Dhaka Reporter's Unity.

Ganosamhati Andolon, a left-leaning political party, organised the event titled "CAA and NRC in India: Impact on South Asia and what Bangladesh can do".

"[Bangladesh] government has been saying it [CAA and NRC] is India's internal

issue; this is objectionable. It is a global problem," Dhaka University Professor Emeritus Serajul Islam Choudhury said. "If the neighbour's house catches fire, ours will too at some point," he added.

Explaining the strike on the multicultural character of Indian subcontinent through the partition in 1947 under British rule, he said, "India is turning into a jail for

He also said, "India is going through an 'extreme economic crisis' and the [Indian] government is trying to divert people's attention from it.

Terming Indian Prime Minister Narendra Modi "second Hitler", Gonoshasthaya Kendra founder Dr Zafrullah Chowdhury predicted that the NRC issue could spark the third world war.

Amend law to stop 'punishment' at schools: speakers

Bangladesh Legal Aid and Services Trust (BLAST) yesterday demanded an amendment to the Children Act, 2013, incorporating a provision to protect children from physical and mental torture they face -- especially in educational institutions -- in the name of punishment.

"Due to an ambiguity in section 70 of the exiting act, taking legal action against culprits involved in physical and mental torture on children are being obstructed in most cases," claimed advocate Tajul Islam, daviser of advocacy and capacity building of BLAST.

He was presenting a keynote on "Legal protection initiative to end physical and mental torture on children", at a viewsexchange meeting at The Daily Star Centre.

Arguing the importance of the amendment to the act, Tajul said 54 countries in the world have already introduced laws or amended their respective children's acts to end mental or physical torture.

"In 2015, the United Nations' Committee on the Rights of the Child recommended

Bangladesh to enact laws to stop physical and mental torture on children in the name of punishment," he added.

In his speech, lawmaker Israfil Alam said many children in remote parts of the country are still being physically or mentally tortured by their parents and teachers.

"Various programmes should be taken

to raise awareness among guardians and teachers, aside from laws, to stop such torture," Israfil, also a member of parliamentary caucus for child rights, recommended.

Priorities should be given to protect children's rights if the government wants to fulfil SDGs, he added.

'Money and muscle cannot be route to elective office'

Says Prof Rehman Sobhan

Centre for Policy Dialogue Chairman Prof Rehman Sobhan yesterday said in an oppositionfree political landscape -- where the government is exposed to little accountability, the quality of governance tends to deteriorate.

"A free media and strong civil society could partially compensate for a weak political opposition," the eminent economist said while delivering a lecture on "Sustaining democracy in Bangladesh: The political legacy of Tajuddin Ahmad," in the capital.

Asiatic Society of Bangladesh organised the

"A democratic order, which is responsive to the needs of our people over the next half century, would need to ensure that it would be truly representative of all the people," said Rehman Sobhan, a member of the first Planning Commission in Bangladesh.

"We would need to ensure that money and muscle power would no longer serve as the most effective route to elective office," he added.

"We would, at the same time, need to make provisions for ensuring that candidates from similar social backgrounds as Bangabandhu [Sheikh Mujibur Rahman] and Tajuddin, with modest

means, who commanded public respect and were incorruptible, are provided with opportunities to enter the parliament," he said. He also said it should be ensured that the

executive remains fully accountable to such a parliament. The parliament is, however, only one pillar of democratic process, Prof Sobhan said, adding, "We

would need to restore freedom of the media, not just by permitting a proliferation of outlets, but by providing them with freedom to express themselves on all issues without fear of intimidation, legal harassment or incarceration.'

He also said civil society organisations should be strengthened and encouraged to express themselves on public issues, once again without fear of harassment or abuse.

Rehman Sobhan said Tajudddin, the first prime minister of Bangladesh, was an unsung hero of Bangladesh's history, who used to practice politics for the interests of people.

Tajuddin was by temperament a worker and an activist; his political intelligence, commitment and organisational skills were exceptional but he never aspired to use those to seek elevation to the highest rank of public office, said Prof Sobhan,

The mobile court, led by executive magistrates Md Abdul Hamid Miah and Mir Nahid Ahsan, also pulled down illegal billboards from road medians at Gulshan-1 and Gulshan-2.

"All development work will have to be done in a compliant manner, otherwise no one will be spared from punishment," said DNCC mayor Atiqul Islam while inaugurating the drive against air pollution at Niketan.

He said many people consider themselves "powerful enough" to do anything they wish, and do not follow rules. "They will have to understand that no one is more powerful than the government," he added.

It is not acceptable that anyone will come and set up billboards, festoons, banners on footpaths, medians or electric poles, the mayor said. There is a provision of taking permission from city corporation

before doing these, and anyone wishing to do so will have to follow the law, he said.

"We are only removing the illegal billboards this time, but we will take legal action against the offenders if anyone does it again," the mayor said.

Atiqul also distributed leaflets to locals to raise awareness about air pollution. The drive comes at a time when residents

of Dhaka city have been facing severe air pollution. Since the beginning of winter, air pollution levels in Dhaka have turned severe mainly due to brick kilns, vehicles

The chief engineer said the way they are proceeding, overloading will be controlled soon.

Asked about poor DPP that often escalate project cost and time, he said there are several agencies involved in mega projects. Land acquisition, service line relocation and some other works, which are not in RHD's control, are often responsible for the delay and that ultimately escalate cost, he added.

Chandan Kumar Basak, an additional chief engineer of RHD, said the Planning Commission asked them to prepare a three-year project, where foreign investment is also involved

During the conference, smuggling of drugs, alcohol, firearms and ammunition into Bangladesh from India, and border management will also be on the agenda.

Information centring different narcotics,

including Phensedyl factories and storehouses in India, and their smugglers will be shared at the conference.

Illegal trespassing of border by BSF, issues regarding Indian nationals and Myanmar citizens will also be discussed, said the BGB release, signed by its Public Relation Officer Md Shariful Islam.

The BGB DG is likely to meet with India's Home Affairs Minister Amit Shah during the programme. The conference will end formally through signing of a "joint record of discussions" by the two sides on December 29.

GAS SUPPLY TO RANGPUR

Pipeline installation work to start next month

Our Correspondent, Dinajpur

Installation of pipeline to supply gas to Rangpur will start from January next year with an aim to explore the industrial sector in the region.

The around Tk 1,800 crore project is expected to be completed in June 2022.

During her visit in 2011, Prime Minister Sheikh Hasina pledged to ensure gas supply to the division through pipeline -- a long standing demand of residents.

Shailaja Nanda Basak, deputy general manager (planning) of Pashchimanchal (western) Gas Company Limited (PGCL), revealed the information at a meeting with industrialists of the region on Monday afternoon at the office of Rangpur Chamber of Commerce and Industry (RCCI).

PGCL is a concern of state-run Petrobangla.

He said the work will start from Bogura then to Rangpur and surrounding areas of Pirganj and Nilphamari.

A supply network will also be built by Gas Transmission Company Limited (GTCL) in consultation with Investment Facilitation Company (IFC).

Mostafa Hossain Ripan, acting president of RCCI, presided over the meeting. He said gas is the prerequisite for promoting

In their speech, industrialists thanked the prime minister for the initiative and said many potential industrialists have purchased plots on both side of Dinajpur-Rangpur Highway in last couple of years to set up factories. But they could not do so for not having gas supply, they added.

They also urged the government to extend the pipeline up to the proposed economic zone in Mohipur (around 1,000 acres) of Gangachhara upazila of Dinajpur.

The deputy general manager said they are assessing the number of functional and potential industries, and the amount of gas needed in this regard.

10 to die for murder of M'singh pharmacy owner

A Dhaka court yesterday sentenced 10 people to death for killing pharmacy owner Mazharul Islam Paltan in Mymensingh's Nandail 12 years ago.

Judge Abu Zafar Md Kamruzzaman of Speedy Trial Tribunal-1 in Dhaka announced the judgement.

The court also acquitted seven accused from the charges, as their involvement in the crime was not proved.

Of the 10 convicts, Eklash Uddin, Abul Kashem Fakir, Kabir Miah, Abul Kashem, Abul Kalam Azad, Chandan, Shukkur Ali and Badal Miah are behind bars, while Faruk Miah and Ruma Akhter are absconding.

According to case documents, drug store owner Mazharul Islam Paltan was killed inside his shop at Shialdhara Bazar in Mymensingh at some point between February 28 and March 1, 2007.

Beauty Akhter, younger sister of Paltan, filed a murder case against unknown persons with Nandail Police Station on March 1 that year.

Police submitted the charge sheet to the court against 18 people in July 2008. As accused Jabbar Mohari died during the proceedings, his name was dropped from

Thirty prosecution witnesses gave their statements before the court.

Two accused -- Ruma Akhter and Faruk Miah -- gave confessional statements to the court, but later went into hiding after securing bail, said Special Public Prosecutor Abu Abdullah Bhuiyan.

According to the statements, Ruma, a sex worker, engaged in sexual activities with the accused in Paltan's shop on night of the

But when they refused to pay Ruma for her services, she started putting pressure on Paltan for the money, he said.

At one stage, an altercation broke out between Paltan and Ruma when he [Paltan] refused to pay. The accused got involved later and beat Paltan to death, the SPP added.

Meanwhile, the prosecution also expressed satisfaction with the judgement.

However, Sanaul Alam Rifat, younger brother of convict Kabir Miah, told The Daily Star that his brother was not involved with the incident.

"We did not get the justice in the case,"

Advocate Muhibbur Rahman Mahboob, a defence lawyer, said that they would appeal to the higher court against the judgement.

Last trace of Ritwik Ghatak in Rajshahi being erased

Authorities of a homeopathic college are gradually demolishing the ancestral home of internationally renowned filmmaker Ritwik Ghatak in Rajshahi city's Miapara area, sparking protests from social and cultural activists across the country.

Several hundred locals under the banner of Ritwik Ghatak Film Society formed a human chain at Shaheb Bazar Zero Point in the city yesterday afternoon, demanding immediate protection of the property bearing the filmmaker's memories.

They called for declaring it a heritage site and establishing a memorial museum on the premises as done with legendary actress Suchitra Sen's ancestral house in Pabna.

They submitted memorandums to the deputy commissioner of Rajshahi, city Mayor AHM Khairuzzman Liton, lawmaker Fazle Hossain Badsha and Cultural Affairs Minister KM Khalid highlighting their demands.

However, the authorities of Rajshahi Homeopathic College and Hospital denied that they are demolishing Ritwik's house.

"The construction materials we found during demolition are modern, but Ritwik lived in Rajshahi in the 1930s or '40s," Anisur Rahman, principal of the college, said. During a visit to the site yesterday

afternoon, this correspondent saw that the college authorities had already demolished part of the one-storey house and erected a boundary wall in the western side of the site.

The principal said the demolition started as the institute's governing body -- headed by the deputy commissioner of Rajshahi -decided to build a garage for vehicles there.

He said the property belongs to the college and the authorities needed to demolish the old structure -- making way for new classrooms and academic buildings

"We couldn't demolish all parts of the building due to financial constraints," the principal said. He said the college was set up at the site on 34-decimal land in 1966.

In 1989, the Ershad government handed over the land -- classified as "enemy property" -- to the college. In 2006, the authorities demolished the northern part of the old building and erected a two-storey building. On the south and eastern part of the site,

the old building still survives.

"The surviving part of the building bears memories of Ritwik Ghatak," Ahsan Kabir Liton, president of Rajshahi Film Society, said.

He said the college authorities destroyed most of Ritwik's ancestral house over the last decade and nothing was done to stop this. Born in Dhaka on November 4, 1925,

Ritwik had to move to Rajshahi as his father Suresh Chandra Ghatak -- a district magistrate, poet and playwright -- was transferred to the city.

Ritwik's father owned the building. Formative years of the filmmaker's life were spent at the house, as he studied at Rajshahi Collegiate School. During his stay in the city, Ritwik edited a magazine called "Avidhara"

He took part in meetings and cultural gatherings with litterateur Sarat Chandra Chattopadhyay at the premises of Miapara Public Library, adjacent to the house.

Renowned fiction writer Mahasweta Devi -- Ritwik's niece -- also stayed at the house, Mahmud Islam Masud, general secretary of Ritwik Ghatak Film Society, said. "On different occasions, we invited Ritwik's sister Protiti Devi and Mahasweta Devi to Rajshahi and they fondly recalled their memories of living in the house," he said.

During the 1947 partition, Ritwik had to migrate to India with his family and the authorities later declared his ancestral home "enemy property" [now vested property].

Yesterday, Md Shariful Haque, additional deputy commissioner of Rajshahi, told journalists that they have instructed the college authorities to stop the work for now. "We'll take a decision in this regard soon."

'Elimination of Inequalities in Sanitation' workshop held in port city

Many schools and colleges in Chattogram don't have female friendly toilets and sanitation facilities. This forces female students to miss classes during their menstruation period, as they don't want to use unhygienic toilets, speakers said at a programme yesterday.

They were speaking at a workshop titled "Elimination of Inequalities in Sanitation" held at the Department of Public Health Engineering (DPHE), Chattogram organised by Dushtha Shasthya Kendra (DSK).

The speakers emphasised the need to set up female friendly toilets in all educational institutions across the port city.

Sumon Roy, executive engineer of DPHE, Chattogram, said, "It is the responsibility of DPHE

to establish toilets in all primary schools of the country located outside city corporations," adding, 'We will ensure water sanitation and hygiene in all primary schools of the country by the next five

He aligned the workshop's theme with the Sustainable Development Goals (SDG), saying "ensuring clean water and sanitation is a key focus of the SDGs."

However, government organisations cannot achieve this goal alone, he added, urging social and non-government organisations to come forward and play a vital role.

Is Trump choking off free trade and decimating WTO?



NO recent trade pacts one between the US and China, and the other among US, Mexico and Canada—have given the economists plenty of reasons to worry. Both of these treaties are meant to promote trade between the

signatory countries and accelerate economic growth in each but they have two major flaws. First, they were negotiated under very "surreal" circumstances which I will explain in a moment. Second, the trade pacts have been drawn up to appease the current US administration and to bolster Trump's election chances. Both pacts also deal a crippling blow to the notion of free trade and signal a further diminished role for World Trade Organization (WTO).

The trade negotiations between the US and its trading partners were being carried out in somewhat extraordinary or unconventional circumstances. US negotiators have an upper hand in both of these parleys because of the sheer economic, political, and military power that the US can, and sometimes does, bring to bear on the other parties. In the theory of international trade, the role of leverage or "force" is never explicitly fully factored in. As we all know, the gains from free trade are mostly discussed in the context of a small country, or trade agreements are conducted by parties of equal size. However, in the case of US-China trade talks, the former has been open about its ability to strike first and impose incrementally higher rates of tariffs on imports of Chinese goods and these could potentially harm Chinese manufacturing and technology sectors.

The just-concluded trade agreement among three big North American countries—the United States, Mexico, and Canada—will

now replace the North American Free Trade Agreement (NAFTA). As the name NAFTA implies, the trade agreement went into effect in 1994 and was designed to remove tariff barriers among the three countries. According to the International Monetary Fund (IMF), trade among the three NAFTA countries more than tripled between 1993 and 2007.

During his election campaign, President Trump promised to renegotiate it, and the new agreement to replace NAFTA will be named United States-Mexico-Canada Agreement (USMCA). In an announcement on its website, the office of the US Trade Representative (USTR), which is responsible for all trade negotiations with foreign countries, claims that USMCA will "support mutually beneficial trade leading to freer markets, fairer trade, and robust economic growth in North America." However, in the very next paragraph, it does not hesitate to imply that some of the provisions will provide support for American jobs.

It is well-known that the intense bargaining leading up to the new treaty was weighted in favour of the US, the party with more clout. It focused largely on auto exports, steel and aluminium tariffs, and the dairy, egg and poultry markets. It gives the United States more access to Canada's dairy market, imposes a quota for Canadian and Mexican automotive production, and increases the duty-free limit for Canadians who buy US goods online from USD 20 to USD 150.

The agreement also provides updated intellectual property protections in line with the promises made by President Trump during the last election campaign. One provision of USMCA "prevents any party from passing laws that restrict the cross-border flow of data." Jim Balsillie, co-founder of Research In Motion (RIM), the company that created BlackBerry phones, was openly critical of the data and IP provisions of USMCA. In an oped in 2018 in the Toronto Star, he lambasted the Canadian policymakers and negotiators

for their "colonial supplicant attitude" towards the US

US Senator Pat Toomey, a Republican, said that USMCA "is the only trade pact ever meant to diminish trade", and labelled it "protectionist". He was aghast that the US will pay Mexico up to USD 45 million a year to enforce Mexican labour laws, under the penalty of raised tariffs and embargoes. "I still believe that free trade is far better for my constituents than restrictive, managed trade, and hope USMCA's protectionism doesn't become the template for future trade agreements," Toomey added.

The details of the Phase I agreement with China still remain under wraps. There is uncertainty about the actual provisions and the possible impact on individual products. The US cancelled a planned increase of tariffs on USD 156 billion of goods that it imports annually from China including smart phones,

toys and consumer electronics. In addition, the US will reduce tariffs by 50 percent on USD 120 billion of goods that were affected by increased tariffs on September 1. These will go down from 15 percent to 7.5 percent. However, US tariffs of 25 percent will remain on USD 250 billion of imports from China on diverse products including machinery, electronics, and furniture.

In return, China agreed to increase imports of American agricultural products by USD 32 billion over the next two years, and this could total USD 50 billion. Total imports from the US would be boosted by USD 200 billion during the same period.

In spite of these potential gains by its agriculture and manufacturing industries, diverse segments in the USA have voiced their concerns. Robert B Zoellick, former president of the World Bank and former USTR under George W Bush, has come out with a scathing editorial in the Wall Street Journal against the US negotiating strategy.

The American farmers were hit hard by the trade war as China raised tariffs on imports of soybean and pork. However, the farm lobby has voiced scepticism about the end result of Phase I. "They need US pork, they need US soybeans. Do they need USD 50 billion of agricultural goods? Absolutely not," according to Dave Marshall, a farm-marketing adviser with First Choice Commodities.

The bottom line is: "investors are still grappling with the winners and losers from trade policy shifts heading into 2020." There is considerable uncertainty about the next steps in the US-China trade spat.


How do all these affect the WTO and its trade court? "President Trump drew concessions from Mexico and China last week while stripping the World Trade Organization of its powers to restrain the tactics he used to secure them, in a series of moves reshaping long-time US trade policy," according to Jacob Schlesinger, a respected journalist of the WSJ Washington team. The US had blocked the appointment of new nominees to the WTO Appellate Body which no longer has the minimum of three judges required to issue decisions and enforce WTO

In these uncertain times, for the smaller countries which are waiting to see the outcome of the realignment of the global trade map, and the future of unfettered trade, the moral of the story is not very encouraging. Powerful countries can challenge and rewrite the tenets of established practices. One powerful or whimsical ruler can redefine the rules of the game. It is good to be a small country as long as you can escape the wrath of the establishment ensconced in Washington. Who will the US target next? Germany? India? Or Bangladesh?

BJP's Defeat in Jharkhand

Jharkhand message may resonate across India



OME vears ago, Bharatiya Janata Party (BJP) had boasted of a "Congressmukt" Bharat. It was the result of the party's victory in a series of assembly elections across India since Prime Minister Narendra

Modi came to power for the first time more than five years ago. That was the time of unprecedented political ascendancy for the BJP in terms of winning elections. The party had earned a formidable reputation for possessing a seemingly unbeatable electionwinning machine.

But politics, particularly electoral politics, could often be a highly unpredictable and slippery path. Came 2018, just a year before the last national election, and the BJP ended up losing power in three heartland states—Rajasthan, Madhya Pradesh and Chhattisgarh—in one go, after having ruled those states. However, overcoming those defeats, the BJP scored a spectacular triumph in the Lok Sabha polls in April-May this year, securing a greater majority than in 2014. One of the key factors in the BJP's victory in national polls was its near-sweep in the same three heartland states just a few months after losing power there. Look at Jharkhand. Just seven months ago, the BJP won 11 of the 14 Lok Sabha seats. It is now out of power in the same state, once again underlining the dictum "politics thy name is frailty".

Just seven months after winning the Lok Sabha election mandate, the BJP now finds itself out of power in Maharashtra, India's richest state, in the west. It just about managed to rope in the support of a regional party to retain power in Haryana in the north, and was unseated in Jharkhand, one of India's most mineral-rich states, in the east. Senior Congress leader P Chidambaram said this about BJP after the Jharkhand poll result: "dented in Haryana, denied in Maĥarashtra and defeated in Jharkhand." Many view this as Congress' pushback at the "Congress-mukt Bharat" phrase.

The setback in Jharkhand means that half of the huge Hindi heartland has slipped out of BJP's control. The party is now in power in two big states, Uttar Pradesh and Bihar, and the small states of Uttarakhand, Haryana and Himachal Pradesh in the Hindi-speaking belt. assembly elections are held in February next year? The BJP surely faces an uphill task.

The BJP's defeat in Jharkhand throws up two significant lessons besides the familiar one of anti-incumbency. First, the stability

provided by the party's government under non-tribal Chief Minister Raghubar Daswhich survived a full five-year term in a predominantly tribal state that had earned the notoriety of chief ministers changing quicker than seasons due to the quicksand of shifting political loyalty—did not cut ice with the electorate. Secondly, playing up the polarising narrative to cover up anti-incumbency and governance deficit may have run its course and is less likely to find traction among voters over a time. The results of Maharashtra, Haryana and Jharkhand assembly elections are likely to reinforce the view among anti-BJP forces that bread-and-butter issues can actually neutralise the impact of polarising planks, and that the BJP may not have succeeded in delinking politics from economics, as suggested by some

The BJP had begun the Jharkhand poll campaign on the development narrative but shifted almost midway to the sensitive issues of Citizenship Amendment Bill (CAB), National Register of Citizens (NRC), abrogation of the special status for Jammu and Kashmir and the Supreme Court order on the Ram temple in Ayodhya. The last two phases of the five-phased polling in Jharkhand were held in the midst of pan-India protests against the new citizenship act and NRC. The Jharkhand poll was also the first state-level electoral exercise after the apex court judgement on the Ayodhya issue. What is more interesting is that Jharkhand is a state with an overwhelmingly non-Muslim population. Most of India's incidents of lynching of persons on suspicion of being cattle smugglers took place in Jharkhand.

By contrast, the opposition Jharkhand Mukti Morcha-Congress-Rashtriya Janata Dal alliance adopted the strategy of confining their plank to governance and state-specific issues to tap into people's anger over breadand-butter issues like economic slowdown, joblessness, agrarian distress and land ownership rights of tribals in Chhota Nagpur and Santhal Parganas areas of Jharkhand. The Raghubar Das government passing the Chhota Nagpur Tenancy and Santhal Parganas Tenancy laws to acquire land from tribals was used to the hilt by the opposition to paint the BJP as anti-tribal, and it led to a huge consolidation of tribal votes against the BJP. The recent election result reflected so tellingly the BJP's alienation from tribals: the JMM and the Congress won 25 of the 28 assembly seats reserved for tribals. So strong was the anti-incumbency that Das himself lost the election in Jamshedpur East constituency to his senior BJP rebel Saryu Roy, and his party's state unit chief and the assembly speaker also bit the dust.

Like post-election in Maharashtra, the Jharkhand result once again showed

the BJP's inability to retain its allies. The squabble in Maharashtra saw the BJP's oldest Hindutva ally, the Shiv Sena, parting ways and doing what was previously thought unthinkable: aligning with the Congress and the Nationalist Congress Party to form government. And a feud over seat-sharing in Jharkhand saw the BJP and its long-standing partner All Jharkhand Students Union (AJSU) breaking the alliance and contesting the poll separately. The BJP-AJSU break-up in Jharkhand cost both dearly, more the BJP which lost several seats by margins due to an important tribal and regional ally proved too powerful for the BJP to take on the JMM-Congress alliance. The Congress displayed its readiness to tie up with the JMM, the most dominant tribal party, as a junior alliance partner and benefitted from it. The AJSU has a sub-caste of Other Backward Caste Kurmis who have a significant presence in Jharkhand and their alienation also cost the BJP's OBC

The Jharkhand mandate is likely to have implications beyond the state's borders. The snapping of ties between the BJP and the AJSU may have a compounding effect in adjacent Bihar where Janata Dal(U) is the BJP's partner in the ruling coalition headed by Chief Minister Nitish Kumar, who is a Kurmi by caste. In Jharkhand, the Janata Dal(U) failed to win a single seat.

The Jharkhand poll outcome has endorsed 44-year-old Hemant Soren, the JMM's Working President, as not only the inheritor of his father Shibu Soren's legacy as the foremost tribal leader of the state but also expressly manifested the electorate's backing for a tribal at the helm of the state's affairs, rejecting the BJP's gamble of propping up a non-tribal leader Raghubar Das as Chief Minister for the first time.

Indonesia bus tragedy kills 27

At least 27 people have died and more than a dozen were injured after a bus plunged into a ravine in Indonesia, officials said yesterday. The bus careered into a 150-metre ravine in South Sumatra province just before midnight on Monday and ended up in a river. According to a passenger manifest, the regional bus left Bengkulu province for Pagar Alam with 27 on board but some survivors told police there were around 50 people inside when the accident happened.

Pakistan to rejoin **US military training**

The United States will allow Pakistan to rejoin a military training program suspended two years ago when President Donald Trump froze security aid to the country. Resuming the program, which represents only a part of the halted aid, is one sign of warming relations between Washington and Islamabad. In January 2018, Trump froze the assistance, saying Pakistan was not doing enough to target bases of the Afghan Taliban and its affiliated Haqqani group.

8 killed in Russian strikes on Idlib

At least eight people, including five children, were killed yesterday in Russian air strikes on a school in northwest Syria sheltering some three million displaced civilians, according to a war monitor. The strikes targeted the village of Jubass near the town of Saraqeb in southern Idlib province, killing civilians sheltering in and near a school. US tracking Santa - and any 'Christmas gift' from N Korea

While the North American Aerospace Defense Command stays alert for any signs of a North Korea missile launch - what officials in Pyongyang have described as a "Christmas gift" - it is also tracking the legendary figure who delivers presents to children across the world, the command said on Monday.

Based in Colorado Springs, Colorado, NORAD is a combined US and Canadian military command whose mission is to issue aerospace and maritime warnings and controls across North America.

For more than six decades, it has also offered real-time animated tracking of Santa Claus, also known as Kris Kringle, as his reindeer-powered sleigh traverses the globe delivering Yuletide gifts to children.

NORAD's Santa tracking website www. noradsanta.org gets nearly 15 million unique visitors from more than 200 countries and territories across the globe.

NORAD in recent years has been tracking North Korean long-range missile tests. Pyongyang warned Washington earlier this month of a possible "Christmas gift". That came after North Korean leader Kim Jong Un gave the United States until the end of the year to propose new concessions in talks over his country's nuclear arsenal and reducing tensions between the two longtime adversaries.

Russia carried out tests Monday to ensure the "security" of its internet infrastructure in case of a foreign cyberattack as part of measures that rights activists worry could also tighten censorship and lead to online isolation.

A controversial law that allows the country to cut internet traffic from international servers came into force in November, but the communications ministry has denied that the government is gearing up to isolate the Russian segment of the internet and said ordinary users would not notice the tests.

The ministry said that the drills are aimed at ensuring the "integrity" of the

"The results of the tests have shown that on the whole both authorities and service providers are ready to effectively react to emerging risks and threats and ensure the reliable work of both the internet and the single telecommunication network," deputy communications minister Alexei Sokolov told reporters.

Apart from testing the safety of the Russian segment of the internet in case of an attack, authorities also tried to ensure the safety of mobile users and whether it was possible to intercept traffic and text messages, Sokolov said.

"The purpose of the task is to ensure the reliable operation of the internet in Russia in any conditions and under any circumstances," he added, referring to the

The law, which Putin signed in May, requires Russian internet providers to install equipment provided by the authorities to enable centralised control of data traffic.

They will also filter content to prevent access to banned websites.

At his annual news conference last week, Putin defended Russia's internet policies, promising that the country was not moving towards closing off the internet."

"A free internet and a sovereign internet are two concepts that aren't mutually exclusive," he said.

WhatsApp wars divide families

With their parents bombarding them on WhatsApp with misinformation and even abuse over their stand on India's new citizenship law, young women are hiding their identities on social media to voice outrage and find alternative families

people, particularly women, have been at the forefront of the ongoing wave of protests over the law, but this can be dangerous in a largely conservative and patriarchal

When Priya takes part in protests, for example, the fear of the riot police -- 25 people have died in the past almost two weeks -- comes second to the terror of her bigoted Hindu father finding out her whereabouts and halting her education

"He just has this hatred of Muslims -- every opportunity he has lost in life, he blames them," says Priya, 20, too scared to give her real name in case her New Delhi family find out.

"I have tried so many times to talk to him. But every conversation we have ends with him threatening to pull me out of college and get me married off," the student tells AFP.

Her story is reflected across India's dining tables, FaceTime chats and WhatsApp family groups in what is turning out to be the biggest challenge to Prime Minister Narendra Modi since he rose to power in 2014.

"My father keeps spamming me on WhatsApp with fake news



and videos -- it's really frustrating,"

She used to hit back with links : to fact-checking websites before his threats to end her education forced THOMSON REUTERS FOUNDATION, Mumbai her to hide her political views from her parents.

Her father, she says, has no idea about her Twitter account, where she uses a handle that shields her identity.

These WhatsApp wars have fectively upended personal effectively personal relationships, says Anshul Tewari, editor-in-chief of Youth Ki Awaaz, crowdsourced news website focussing on India's youth.

"Young people today care enormously about having a voice and being heard," Tewari tells AFP, pointing to the prodemocracy protests in Hong Kong and climate change marches around the world.

But unlike their global counterparts, young Indians have to find ways to express themselves against the backdrop of a culture which places a huge premium on parental authority.

"In many cases, Indian parents feel entitled to decide who their children should love, how they should live and even how they should think," says Tewari.

That sense of control is particularly pronounced when it comes to the lives of young women, he adds.

Like Priya, the Mumbai-based video editor has been actively involved in the demonstrations against the citizenship law, which she calls "a gross violation of human rights".

INDIA'S CITIZENSHIP LAW

100,000 Sri Lankan refugees not eligible

Nearly 100,000 Sri Lankan refugees living in India are not eligible for citizenship under a new law, sparking concerns they may be forced to return to the island nation they fled during a decades-long civil war, many with no homes to return to.

India's Citizenship Amendment Act (CAA) aims to fast-track citizenship for persecuted Hindus, Parsis, Sikhs, Buddhists, Jains and Christians who arrived in India before December 31, 2014, from Muslim-majority Afghanistan, Bangladesh and Pakistan.

The law excludes nearly 100,000 Sri Lankan Tamils, an ethnic minority, who live in India, including about 60,000 in camps in southern Tamil Nadu state, according to the home department.

Most of these refugees are Hindu or Christian, whose forefathers were born in India, said S Velayutham, an advocacy officer at the non-profit Organisation for Eelam Refugees Rehabilitation in the southern city of

"Many were sent by the British as indentured labourers on Sri Lankan tea plantations, and hoped for a better life in India when they came here during the war," he said.

"Some 25,000 children were also born in the camps. They do not know any country but India, but now they may have no choice but to go to Sri Lanka," he told the Thomson Reuters Foundation.

Taliban kill 15 in attack on Afghan security checkpoint

Taliban militants ambushed a government checkpoint in Balkh province in A north, killing at least 15 members of the security forces, local officials said yesterday, the latest in an escalating series of insurgent attacks. Mohammad Yousuf, the district governor of Dawlatabad where the incident took place said, said dozens of Taliban insurgents targeted a checkpoint manned jointly by Afghan soldiers and intelligence agents, killing 15. More than 18 years after US-led forces toppled the hardline Taliban regime, Afghan forces are suffering record casualties with Afghan and US officials warning that the toll is not sustainable.

Nepal detains 122 Chinese for cyber crime, bank fraud

Police in Nepal have detained 122 Chinese men and women in its biggest crackdown on crime by foreigners entering the country on tourist visas, officials said yesterday. The chief of police in the capital Kathmandu said the suspects were rounded up in raids on Monday following information that they were engaged in suspicious activities. The Chinese are suspected of cyber crime and hacking into bank cash machines, the police chief, Uttam Subedi, said. Another senior police officer, Hobindra Bogati, said the Chinese embassy knew about the raids and had supported the detentions. Last week, authorities in the Philippines arrested 342 Chinese workers in a raid on an unlicensed gambling operation.

Queen admits 'bumpy' year in Christmas message



Queen Elizabeth II called 2019 "quite bumpy" in a Christmas message at the end of a chaotic year which saw Britain bitterly divided over its split from the European Union and her scandal-plagued son Prince Andrew withdraw from public life. The year was filled with disappointments for the queen -- a seminal figure in British public life who assumed the throne in 1952 and is beloved by much of the nation. The queen will point to the life of Jesus as an example of how reconciliation can be achieved and "how small steps taken in faith and in hope can overcome long-held differences and deep-seated divisions" in her speech, which will be broadcast on Christmas Day. The remarks were widely interpreted as a reference to the Brexit debate that has torn Britain apart since it voted to leave the EU in a 2016 referendum. SOURCE: AFP

Bethlehem welcomes pilgrims for Christmas celebrations

AFP, Bethlehem

Pilgrims from around the world yesterday gathered in the biblical city of Bethlehem, revered by Christians as the birthplace of Jesus, to celebrate Christmas in the Holy Land.

Palestinians and foreigners began converging on the "little town" in the Israeli-occupied West Bank from early morning, with Christmas Eve festivities taking place in and around the Church of the Nativity.

Tourists queued to visit the grotto inside the church, believed to be the exact site where Jesus was born, with Ola, a Nigerian visitor, saying it was a "special day."

Outside in the winter sun, hundreds watched as Palestinian scouts paraded to the sound of drums.

"I feel really emotional to be here today, it's wonderful," said Germana, an Italian travelling with her husband and two children.

Archbishop Pierbattista Pizzaballa, apostolic administrator of the Latin Patriarch of Jerusalem and the most senior Roman Catholic official in the Middle East, was due to travel from Jerusalem to Bethlehem yesterday

He will lead midnight mass in the Church of the Nativity, with Palestinian president Mahmud Abbas expected to attend.

Bethlehem is close to Jerusalem, but cut off from the holy city by Israel's separation barrier.

The first church was built on the site in the fourth century, though it was replaced after a fire in the sixth century.

This year celebrations were bolstered by the return of a wooden fragment believed to be from the manger of Jesus.

Sent as a gift to Pope Theodore I in 640, the piece had been in Europe for more than 1,300 years before being returned last month, Francesco Patton, chief custodian for the Holy Land, said.

Russia says it is the longest railway bridge in Europe.

Ukraine was unhappy about both the rail link and Putin's presence at the opening.

President Volodymyr Zelensky's representative office for Crimea said in a statement on Facebook that the rail link and Putin's visit to Crimea were "a gross breach by the Russian side of Ukraine's sovereignty and territorial integrity.

It showed "disregard by the Kremlin of the universally recognised principles and norms of international law," the statement said.

a long form. There will be a mobile app for people to upload their details. It's self-declaration. No document is required. No proof is required. No biometric is required. This is already accepted by all the states. All the states have already notified it," Javadekar

"NPR will be used as NRC we have never said, never meant," Javadekar replied when a reporter pointed out that Union Minister Kiren Rijiju in July 2014 told parliament that the "government will create the NRC based on information from the NPR by verifying citizenship". The NPR is a list of "usual residents"

of the country. A "usual resident" is defined for the purpose of NPR as a person who has resided in a local area for the past six months or more or a person who intends to reside in that area for the next six months or more, home ministry officials said.

The data for NPR was last collected in 2010 along with the house-listing phase of Census of India 2011. The data was updated in 2015 by conducting door-to-door survey. The digitisation of the updated information has been completed.

Now it has been decided to update the NPR along with the house-listing

September next year in all the states and federally-ruled territories except Assam, according to the website of the Office of the Registrar General, and Census Commissioner.

Assam has been excluded because the National Register of Citizens (NRC) exercise has already been conducted in the state.

The NPR will be prepared at the local (village/sub-town), sub-district, district, state and national level under provisions of the Citizenship Act 1955 and the Citizenship (Registration of Citizens and issue of National Identity Cards) Rules, 2003. It is mandatory for every usual resident of India to register in the NPR, according to the

The objective of the NPR is to create a comprehensive identity database of every usual resident in the country. The database would contain demographic as well as biometric particulars, officials said.

Meanwhile, Indian authorities yesterday stepped up security and shut down the internet in various places as nationwide protests against citizenship law and NRC were escalating.

An interior ministry official said the government expected all state security officials to be on duty on Christmas phase of Census 2021 during April to Eve and through the holiday week.

In the full verdict, the apex court bench said, "We finally reiterate that the petitioners shall be fully compensated for their loss due to the cancellation of their leases, in accordance with the decision of the High Court Division".

The top court said there is no ambiguity about the notification issued on April 19, 1999, by which, among others, the sea beach from Cox's Bazar to Teknaf, including Jhilanja Mouza, was included in the ECA and that was done to protect the natural and ecological balance of the areas in question.

"However, we hope that in the days

and years to come, the government will adhere to the policy of preservation of the ecological balance and protection of the natural resources of our country not only for our future generations, but also to ensure protection of the environment from degradation and the harmful effects of climate change. Certainly, this much we owe to our progeny.

"It would indeed be a travesty of justice if the petitioners having been deprived of their business opportunities, the plots are leased out to others for the purpose of construction and commercial development," the SC said in the full

Attorney General Mahbubey Alam told The Daily Star yesterday that the SC verdict would play an important role in helping the preservation and protection of the environment.

All the leases of plots in Jhilanja Mouza granted April 19, 1999, must be cancelled, and the structures built in the area must be demolished in line with the SC directive, he added.

On July 22, 2010, the HC declared valid a government decision cancelling leases of 55 plots in the mouza. It delivered the verdict after rejecting 39 writ petitions challenging legality of the government decision.

Buckingham Palace has released little information about the duke's health, saying only that he went in for "observation and treatment in relation to a pre-existing condition".

It stressed that it was a "precautionary measure". The duke was reportedly flown there by helicopter from the royal Sandringham estate in eastern England, where he has been based since retiring from public duties in



Tourists suffer as Kuakata beach turns 'boat landing station'

Separate spot for watercraft demanded as visitors can't walk and bathe with ease

Trawlers, speedboats and other small watercrafts are often kept anchored haphazardly in Kuakata sea beach, much to the nuisance for a large number of tourists in the picturesque area.

Tourists coming from different areas of the country as well as from abroad often walk on the beach and most of them like to take bath in the sea.

But they face disturbance as numerous trawlers, water bikes and speedboats, some of them meant for arranging rides for tourists, are anchored in the water beside the beach. Many small fishing boats are also kept on the beach where tourists are supposed to walk freely.

The situation worsens during the tourism season in winter when larger number of fishermen also go for fishing in the sea.



The unscrupulous anchoring of boats affects around a two-kilometre area on both sides of the Zero Point at Kuakata, said locals and visitors.

A section of traders keep boats in the water to carry tourists from

Kuakata to Fatrarban, a reserve forest about 10 km to the west.

Rakibul Hasan, a tourist from Khulna, said he with his five-member family came to enjoy natural beauty of the Kuakata beach but they are feel disturbed due to

keeping of a large number of boats there. "We cannot walk on the beach and take bath in the water smoothly. Natural beauty of the spot is also affected due to scattering of the boats," he said.

"Sea water is polluted by fuel waste falling from these boats. Wastes from fishing boats including pieces of fishing nets also lie on the beach," said Sabiha Muntasir of Faridpur.

The authorities concerned should arrange a separate station for anchoring of these water vehicles, keeping in view the interest of tourists, said Kamal Maruf, a tourist from Dhaka.

Upazila Kalapara Officer Md Munibur Rahman, also member secretary of Kuakata beach management committee, said, "We have already asked the tourist police to take necessary steps in this regard. We will take required measures to keep the beach neat and clean."

KILLING OF 3 SANTALS IN GAIBANDHA

Court orders further probe by CID

A court in Gobindaganj upazila of Gaibandha on Monday ordered Criminal Investigation Department (CID) to conduct investigation of the case filed over the killing of three Santal people, and torching and looting their houses in Bagda Farm area of Gobindaganj on November 6 in 2016.

Judge Partha Bhadra of Gobindaganj Senior Judicial Magistrate's Court passed the order after accepting a naraji (no-confidence) petition of filed on behalf of Santals on September 4, against the Police Bureau of Investigation's

'Gaibandha PBI in their final charge sheet submitted on July 28 this year dropped the names of 11 main accused of the November 6, 2016 incident," said Advocate Sirajul Islam Babu, one of the lawyers who were present on behalf of the Santal community during the third hearing of the naraji petition on Monday.

"Through our naraji petition we urged the court to include the main accused including former MP Abul Kalam Azad, Abdul Awal, former managing director of Rangpur Sugar Mill, its former general manager Abdul Mazid, Abdul Hannan, former UNO of Gobindaganj, Shubrata Kumar Sarkar, former OC of Gobindaganj Police Station, Mahbubur Rahman, subinspector of DB police, constable Sajjad Hossain and Rezaul Karim Rafik, chairman of Katabari Union Parishad.

"The court accepted our naraji petition and ordered the CID to conduct further investigation in the case that Thomas Hembrom filed on November 26, 2016 against 33 named and 500/600 unknown people who allegedly attacked the Santal Palli, set fire on their makeshift houses, looted their properties and killed three Santal men on November 6, 2016," said Sirajul Islam Babu.

On that day, more than 2,000 Santal and Bangalee families were ousted from the "disputed" Sahebganj-Bagda farmland under Gaibandha's Gobindaganj upazila, where Rangpur

Sugar Mill was established during the Pakistan period.

The eviction took place following a violent clash between the dweller families, mill employees and police.

Three Santal men were killed and 20 others, including nine policemen, injured in the incident.

On behalf of the Santal and Bangalee communities, Thomas Hembrom filed a case with Gobindaganj Police Station against 33 named and 500-600 unnamed accused on November 26, 2016.

But the charge sheet submitted by Gaibandha PBI on July 28 this year dropped the names of 11 prime accused in the case, said Santal leaders, adding that the charge sheet did not include name of any police officials although a video footage of the attack showed their involvement and two cops were suspended in 2017, following a police investigation.

Through our naraji petition we appealed to the court to include the 11 prime accused in the PBI charge sheet, but the court ordered the CID to do further investigation. We are afraid that verdict of the case will now take much longer time," Zafrul Islam Prodhan, secretary of Sahebganj-Bagda farm Bhumi Uddhar Sangram Committee, told The Daily Star after Monday's court order.

Wild elephants kill one

An elderly man was trampled to death by a herd of wild elephants in Bandarban's Naikhyangchhari upazila early yesterday.

The deceased is Siddique Ahmed, 85, of Sonaichhari area. Naikhyangchhari Upazila Nirbahi Officer (UNO) Sadia Afrin Kochi said wild elephants broke into the mud house of Siddique and trampled him to death on the spot around 3:00am.

During the winter every year, elephants from nearby forest often come down in different areas of the upazila in search of food, the UNO added.

Mentionable, two people, including a woman, were killed in separate elephant attacks on Friday and Sunday.

Fog, cold harm Boro seedbeds

S DILIP ROY, Lalmonirhat

Boro seedbeds in many areas of Lalmonirhat district are turning yellowish under the impact of the ongoing cold wave and dense fog.

Farmers are now worried about rise in the production cost as many of them will have to sow seeds again to cultivate the paddy due to damage of seedlings caused by the adverse weather.

Several farmers said they are covering their seedbeds with polythene sheets but it does not help much to prevent the damage due to lack of sunlight.

Lalmonirhat Sadar Upazila Agriculture Officer Enamul Haque said Boro seedbeds in some areas of the district are affected due to severe cold and fog but seedlings won't be damaged if the weather improves shortly.

"We suggest the farmers to water seedbeds at night, cover them with polythene sheets and use proper fertiliser to save seedlings from the harmful effects of cold and fog. Our officials are visiting the fields and sharing views with farmers

on ways to save the seedlings," he said.

Afzal Hossain, 65, a farmer at Sakoya village in Aditmari upazila said cold and fog has caused damaged to two-week-old seedlings on his 25 decimals of land.

"Boro seedlings on many seedbeds here have already turned yellowish due to lack of sunlight for the last few days. It will not be possible for me to cultivate the crop this year if seedlings on my 20 decimals of land are completely damaged," said Nayeb Ali, 55, another farmer of the village.

"If the cold and fog continues for more several days, our Boro seedlings will be badly damaged and we will face seedling crisis during Boro transplantation in January," said Delowar Hossain, 58, a farmer at Rajpur village in a Teesta river basin area of Lalmonirhat Sadar upazila.

The Department of Agriculture Extension in Lalmonirhat has set a target of Boro cultivation on 70,000 hectares of land, including high yielding varieties on 48,000 hectares, in five upazilas of the

Illegal sand trade poses threat to Titas bridge

At a time when the government is conducting drives against river encroachment, an influential sand trader is not only constricting flow of the Titas river in Banchharampur upazila by occupying its bank, but also endangering Sheikh Hasina Titas Setu over the river.

Ignoring the risk posed to the Tk 94-crore bridge that the prime minister herself inaugurated last year, the sand trader, Saidul Islam, has taken up several bridge piers that he is using to make an enclosure where he stockpiles

Moreover, the sand stockpiled in the enclosure is being lifted from the river right below the bridge -- another violation of the law.

Sheikh Hasina Titas Setu, the first Y-shaped bridge in the country, connects three upazilas -- Banchharampur in Brahmanbaria and Muradnagar and Homna in Cumilla. The eyepleasing structure, 771.20 metres in length, has become a popular site to visit among locals and is an alternative route option for travellers going to Chittagong from Dhaka and vice versa. Such an asset of the country is under threat, but the authorities concerned seem to be

indifferent to their duties, alleged many locals. Saidul has been conducting sand trade for year in a similar fashion by occupying the bank of the Titas in Charlohania area under Fardabad union of the same upazila as well, they also said.

While visiting the bridge, this correspondent found a wide area below the bridge, alongside the bridge piers on the south side of the river, filled with sand, while a large number of heavy vehicles including trucks were being loaded with

Workers there said the sand business belongs to Saidul Islam of Charlohania village.

Requesting not to be named, a school teacher from Charlohania village said, "We see activity of hundreds of trucks and power tillers beside the piers every day. Although selling and lifting of sand from the river near the bridge are prohibited, no one came forward to put a stop to the illegal business.'

Boatman Solaiman Mia said the sand enclosure has choked the river's flow below the bridge, causing hindrance to two-way movement of river vessels.

Accidents between vessels are quite frequent in the area since the business sprung up there, he added.

When reached for his comment, Saidul Islam claimed that he pays rent to conduct his sand trade below the bridge. "Not just me, many others in the area are occupying land below the bridge as well as the river bank," he said. Engineer Jahangir Hossain of Local

Government Engineering Department in Banchharampur upazila said he was not aware of any sand trade next to the bridge. "If that's the case, I will take action." Nafisa Naz Neera, assistant commissioner

(land) in the upazila, said she asked land officer in Fardabad union to find out about the allegations of encroachment on the Titas river.

Necessary action would be taken once the allegations of encroachment are found to be true, she added.

Bidyaneer, a school for underprivileged children

Ritu and her classmate Shakila started teaching the poor kids at Gurudayal Government College compound 3 years ago

Three years ago, on November 7, a street child came to Mousumi Ritu seeking alms. Little did the five-year-old now that her approach would melt the heart of Ritu, a master's student at Gurudayal Government College in Kishoreganj town.

Ritu, who was doing BA in Bangla back then, started teaching the kid right away. She used to sit with the girl on the college field after class. Seeing that, her classmate Shakila Ishrat joined in and they both started teaching underprivileged children inside campus.

"We found many children both inside and outside campus who worked in tea-stalls, restaurants and wanted to study, but could not do so because of poverty," recalled Ritu. "We started collecting them and within a month there were 17 children taking lessons from us."

Ritu and Shakila managed a land in Harua Pagla mosque area where they set up their sports ceremonies to make learning joyful for school, Bidyaneer. The number of students rose the children," she said.

we were kidnappers. But nothing could stop us as we took it as our mission to help the destitute children," Ritu told this paper.

But soon they faced financial crisis as the students started asking for education materials.

"I gave a post on Facebook seeking donations. A good soul Tanmoy Sheikh Raj stepped forward and arranged education materials like books, writing pads and bags," said Ritu.

Now Bidyaneer offers classes in two shifts: 3:30am to 10:00am and 3:00pm to 5:00pm, six

There are 170 children in pre-primary and primary sections up to grade four under the supervision of eight teachers, who are mostly university students providing voluntary services, according to Shakila Ishrat.

Three months ago, President of district "People used to give us suspicious looks as if Chhatra League Shafiqul Gani Dhali Limon and his friends constructed a tin-shed building on five-decimal land in Harua where the school activities are currently on.

> But the children have to sit on the floor as the school has no furniture.

"We are getting support from various sectors but still there is no toilet or tube-well in the school. There is no source of drinking water, said Mosharraf Ahmed, a teacher.

Priti Akhter, an orphan who is in the preprimary section, said she wanted to be a doctor to serve poor patients. Another orphan Junaved Hossain of class one expressed his desire to pursue higher education in future.

"It feels wonderful when we hear about these big dreams. They want to be doctors, engineers, police officials and so on," said Shakila.

Chhatra League's Limon said, "This school has motivated us to do more for the society and the poor section of people in particular.

Air of gloom over 100 indigenous families this Christmas

Christmas is the biggest annual festival for about a hundred indigenous families of Khasi and Garo communities that live in Jhimai Punji of Kulaura upazila.

But this year, the event is unlikely to bring any joy to their hearts as they have been living in fear of being evicted from their dwellings since last month.

While visiting the neighbourhood, called punji, headman of the punji Rana Surong said the frightened communities started guarding their properties since November 15.

On that day, at least three members of Khasi community were hospitalised due to serious injuries sustained in an attack while transporting construction materials on a truck for an under-construction church in the punji.

People belonging to Kedarpur Tea Company launched the attack on them while the truck was entering the punji through a gate installed by the firm authorities.

Concealing the fact that both the Khasi and Garo communities had been living on 406 acres of hilly land in the area for over a hundred years, the tea garden authorities leased the area from the government, said the headman. "It's our home. It's where we belong. We don't want to lose it."

Punji resident Dorina Dhar said, "Ever since the attack, we are feeling highly insecure as the tea garden authorities might evict us any moment. We are passing each day in fear and the male members of our families have been standing guard around the punji."

This Christmas will not make any difference to them because she, like many others in the punji, already lost all her savings to cover the expenses of the legal battle over the land ownership, she added.

Father Joseph Gomes, a member of Bangladesh Poribesh Andolon (Bapa) central unit, said without settling the claim of the Khasi and Garo communities over the land, where they had been living for over one hundred years, the government leased out 661.55 acres of land to Kedarpur Tea Company.

In addition to that, Jhimai Tea Garden, an affiliated company of Kedarpur Tea I'm not fully aware of the situation.'

Company, illegally occupied over 200 acres of land that is also home to many Khasis

The tea garden authorities once tried felling 2,096 trees in and around the punji. They are still making attempts to expand

their garden by clearing the woodlands. They have been causing obstructions in the movement of the two communities by making a gate at the main entrance of the punji and sometimes they do not even allow any ambulance through the gate, he alleged.

Flora Bably Talang, general secretary of KUBORAZ (Kulaura, Juri, Barlekha and Rajnagar upazilas), an association of Khasis for development of punjis, said it would be impossible for the communities to survive without the land as many jobless Khasi family's live on betel leaf cultivation on the land.

"If necessary, we will stage mass protests against the eviction plan." She added.

Rebutting the land ownership claim of the Khasis and Garos, Jhimai Tea Garden manager Moniruzzaman said the indigenous people encroached on 371 acres of land, on which the tea garden authorities have lawful occupancy claim.

Claiming that they do not create any obstruction to the indigenous communities while passing through the gate, he said they sometimes restrict use of trucks in the punji to protect properties of the tea garden.

Meanwhile, on December 11, five nongovernment rights organisations, led by Bapa President Sultana Kamal, visited the area.

Sultana Kamal said about 100 indigenous families have been confined to their village as Jhimai Tea Garden authorities seek to expand the garden by illegally occupying the land that belongs to the indigenous communities.

The role of indigenous population in conserving forest, biodiversity and the environment is undeniable and a threat to their existence could easily be defined as a threat to natural forest and the wildlife, she also said.

Contacted, Assistant Commissioner (Land) of Kulaura upazila Nazratun Naveem said, "I joined the office three months ago.




dream of being on so to get this opportunity in my career, it's definitely something that I'm looking forward to.

Big pay rises are in store for players at January's Australian Open with organisers yesterday announcing a 13.6 percent boost in the total purse to Aus\$71 million (US\$49.1 million). The winners of the men's and women's titles at the first Grand Slam of the year will both take home Aus\$4.12 million, only a small increase from a year ago. But players beaten in earlier rounds do much better. Anyone crashing out in round one will receive Aus\$90,000, up 20 percent, while second round players get a 21.9 percent hike to Aus\$128,000. Tournament director Craig Tiley said every round would enjoy double digit percentage increases, bar the finalists. ROHINGYAS USING MOBILES

2.94 lakh SIMs to be blocked

The government is set to block a few lakh mobile connections that are currently being used in Rohingya camps in Cox's Bazar as it ramps up its efforts to crack down on criminal activities by a section of the refugee population.

According to the SIM registration process, Rohingyas cannot get mobile connection, for which a national ID card or passport is needed.

The refugees have neither, and yet as many as 2.94 lakh of the total of 11 lakh of them have managed local SIMs, according to tests by the Bangladesh Telecommunication Regulatory Commission between November 19 and 21 in the camps in Ukhia and Teknaf upazilas.

"Our intelligence agencies have noticed that using these mobile connections some Rohingyas are engaging in lots of criminal activities," Telecom Minister Mustafa Jabbar told The Daily Star on Monday evening.

Earlier in September, the telecom watchdog blocked 3G and 4G services in the camp areas with the view to checking the use of mobile communication applications like WhatsApp, Viber and WeChat by the Rohingyas.

Some of the Rohingyas used the apps to contact people in Myanmar and organise crimes on both sides of the border, said a BTRC official. Later, all services, except voice calls, were blocked in the area to tighten the situation.

Those were preceded by a blanket ban on SIM card sales in the area. A mobile court put five Rohingyas behind bars for setting up shops in Cox's Bazar and selling mobile phones and SIM cards to refugees.

And yet, it appears none of the steps were fully effective in checking the Rohingyas from using mobile services. The tests conducted by the BTRC technical team, which

is comprised of representatives of all mobile operators, last month also found 3G and 4G reception of Banglalink and

SC says; directs govt to cancel land leases in ecologically critical Jhilanja area of Cox's Bazar, compensate leaseholders

Stressing the need for formulating a policy to preserve ecological balance and protect natural resources, the Supreme Court has directed the government to cancel leases of plots in Jhilanja Mouza, an "ecologically critical area (ECA)", in Cox's Bazar and to demolish the structures constructed in the area.

In the full text of a verdict released recently, the apex court also ordered the authorities concerned not to grant any further lease within Jhilanja Mouza or any area which has been classified as an ECA.

The SC, however, asked them to compensate the leaseholders for cancelling their leases and knocking down the structures.

"We, therefore, direct that all leases within Jhilanja Mouza granted after April 19, 1999, be cancelled in the same way as those of the writ petitioners, and any constructions made thereon be demolished. Of course, the leaseholders shall be compensated for their loss due to such cancellation/demolition. We further direct that henceforth no lease shall be granted within Jhilanja Mouza or any area which has been classified as an ecologically critical area," the top court said in the full judgment.

A seven-member bench of the SC's Appellate Division headed by Chief Justice Syed Mahmud Hossain had delivered a short verdict on December 9 last year after dismissing five separate review petitions and a leave to

appeal one filed by some leaseholders against its 2015 verdict. In its 2015 verdict, the SC upheld a High Court judgement that on July 22, 2010, had declared valid a government decision to cancel lease of 55 plots in the mouza.

INDUSTRIAL LOANS BB okays single-digit interest rate

Bangladesh Bank decides to cap the interest rate, a move that would be a boon for manufacturers as their cost of funds would go down. The decision, which aims at making businesses vibrant, comes at a board meeting of the central bank at the Bangladesh Bank headquarters in the capital. Businesspeople welcomed the central bank's initiative,

saying the measure will give a shot in the arm of the industrial sector, giving them respite from the burden of higher interest

But bankers and experts expressed their concern and said it would have a negative impact on the banking sector as lenders will shy away from disbursing loans to the industrial sector due to the lower interest rate.

Putin drives first train across Crimea bridge



President Vladimir Putin on Monday stood in the driver's cabin of a train for the official opening of a railway bridge that links annexed Crimea to southern Russia, with the launch drawing sharp criticism from Ukraine and the EU.

During his ride from Kerch in Crimea in a shortened three-carriage train, Putin also spent time drinking tea with engineers on the 227-billionruble (\$3.6-billion) project.

The rail bridge, which Putin praised as "magnificent," is 19 kilometres (12 miles) long. The bridge for car traffic opened in May last year when the president drove a truck across it.
