## 4th death anniv of Dr Syed Yousuf Hassan

Today is the fourth death anniversary of Dr Syed Yousuf Hassan, an active participant in the Language Movement of 1952.

He was one of the founding members of National Awami Party (NAP-Muzaffar) and was active in the progressive movements of the country during that time.

The Pakistani government had confiscated his passport and had his citizenship cancelled while he was abroad.

He visited China in 1952 to attend the Asia Pacific Peace Conference with Bangabandhu Sheikh Mujibur Rahman and Ataur Rahman among other prominent individuals.

He was honoured by Bangla Academy, Shilpakala Academy and many other organisations for his contributions to the Language Movement, says a press release.

Ariful Islam, a trader from New Market, said business is brisk because of unusually cold weather.

"Our sales have been good over the last few days. We hope to sell warm clothes for another two months," he added.

Jatrabari resident Hasan Mia said he bought clothes for himself and his children from the market.

"We needed warm clothes after the temperature saw a dip. We don't know when the weather will improve," he added.

The demand for seasonal cosmetic items such as petroleum jelly, moisturiser cream, lotion, lip balm and glycerin has also gone up.

Polwel Super Market (an imported apparel business hub in Dhaka), said they were selling only imported high-end clothes.

"The sales increase if there's severe cold. Our sales have been great in the last several days because of the cold wave. It'll increase further if the cold persists," he added.

### ALAMGIR'S INVOLVEMENT

According to the charge-sheet by PBI, Shammi was Alamgir's second wife. He had married Shammi, hiding his first marriage. In 2013, he married Israt Jahan, unbeknownst to Shammi, by providing a false name and address, and would often visit Israt's house -- which he paid for, neglecting his familial duties to Shammi and their two children. At one point, Shammi found out about the secret marriage, and it caused conflicts in their marriage, the charge-sheet says, adding that Alamgir often beat up Shammi. On the evening of June 7, 2017,

Alamgir and Shammi locked into an argument and Shammi was tortured that day.

In his statement, Alamgir's son had also mentioned that his father had married again, and used to abuse his mother. He also mentioned that Alamgir beat up Shammi on the evening of the incident, and injured her nails with a sharp blade. The injury to the nails of the feet are also mentioned in the post-mortem report.

Alamgir, who was arrested after filing of the case, secured bail on June 26 this year, according to a lengthy letter written by Farhad to the chief justice. In the letter, Farhad also alleged that Alamgir's family have been bribing to influence the investigation into the case -- raising apprehension about why Dr Sohel, who conducted the autopsy, was kept in the review committee along with a subordinate.

He also provided documents to support his claim that the original inquest report was tampered with.

### THREATS TO VICTIM'S FAMILY

Farhad filed a general diary (GD) with Kotwali Police Station in the capital on October 27, saying he has been receiving threats from Alamgir and other accused in the case. They have been threatening him over phone to withdraw the case and hand over the children of Shammi -- who are in Farhad's custody in his village home in Mymensingh -- to them, he claimed. Farhad reported that on October 27, Alamgir saw him at the Court House street and charged at him in a threatening manner, and has continued to issue threats. Contacted, Alamgir denied the allegation, and said he did not issue any threats to Farhad.

will be cleaned up soon."

Six surveyors of DSCC, who were involved in the leasing process, were suspended after ACC filed the case, he said.

ACC tasked one of its deputy directors, Hafizul Islam, to prepare charge sheet of the case. The charge sheet, however, was yet to be submitted.

Contacted, Hafizul declined to make any comment over the delay in filing the charge sheet.

"I've heard the market has been demolished," he added. DSCC councilor Sarwar Hasan Alo could not be reached for comments despite repeated attempts.

On August 23, 2015, The Daily Star ran a report titled "Road given to AL men" which highlighted allocation of the road for kitchen market in clear violation of law.

On December 14, 2015 a High Court bench of Justice Farah Mahbub and Justice Kazi Md Ejarul Haque Akondo questioned legality of construction of the kitchen market and asked the authorities concerned of the government to explain why the construction should not be declared illegal.

She will be buried at her family graveyard at Balia Sonapatila village in Thakurgaon Sadar upazila following the third namaz-e-janaza after Asr prayers.
