Two Rab members got shot when criminals opened fire on them during an anti-narcotics drive at a Rohingya camp in Teknaf yesterday.

"A team of Rab went to a Rohingya camp in Nayapara to recover yaba pills. When the team was returning after arresting suspects, criminals opened fire on Rab members from behind," said Rab Director (Legal and Media) Lt Col Sarwar-Bin-Quasem.

Following a tip-off, the team from Rab-15 raided the camp around

## 43 Bangladeshis killed

Earlier in June at another DG-level talks in Dhaka, the then BSF director general Rajni Kant Mishra had termed border killings as "unfortunate deaths" and said the number of such incidents increased.

Border killings have continued for years despite a commitment from top BSF officials that the number of such deaths would be brought to zero. Apart from killings, torture frequently

takes place on the borderline.

During the last week of April, BSF members tortured a Bangladeshi man by pulling out all 10 of his fingernails with pliers after he was caught for "illegal entry".

Such incidents of torture have caught media attention and the BSF has been heavily criticised by human rights

Talking to this newspaper, Mizanur Rahman, former chairman of National Human Rights Commission, termed such incidents "high-handedness of

"...Unfortunately our government is not that vocal about this issue. Our ministers or secretaries always say that they bring up the issue for discussion with their Indian counterpart. But we don't see any improvement.

"Our government will keep on saying that the bilateral relationship with India is better than any time in the past. On the other hand, such border killings

will go on ... It's very unfortunate," he said, adding that now the government should step up its efforts to address the

Talking to The Daily Star earlier, Brad Adams, executive director of Human Rights Watch's Asia Division, had said despite promises by successive Indian governments to end abuses and hold its forces accountable, there appeared to be complete impunity for BSF soldiers.

He mentioned that there has been a renewed push by the Indian government to stop illegal cattle trade at the border since 2014. "However, a duty to prevent cattle smuggling or other illegal activities at the border does not give the BSF a licence to kill," he said.

Since 2000, more than 1,000 Bangladeshi nationals have been killed in border areas, according to rights defenders who described the areas as "killing fields".

Of the killings, the Felani murder caught everyone's attention. The 15-year-old was gunned down by some BSF members on January 7, 2011, when she, along with her father, was returning home from India through Anantapur border along Phulbari upazila of Kurigram.

The photo of Felani's body hanging upside down from barbwire fence sparked outcry and condemnation throughout the country. Nearly nine years on, her family's wait for justice seems far from over.

among the injured. Two photojournalists Habibur Rahman and Sohel Ahmed Sumit of Sarabangla news portal were wounded while covering the incident. During the clash, vehicular movement at the intersection came to a halt.

Of the injured, 22 DLA activists and nine policemen took treatment at Dhaka Medical College Hospital, Inspector Bacchu Miah, in-charge of DMCH police outpost, told The Daily

"Police attacked a peaceful procession that left around 50 leaders and activists injured. Most of them are females," said Abdullah Al Kafee Ratan, coordinator of the DLA.

Abul Hasan, officer-in-charge of Shahbagh Police Station, said they asked the demonstrators not to break the barricade when they reached near the Matsya Bhaban area, but they did not listen.

They [demonstrators] attacked us with the sticks attached to the placards, injuring at least nine policemen," he said, adding that they detained four people from the procession on charges of attacking police.

Asked about the "attack" on the procession, Sazzadur Rahman, deputy commissioner (Ramna division) of the DMP, said the protesters attacked police first with sticks. They also threw brick chunks, leaving the nine policemen

"Police just dispersed the procession to bring the situation under control with a mild baton charge.

### BSCIC estates in a shambles

and ash is piled up here and there. Industry owners said the roads were so bad that truckers do not want to come inside the estate.

Visiting the area, this correspondent found that the drainage system was poor and did not cover the entire BSCIC area. Where there was drainage system, the drains were clogged.

They alleged that the government did not take sufficient care of the infrastructure there.

"There is no good road inside the BSCIC estate, no drainage system. So, when there is a small amount of rain, the whole area is submerged. The estate should also have its own water supply system but it doesn't," Mohan Patwari, owner of Patwari Business Ltd, told The Daily Star.

Patwari added that in the rainy season the situation gets worse as factories get flooded and their operations suspended.

Dinajpur BSCIC officials also acknowledged the problem and said the situation was similar in other BSCIC A report by the Bangladesh Institute

of Development Studies (BIDS),

released earlier this year, sheds light on

the challenges the BSCIC estates have been facing over the years. The BIDS study, conducted between September 2017 and March 2018, is the first such study to identify problems

since BSCIC started its journey in 1957. The report said that except for few BSCIC estates, all face severe waterlogging due to poor maintenance of the existing drainage system.

It also stated that none of the BSCIC estates has boundary walls, a major concern for industry owners and employees who need to protect their equipment and goods. Street lights too are not available in most of the estates, deteriorating security.

a dedicated gas and electricity supply connection and red tape hamper proper functioning of the industrial units.

"Almost all of the estates have an electricity connection while only 57 percent of the estates have a gas supply connection. About 80 percent of the estates have water supply facilities and one estate has CETP [Savar tannery]. In about 37 estates, ETPs [effluent treatment plants] have been established by individual enterprises," the report stated.

It also said around 22 percent of BSCIC industrial plots have remained unutilised years after years. Weaknesses in rules and regulations, problems in the selection process, infrastructure bottlenecks (such as poor gas/ electricity connections) were the key reasons behind the plots not being

The study also found that around 34 percent stakeholders argued that plots in the estates were allocated based on political and other influence. Other factors included a weak

selection process of entrepreneurs for the plots and corruption of BSCIC officials. Some entrepreneurs applied for plots only to resell for profit. Monsur Hossain, senior research fellow and study director of BIDS, said

if the site selection process was better,

the BSCIC estates could have been more

effective. "The low utilisation of BSCIC plots is alarming. The government's decision to set up BSCIC in all the districts is not logical and this type of initiative was not successful even in India and China," he

For example, Khagrachari BSCIC is almost empty, so special incentives could be given to the entrepreneurs to encourage them to utilise those BSCIC plots, he added.

The BIDS report said the plot

The report also said the absence of utilisation rate is the lowest in Barishal division (50 percent) and the highest in Rajshahi division (95 percent).

BSCIC Chairman Mostaque Hassan said there were 496 vacant plots but those would be filled as soon as advertisements had been published to

allot the plots. Jhalakathi, Panchagarh, Sunamganj, Kurigram, Srimangal and some other places there is a crisis of potential entrepreneurs. For example, in Srimangal, there are 80 plots but we got only 10 applications. On the other hand, in Mirsarai, we have got more application than the number of plots,'

said Mostaque Hassan. Regarding the poor facilities, the BSCIC chairman said: "Yes, it is true that in some cases the infrastructure of BSCICs is not good but we are trying to improve the situation.

He also said most of the times plots were allotted fairly.

"But in reality, we found that some industries suffered as they started with bank loans [which they could not repay]. When we take the initiative to cancel the plot allotment, the bank concerned files a case. In that case, we can't do anything until the issue is settled," said Hassan about ailing entrepreneurs whose units are "sick" or have shut down completely.

The BSCIC estates were established in six phases since 1960, the latest phase being completed in 2010.

A total of 1,969 acres were used for establishing 74 estates -- of which 3.6 percent was for administrative and other purposes (mosques/banks/green spaces etc.) and 19 percent was used for roads and drainage system, the study report said. A total of 10,389 plots were

developed and 96.8 percent of them were allotted to entrepreneurs. Our correspondents in Barishal, Kushtia,
