

New platform launched to 'restore democracy'

UNB, Dhaka

"Ganotantra Uddhar Andolon", a new platform of opposition parties, was launched yesterday in the city with an objective to "restore democracy" in the country.

Nagorik Oikya convener Mahmudur Rahman Manna came up with the announcement at a rally in front of Matsya Bhaban, marking the anniversary of the 11th national election.

Leaders of different opposition parties and civil society members took part in the rally, registering their protest against the last general election held on December 30, 2018.

"We have launched a new organisation, Ganotantra Uddhar Andolon. It's not a platform only for Nagorik Oikya, BNP or other parties. Internationally-renowned photographer Shahidul Alam, and Dhaka University professors Asif Nazrul and CR Abrar also joined this programme to restore people's rights," he said.

Manna said they want to wage a strong movement with people of all walks of life to "restore democracy" in the country.

He urged all to continue the movement for the restoration of democracy until it succeeds.

Noted photojournalist and activist Shahidul Alam said the government has stolen the votes of people.

He said he wants to get back that Bangladesh for which people had waged the Liberation War and made supreme sacrifices.

"I think if we take to the streets imbued with the spirit of truth and fairness, we'll get back that Bangladesh. A few people can't snatch Bangladesh from us."

Alam said he dreams of a Bangladesh where people of all walks of life can express their opinions freely.

Jatiya Samajtantrik Dal (JSD) President ASM Abdur Rob said, "Awami League leaders siphoned off crores of taka abroad by indulging in widespread plundering and corruption. We must resist and oust them," he said.

Mentioning that Bangladesh's election system is part of its constitution, Asif Nazrul said making this election system a "laughing stock" is tantamount to an act of treason.

"The government repeatedly assured us of meeting our demands, prompting us to call off protests earlier."

Boniz Uddin Miah, liaison officer of Bangladesh Jute Mills Corporation (BJMC), said in this situation they have nothing to do as the workers are not trusting the jute ministry or

BJMC.

To press home the demands, around 31,000 workers and their family members have been rallying in front of the main gates of their respective mills -- Star, Platinum, Alim, Eastern, Daulatpur, and Khalishpur in Khulna; and Jashore Jute Industries and Carpeting Jute Mill in Jashore -- since December 24.

Lower court lawyers to face MCQ test for practicing at HC

Lawyers enrolled to practice law at lower courts will have to pass a preliminary test, aside from the written and viva voce in order to practice law in the High Court from now on.

Earlier, lower court lawyers had to qualify in only a written and an oral test for practicing law in the High Court Division of the Supreme Court.

Bangladesh Bar Council, a statutory body regulating the country's lawyers, issued a notification to this effect on Sunday saying that the next High Court permission preliminary exam will be administered in Multiple Choice Question (MCQ) format.

"The MCQ examination will be of 100 marks, with a required qualifying score of 50," the notification said, adding that the duration of the exam will be one hour.

Form fill-up of the preliminary (MCQ) examination for permission to practice in the High Court Division will continue from March 1 to March 31, says the notification.

It said, "Advocates (having a valid registration card) who are entitled, under Article 21 (1) and Rule 65A (i) of the Bar Council Order and Rules, 1972, to be permitted to practice in the High Court Division may apply in the prescribed form along with a payment fee of Tk 12,000 and form fee of Tk 1,500 in favour of Bangladesh Bar Council".

Body of 2-yr-old found

Police yesterday recovered the body of a two-year-old girl from the tank of a sanitary latrine at West Sarafbata village in Rangunia upazila of Chattogram, 15 days after she went missing from her grandfather's house. The deceased is Jannatun Asifa, daughter of Jamir Uddin, said police.

Family members said, Jannatun's mother went to visit her father at the village with her two children on December 12. On December 16, the mother went to attend an event with her five-year-old son, leaving Jannatun with her aunt at the house. She went missing that day, her aunt said.

Family members filed a general diary, said Sub-inspector Mahub Hossain of Rangunia Police Station. Yesterday, locals found her body in the tank near the house. Police went to the spot and recovered the body, he said.

"We sent the body to Chattogram Medical College morgue for autopsy," said SI Mahub.

Filing of a case was under process with the police station, he added.

AFM Obaidur no more

Man who rushed Avijit, Bonya to hospital testifies

A Dhaka court yesterday recorded statements by two witnesses in a case filed over the murder of writer-blogger Avijit Roy on February 26, 2015. The defence cross-examined the witnesses.

Prosecution witness Jibon Ahmed, a photojournalist, chronicled his experience of the day before the court of Judge Md Majibur Rahman of the Anti-Terrorism Special Tribunal of Dhaka.

In his statement, Jibon spoke of his role as a photographer of the crime scene and how he rushed Avijit and his wife Rafida Ahmed Bonya to Dhaka Medical College Hospital in critical condition.

Another prosecution witness, Tarifur Rahman, a hawkler, told the court he went to the scene upon hearing of the incident and saw blood stains on the street.

Bonya -- a key prosecution witness -- did not appear before the court yesterday though she was summoned on December 11.

Ten out of 33 prosecution witnesses, including Avijit's father Ajoy Roy, have testified before the tribunal so far.

Four accused -- Mozammel Hossain Saymon, Abu Siddiqi Sohel, Arafat Rahman Siam and Shafiqur Rahman Farabi -- were produced during yesterday's hearing.

Two other accused -- Sayed Mohammad Ziaul Haque alias Maj (sacked) Zia and Akram Hossain Abir -- are on the run.

The court set January 19 for the next hearing.

to increase its budget allocation for the youth sector.

Addressing the seminar, parliamentarian Nahim Razzaq of Awami League said youths have to be proactive and show urgency in achieving targets.

Family and well-wishers bid farewell to Gaibandha-3 MP Yunus Ali Sarker as he was laid down at his family's graveyard in Bhatgram upazila around 4:30pm yesterday.

He was buried near his parents' graves. His final namaz-e-janaza was held earlier at Bhatgram High School grounds, where several thousand people attended.

Before that, two namaz-e-janazas of the lawmaker were held -- one at the south plaza of the National Parliament building in the capital, and another at Rangpur Medical College Hospital premises.

Yunus Ali died on Friday at Bangabandhu Sheikh Mujib Medical University Hospital, after suffering from lungs-related complications.
