He left behind his wife Raihana Bashir; daughter Sonia Bashir; sons Aref Rahman Bashir and Shahed Rahman Bashir; son-in-law Ihtisham Kabir; daughter-in-law Sabah Moyeen; grandson Ihsan Bashir Kabir and granddaughter Siena Bashir Kabir.

All are requested to pray for the salvation of his departed soul.

## Youth stabbed to death in Mohakhali

A youth was stabbed to death in the capital's Mohakhali on Friday night.

The deceased is Rafi Ahmed Shipu (22), a resident of Wireless area.

The incident took place around 9pm in front of “Mohakhali Amtali XI Club” while Shipu and two of his friends were chit-chatting.

Mosabbir Islam Abir, a friend of Shipu, said a local youth named Ananta came and threatened Shipu. Suddenly, he stabbed Shipu, said a witness, wishing not to be named.

Shipu was taken to Metropolitan Hospital where doctors declared him dead.

The deceased’s uncle Ali Azgar Khan said Shipu used to look after his father’s grocery shop in Mohakhali.

The victim’s father filed a murder case against Ananta, aged around 23, with Banani Police Station. Police said they are yet to find any motive behind the killing.

Sub-inspector Ahsan Habib of Banani Police Station, who is investigating the case, said the victim and the accused reside in the same locality and drive is going on to arrest the accused.

Shipu’s body was taken to a local mosque yesterday afternoon.

Protesting his death, locals in the area demonstrated and sought immediate punishment for the killer.

His mother Rina Begum said, “My son was killed for refusing to pay extortion money. I want justice for my son.”

## BLAST AT CTG POLICE BOX

# Similar to attacks on Dhaka cops

The blast inside a traffic police box which injured three persons including two cops in Chattogram’s Sholoshahar Gate-2 area on Friday night resembles multiple attacks that happened in Dhaka last year.

After analysing the evidence collected from the spot, officials of Chattogram Metropolitan Police (CMP) noted that a similar Improvised Explosive Device (IED) went off inside the police box.

However, CMP officials did not confirm whether this was a militant attack.

Additional Commissioner (administration and finance) Amena Begum of CMP said, “We don’t know whether it was a militant attack or not... we will be able to tell [after] investigating the damage.”

“It was a locally made IED that exploded inside the traffic police box and we are looking into who made it,” said Amena Begum while addressing media at her office in CMP headquarters.

“Members of Anti-Terrorism Unit (ATU) from Dhaka visited the spot and they have collected all the

evidence. They have been trying to detect clues,” she added.

Police official Amena Begum also said “Following the blast, CMP issued a high alert to all units. Security in

police stations, outposts and other important government establishments have been beefed up.”

“We suspect there might be more attacks like this and we asked police personnel to stay alert,” the official added.

Seeking anonymity, a bomb expert of CMP told The Daily Star, “The making of these IEDs matches that of the ones found in Dhaka last year. This IED was made with a rocket flare, a GI pipe, ball bearing, battery and circuit.”

“We are also trying to determine whether the bomb was timer-based or remote-controlled,” added the official. Amena Begum further said, “After the explosion, we seized a GI pipe and ball bearings from the spot.”

Additional Deputy Commissioner (ADC) (Operation) Polash Kanti Nath of Counter Terrorism (CI) unit of CMP told this newspaper, “The blast is similar to the attack on policemen in several spots of the capital last year.”

He was referring to multiple attacks in Dhaka which occurred between April-September last year. Counter Terrorism and Transnational Crime

## RU teacher sued over sexually harassing student

The family of a Rajshahi University student has sued an RU teacher on the charge of sexually harassing her.

The case was filed under the Women and Children Repression Prevention Act with Chandrima Police Station on Thursday night, confirmed Officer-in-Charge Sirajum Munir.

The accused -- Dr Md Amirul Momanin Chowdhury -- is a professor at graphics design, crafts and history of art department of the university.

On Wednesday, 13 RU students filed complaints of sexual harassment against him with the university’s sexual harassment prevention cell.

At that time, Prof Laila Arjuman Banu, a member of the cell, had said it was shocking that a dozen of complaints were filed at a time.

The students alleged that the teacher harassed them physically and mentally for a while. “Many knew about it but no one was ready to talk about it. But by now we feel so distressed that we cannot concentrate on academics,” said some of the complaints.

There were allegations of multiple

## 7 ‘Ansar al Islam’ men held in Dhaka, Pabna

Rab claimed to have arrested seven alleged members of banned militant group Ansar al Islam from separate raids in Dhaka and Pabna districts early yesterday.

In Dhaka, a Rab-4 team carried out raids in Ashulia and Dhamrai. They arrested five and seized books and digital content promoting extremism, said Mozammel Haque, commanding officer of Rab-4.

The arrestees are Oliul Islam (23), Moazzim Mia (20), Sabuz Hossain (26), Ariful Haque (20) and Rashida (33).

In a press conference at Rab media centre in the capital, the Rab official claimed the arrestees, during primary interrogation, admitted that they were active members of the outfit.

They were trying to recruit fresh operatives, collect funds and had been propagating militant activities online, he added.

According to Rab, Oliul was arrested in 2019 for his involvement in anti-state activities. He came out on bail after two months and reengaged in militancy. While in prison, he met the other arrestees and continued militant activities through various secret apps and on social media for more than three years, Rab said.

Madrasa teacher Moazzim stepped into militancy through social media a couple of years ago. His task was mainly to collect funds from like-minded people, Rab said.

Sabuz, an employee at a mobile shop in Savar, and RMG worker Ariful got involved in militancy through Moazzim. Sabuz was admin of a messaging group that propagated militancy and extremism, Rab said.

Rab claimed Rashida, coordinator of Manikganj unit of the militant group, got acquainted with Moazzim through Facebook while she was in Qatar in 2017. She got involved a year ago.

Meanwhile, a Rab-2 team arrested two men from Pabna. They are Sakib Al Imtihan (21) and Sadat Fahim (20), said Md Mohiuddin Faruqe, a company commander of Rab-2.
