After retiring from his government job, he served in various private universities, including Prime University.

He was also involved with various social and cultural organisations.

CTG Customs House

New social distancing measures in place as Covid-19 cases soar

With cases of coronavirus infection increasing among staffers, officials at Chattogram Customs House have started a token system to limit the number of visitors on the premises from Sunday.

Till date, 24 employees of the customs house have contracted the novel coronavirus, while one officer has died from it. There are 7,000 employees working at the customs house. Of them, more than 3,000 work as clearing and forwarding (C&F) agents -- who are assigned to deliver goods from customs on behalf of importers and exporters -- visit the place every day.

Following the new token system, C&F agents will not need to crowd in front of officials during assessment of bill of entry for releasing their goods.

As per the system, there will be a token above the bill of entry with the bill of entry number, date, C&F agent's name, and phone

number written on it. The documents will be received with the serial number in a specific counter and the customs officials will deliver the documents after assessing them following a serial.

Customs Commissioner Fakhru Alam told The Daily Star, "This system has been introduced to maintain social distancing so C&F agents will not have to be on premises anymore after submitting documents."

"Before the token system, we took several measures but failed to maintain social distancing. It is quite impossible due to the huge number of service recipients coming here every day," he said.

Altaf Hossain, general secretary of C&F Agents' Association, said the new system has reduced the risk of being infected with coronavirus, although it takes more time for assessment. Along with customs officials, many C&F workers have also been infected due to negligence in social distancing, he said.

45 Indian sailors to fly home today

US-Bangla Airlines will repatriate 45 Indian sailors stranded in Bangladesh due to suspension of passenger flights by a special charter flight today.

"Carrying the Indian sailors, the special flight of US-Bangla Airlines will leave Hazrat Shahjalal International Airport at 9am and is scheduled to land in Delhi at 12:30pm," the airlines said in a press release.

The sailors, currently in Chattogram city, will come to Dhaka, the release undersigned by Kamrul Islam, general manager, public relations, US-Bangla Airlines, also said.

-- thinks the awareness campaigns by government bodies and NGOs were not coming to any use among villagers.

"Using mask is rare deep inside villages. Maintaining social distance is a far cry too. I saw children preparing dolls with the masks we distributed among their parents to wear," Jahangir, who extensively travels to such villages, said.

Coronavirus spreads in villages in three main ways: when infected workers return home, when workers go to towns to find jobs, and when rural traders visit town markets to buy goods and return home afterwards.

Jahangir said he surveyed at least 500 labourers, who travel to Rajshahi city daily for work, from three villages: Horipur, Deopara and Damkura. Most of them work at construction sites and eat in local hotels.

This daily travel and eating out puts not only the labourers, but also their villages under immense danger of contracting the virus en masse, he added.

It also proposed for special allocation in IT sector, and increasing allocation in agriculture and food sectors.

Expressing concern over job cuts in the readymade garments industry, the party said, "Owners of factories took Tk 5,000 crore in incentives. You (owners) will take incentives and at the same time will terminate workers -- this is double standard. During the crisis of pandemic, termination of workers is inhuman and wrong decision."

Fakhru said as economic activity have shrunk, so income tax and vat collection will be lower. To meet the budget deficit, the government has to emphasise on foreign loans.

He also criticised the government for poor governance and loan default, and said, "Covid-19 is signalling a change in the economy, politics and overall people's lives. The economy will be stuck if changes do not take place and social stability will be hampered."

The process of change entirely depends on the state and democratic process of the state, he added.

"The incumbent government is not accountable to the people as it was not elected by people's vote. But even after that, in the time of great crisis, we are urging the government to forge a national unity burying all sorts of divisions to tackle the situation."

Rana Shikder, who flew in from Singapore to be with family in his final days, passes away at home

Rana Shikder, who flew from Singapore to Bangladesh with the help of doctors of Singapore, died yesterday at his home. Thirty-two-year old Rana was waiting for death as he was suffering from stomach cancer.

He breathed his last at 3:30pm. His son and mother were beside him as per his wish, said Anis Shikder, uncle of Rana.

He left behind his wife and a son and a host of relatives to mourn his death.

Anis said Rana was buried at a graveyard in Syedpur area of Narayanganj after Maghrib prayer.

The Daily Star ran a report on him after his return from Singapore.

Rana went to Singapore last year and in early May this year he was diagnosed with stomach cancer.

After being diagnosed, Rana wanted to go home to Karaitala, Narayanganj and spend his remaining days with loved ones.

Cynthia Goh, a senior consultant of



the Singapore National Cancer Centre, came forward to help Rana and arranged a charter flight for him and also collected money through crowdsourcing.

Hearing the news of Rana's death, Cynthia told The Daily Star, "I am grateful to God that I got a chance to play a small role in his life."

"The pleasure is that Rana got the chance to fulfil his last wish to spend his last moments with family members. And the family members also got time to spend some time with him."

"The next journey of Rana will surely be smooth," she wished.

GAS CYLINDER BLAST

7 of a family injured in Savar

At least seven members of a family, including two children, suffered burn injuries in a fire caused by a gas cylinder blast in Ashulia of Savar early yesterday.

The injured are: Liton (32), Shanta (25), Imran (5), Azizul (7), Salma (30), Shohel (27) and Ripon (26); they were taken to Dhaka Medical College Hospital, said Jihad Mia, warehouse inspector of DEPZ fire service in Savar.


He said the explosion occurred on the

ground floor of a two storey building at Purbo Kathgora area around 5pm, when one person tried to light a stove with a matchstick.

Gas cylinders are used for cooking at every apartment. The explosion might have occurred due to a gas leak, he added.

Doors, windows and some belongings were damaged. A portion of the brick wall and roof also collapsed, he said.

Among the injured, Liton and Shanta's conditions are critical, said the fire service official, quoting a DMCH doctor.
