

‘Debris of Desire’ selected at SIFF

“Debris of Desire”, a film produced by Bangladeshi filmmaker Josim Ahmed, has made the official selection of the Shanghai International Film Festival (SIFF).

Directed by Indranil Roychowdhury, the Bangladesh-India joint production is part of the Asian New Talent Award at the prestigious film festival, that is set to begin on July 25.

The film, carrying the Bangla title “Mayar Jonjal”, stars Aupee Karim and popular Indian actor Ritwick Chakraborty, and follows Satya and Chandu, two struggling members of the underclass, who turn to a life of crime.

“SIFF is not only a renowned film festival around the world, but is also the biggest film market in Asia. It is indeed a privilege to have my work selected in the festival,” Josim Ahmed told this newspaper.

The film will be showcased in the Shanghai Film Art Center, Tianshan Cinema-Hongqiao Art Center and OSGH Cinema on July 25, July 29 and August 1 respectively. The festival, one of the first major film events to be held physically since the Covid-19 outbreak, will run until August 2.

Six ‘JMB members’ arrested in Savar

Rapid Action Battalion (Rab) claimed to have arrested six suspected members of banned militant outfit Jama’atul Mujahideen Bangladesh (JMB) in Savar early yesterday.

The arrestees were identified as Omar Faruk Rubel alias Sunny (28), Habibur Rahman alias Badsha (48), Saidur Rahman (55), Mahbubur Rahman alias Dudu (55), Shafiqul Islam Shafiq (37) and Golam Mostafa (51), said Rab.Tipped off, a team of Rab-4 arrested the six after conducting a drive in Badda-Bhatpara area of Savar, said Sajedul Islam Sajal of Rab-4, also a senior assistant superintendent of police.

The elite force members also recovered several books and leaflets on extremist ideology, and seven mobile phone sets from their possession, said the Rab official.

The arrestees will be handed over to Savar Model Police Station after completing legal process, added Sajedul.

Filing of a case was underway, said Saiful Islam, inspector (investigation) of the police station.

areas like ponds, haor and swamplands are integral in managing massive rainfall the region experiences. But unfortunately, the city and its surroundings lost many of such areas over the decades.”

“We must protect water retention and vegetation areas, and take measures centring over-siltation of the river. We need a long-term plan that would consider these issues while developing the city and surroundings,” said the architect and urban planner.

Md Shahiduzzaman Sarkar, executive engineer of BWDB in Sylhet, said after a couple of hours of rain, Surma starts overflowing beside the city. Consequently, many areas become inundated and the canal water does not go down.

“Surma needs to be dredged to regain its navigability. As BIWTA is working on a massive project centring this issue, we cannot make immediate plans to dredge part of the river beside the city,” he said.

SCC Chief Executive Officer Bidhayak Roy Chowdhury said, “When Surma overflows, we

really have nothing to do. The river needs to be dredged properly soon.”

When asked about protecting water retention and vegetation areas, he said, “We are protecting all water retention areas inside the city limit, but most of such lands are outside the perimeter.”

The city corporation covers only 26.5 square kilometres. A proposal to include another 160.62 square kilometres of surroundings had been placed and is awaiting approval from local government and rural development ministry, he further said.

The proposal was placed in 2014.

“Once approved, we will protect all water retaining areas in accordance to a comprehensive plan,” Chowdhury added.

Contacted, BIWTA authorities said while they have made considerable progress, dredging part of the river beside the city will take substantial time to commence.

As for the Ecneec mega project, authorities concerned are yet to go fully operational with it. They have only recently received the allocation, informed the CEO of the city corporation.

‘Find alternatives to mass layoffs’

Academics, journalists urge media houses

Teachers of different universities and well-known journalists have urged the owners and editors of media houses to not let go of journalists and employees, and find out alternative ways to overcome the financial crises created due to the Covid-19 pandemic.

In their statement, 60 teachers and 16 journalists asked both public and private organisations not to stop advertising, which is a good source of revenue for the media.

“We all know that the novel coronavirus has created a dangerous situation and the future holds more uncertainty. It is expected that during this grave crisis, people will come together to help one another,” reads the statement.

“Owners of many television channels and newspapers decided not to give bonus to journalists and staff members within a month of declaration of closure by the government. Some well-established and profitable organisations awarded 25 percent of bonus. Some media outlets are planning to dismiss and send journalists on forced leave without salary... news like these are alarming,” the statement also added.

“We’re well aware that economic activities are undergoing a setback due to the coronavirus and media is being adversely affected... Media [outlets] could not collect arrears of advertisement from public and private organisations. On the other hand, sale of newspapers has also dropped. Overall, the situation has become tougher for mass media,” it said.

The statement said, “Considering all adversities, it is our earnest request to the owners and editors to not shut down their organisations, discharge journalists or reduce salary and allowance, rather work together to find a way out of this crisis.”

Media owners will be able to overcome the situation without dismissing anyone if they work together and come up with a creative solution, it added.

Among others, Prof Dr Shakhawat Ali Khan, Prof Dr Golam Rahman, Prof Dr AAMS Arefin Siddique, Prof Dr Sheikh Abdus Salam, Prof Dr Mofizur Rahman of Dhaka University, Prof Dr Dulal Chandra Biswas of Rajshahi University, Ali Asgar Chowdhury of Chittagong University, journalists Zulfikar Ali Manik, Munni Saha, and ZI Mamun signed the statement, among others.

relevant officials of the city corporation. In this regard, a committee has already been assembled and a three-tier working plan is also being prepared.

The plan will focus on finding out the best way to establish a safe bicycle network for the city. It will work on relevant issues such as how the lanes are going to be marked.

Jalal Ahmed, president of the Institute of Architects, said an integrated plan is very important in order to separate motorised and non-motorised vehicles from moving together.

Contacted, DNCC Mayor Atiqul Islam said they have asked committee for an integrated plan so that the city corporation can take appropriate initiatives. “In spite of challenges, we will go for an integrated bicycle network as it will be beneficial for the environment and public health,” the mayor said.

Bicycles are also considered logistically

superior for some cases. “At least 49 percent of trips in Dhaka every day are short-distance ones within two to five kilometres,” said Saifuddin Ahmed, executive director of Work for a Better Bangladesh Trust and member secretary of the planning committee.

“If bicycling and walking is given priority, it will help reduce the use of motorised vehicles,” he said, which can play an important role in reducing air pollution.

“The world is now rethinking the use of bicycles due to the coronavirus pandemic,” Saifuddin said.

Akhter Mahmud, president of Bangladesh Institute of Planners said, “Modern cities are planned by prioritising walking and cycling. Big portions of the city are reserved for that. If we create a pedestrian and cyclist-friendly city, people will be able to move smoothly, safely and in a much more environmentally-friendly manner.”

financial banking account regularly, he said, adding, “We got numbers of some senders and are trying to get details.”

“We have also come to know that Mohona was in touch with top Neo-JMB leaders. We got some names from her and are conducting drives to arrest them,” he said.

He, however, refused to disclose details of this leadership as it may alert them.

After converting to Islam from Hindu religion in 2009, Mohona met members of Neo-JMB’s female wing on social media and started working as a member.

She was then added to a messenger group where she met two youths -- Al Amin and Rasel.

“Of them, Rasel lives in Bogura. To make her a Bangladeshi national, Rasel managed to get a birth registration and NID card for her,” said a high official of the CTTC unit.

Later, Rasel sent the documents to Mohona’s address at Jatrabari in 2017

through courier service, said the official. CTTC unit is now conducting drives to trace Rasel’s whereabouts.

During interrogation, Mohona said she got married to one Amir Hossain Saddam over phone last year. They stayed in Keraniganj for 14 days before he left for Oman.

The CTTC officials, however, are suspecting that Saddam is still in the country.

Another CTTC official said they have come to know that there may have been a change in the militant outfit’s leadership and Mohona, among others, was planning to make a declaration of that through some subversive activities.

The CTTC unit also collected her address in Hugli of West Bengal and contact numbers of her family members.

“We are now trying to cross check the information she gave us,” said the official involved with the investigation.

3 held with 3,600 litres of shark oil

Rapid Action Battalion in a drive arrested three persons with 3,600 litres of shark oil in port city's Cinema Place area early yesterday.

Tarek Aziz, assistant superintendent of police posted at Rab-7, told The Daily Star, “The shark oil was being carried to Mymensingh from Maheshkhali. We intercepted a truck carrying 18 barrels of oil worth Tk 21 lakh in front of Nabi market and arrested them.”

In primary interrogation, the accused confessed to the offence. They used to produce shark oil illegally for a long time after killing the endangered species in Kutubdia and sell it across the country, the ASP quoted them as saying.

The three were handed over to Kotwali Police Station and a case was filed against them on the charge of catching, killing and selling the endangered fish, he said.
