## Cops' FIR, inquest report contradict each other

STAR REPORT

The first information report and the inquest report prepared by police over the death of Sinha Md Rashed Khan contradict each other, raising doubts about the precise sequence of events that led to the former army officer's death.

The FIR, filed by Subinspector Nandadulal Raxit of Teknaf Police Station, claimed that Liaqat Ali, in-charge of Baharchhara Police Investigation Centre, fired four shots at Maj

(retd) Sinha to protect himself and the lives of his fellow officers. However, the inquest report said a total of six gunshot wounds were found in the ex-army major's body after it was brought

to Cox's Bazar Sadar Hospital morgue. "His eyes are half-open. His body bears a total of six gunshot wounds: one beneath his left shoulder bone, one in his left rib cage, one above his left hip, one in his left arm, one in his back and one above his hip," mentioned the inquest report prepared by SI Aminul Islam of Cox's Bazar Model Police Station at 1:30am on



But police's claims of firing shots in self-defence raised a question as to why the law enforcers had to fire four or six shots to protect themselves. Sinha's mother Nasima Akhter also asked a similar question.

Police could have shot him in the leg, injured him or made him surrender or interrogated him instead of killing him, she

told this newspaper.

The FIR claimed that when Sinha was taking out his gun from the right side of his body, the cop fired four shots at him.

His family and friends told The Daily Star that the 36-year-old was right-handed. According to the inquest report, all the injuries on the front side of his body were in the left part.

Sinha, who served in the Special Security Force (SSF), was killed in police firing at Baharchhara police check post on Marine Drive road in Teknaf on Friday night, triggering angry reactions on the social media with many decrying it as police excess.

## Why was my son killed?

Asks mother, demands justice

'Why was my son killed? If he had broken any law, they could have shot him in the leg or injured him or made him surrender or taken him to the police station for interrogation. But why was he murdered?

Nasima Akhter, mother of Maj (retd) Sinha Md Rashed Khan, demanded to know as she spoke to The Daily Star yesterday morning. She made the demand also when Prime Minister Sheikh

Hasina talked to her over the phone around 10:15am. The PM assured her of a fair investigation and justice.

It is indeed a justified demand. But more importantly, beyond the question of whether Sinha was shot unprovoked by a trigger-happy cop or whether he was shot by the police in self-defence, a mother has lost her son.

Speaking to this correspondent at her four-storey home, built lovingly by Sinha for his mother and sisters in the capital's Uttara Sector 14, Nasima said, "We will file a case and seek justice '

She remembered the details of the day her son was killed and how she found out what happened. "I spoke to him around eleven every night. On the night he was killed, I called him several times, but he did not receive the phone. Then after midnight, I received a phone call from a number.

"The voice asked me about Sinha's identity and where he works. I answered and then asked who I was speaking to. The caller identified himself as the officer-in-charge of Teknaf Police Station.'

### Tests reduce yet cases rise in 5 days

50 reported dead in one day

Though the number of tests dropped significantly in the last five days, including the Eid holidays, the country witnessed a spike in the rate of daily Covid-19 positive case.

Between July 21 and 30, a total of 1,22,534 samples were tested, and results showed that 22.39 percent were positive. From July 31 to yesterday, 9,131 were

positive out of 37,061 samples tested, taking the infection rate to 24.6 percent. Experts and WHO have been repeatedly asking the government to increase testing

coverage to curb the spread of the deadly virus, but the country is lagging far behind in testing. During yesterday's Covid-19 briefing, Prof Dr Nasima Sultana, additional director

general (administration) of the Directorate General of Health Services, said another laboratory began testing samples. That brought the number of labs

around the country to 83. A total of 7,712 samples were tested in

83 labs across the country in 24 hours till 8:30am yesterday, she said, adding that 1,918 more people were diagnosed with coronavirus.

## Export makes a in July

This comes after record remittance inflows REFAYET ULLAH MIRDHA and AKM ZAMIR UDDIN

July, it seems, will go down the annals as the month in which the Bangladesh economy lifted the pall of gloom brought on by the global coronavirus pandemic.

that Bangladesh's exports and remittance, the two pillars of the economy, would take a massive hit. But July's data of the two indicators suggests the fears were outsize. Exports fetched \$3.9 billion in July, up 44.4 percent from the previous

month and 0.60 percent from a year earlier, according to data released by the Export Promotion Bureau vesterday. After declines in four consecutive months since February, July's export

data "comes as a big relief", said Zahid Hussain, former lead economist of the World Bank's Dhaka office. "This much recovery amid the pandemic was unexpected," said Ahsan H

Mansur, executive director of the Policy Research Institute of Bangladesh. What is more remarkable is July's inflows beat the target for the month by 13.4 percent.

"It is a remarkable achievement given the disruptions to production and trade caused by the virus," Hussain said.

The charge was led by the garment sector, which accounts for about 84 percent of the country's total export earnings.

Garment shipments raked in \$3.2 billion, which is 14.1 percent more SEE PAGE 2 COL 3

#### Huge blast in Beirut kills at least 10

Hundreds injured REUTERS, Beirut

A huge explosion near the centre of Beirut killed at least 10 people, injured hundreds and sent shockwaves across the Lebanese capital yesterday, shattering windows and causing apartment balconies to collapse.

The most powerful explosion to hit Beirut in years shook the ground, leaving some residents thinking an earthquake had struck. Dazed and weeping, some of them wounded, people walked through streets checking to see if

relatives were hurt. The blast occurred in the city's port area. Lebanon's interior minister said initial information indicated highly explosive material, seized years ago, that had been stored there had blown up. Lebanon-based broadcaster Mayadeen cited the country's customs director saying tonnes of

## Tax cheats can whiten money until Nov 30

Amnesty to black money has always been a nonstarter, so Finance Minister AHM Mustafa Kamal's move to tuck in the facility with added benefits in this fiscal year's budget has left many scratching their heads.

But it now appears the government is racking its brains to ensure the provision is a success this time.

In its latest move, the National Board of Revenue has set a deadline for tax cheats who want to legalise their untaxed

To avail the opportunity, they have to declare their untaxed asset and pay the stipulated tax while submitting their income tax returns within November 30. A notice would be issued by early next month detailing all

aspects for whitening the black money, said a revenue official working on the matter. He wished to remain unnamed as he is not authorised to speak with the media. This comes after the NBR last week came up with a declaration form for tax cheats interested in investing their

undisclosed wealth with the capital market on paying taxes at a rate of 10 per cent. The facility was added in fiscal 2020-21 and the investments

would be locked in for a year. The individual has to declare and give the stipulated tax within one month of pouring in the untaxed money in the

Besides, the individual has to provide particulars including his/her NID and TIN numbers, contact details, amount of money deposited in the share market, the beneficiary owner's account, the name of the brokerage house, among others.

From this fiscal year, individual taxpayers will be allowed to disclose any type of undisclosed properties, including

## Govt extends restrictions over Covid-19 till Aug 31

Bss, Dhaka

The government on Monday issued an order extending countrywide restrictions on public activities and movements until August 31 to contain spread of novel coronavirus.

The Cabinet Division issued a notification mentioning "the restriction will continue from August 4 to August 31. The weekly holidays will also be under the purview of the restrictions."

Markets, shops, and shopping malls must be closed by 8:00pm. The authorities concerned must ensure temperature-checking and handwashing facilities, sanitizers, and vehicle disinfecting services at the entries to shopping malls. Besides, social distancing and health guidelines must be followed strictly, said the notification which contains a 10-point directive.

It said people should be encouraged in using e-commerce platforms to purchase goods and food items.

During this period, none will be allowed to go outside of home between 10:00pm and 5:00am except for urgent activities (works for burying bodies or last rituals, necessary purchasing or selling, including medicines, medical services and movement towards workplaces), the notification said.

Wearing face mask, keeping social distancing and maintaining health guidelines are a must for everyone while staying outside of home. Otherwise, the rule violators will face legal actions.

The government, autonomous, and private offices, banks and financial institutions, trade and commerce, industries and factories and serviceproviding institutions would remain open maintaining health guidelines issued by the Health Services Division

(HSD) of the health ministry.

All employees and expectant mothers would refrain from being present at workplaces.

All kinds of transportation services, including public transport, will remain open maintaining health guidelines issued by the HSD.

The ministries and divisions concerned would issue necessary keep educational directives to institutions and coaching centres shut during the restriction period.

All kind of rallies, meetings, mass gatherings and functions would remain stopped during the restriction while arrangement of programmes in virtual platforms should be given priority.


Devotees can offer prayers at mosques and other places of worship following the directives issued by the religious affairs ministry.

Movements in severely infected areas should be controlled following the guidelines and strategy of zone-wise containment system formulated by the Directorate General of Health Services

Supply and availability of daily essentials should be ensured for the people while city corporations and district administrations will make overall coordination of such activities in their respective areas of jurisdiction.

The Local Government Division, information ministry, religious affairs ministry, Health Services Division, and the district and upazila administrations will carry out massive awareness campaigns to check the spread of Covid-19.

Ministries and divisions concerned have been requested to take necessary measures in line with the directives.



including Liagat Ali, were closed. The government also formed a committee which is investigating the incident.

Nandadulal named Shahedul Islam alias Shifat, who was accompanying Sinha, as the lone accused in the FIR. Shifat, a student of a private university, was charged with obstructing government activities and drawing firearms in an attempt to kill, it said.

Besides, police also filed a case against Sinha and Shifat under the 2018 Narcotics Control Act, showing 50 pieces of yaba and 250 grams of

cannabis in the seizure list. The FIR, however, didn't say much about the weapon -- Walther P22 -recovered from the spot.

Sinha, along with Shifat, was going back to Cox's Bazar from Teknaf by his private vehicle.

The ex-army officer, who was from Jashore, took early retirement from the army in 2018 and had been making travel documentaries for a Youtube channel called "Just Go."

He took three students of a private university with him to Cox's Bazar from the capital on July 3 and had been staying at Nilima Resort in Himchhari area. They went to different mountainous areas of Teknaf for shooting, according to his family members.

But ever since the killing, multiple versions of the incident continued to circulate

In the FIR, police claimed that Sinha had aimed his pistol at the law enforcers and that they fired shots in self-defence.

They had taken position at the checkpoint at 9:15pm, and Sinha's car arrived there approximately 20 minutes later, the FIR mentioned.

They gave a signal to stop the car approaching the check point. But it tried to cross the checkpoint, defying the signal. At one stage, Liaqat used a block at the chock post to stop the car and asked the people inside it to come out with their hands up.

Liaqat asked the person in the driving seat to come out of the car and put his hands up. Then the policemen wanted to know his identity.

The FIR stated, "Sinha began arguing with the policemen for a little while, and then suddenly took out a gun from the right side of his body." He was then

shot by Liaqat.

Police claimed that they immediately took him to Cox's Bazar Sadar Hospital

But the arrival records of the hospital show that the body was brought in at 11:55pm, meaning there was a delay in taking him to hospital after he was critically wounded.

The scene of the incident in Shamlapur area is 48 kilometres from Cox's Bazar Sadar and it takes less than an hour to reach that place.

Hospital sources said Sinha was in army combat T-shirt and trousers when he was taken to the hospital. His body was later brought to the Combined Military Hospital in the capital where his family members were allowed to see only his face for a few minutes on

He was buried at Banani Graveyard on Monday. The autopsy report is yet to

The FIR said one Nurul Amin, 22, of Marishbunia village of Baharchhara

Union is a witness to the incident. However, when a correspondent of this newspaper visited his house on Monday, it was found locked.

Nurul's neighbours said he along with his family left the house the same day but they did not know where he went. Nurul, a farmer, is involved with the community police.

Similarly, Md Aiyas (40), listed as a witness in the FIR, also left his house, locals told our correspondent.

The locals also said the muezzin of Baitun Noor Jame Masjid was a witness to the incident. The mosque is about 10 yards away from the scene of the incident. However, the muezzin has been missing since August 1 afternoon. He has not been listed as a witness in the FIR.

The committee, formed by the home ministry, went to Cox's Bazar yesterday to investigate the incident.

The team members had a long meeting at the Circuit House and drew up an action plan, Chattogram Additional Divisional Commissioner Mizanur Rahman told reporters later.

"The members will go wherever they need to go... The investigation team will talk to witnesses," he said, adding that efforts would be made to submit the report in seven working days.

## Bangladesh likely to allow

The vaccine had its phase one and two clinical trials done in China "without showing any side effects," he said, adding that the Chinese company wanted to conduct a trial in Bangladesh as coronavirus infection has decreased

"There are still many coronavirus patients in Bangladesh. The Chinese company needs 4,200 people for the trial," Mannan said.

An official present in the meeting told this correspondent that the health ministry officials were convinced after a detailed discussion with the icddr,b scientists about the vaccine trial.

He said there was a misconception that people are used as guinea pigs for drug trials -- which is not true.

Now there are globally-recognised rules and regulations for clinical trials and those would be rigorously maintained in Bangladesh, he said.

Scientists say if the vaccine goes through successful trial in Bangladesh, the country's pharmaceutical companies would be able to go for its production.

In that case, the people will get the vaccine quickly and at an affordable price and the country's capacity for vaccine research will be developed, scientists also said.

Earlier in mid-July, Mannan said the decision of vaccine trial was a matter of the two governments.

Health Minister Zahid Maleque on

decide on the trial upon consultation with the National Technical Advisory Committee for tackling Covid-19. Mannan yesterday said it would take

at least six months to conduct the phase three trial in Bangladesh.

"Therefore, we will not only depend on the Chinese company vaccine. We will also try to get supplies of vaccines from the US, the UK and the European Union countries if they find effective vaccines earlier," he said

Globally, about 150 research firms are conducting trials of the Covid-19 vaccines. Oxford University in the UK, Moderna in the US and two Chinese companies are at an advanced stage of

Developed countries are already signing deals with vaccine producers for getting vaccines at the earliest. Vaccine alliance GAVI is also working to ensure that the least developed countries get vaccine supplies free of cost. Bangladeshwill also get free vaccines.

"Therefore, Bangladesh government must make the best efforts to establish effective contacts with GAVI and other actors concerned," said a medical scientist who worked with the World Health Organization.

At the same time, Bangladesh should also invite vaccine companies for trial in Bangladesh as it would help the country develop the capacity in medical research, he said

### Why was my son killed?

"When I asked the officer to hand the phone to Sinha, he said my son was a little far away and cut the call. I was feeling uneasy so I kept calling the number, but nobody picked up my

Nasima then informed a friend of the deceased army official and asked him to look into it. "I thought Sinha might have been under arrest or something, so I asked him to find out."

The next day was Eid. Nasima kept calling both her son and his friend, but nobody responded. "Around 11:00am, policemen from Uttara (west) police station came to my house. I greeted them, invited them to eat and told them that I am worried about my son. I thought he was under arrest in Teknaf and if I tell them how good my son is, they will release him.

Later in the day, Sinha's friend called back. "He made an excuse for not picking up my calls and asked for the mobile number of my daughter. When I asked why, he said he wanted

to exchange Eid greetings with her. By that time, he already knew what had happened and he did not want me to know it first.

"Around 7:30 in the evening, his colleague's sister came to visit. She started saying she understands the pain of losing a child. That is when I realised Sinha is no longer alive," narrated the mother in excruciating detail.

Sinha, 36, was killed in police firing at a check-post in Teknaf on Friday night. He was returning after shooting for a travel documentary. The home ministry has formed a high-powered committee to investigate the incident.

The retired army official was born on July 26, 1984. He served at the Special Security Force (SSF) as the prime minister's bodyguard between 2009

"Following that he worked in many other cantonments, including in Cox's Bazaar's Ramu which was his favourite. Nasima said. He also went to a UN mission in Ivory Coast. In 2018, while he was posted in Rangpur cantonment,

he decided to take voluntary retirement.

"He wanted to travel the world and an army position left him rooted to one spot. He wanted to explore the Everest base camp and cycle around China. He wanted to begin his world tour this year, but the pandemic stood in his way," she

The family reminisced how he had prepared for the tour by buying a trekking backpack and putting up a whiteboard to map out his plans.

"He was different. He had gone to some villages on a tour and brought home two praying mantis insects. He named them Nontey and Fontey. They used to live in a plant in the balcony as his pets," remembered Sinha's sister

Individual taxpayers will also be able to make any disclosure of undisclosed cash, bank deposits, savings certificates, bonds or any other securities on paying taxes at a rate of 10 per cent.

No authority, including the NBR and the Anti-Corruption Commission, would be able to raise any question on such declarations.

Until last fiscal year, tax cheats were able to whiten their assets by investing in residential buildings by paying a tax of 10 percent on the amount invested, which for regular taxpayers is between 10 and 30 percent. They will also not face any questions about the sources of their income if they invest in economic zones and hi-tech parks.

In the upcoming weeks, the tax administration would run ads newspapers and televisions, commission TV programmes and publish leaflets and brochures to inform of the added privileges this fiscal year and also encourage people to bring their untaxed money to the mainstream

The NBR would particularly highlight the opportunities introduced in the current budget that no questions would be asked about the sources of the money disclosed, said an official of the government agency. In fiscals 2007-08 and 2008-09, Tk

9,682.99 crore was legalised during the regime of the Army-backed caretaker government, which was the highest in the country's history, NBR data showed. In the previous two governments of the Awami League, Tk 1,805 crore

## Export makes a stunning rally in July

than the target set by the commerce ministry for July. In July last year, apparel exports stood at \$3.3 billion.

However, Mohammad Abdus Salam, acting president of the Bangladesh Garment Manufacturers and Exporters Association, is not jubilant about the development.

"Had the sector's export earnings soared 25 percent or more, we could have said the garment sector performed

Besides, July's earnings were higher because most of the shipments that were stuck between April and May for the lockdown all over the world were dispatched in the last two months, he told The Daily Star over the phone.

Salam though remains cautiously optimistic.

Bangladesh is strong in basic garment items, whose demand held up amid the pandemic in the Western world, he said, adding that the reopening of stores in the EU and the US is giving hope to the apparel exporters.

"We are expecting that the garment export will rebound strongly from September onwards because international retailers are coming back with work orders and they are mainly for basic garment items," Salam added.

Exports to European and nontraditional markets appear to have played the dominant role in the rebound, Hussain said, adding that retail sales in the eurozone have recovered significantly since May to near pre-lockdown levels.

"Governments in Europe have spent billions to limit the damage to employment. The good news is France, Germany, and most of Europe have extended short term work support schemes through the rest of 2020. This will help sustain the recovery in consumer spending. Credit must also be given to the

prompt support provided by the

Bangladesh government to keep the supply chains flowing and exporting enterprises afloat through the subsidised credit for wage payments, Hussain said. In July, jute and jute goods, home

After sending home a record \$18.2 billion last fiscal year that ended on June 30, migrant workers sent in another \$2.6 billion in July, which is a record for a single month.

### Padma eats up bridge-making equipment

At least 192 railway stingers and 220 roadway decks, supposed to be used for construction of Padma Bridge, fell into the Padma in between 2:00pm and 8:00pm on Friday as erosion hit a part of the bridge project's construction yard. Experts, however, said the erosion

will not affect the main Padma bridge site as it occurred in Kumarbhog area of Munshiganj's Louhajang upazila, nearly two kilometres off the bridge site. Speaking to The Daily Star yesterday,

Bridges Division Secretary Belayet Hossain said no erosion was reported after July 31.

He along with Cabinet Secretary Khandker Anwarul Islam, also the immediate past Bridges Division secretary, and some experts has already visited the erosion site.

Replying to a question, he said, "No damage was done to the main structure of the Padma Bridge due to the erosion.

He said as the construction yard is situated outside the river training area of the Padma Bridge project, the Water Development Board will take up a separate project to protect the areas vulnerable to erosion.

Asked about losses caused by erosion, Belayet said the contractor primarily estimated the losses at around Tk 90 crore.

"However, the losses will be less if the railway stingers can be salvaged as expected by the project authorities. Speaking about the recovery of the oadway decks and railway stingers, an

independent expert said most of those are too heavy to be swept away by river "The decks and stingers are likely to be piled up on the riverbed near the erosion site. Those will be covered with sediment. It is possible to salvage those from the riverbed by using cranes.

The salvaged decks and stingers can be used in the bridge if those do not lose strength," he said. An official of the Padma Bridge project said the government will conduct a survey on more than 20 km area on both sides of the bridge site to predict the possibility of any further

The survey may begin next week, the official added. The Padma had devoured a part of the construction yard in August and

#### Court rejects bail of JKG officials

## Insurance scheme launched to cover losses due to flood

The World Food Programme (WFP), Oxfam Bangladesh and Green Delta protect casual agricultural labourers in the country from the floods during

The scheme will support 2,000 casual farm labourers in Jatrapur and Ranigonj unions and Chilmari upazila of Kurigram, said a WFP statement

Based on the parameters of the flood index, each household will receive a pay-out of BDT 2,700 to 18,000 to cover wage losses caused by severe flooding during monsoon -- which runs from the beginning of July to end of September this year.

"People in Bangladesh do not have protection against losses and damages caused by annual flooding. That's why WFP is introducing this flood insurance scheme - the first of its kind," said Richard Ragan, WFP Country Representative in Bangladesh.

Already dealing with the severity of the Covid-19 pandemic, Bangladesh is currently facing a devastating flood that has submerged towns, washed away homes, and destroyed crops. Expers say climate change and frequent rainfall have lead to the increase in flooding.

Developed with funding from the Korea International Cooperation Agency (KOICA), the overall goal of the scheme -- which is a risk transfer solution -- is to enhance households' and communities' abilities to absorb climate shocks, improve their ability to reduce and manage risk, and maintain food security.

"KOICA believes that the innovative approaches -- such as Index-based Flood Insurance, Forecast-based Financing and Seasonal Livelihood

#### Boost monitoring to minimise farmers' losses: agri minister

Agriculture Minister Dr Muhammad Abdur Razzaque yesterday asked officials concerned to visit flood-hit areas as soon as possible, and monitor and supervise field activities to recoup farmers' losses.

Despite the ongoing pandemic situation, Kumudini Hospital in Tangail's Mirzapur has been continuing its health care services through various initiatives to help people in need.

The entire Kumudini Complex as well as nearby roads has remained inundated for the last two weeks as water level increased in the adjacent Louhajang river.

## Teesta devours over 500 dwellings in five days

Human chain in Aditmari UZ demands immediate protective measures

OUR CORRESPONDENT, Lalmonirhat

The victims of ongoing erosion by the Teesta joined a human chain on the riverbank at Balapara of Mahishkhocha union in Lalmonirhat's Aditmari upazila on Monday demanding immediate government steps to save them from the menace.

The river devoured around 500 dwellings in wards No 4 and 5 of Mahishkhocha union in the last five days while more than 1500 houses are under threat, said participants in the human chain.

Arable lands, orchards and other important establishments in the char (landmass emerging from riverbed) area are also going into the rivered.

Abdul Mannan, a former union parishad (UP) member, with his six-member family has taken shelter in other's land after losing their house to the Teesta.

"Only a week ago we had home, arable land and orchards. Today we are landless and destitute. Hundreds of families have become landless due to serious erosion by the Teesta in the area. Some have taken shelter on government roads and some on other people's land.

Instead of giving relief, the government should take effective steps to save dwellings and arable lands by building an

embankment on the left bank of the Teesta,

Babul Miah, a victim of the river erosion, said, "Many of us have somehow removed the houses elsewhere. Around 500 dwellings along with arable lands have gone into the Teesta in last five days."

"We could not celebrate the Eid as the Teesta has made us homeless and landless. The government's relief programme benefits only a section of the society," said Abdul Jalil, another victim of the erosion.

Mosaddek Hossain Chowdhury, chairman of Mahishkhocha UP, said, "Many people in the union are becoming victims as the Teesta continued devouring homesteads, arable lands, orchards and establishments. The Water Development Board and upazila and district administrations have been informed about the situation, but no action has been

Mizanur Rahman, executive engineer of Lalmonirhat Water Development Board, said, "We have visited the affected areas of the Teesta char in Mahishkhocha union. Attempts are on to prevent erosion by throwing geo-bags at important places. The decision to construct embankment on the riverbank is up to the higher authorities of

#### 3 AL men killed in 2 districts

Three local leaders of ruling Awami League (AL) and its youth wing were killed in separate incidents in Patuakhali and Tangail during the Eid vacation.

Patuakhali correspondent reported that: two local leaders of ruling AL were killed allegedly by their rivals over establishing supremacy in Baufal upazila on Sunday.

The deceased are Rakib Uddin Rumon, 33, vicepresident of Keshabpur Union unit Juba League, and Rivad Hossain Ishat, 24, an activist of the union unit Swechchhasebak League.

Police, however, detained nine people on Monday for their alleged involvement in the murder, Patuakhali Additional Superintendent of Police Mahfuzur Rahman said.

Quoting locals, police said a group of 50 to 60 criminals swooped on the duo while they were taking tea at a tea-stall at Keshabpur Bazar around 7:00pm on Sunday and stabbed them indiscriminately.

Hearing scream, villagers took them to Baufal Upazila Health Complex, where the doctors declared Ishat dead, while Rumon succumbed to his injuries around 9:00pm the same night.

Being informed, police recovered the bodies and sent those to Patuakhali General Hospital for autopsy on Monday morning, police said.

Away in Tangail, a union level leader of AL was killed in Gopalpur upazila on Friday.

The deceased, Aminul Islam Nixon, 48, was former general secretary of Hadira Union unit AL.

A group of unidentified criminals waylaid Nixon in Norilla area while he was returning Dhanbari upazila and stabbed him.

Locals took him to nearby Madhupur Upazila Health Complex, where the doctors declared him dead.

China slams US after Trump gives TikTok 6 weeks to sell itself to US company

China yesterday accused the United States of "bullying" over popular video app TikTok, after President Donald Trump ramped up pressure for its US operations to be sold to an American company.

In the latest diplomatic spat between the world's two biggest economies, Beijing hit back after Trump gave TikTok six weeks to arrange a sale of its US operations -- and said that his government wanted a financial benefit from the deal.

"This goes against the principles of the market economy and the (World Trade Organization's) principles of openness, transparency and non-discrimination," said foreign ministry spokesman Wang Wenbin. "It's outright bullying."

The app has been under formal investigation on US national security grounds, and Trump said that Microsoft was in talks to buy TikTok.

He has given ByteDance until mid-September to strike a deal, a tactic that is almost unheard of.

"It's got to be an American company... it's got to be owned here," Trump said on Monday. "We don't want to have any problem with security.

The US and China have clashed over various fronts recently, essentially barring Chinese telecoms company Huawei from the US market and waging a global campaign to isolate the company over national security concerns.

TikTok has as many as one billion worldwide users, who make quirky 60-second videos with its smartphone app.

But the pressure for a sale of its US and international business, based in Los Angeles, has left the company and its Chinese parent ByteDance facing tough decisions.

In an earlier statement on Monday, ByteDance said it has always been committed to becoming a global company and was considering "re-establishing TikTok headquarters in major markets outside the United States".

UK media reported that it was considering a relocation to London.

North Korea is pressing on with its nuclear weapons program and several countries believe it has "probably developed miniaturised nuclear devices to fit into the warheads of its ballistic missiles," according to a confidential UN report. The report by an independent panel of experts monitoring UN sanctions said the countries, which it did not identify, believed North Korea's past six nuclear tests had likely helped it develop miniaturised nuclear devices. Pyongyang has not conducted a nuclear test since September 2017. The interim report, seen by Reuters, was submitted to the 15-member UN Security Council North Korea sanctions committee on Monday.

#### Al Jazeera office in Malaysia raided after migrant report

Broadcaster Al Jazeera said Malaysian police had raided its office in Kuala Lumpur yesterday, amid an investigation into a programme it aired on the country's treatment of undocumented foreign workers during the coronavirus pandemic. The July 3 programme, entitled "Locked up in

Malaysia's lockdown", prompted a backlash in the Southeast Asia nation, with authorities branding the report inaccurate, misleading and unfair. Malaysia arrested hundreds of undocumented foreigners, including children and Rohingya refugees, after the country imposed a lockdown to contain the spread of the new coronavirus. Human rights activists have condemned the arrests as inhumane. Malaysian officials have said they were necessary to prevent the spread of the virus. Al Jazeera said it stood by its report and called on authorities to drop the criminal investigation.

## No 'silver bullet' for Covid-19

Warns WHO; groundwork completed in China to probe origin of virus

AFP, Geneva

The World Health Organization has said it had completed the groundwork in China to probe the origins of the new coronavirus -- as it warned there might never be a "silver bullet" for Covid-19.

WHO chief Tedros Adhanom Ghebreyesus urged governments and citizens to focus on known basic steps to suppress the pandemic, such as testing, contact tracing, maintaining physical distance and wearing a mask.

"We all hope to have a number of effective vaccines that can help prevent people from infection," Tedros told a virtual press conference. "However, there's no silver bullet at the moment -- and there might never be.

"The basics of public health" are most effective for now, Tedros particular was sending a "powerful message to those around you that we are all in this together".

Infections are surging in some countries around the world, but Tedros insisted that however bad the situation was, past examples such as South Korea showed it could be turned around.

"When leaders step up and work intensely with their populations, this disease can be brought under control,"



#### Rajapaksas eye super-majority in Lanka polls

Sri Lankans head to the polls today with the ruling Rajapaksa brothers looking for a super-majority in parliament to change the constitution and unravel democratic safeguards.

Political observers say the siblings -- renowned for their ruthless crushing of Tamil separatist rebels to end a decades-old conflict in 2009 – want to end presidential term limits, bring the judiciary and police under their direct control, and extend their dynastic power to a new generation.

Presidential term limits were introduced in 2015 under former president Maithripala Sirisena when parliament approved sweeping constitutional amendments.

Those changes also made the judiciary, police, civil service and election commission independent branches of government.

If the Rajapaksas' party secures a two-thirds majority in parliament, they will be able to sweep away those reforms to sxtend grip on power, fears political analysts of the island nation.

## Kashmir under curfew ahead of 'black day'

Thousands of Indian troops imposed a curfew in Kashmir yesterday, with razor wire and steel barricades blocking main roads a day ahead of the one-year anniversary of the restive region being stripped of its autonomy.

Prime Minister Narendra Modi imposed direct rule last August 5, promising peace and prosperity after three decades of violence that have seen tens of thousands of people killed in an anti-India uprising.

Officials announced a two-day "full curfew" on Monday citing intelligence reports of looming protests in the Muslimmajority region of seven million people, where locals have called for the anniversary to be marked as a "black day".

Police vehicles fitted with megaphones patrolled the city of Srinagar, with officers ordering residents to remain indoors. Yesterday, thousands of troops fanned across the city and surrounding villages.

For locals, the new curfew brought back memories of the weeks-long clampdown a year ago. Then, a total communications blackout was imposed, with phone and internet access cut and tens of thousands of fresh troops moved into the valley -- already one of the world's most militarised regions.

Around 7,000 people were taken into custody -- including three former chief ministers. Hundreds remain under house arrest or behind bars to this day, mostly without charge.

The move to scrap Kashmir's special status, which has been accompanied by an upsurge in violence that is set to make 2020 the bloodiest year in a decade, has triggered major economic hardship exacerbated by

Many locals are also angry that for the first time, people from outside Kashmir are being granted rights to buy land, fearing that India wants to change the region's demographic makeup.

"Indian government claims that it was determined to improve Kashmiri lives ring hollow one year after the revocation of Jammu and Kashmir's constitutional



status," Meenakshi Ganguly from Human Rights Watch said in a statement. "The authorities instead have maintained stifling restraints on Kashmiris in violation of their basic rights.

Kashmir has been split since 1947 between India and Pakistan, both of which claim it in full. it has been the spark for two wars between the arch-rivals.

In Pakistan, Prime Minister Imran Khan is expected to visit Muzaffarabad, capital of Pakistan-administered Kashmir, today to mark what Islamabad has labelled the "Day of Exploitation". Anti-India protests are planned throughout Pakistani Kashmir while all major cities in Pakistan will hold solidarity marches, along with a oneminute silence.

HERE cannot be anything better in the midst of the gloom and despondency that Covid–19 has brought upon us than the news that remittance in the month of July has beaten all odds. It has belied all the negative predictions that Bangladesh would be one of those Asian economies, according to the Asian Development Bank, that would suffer the most from a fall in foreign remittance. Defying all expectations of a huge fall due to the economic slump caused by the global coronavirus pandemic, we have seen our workers abroad send in USD 2.6 billion in July, a record for a single month. This has pushed foreign exchange reserves beyond the USD 37 billion mark for the first time in history. Equally gratifying to note is the percentage of increase—62.5 percent more than last year and 42.1 percent from the month of June, according to Bangladesh Bank. A big thanks to our expat workers for this.

The worries that the most important prop of our economy would be severely dented by the pandemic that has affected all the economies has not come to pass, at least as of yet. While we can justifiably feel happy about the remittance figure, we should go deep into the underlying causes and see whether the spike is episodic—is it a one-off phenomenon, or will it be a repetitive feature, of course with the normal variations? Is the spike the result of the two percent incentive declared by the government to discourage illegal transfer by expatriate workers? While that is good news, it would be well to consider that the rise could also be due to the fact that the returning workers have chosen to bring back all their savings from abroad, there being little chance for them to get back their jobs once the pandemic has receded.

While we might feel comfortable with the current situation, we should plan for the eventuality that the large number of our workers who have returned home may not get their jobs back. As such, we should focus on creating jobs for the returnees while they are here and help them to seek new destinations after the pandemic is over, as well as add value to these workers and help them graduate from low to higher paying jobs.

### Young but wise: Inspiring story of a library activist

Atif Asad's initiative should inspire millions in their quest for knowledge

OUNG and wise are not attributes we use interchangeably or place side by side when describing a person. Wisdom, we like to believe, comes with age. Yet the story of 19-year-old Atif Asad, a resident of a remote village in Jamalpur's Sarishabari upazila, shows us that it is never too early to start the good fight. According to a report by The Daily Star, Atif, a first-year honours student at Jamalpur Government Ashek Mahmud College, has established a library to enlighten not just students like him but also people in general. The library, founded in January 2018 with only 20 books, now boasts over 2,000. This is not your usual brick-and-mortar library in the heart of a town where people occasionally visit and read in the comfort of carefully archived collections with modern amenities. Housed in the veranda of his house with shelves made of jute sticks, he built his library from the ground up, slowly enriching his collection with help from young learners and local benefactors. His vision is built on a model of maximising outputs that sees him take his books to the doorsteps of his readers, rather than expecting them to visit his library.

This model has proven to be effective in a poor village like his where education is viewed as a luxury for those who can afford it. Riding his cycle, Atif travels to neighbouring villages 10 to 15 kilometres away to give his books, and makes the same journey to bring them back when his readers—now around 100—are finished with them. This is no easy task for someone who also has to work as a mason's helper to provide for his family as well as support his own education. His struggle didn't diminish his spirit; on the contrary, it enabled him to look past the tribulations of his life and focus on the importance of literacy for people who come from similar backgrounds.

We congratulate Atif for his tireless service for his community and expect others to follow his example. Such initiatives are an important way of improving lives in the rural backwaters of Bangladesh, which usually receives scant attention from the country's policymakers. Atif's story is also proof that any radical change desired in a society must involve contributions from the community members who understand their limits and problems and can solve them in the best way possible.

## Kajol may have been found, but justice is still missing

days have passed photojournalist Shafiqul Islam Kajol, also the editor of The Daily Pokkhokal, went missing after leaving his office on the evening of March 10. Fifty-

three restless nights and days his family spent searching for him. Fifty-three days the media wondered aloud whether one of their own would return alive. Yet, for 53 days, the authorities showed little interest in finding what happened to

This, despite the coincidental fact that the day before he disappeared (March 9), almost close to midnight (at 11:30 pm), a case was registered against Kajol under the infamous Digital Security Act, along with 31 others. As well as the presence of a CCTV footage from outside his office showing several unidentified men snooping around his motorbike—and at one point meddling with it—for at least three hours before he was to be last seen. It wasn't until a month and a half later that Kajol was suddenly "discovered" near the India-Bangladesh border by a BGB patrol—as the authorities claimed—in what appears to be a bizarre stroke of

Instead of finding what happened to Kajol during those 53 days, the authorities immediately put all their effort to go after him. In fact, if one didn't know any better, one might think that Kajol had committed a violent crime judging by the way he has been treated since being "discovered" near the border, beginning with him being dragged into a local court in Jashore with his hands cuffed behind his back—in violation of a High Court directive in this regard.

Why weren't the authorities at all curious to know what had happened to him? Did they already know? If so, why haven't they shared it, not even with his family? These are reasonable

questions. After all, according to Ain O Salish Kendra, between 2014 and August 2018, 310 people had disappeared in the country, of whom only 33 people have so far been "discovered"—and we know nothing about what had happened to

The sheer number of disappearances and the state's outright failure to uncover and reveal what happened to those who disappeared have prompted even

And, it was only on June 23 that he was arrested for the first time in the DSA case, after having spent 52 days in jail already on top of the 53 days during which he was missing.

How is that justice? And is this "actually" about justice?

So far, many artists, journalists, human rights defenders and others have emphasised that it is not, through their activism for Kajol, which may very well have led to his (relatively early) "discovery". And the huge number of people that have vehemently opposed the treatment of Kajol illustrates quite blatantly how the majority of people view

And how they do is not how the authorities have tried to portray it, but more in line with what Brad Adams, Asia director at Human Rights Watch said: "Bangladesh authorities are flouting the rule of law, arbitrarily arresting anyone they feel might be criticising the government... At a time when the government should be reducing the prison population to protect against the spread of Covid-19, they are locking people up simply for their comments on

The authorities, of course as we all know, have repeatedly denied such allegations before. And will no doubt do so again. But the (mis)treatment of journalists—as in Kajol's case—that we have been witnessing for some time now, speaks much louder than empty rhetoric.

## A ten year journey to achieve resilience to climate change



International Centre for Climate Change and Development at the Independent University, Bangladesh will be holding the 7th annual Gobeshona conference with an overall

theme of starting a ten year journey to promote locally led adaptation towards resilience in Bangladesh, as well as in other vulnerable developing countries, including the Least Developed Countries (LDCs) and the Climate Vulnerable Forum (CVF) countries.

The aim of the proposed journey is not to announce a new grand topdown action plan for the upcoming decade to 2030, as there are already sufficient goals including the Sustainable Development Goals (SDGs) as well as the Paris Agreement on Climate Change. In Bangladesh, we have just published the Perspective Plan to 2041.

In contrast, the ten year journey is an attempt to influence and modify all the top-down efforts by national governments as well as international institutions who are supporting adaptation and resilience plans, and to ensure that they genuinely support the empowerment and actions of the most vulnerable communities, in both towns as well as rural areas, in order to enhance their resilience to the adverse impacts of climate change while also tackling poverty at the same time.

The first element of this journey is the structure of knowledge sharing and evaluating our successes or failures (we explicitly accept that we will indeed make mistakes and that we will acknowledge such mistakes and do our best to learn from them and not repeat them). This will be done through three key meetings each year.

The first meeting will be the annual Gobeshona conference held in Bangladesh each January where the partners who will be involved in carrying out the monitoring, evaluation and learning (MEL) of locally led adaptation (LLA) will meet and share their findings. One such group is the LDC Universities Consortium on Climate Change (LUCCC), who will be carrying out a bottom up learning programme in each

The second annual meeting will be the international conference on community based adaptation (CBA), which takes place mid year in a different part of the world each year. This meeting brings together several hundred participants from all over the world who have been actively engaged in LLA for over a decade.

The 14th annual CBA conference this year was supposed to have been held in Bangkok, Thailand in May this year, but had to be postponed to September and will now be an online event. This event brings together the Community of Practice on CBA from all over the world and next year's CBA15 will be held in Bangladesh in the second half of 2021, hosted by BRAC. At this annual event, the grassroots groups themselves will share their experiences and evaluate to

involved. This will be an occasion to see to what extent this noble, but very topdown, initiative actually enhances LLA.

Finally, the fourth meeting each year is the annual Conference of Parties (COP) of the United Nations Framework Convention on Climate Change (UNFCCC), which is held in November or December each year on a different continent. The next COP26 will be held in Glasgow, Scotland in November 2021 (postponed from November 2020

government is already working on its Eighth Five Year Plan, and then the Ninth Five Year Plan will take us to 2030. At the same time, we also have the Perspective Plan to 2041 and the Delta Plan to 2100 to guide us. The setting up of the Global Centre on Adaptation for South Asia in Dhaka will also be an opportunity for Bangladesh to share knowledge with other vulnerable developing countries on adaptation and resilience.

Finally, the goal of the ten year journey

what extent the top-down efforts are actually helping them on the ground. It will be a place for all national and international projects and programmes to come and be answerable to the grassroots communities. One set of LDCs who are part of the LDC Initiative for Effective Adaptation and Resilience (LIFE-AR) have already promised to allocate 70 percent of their adaptation funding to support LLA and will be invited to report back regarding their performance at each CBA conference.

The third event that takes place each year is the United Nations General Assembly, which is also associated with the UN Secretary General holding a Climate Change Action Summit. At last year's summit, the UN Secretary General launched an initiative on adaptation and resilience with the United Kingdom and Egypt as the co-leaders with several other countries, including Bangladesh,

due to the pandemic) and will bring together all the national governments in the UNFCCC to review progress. Under Article Six of the Paris Agreement adopted at COP21 in 2015, countries agreed to set up and achieve a global goal on adaptation, which should also include locally led adaptation.

This journey is being planned to include a number of partners, ranging from national governments of some of the LDCs as well as CVF under the leadership of Bangladesh. At the same time, intentional development partners, multilateral development banks and UN agencies are also invited to join to share their experiences in supporting LLA. The one condition for joining is to be open to being critically evaluated by the grassroots groups that are supposed to be the beneficiaries of their respective programmes.

In the Bangladeshi context, the

is to enable the countries involved to transform themselves from being some of the most vulnerable to the adverse impacts of climate change to becoming some of the most resilient. This will require all the citizens of each country to understand the risks of climate change impacts and also become prepared to deal with them effectively when they

The one big lesson that the global Covid-19 pandemic has already taught us is that in every country where the leaders as well as the citizens have listened to the scientists and acted according to their scientific advice, the death toll has successfully been minimised. This lesson applies to tackling the climate change impacts which will continue for decades to come.

T all began with an op-ed that Shyamal Dutta, the editor of the Bhorer Kagoj, wrote on the front page of the Dhaka-based newspaper. The blistering intro narrated the genocidal events that took place in what was East Pakistan in 1971 in the hands of the Pakistani military. It went on to remind readers that successive Pakistani leaders failed to apologise for those atrocities committed by their predecessors.

The article would have been just fine as a lesson on history. Instead, Shyamal Dutta invoked all these painful memories because Pakistan's current leader, Imran Khan—who he mistakenly called the nephew of General AAK Niazi, the man responsible for the carnage in 1971 spoke to Bangladesh's Prime Minister Sheikh Hasina for about 15 minutes.

A mere phone call, the article suggested, represents a major shift in tone vis-a-vis Bangladesh's stalled relations with Pakistan—that too, at the expense of Dhaka's historical relations with India.

The call was initiated by the Pakistani side, and it would have been discourteous of Bangladesh if it declined a call from a foreign head of government. "After all," Bangladesh's Foreign Minister Abdul Momen has said, "we live in the same world.

Thorny matters such as the Kashmir issue were raised by the Pakistani premier, to which the Bangladeshi prime minister reiterated the country's position that it was India's internal matter—an act publicly appreciated by India's high-level officials. In fact, Bangladesh did not take cognisance of the standing of Pakistan regarding these issues, as evident by the statement put out by Bangladesh which only mentioned discussions related to

For all its explosive claims, Shyamal Dutta's article did not garner much attention at the initial stage and it would have perhaps remained so only if it had not been for *The Hindu*, the influential Indian newspaper which picked up the

story with grave urgency.

The Hindu avoided Dutta's emotional remembrance of atrocities committed in the war and instead focused solely on some of the piece's most incendiary claims, such as priority towards Chinese projects in Bangladesh and disregard for Indian ones. The title of the report was equally suggestive: "Bangladesh's PM Sheikh Hasina did not meet the Indian envoy, despite requests.

That a foreign envoy did not have a

in four months is not earth-shattering news anyway. But, against the backdrop of the phone call between Sheikh Hasina and Imran Khan, suddenly it became a big deal.

There was only one problem, though. The source of the news was not Shyamal Dutta himself. In the original Bangla article, he referred to "the Indian media" when he claimed Riva Ganguli Das, the outgoing Indian high commissioner to Dhaka, was reportedly not given access to PM Sheikh Hasina in the last four months despite multiple requests.

Even then, The Hindu did not only omit Dutta's attribution to "the Indian media" but also failed to take into account a key factor: the Covid-19 pandemic. The outbreak has claimed hundreds of thousands of lives around could not take place due to the threat of

To put the final nail in the coffin, a highly placed source in the High Commission of India in Dhaka disputed the very premise of the story: the high commissioner did not even seek any appointment with PM Sheikh Hasina in the last four months whatsoever.

Nonetheless, the story was picked up by other regional outlets including Dawn and Asia Times. It will go down as an international example of uncritical reporting influenced by preconceived bias, not to mention the poor attribution practices.

Not just this particular aspect of the story; the entire notion that Bangladesh is shifting away from India, bit by bit, is grossly exaggerated. In fact, contrary to

acquisition of Beximco LPG, one of Bangladesh's largest liquid petroleum gas provider, by India's state-owned Indian Oil Corporation. During the pandemic, India has also shown several instances of goodwill gestures to Bangladesh.

Most importantly, the two countries share a relationship that is not based on a zero-sum game. By the same token, Bangladesh's relations with India should not be measured by its relations with other countries and vice versa. In fact, the ties are so powerful that even the realpolitik issues—which would have been the thorniest had it been between countries with normal ties—have been peacefully resolved by the two countries

For two nations sharing the longest boundary in the world, Bangladesh and India have resolved land boundary issues dating back a very long time. Even sensitive maritime boundary issues have been resolved in an amicable and exemplary manner. These achievements should be celebrated as a victory of peaceful diplomacy in a world beset by a myriad of land and maritime disputes, not least the South China Sea crisis.

There is no denying that Bangladesh has appreciated Chinese investment proposals, including in major infrastructure projects. But PM Sheikh Hasina's government has made it very clear that it intends to strike a delicate balance when it comes to its relations between China and India. It is in line with the policy that the country continues to maintain its relations with two major Asian powers.

Although Indian policymakers understand Bangladesh's positions, certain members of the Indian media are more than eager to paint a picture of fraying proximity between the two neighbours. Especially in the wake of the Galwan standoff, some media outlets are trying to cash in on the increased sensitivity among the local population regarding anything remotely related to China. Let us also remember how Ananda Bazar, the prominent Indian Bangla daily, disparagingly described Bangladesh taking Chinese "charity" in a story, which was later retracted due to intense public pressure coming from social media.

Amid the hostile treatment from certain sections of the Indian media, the leadership of both countries have opted for continuous harmony. On July 27, at a virtual meeting, Bangladesh's Foreign Minister Abdul Momen termed the bilateral relations between India and Bangladesh as "rock solid." His Indian counterpart, J S Jaishankar, was equally effusive, "very few countries in the world share such close fraternal ties as ours." If anything, this affirmation should quell the confusion spiced up by the clickhungry media.

## Revitalising these four areas will help developing Asia cope with the new normal

more than 650,000 people around the world have died from the (Covid-19). The pandemic has brought

despair to countless families and caused unprecedented economic damage The response has been significant: governments halted global travel, imposed nationwide lockdowns, quarantined large swaths of the population and scaled up medical care services. Governments have also funded the development and production of testing technology, in addition to the ongoing search for a vaccine.

Yet, it is widely accepted that even when a vaccine is ready and effective, the virus is likely to persist given challenges associated with universal vaccination. The highly contagious nature of the virus means that where there are resurgences in cases, areas that had reopened will need to reimpose restrictions. This is the pattern that we are seeing playing out in several countries including Kazakhstan, India and Pakistan, the People's Republic of China, and most recently Viet Nam.

So, we must learn to live with the virus. In this uncertain "new normal", the prospects for rapid economic recovery are limited. A return to business as usual looks unlikely, too, and may not

fully restore the economy. Focusing on high-impact segments of the economy is therefore an efficient approach to

reaching a new normal. Revitalising four key areas can help developing Asia cope with the new normal and find a path to economic

First, revitalise the health sector. Due to the lack of long overdue investment, there is a significant gap not only in hospital infrastructure, but also at the primary care level, including human resources necessary to staff effective health systems. In response to the pandemic, developing Asia has made record investments in strengthening the health sector. For example, the Indian government in April sanctioned approximately USD 1.9 billion to address the immediate gaps in strengthening the Covid-19 response by scaling up delivery of services. This was followed by the recent announcement of a major programme to comprehensively strengthen the public health system. Bangladesh, Nepal, Pakistan, Uzbekistan and Kazakhstan have adopted similar approaches in their pandemic response plans. There is also a sizeable gap in health-related sectors such as pharmaceuticals and health insurance. Current levels of investment are insufficient to achieve Universal Health Coverage (UHC); however, countries have committed to achieving UHC by 2030. The health sector has huge growth potential

Second, revitalise the social protection

sector, which remains fragile and underfunded in developing Asia. In response to Covid-19, great efforts have been made to ensure that affected populations are covered by social safety nets. For example, in India, the government announced a scheme to provide free food to 800 million peopl until November 2020, as well as direct cash transfers and free cooking gas to women, old and socially disadvantaged groups. The Pakistani government has allocated USD 1.2 billion for emergency cash transfer payments to 16.9 million poor households, including daily wage workers. In Nepal, over one million poor families have been assisted by similar programmes. In Uzbekistan, more than USD 70 million has been allocated to expand the social safety net for the poor and vulnerable. Yet, social protection schemes require long-term efforts to develop, including establishing disaggregated databases, registration and monitoring systems, and strong budget support. The development of the social security sector will help promote economic inclusion and sustainable

Third, revitalise digital technology. The pandemic is transforming people's behaviour and social norms. Working from home has completely changed people's mindset. Web-based collaboration and sharing platforms have been widely recognised for their effectiveness in facilitating remote collaboration and co-working, while webinars are successfully replacing

physical seminars. More importantly, digital technology has been widely and effectively used to promote trade and tourism, support small and mediumsized enterprises and boost microfinance. It is being used increasingly in government, procurement, and education. Strategically developing digital technology will have a huge impact on the quality of growth.

Fourth, revitalise the global supply chain. During the great lockdown, the global supply chain virtually came to a standstill, resulting in incalculable job losses and economic damage around the world. For example, Bangladesh's exports of apparel products were affected due to cancellation or suspension of orders, while international contracting projects in Pakistan, Nepal, Uzbekistan and Georgia were largely suspended due to the interruption of raw materials supply. The pandemic has highlighted the need for urgent reform of the global supply chain. We must pursue high-level multimodal transport, more effective trade facilitation, and stronger trade and supply chain financing mechanisms. In addition, further enhancing the international network of global supply chains will help to ensure that goods continue to flow in the face of disruptions. The global supply chain is the main artery of the world economy and its smooth flow is the basis of economic recovery.

Developing Asia has experienced many crises and disasters and has always bounced back. Following the

Asian financial crisis, which severely hit the banking sector, the region adopted painful but necessary regulatory reforms of its systemically important financial institutions. These reforms introduced vital resilience into the Asian banking

system, enabling it to survive the global financial crisis a decade later. The Covid-19 pandemic should give us similar inspiration—the more severe the crisis, the greater the chances for reform and revitalisation.

As we confront the new normal, a return to business as usual looks unlikely and may not fully restore the economy. Instead, a unique revitalisation in these areas can offset losses and help realise developing Asia's potential.





Last fiscal year, leather exports fetched \$98.3 million, down 40.3 percent from a year earlier, according to data from the Export Promotion Bureau. The overall export of the leather and leather goods sector stood at \$797.6 million, down 21.8 percent year-on-year.

## Limited spectators at Afghanistan game?

The Asian Football Confederation (AFC) will allow its member associations to hold the upcoming Joint

Qualifiers for the 2022 World Cup and 2023 Asian Cup in the presence of full spectators, limited spectators or without spectators amid the coronavirus pandemic.

Since the postponement of all types of matches in March following the outbreak of the coronavirus, there had been an apprehension that the AFC might instruct member associations to hold the Qualifiers behind closed doors with hopes to curb the spread of the coronavirus.

"The AFC sent the guidelines and protocols on July 31, where they mentioned holding the match in three ways -- like normal, with limited spectators or behind closed doors," Bangladesh Football Federation (BFF) competition manager Zaber Bin Taher Ansari told The Daily Star yesterday.

"The BFF has to take the highest level of health and sanitary measures if we want to hold the match like normal in presence of a full crowd. However, the AFC sufficient manpower, who will is encouraging us to admit only ensure sanitary measures, and



50 per cent of the total capacity. All spectators must wear masks, maintain social distancing and hygiene inside the seating area and their temperature must be scanned before entering."

He added that the AFC also encouraged them to put only 30 to 50 per cent of tickets on sale, keep eight per cent for the visiting team and the rest reserved as

complementary for stakeholders. The AFC has also recommended dividing the stadium into nine areas to be monitored with

"I suppose supporting the team from the gallery depends on how many spectators are allowed to watch the matches. If it is only a small amount, then it won't have much of an impact on the players' performance," said Jamie.

### BCB refutes FICA claims FICA says non-payment in BPL is still an issue

Bangladesh Cricket Board [BCB] has termed FICA's [Federation of International Cricketers' Associations] claims regarding the handling of franchisee event contracts and payment of players from ICC events misleading and misinformed.

In a report titled 'Men's Global Employment Report 2020', FICA listed the Bangladesh Premier League T20 (BPL) as one of the sanctioned leagues and the only league among the ICC's Test-playing nations where the issue of late payment or nonpayment continues.

Since the start of the BPL in 2012, the first few editions of the cash-rich T20 tournament were marred with irregular payments. The BPL also endured match-fixing and spotfixing scandals in its initial stage, but the franchise-based tournament seemed to have come a long way in terms of ensuring payment to players and support staff in the latter editions, until the FICA report revealed recent irregularities.

In a statement yesterday reacting to the claims made by FICA on BPL payments, BCB said, "BCB would like to clearly state that the only unresolved/disputed payment from the BPL concerns four (04) persons -three overseas players and a coach, of one particular team that had participated in the 6th edition of the BPL held in 2018. This is an isolated case in a tournament where more than 170 local and overseas players and support staff were contracted.

"Between January and April 2020, the BCB received complaints from the representative(s) of the players and coach that the franchisee in question had failed to comply with its obligations and did not complete payment. As per the franchisee agreement it was the responsibility of the franchisee to directly pay in full its contracted players and support staff.

"Nevertheless, as the regulatory body of the event the BCB had duly inquired the matter and subsequently has initiated legal proceedings against the accused franchisee

to realise the pending payment and resolve the issue. It should be noted that the Board has kept constant contact with the concerned individuals and representative(s) who are fully aware of the steps taken by the BCB."

According to sources all three players and the coach mentioned by the BCB had participated for Sylhet Sixers in the 2018 edition. It was learned that the three overseas cricketers were West Indian cricketer Nicholas Pooran, Pakistani pace bowler Sohail Tanvir, Gulabdin Naib from Afghanistan and the coach is former Pakistan pace legend Waqar Younis.

"Initially, there were issues irregularities in players' payment in the BPL and I heard a few local and foreign cricketers were anxious about their payments. But it has changed over the years -- there might be one or two cases of payment irregularity.

Personally, I have never faced such a situation in the BPL as I have been playing the tournament since the beginning," said an experienced domestic cricketer who preferred not to be named.

The FICA report also mentioned that Bangladesh national players are still owed their ICC event prize money, which the BCB

claimed as a 'misrepresentation of facts'. "The board has completed prize money payments to players from all previous ICC events including the last, which was the ICC Cricket World Cup 2019 in England and Wales. It may be mentioned that the BCB has maintained a standard by which players on a number of occasions have received additional incentives from the Board on top of the prize money from ICC events during distribution," said the BCB statement.

## Murray wants assurances on quarantine



Players need assurance that they would not face mandatory quarantine upon returning to Europe from the U.S. Open before travelling to New York

amid the Covid-19 pandemic, former world number one Andy Murray has said.

Organisers United States Tennis Association (USTA) will set up a strict biosecurity 'bubble' to minimise the risk of coronavirus during the Grand Slam, which will be played from Aug. 31.

The Western & Southern Open, which was relocated from Cincinnati this year because of Covid-19, will also be held in New York from Aug. 20-28 and will serve

as a tune-up for the hardcourt Grand Slam. Mandatory quarantine would rule out players' participation in other ATP and WTA claycourt events scheduled in Europe before the French Open from the end of September. The two major claycourt events in the leadup to Roland Garros are in Madrid and Rome.

While Spain does not require mandatory quarantine, Italy would need travellers to quarantine for 14 days if coming from the U.S. The USTA has said the organisers are

working with authorities to resolve issues. "My understanding is that it would be sorted before we go to America. But things can change in the next 10 to 12 days,"

Murray told British media. "Hopefully before we leave, the players will have the assurances that, when they come back from America, they won't have to quarantine for two weeks.

If that is the case, and if you do well in the U.S. Open, you can't just arrive on the Sunday before the French Open starts on the Monday. That's not going to work.'

## Steps taken, yet rawhide wasted

Demand still not there despite reduction in prices

The government was hoping there would be no recurrence of the waste of rawhide last Eid-ul-Azha.

It fixed a lower rawhide price than last Eid and even kept the window open for rawhide and wet blue exports after a gap of 30 years, all to tempt traders to snap up the sacrificial animals' skins from the ordinary citizens.

And yet, the same scenes were played out this year, and with greater zeal.

This Eid-ul-Azha, 70 lakh cattle were sacrificed, down 30 percent from last year, according to Commerce Secretary

Still, the volumes of rawhides thrown away -- in almost all districts including Sylhet, Rajshahi, Dhaka, Natore, Pabna, Noakhali, Gazipur and Chittagong - were higher than last year, report our correspondents.

Last week, the government fixed the price of salt-applied cow and buffalo rawhide between Tk 35 and Tk 40 per square foot in Dhaka, which is 29 percent lower than last year. Outside of the capital, the prices were Tk 28 and Tk 32 per square foot, down 20 percent year-on-year.

The prices of male goat skins were set between Tk 13 and Tk 15 per square foot, which is 27 percent less than last year. The female goat skin prices were fixed between Tk 10 and Tk 12 per square foot, down 23 percent from last Eid.

### UN warns of 'generational catastrophe'

Says getting students safely back to classroom must be top priority

**UN Secretary-General Antonio Guterres** warned yesterday that the world faces a "generational catastrophe" because of school closures amid the coronavirus pandemic and said that getting students safely back to the classroom must be "a top priority.'

Guterres said that as of mid-July schools were closed in some 160 countries, affecting more than 1 billion students, while at least 40 million children have missed out on pre-school.

This came on top of more than 250 million children already being out of school before the pandemic and only a quarter of secondary school students in developing countries leaving with basic skills, he said in a video statement.

### Mumbai installs female figures on traffic lights

## India tops world for first time

The Philippines orders millions to stay home as global cases soar

More than 800 people died of novel coronavirus in India on Monday, the highest number of new deaths in the world for that 24-hour period, according to the Union Health Ministry data.

The country has also seen more new infections than any other country on earth. India's Covid-19 tally crossed the 18.5-lakh mark yesterday, two days after it went past 17 lakh, with 52,050 cases being reported in a day.

India's rising case numbers are an indicator of the country's struggle with containing the virus as it continues to lift restrictions and open up its economy. Flooding in some parts of the country are adding to the problems.

In the Philippines, millions of people were ordered to stay home yesterday as global coronavirus infections kept soaring, with the World Health Organization warning against relying on a vaccine "silver bullet" to end the

More than 18.3 million people worldwide have been infected with the virus since it first emerged in China late last year and it shows no sign of slowing down.

Brazil is driving a surge in Latin America and the Caribbean where infections have topped five million. South America's largest country has recorded 2.75 million cases, and close to half the region's more than

202,000 deaths. Only the United States has been worse affected. Desperate to contain the spread and relieve pressure on overwhelmed hospitals, some countries such as the
