joined as managing director of NRB Global Bank in 2015.
Documents show, Proshanto's organisation HAL international owned 7.41 percent shares of IFLSL in 2015 and 2016. Being a shareholder of IFLSL, with Rashedul's help easily managed to get loans worth about Tk 2,500 crore for 40 fake organisations.
ACC sources said without any scrutiny, Rashedul approved the loans and severely harmed IFLSL.
This correspondent tried to reach Rashedul for comments but failed. Proshanto now lives in Canada.
Sources said Proshanto took loans from IFLSL but did not pay back. He used the money to buy shares of PLFSL and took control over it. He then took money from the organisation in the same way.
Recently, Bangladesh Financial Intelligence Unit directed commercial banks to freeze accounts of 83 persons, including Proshanto, his mother Leelaboti Halder and brother Pritish Kumar Halder.
The allegations against Proshanto were made after ACC launched the enquiry into illegal casino owners. On January 8 this year, ACC filed a case against him for amassing property worth around Tk 274.91 crore from unknown sources. ACC Deputy Director Gulshan Anowar Prodhand is enquiring about the fraud.
In this connection, ACC summoned former IFLSL chairperson MA Hashem, and directors Nasim Anwar, Basudev Banarjee, Mohammad Abul Hashem, Nawsherul Islam, Anwarul Kabir, Rashedul Haque and Irfan Ahmed Khan for quizzing.

Woman, son found murdered in Ctg

A woman and her eight-year-old son were found murdered in Shamsheer Para area of the port city on Monday night.
The deceased were identified as Gul Nahar Begum (33), and Rifat (8), said police.
Gul Nahar had stab marks in her abdomen while her son's throat was found partially slit, said police. The bodies were found in separate rooms.
Bijoy Basak, deputy commissioner (north zone) of Chattogram Metropolitan Police, said Gul Nahar's daughter, who is an RMG worker, found the bodies after she returned home from work around 8pm.
Gul Nahar had been living separately with her 15-year-old daughter and son Rifat for seven years after her ex-husband remarried, said Basak.
He said they used to live in a rented tin-shed house. One Faruk lived with the family as a tenant.
She used to cook biriyani and Faruk sold those in Bahaddarhat area.
Faruk has gone into hiding and police are looking for him, he added.

Nutrition security at risk

FAO official tells PIB webinar on Covid-19

The increased rate of poverty due to Covid-19 has left the country's nutrition security at risk and the physical growth of its one-third of children has been interrupted due to undernutrition, a FAO official has said.
Mohammad Mizanul Haque Kazol, national poverty and social protection policy advisor of the Food and Agriculture Organization, was delivering a technical session on Nutrition Sensitive Social Protection in the Context of Bangladesh on Monday, says a press release.
Quoting a research conducted by Brac on "Economic Impact of Covid-19 and way forward for Bangladesh", Mizanul said 95 percent households experienced income

loss and 51 percent households' income reduced to almost zero due to Covid-19.
He added that 3 percent households did not have any food, 16 percent had only 1-3 days' food, and 22 percent households have 30 or more days' food.
Mizanul Haque also mentioned that the Bangladesh government adopted social security strategy in the year 2015.
He also highlighted few weakness of the strategy.
Md Elius Bhuiyan, director (training and studies) of PIB; Naoki Minamiguchi, chief technical advisor of MUCH project, FAO; and Feroz Al Mahmud, research director of the Ministry of Food, delivered speech at the webinar with Zafar Wazed, director general of PIB, in the chair.

In his statement, Monirul said, after receiving the FIR on July 10 last year, he recorded it with its Integrated District Office-1 of Dhaka as a regular case.
In their statements, Mrinal and Rezaul, said ACC director Benajir Ahmed on July 29 last year went to their Gulshan Corporate office and seized documents about loan sanctioning of Tk 4 crore.
The court also set September 1 for the next hearing in the case. Earlier on August 18, ACC director Syed Iqbal Hossain and also the case's complainant, gave his statement before the same court.
Seven accused including Chisty were present in the court yesterday.
On December 10 last year, the Anti-Corruption Commission pressed charges against the 11 persons. On August 13, the same court framed charges against SK Sinha and 10 others.
Justice Sinha resigned on November 11, 2017, from abroad.
He is now in the US.

Distinguished Fellow at CPD and convener of the Citizen's Platform for SDGs in Bangladesh Debapriya Bhattacharya said that the worst-affected people, especially people with disabilities and marginalised communities should have been prioritised when selecting beneficiaries.
He said that local government authorities should display the names of beneficiaries to increase transparency.
Rangpur district Deputy Commissioner Asib Ahsan said that it was a challenge to distribute assistance among flood victims and those affected by the pandemic while still maintaining social distance. He said that they received some allegations and are trying to resolve it immediately.
NGO Affairs Bureau Director General Md Rashedul Islam said PM Sheikh Hasina had directed that people irrespective of parties get the benefit if they are in need.
He said joint efforts from all are needed to face multiple disasters like the virus outbreak and flood.
Oxfam in Bangladesh's Country Director Dipankar Datta, CPD Executive Director Fahmida Khatun and others also spoke at the webinar which was moderated by CPD Distinguished Fellow, Prof Mustafizur Rahman.

Dilip Kumar Datta, professor of environmental science at Khulna University, told The Daily Star that water stuck in blocked drains sometimes contaminate water supply line, and cause waterborne diseases.
Asked, Md Abdul Aziz, chief conservancy officer of KCC, however claimed that KCC regularly cleans all drains to ease water flow and stop breeding of mosquitoes.
When pointed out the condition of the drainage system, he said, "It's a continuous process but shortage of manpower sometimes interrupts the work flow."
Mentionable, over 509 employees, including 203 permanent workers, are employed in the conservancy department of KCC. About 580 to 600 tonnes of waste is produced daily in Khulna city, of which KCC has a collection capacity of 65-70 percent, Aziz said.
"It's in our nature to dump waste in drains. People have to come forward to assist us to solve the issue. Many residents do not want to go to the garbage collection points and throw waste in drains or footpath... we have to change our mindset," he stressed.
While visiting different areas including Boyra, Mujuinni, Khalishpur, Boikali and Daulatpur, this correspondent saw there were only seven waste bins available. A dumpster was seen near Abu Naser hospital.
This newspaper spoke to many locals, who said they were reluctant to walk long stretches to throw waste.
"We are trying to establish more concrete waste containers and portable small bins to collect waste. We are also planning to cover the drains," assured the chief conservancy official.
