Life term without parole urged for ‘remorseless’ gunman

Families of victims gunned down at two New Zealand mosques urged a judge to impose the toughest possible sentence, life without parole, on the gunman as he showed no remorse and appeared to smirk at one survivor during a sentencing hearing yesterday.

Mirwais Waziri, who was wounded during the 2019 attack at Christchurch’s Al Noor mosque, put aside his prepared court statement and addressed white supremacist Brenton Tarrant directly, after seeing that he did not have “any regrets.”

“He does not regret anything,” said Waziri in the High Court in Christchurch on day two of the sentencing hearings.

“Today you are called terrorist and you proved to the world that us Muslims are not terrorists. I say to the people of New Zealand that terrorist do not have religion, race and colour,” said Waziri, “ whose words drew applause from the public gallery.

Nathan Smith, originally from Britain and a survivor of the Al Noor mosque shooting, also spoke directly to Tarrant who sat in grey prison clothes cornered by guards.

“When you get a free minute, which you will have plenty of. Maybe you should try to read the Quran. It’s beautiful,” he said, reacting to Tarrant’s apparent smirk.

Tarrant, a 29-year-old Australian, is scheduled to be sentenced this week after pleading guilty to 51 murders, 40 attempted murders and one charge of committing a terrorist act during the 2019 shooting rampage in the city of Christchurch which he livestreamed on Facebook.

Prosecutors have told the court Tarrant carefully planned the attacks to cause maximum carnage by accumulating high-powered firearms and ammunition, training at rifle clubs and studying mosque layouts.

A murder conviction carries a mandatory sentence of life in prison. The judge can impose a life term without parole, a sentence that has never been used in New Zealand.

GOP warns of ‘era of chaos’ under Biden

Securing nomination, Trump claims Democrats using pandemic to steal election

President Donald Trump and his fellow Republicans opened their national convention on Monday by painting a dire portrait of America if Democrat Joe Biden wins the White House in November, arguing he will usher in an era of radical socialism and chaos.

Trump set the tone early in the day when he addressed delegates in Charlotte, North Carolina, after formally securing their nomination for another term, and claimed without evidence that Democrats were trying to steal the election.

Republicans had vowed to offer an inspiring, positive message in contrast to what they characterized as a dark and gloomy Democratic convention last week. But the first night’s prime-time program featured speakers who peppered their remarks with ominous predictions if Democrats win power.

“They want to destroy this country and everything that we have fought for and hold dear,” Trump campaign adviser Kimberly Guilfoyle said. “They want to steal your liberty, your freedom. They want to control what you see, and think, and believe, so they can control how you live.”

The four-day convention opened at a critical



juncture for Trump, 74, who trails Biden, 77 in national opinion polls during a pandemic that has killed more than 176,000 Americans and erased millions of jobs.

Democrats drew their own dismal picture of what four more years under Trump would look like at their convention last week.

Donald Trump Jr., the president’s oldest son and Guilfoyle’s boyfriend, portrayed the ongoing civil unrest as violent assaults on small businesses by anarchists and said Democrats would fail to keep neighborhoods safe.

The convention’s opening night also laid out what promises to be a central theme of the week:

that Biden, a former vice president, and his running mate, US Senator Kamala Harris, will merely be puppets of radical left-wing activists.

Two Republican rising stars - Senator Tim Scott of South Carolina and Nikki Haley, Trump’s former ambassador to the UN, who is Indian American - dismissed the idea that Biden and his party would be better stewards of minority voter interests.

“In much of the Democratic Party, it’s now fashionable to say that America is racist,” said Haley, widely seen as a possible future presidential contender. “That is a lie.”

Earlier in the day, the president repeated his assertion that voting by mail, which is expected to be far more common during the pandemic, will lead to widespread fraud.

As he has done repeatedly, Trump described states’ responses to infections of Covid-19, the illness caused by the coronavirus, in starkly partisan terms, casting lockdowns and other steps recommended by public health officials as attempts to influence voting in November.

“What they’re doing is using COVID to steal an election,” Trump said of Democrats. “They’re using COVID to defraud the American people - all of our people - of a fair and free election.”

Israel continues pounding Gaza

Israeli tanks and aircraft carried out new strikes on Hamas targets in Gaza overnight in response to the launch of so-called fire balloons across the border, the army said yesterday. Israel has bombed the Hamas-ruled enclave almost daily since August 6, in response to the airborne incendiary devices and, less frequently, rockets launched across the border. The flare-up comes after US Secretary of State Mike Pompeo visited Israel on Monday and as British Foreign Secretary Dominic Raab was due to hold talks in both Israel and the Palestinian Territories yesterday.

India building collapse toll hits 5

Rescue workers in western India yesterday pulled a toddler alive from the rubble of an apartment building some 20 hours after it collapsed killing at least five people. The emergency services have found 76 people alive, but there are still around 14 unaccounted for following the disaster on Monday evening in Mahad, an industrial town about 165 km south of Mumbai.

Greta Thunberg back in school after a year

sheltered in camps in Cox’s Bazar stayed inside their makeshift homes and prayed for those killed and tortured.

“No, there was no gathering of people anywhere in the camps. All the activities in the camps were off. We stayed indoors. Some went to mosques and prayed for those killed,” said Mohammad Noor, leader of a camp at Kutupalong, reports our correspondent in Cox’s Bazar.

“Those of us involved with NGOs also did not work. It was almost a total silent day,” said Badrul Islam, another camp leader known as Majhi at Noapara in Teknaf.

“We still didn’t get our rights and still all Rohingya people and other ethnics in Myanmar continuously face this threat. It’s because the UN officially didn’t declare the crimes as genocide,” said a joint statement of several Rohingya organisations. Those include Rohingya Students’ Union, Rohingya Students’ Network, Rohingya Youth for Legal Action, Arakan Rohingya Society for Peace and Human Rights, Rohingya Youth Federation, Rohingya Community Development Program, Education For Rohingya Generation and Rohingya Women For Justice and Peace.

They demanded that the UN declare August 25 as Genocide Day for the Rohingya.

Meanwhile, Burmese Rohingya Organisation UK (BROUK) said the world must not forget the ongoing genocide against the Rohingya people.

“This is a day when Rohingyas everywhere remember the genocide and the worst crimes committed against us in our history,” said Tun Khin, president of BROUK, in a statement.

“But just because the headlines have become fewer today, it does not mean that the Rohingya people are no longer suffering. Make no mistake -- the genocide is going

on, and Myanmar’s leaders are still intent on erasing the Rohingya as a people.”

For the 600,000 Rohingyas, who remain in Rakhine today, life continues to resemble an open-air prison, he said. Close to 128,000 Rohingyas, who were displaced by state-sponsored violence in 2012, continue to live in squalid displacement camps, with limited access to education and other basic necessities. Besides, renewed fighting in Rakhine between the Tatmadaw and the Arakan Army, combined with the Covid-19 pandemic, has further imperiled the lives of civilians in the region.

BROUK said the Bangladesh government has generously sheltered some one million Rohingyas, but restrictions on refugee rights, access to education, work and freedom of movement remain matters of concern.

Tun Khin said despite well-documented serious human rights violations by the Tatmadaw and others against the Rohingya, not a single person has been meaningfully brought to justice over the past three years. However, following the Gambia’s case last year, the International Court of Justice issued a provisional order for Myanmar to prevent acts of genocide, while the International Criminal Court approved an investigation.

BROUK has furthermore brought a universal jurisdiction case in Argentina against Myanmar’s military and civilian leadership for their role in the genocide against the Rohingyas.

“We do not want revenge, but a chance to build a life of dignity, which is only possible if there is justice for crimes against us.

“The world must support international justice efforts. We call on more states to support the Gambia’s case at the ICJ, and to launch universal jurisdiction cases in their own countries,” added Tun Khin.

Congress likely to appoint panel to assist Gandhi

Report says 4 senior leaders to help the interim party chief to take important decisions

The Indian National Congress is likely to appoint a panel of senior leaders to assist interim chief Sonia Gandhi till she is at the helm of affairs, for though the party maintains all is well but the discontent, evinced by a letter seeking a leadership change, may not have been fully doused.

Sources quoted by IANS said that the party may appoint a panel of four persons to take important decisions.

After a marathon seven-hour long meeting in the wake of a letter demanding change in leadership, the Congress party on Monday decided that Sonia Gandhi will remain party chief, at least for the next six months.

The party has reportedly set a time frame of six months for a session of the All India Congress Committee to search for the new chief as Sonia has made it clear that she is not willing to continue at the post any more.


The Congress working Committee (CWC), the party’s highest decision-making body, has authorised the Congress president to affect “necessary organisational changes” that she may deem appropriate to take on the challenges.



Hinting at the committee, several leaders said that Sonia Gandhi will be assisted by four persons so that the consultation process is more wide than what she had done in past while going for treatment abroad.

The meeting came weeks after around 23 top Congress leaders wrote a letter to Sonia Gandhi on the issue of leadership change and elections in the CWC.

The letter called for an urgent need for “full time and effective leadership”, which is both “visible” and “active” and an “urgent establishment of an institutional leadership mechanism” to “collectively guide the party’s revival”. It also asked for decentralisation of power, elections in the party at all levels and empowerment of its state units.
