PM hints at no exams this year

JSC-JDC exams cancelled; officials asked to devise alternative evaluation method for promotion; fate of HSC still not decided



"There will be no exams . . . we are thinking about what more we can do. Maybe we can promote without an exam."

This year's Junior School Certificate and its equivalent exams were cancelled yesterday while Prime Minister Sheikh Hasina hinted that students might be promoted without having to sit for class final tests.

The move comes after the government cancelled Primary Education Completion Examination (PECE) and its equivalents for this year due to the pandemic and the closure of schools.

"The JSC-JDC exams will not be held in 2020," the education ministry said in a statement.

It said the ministry was trying to figure out what would be the best way to promote students to the next classes.

Apart from cancelling the exams, the government extended the closure of all educational institutions, including universities, to October 3. They have been closed since mid-March.

The education ministry had sent a proposal to the prime minister's office last week seeking the prime minister's approval to scrap the JSC and Junior Dakhil Certificate Examinations.

"The prime minister approved the

'MURDERED' GIRL ALIVE

HC summons 2 investigation officials

The High Court yesterday summoned two investigation officers in a case in which three accused confessed to raping and killing a class-V female student, who was later found alive in Narayanganj.

The bench of Justice M Enayetur Rahim and Justice Md Mostafizur Rahman came o with the order following a petition filed challenging the legality and activities of the police station concerned in dealing with the case.

It directed the investigation officers to appear before it on September 17 along with all the case records and confessional

statements of the three accused, who are now in jail. Five lawyers led by Mohammad Shishir

Manir submitted the petition on August 25. According to the petition, the class-five student went missing on July 4. Her father filed a case with Narayanganj Sadar Model Police Station on August 6 over abduction of his daughter.

Later, police arrested three accused who made confessional statements before the magistrate concerned while on remand,

Govt allows trial of China vaccine

Icddr,b to run phase-III trial, says health minister

release from the icddr,b yesterday.

After months-long stalemate, the government has finally given nod to the icddr,b to run phase-III trial of the Chinese vaccine for Covid-19.

Health Minister Zahid Maleque announced this yesterday while talking to journalists at the secretariat. Earlier, the minister held a meeting with the icddr,b officials. Chinese

ambassador to Bangladesh Li Jiming also joined the meeting. The government has conducted various analyses on the efficacy of the vaccine before permitting Chinese company Sinovac to run the trial, the

minister said. He also said the government would be cordial in allowing trial-run of vaccines developed by other countries, including India. On July 18, Bangladesh Medical Research Council permitted the icddr,b,

to run the trial of the Chinese vaccine in seven hospitals. But the trial became uncertain after the health minister and the secretary said the government would take time to decide on the trial.

International Centre for Diarrhoeal Disease Research, Bangladesh (icddr,b) has congratulated the government for its decision. "We appreciate the Government of Bangladesh for taking time to

evaluate our application for the phase III trial of the Sinovac's Covid-19 vaccine critically and give approval for the trial. "We share a common goal with the government to bring the safest and most effective Covid-19 vaccine to Bangladesh at the earliest possible time so that the country may return to normalcy at the soonest," said a press

Every house to be lit up by 2021: PM

Prime Minister Sheikh Hasina yesterday reaffirmed her government's goal of illuminating every house of the country by next year and urged the people to be frugal with electricity use.
"We have taken up

massive programmes to celebrate the birth centenary of Father of the Nation Bangabandhu Sheikh Mujibur Rahman in 2020 and the golden jubilee of the country's independence in 2021. Our goal is to light up every house of the country by 2021," she said.

The PM was addressing a programme marking the inauguration of cent percent electrification in 31 upazilas of 18 districts.

She also opened two power plants, 11 grid sub-stations and six new transmission lines through videoconferencing from the Gono Bhaban.

SOCIAL DISTANCING

Only a quarter practised it

Finds a DGHS survey on 1,549 people in March-April

Only one out of four people practiced social distancing in the country in March and April, finds a study.

The study by the disease control unit of the Directorate General of Health Services also revealed that more than half (51.6 percent) of 1,549 people surveyed had appropriate knowledge on Covid-19 preventive measures.

Among those having appropriate knowledge, 52.1 percent used face masks. Besides, 51.8 percent of them practiced hand washing,

according to the study titled "Assessment of knowledge, attitudes and practices towards prevention of Covid-19 among Bangladeshi population".

Prof Shah Mahfuzur Rahman, assistant professor at the Institute of Public Health, presented the findings of the study at an event at the DGHS in the capital's Mohakhali

A total of 1,549 people were interviewed in March and April for carrying out the survey using online, selfadministered and face to face methods.

The disease control unit also conducted two more surveys among 384 university and medical college students and 604 health workers and staffers across the country. The surveys were carried out in June, July and August.

Magistrate Court-3 (Teknaf) Md Helal Uddin took the complaint into cognizance and asked the OC of Teknaf Police Station to submit before the court by September 10 the report, if any, filed after Jalil's death on July 7.

In her complaint, Senuara said her husband was shot dead after being in detention for seven months. She alleged that police demanded Tk


