WATERLOGGING IN DHAKA

Collective failure made it perennial

Experts say only city corporations taking over drainage management won't solve it

The desire expressed by the two Dhaka city mayors to take over the responsibility of drainage management from Dhaka Wasa in a bid to end the capital's perennial waterlogging problem has widely been regarded as a popular idea.

But experts said just changing the custodian without addressing the core issues that have failed Wasa -- such as the absence of total authority of one particular body and lack of coordination with six other organisations -- might also fail the two city corporations.


The idea of handing over the drainage management to city corporations came to

light last month when the two mayors --Dhaka South's Shekih Fazle Noor Taposh and Dhaka North's Atiqul Islam -- said theywished to take over the job.

They also criticised the Water Supply and Sewerage Authority (Wasa) and Bangladesh Water Development Board (BWDB) for their failure to solve the long-standing

The two mayors blamed Wasa for failing to properly clean the canals, drains and box culverts under its jurisdiction, causing waterlogging in the city last month due to heavy rain. They also slammed BWDB for failing to pump out storm water in time

Covid danger far from over

Experts warn, suggest proper intervention to check further transmission

There is no chance the coronavirus outbreak will come to an end without proper measures to curb its transmission, leading experts said.

The transmission might become even more dangerous because people do not abide by the virus restrictions, they warned.

Besides, the actual level of transmission remains unknown until a countrywide survey is done.

"Those who are dying with Covid-19 symptoms are not counted in the [government] list. I have talked to different hospitals across the country. The number of patients with breathing problems have increased compared with the number 10 days earlier," Dr M Iqbal Arslan, president of Swadhinata Chikitshak Parishad told The Daily Star.

Health and Family Welfare Minister Zahid Malegue drew flak from experts two weeks ago after saying, "Whether the vaccine comes or not, coronavirus will leave the country.

According to the Directorate General of Health Services (DGHS), the number of confirmed Covid-19 cases surpassed the three-lakh mark on August 26.

The death toll had also crossed the 4000-mark the same day, and on an average around 40 patients have been dying every day over the last month. On Wednesday, acting director general of the DGHS Prof ABM Khurshid Alam told journalists at an event that the transmission was on the rise near the country's borders.

Beximco Pharma ties up with Indian firm

To invest in venture with Serum Institute of India

Beximco Pharmaceuticals, one of the leading drugmakers of the country, announced yesterday it will invest with Bangladesh receives Covid-19 vaccine by the regulator.

The announcement came more than a week after Indian Foreign Secretary Harsh Vardhan Shringla's visit to Dhaka and a day after the Bangladesh government announced approval of the stage three trial of a vaccine of Chinese company -- Sinovac Research and Development Co Ltd.

During Shringla's visit, Dhaka had sought to collaborate with Indian vaccine developers for trial in Bangladesh. The secretary did not speak of any collaboration for the trial, but said Bangladesh would be a priority country in terms of getting

Covid-19 vaccines once developed and approved.

In a press statement,

Pharmaceuticals said it will make a financial contribution to advance the development the Serum Institute of India (SII) to ensure of the vaccine, which will be adjusted based on the vaccine price under the terms of the planned arrangement.

The number of doses to be provided to Bangladesh on a priority basis and Beximco Pharmaceuticals investment amount will depend on regulatory approvals, SII's production capacity and earlier commitments to other countries, it

The SII, the world's largest vaccine producer, has partnered with AstraZeneca of UK, the Gates Foundation and Global Alliance for Vaccines and Immunisation (GAVI) to produce more than a billion doses of vaccine for global supply.

Ailing Abe quits as Japan PM

Leadership race begins to replace the country's longest-serving PM

Japan's Prime Minister Abe Shinzo vesterday announced he will resign, ending his record-breaking tenure in a bombshell development that kicks off a leadership race in the world's third-largest economy.



Abe said he is suffering a recurrence of the ulcerative colitis that forced him to cut short a first term in office, and that he no longer felt able to continue as prime minister.

"Now that I am not able to fulfil the mandate from the people with confidence, I have decided that I should no

longer occupy the position of the prime minister," he said. While speculation about Abe's political future has grown in recent weeks, after two hospital visits for unspecified health checks, the resignation nonetheless came as a

Even as recently as yesterday morning, the government spokesman had appeared to dismiss concerns about Abe's health and suggested he would stay on.

But Abe made clear that would not be possible, apologising for once again cutting short his tenure.

"I would like to sincerely apologise to the people of Japan for leaving my post with one year left in my term of office, and amid the coronavirus woes," he said, bowing deeply.

Abe said he would "firmly execute my duty to the end", and until the next prime minister is appointed, possibly through a leadership election involving ruling party lawmakers and members.

Amnesty accuses cops of rights abuses

Delhi 2020 Religious Riots

Police in Delhi were "complicit and an active participant" in the February violence in which 53 people, mostly Muslims, were killed, according to an investigation by Amnesty International India.

"The Delhi police personnel were complicit and an active participant in the violence that took place in Delhi in February 2020, yet in the last six months not a single investigation has been opened into the human rights violations committed by the Delhi police," the rights group said in a statement yesterday.

Amnesty said it spoke to riot survivors, witnesses, human rights activists and retired police officers and analysed several user-generated videos for the investigation that reveals a "disturbing pattern of grave human rights violations committed by the Delhi police during the riots".

The rights group called on the Indian government to conduct a thorough and impartial investigation into the alleged human rights violations committed by the police in what was the worst réligious violence seen by the capital in decades.

"The Delhi police reports to the Union Ministry of Home Affairs (MHA) and it is shocking that there has been no attempt by the MHA to hold the Delhi police accountable till now," Avinash Kumar, executive director of Amnesty International India, said in a statement.

Deadly violence broke out in February after weeks-long peaceful sit-in protests by Muslims in northeast Delhi against a controversial new citizenship law were targeted by Hindu nationalist mobs. More than 500 people were also injured, according to the government.

The police were accused of either supporting the mobs or looking the other way as the capital burned.

"Delhi has witnessed two major communal violence incidents across a period of four decades - the 2020 riots and the 1984 Sikh massacre,' Amnesty said. "A common link between both the incidents is the human rights violations committed by the Delhi police."

However, during a coordination meeting held at the LGRD ministry on July 22, he blamed Dhaka Wasa and BWDB for the city's waterlogging.

While visiting some canals and pumping stations after the meeting, the mayor said the two entities -- mainly responsible for curbing waterlogging in the city -- did not carry out their duties properly.

"Although it is the duty of Wasa and

the water development board to solve waterlogging, both the organisations have totally failed. Give us the duty to solve the problem through long-term

City dwellers have been suffering for years because Wasa and BWDB have not been discharging their duties properly, he added.

In another programme organised by the LGRD ministry on August 13, Taposh expressed his resentment for the Detailed Area Plan not being implemented by Rajuk.

Asked about transferring the charge of drainage management, LGRD Minister Md Tazul Islam on August 16 said things are at an evaluation stage. And the whole process involves some legal issues and capacity building of the city corporations.

"It will take time and also the capacity of the city corporations will also have to be increased. Wasa has the manpower, technology and logistics. If we suddenly hand it [the responsibility of drainage management] over to the city corporations, both organisations might suffer," he added.

A DECADE OF FAILURE

Under-fire Dhaka Wasa Managing Director Tagsem A Khan, who in his 11-year-long tenure has failed to provide safe drinking water to over one crore city dwellers and solve waterlogging, told The Daily Star in a recent interview that waterlogging during monsoon cannot be solved with only an artificial drainage system.

And in this context, Prof Adil Mohammad Khan said conservation of water bodies like rivers and canals, wetlands, water retention areas, and flood flow zones are all vital for drainage of storm water as well as for sustainable ecological balance, heat absorption and biodiversity.

The flood flow zones and lakes are under Rajuk. But over the last one decade, those zones have been greatly reduced due to encroachment, he

According to a 2019 study by the Bangladesh Institute of Planners (BIP), individuals, businesses, real-estate developers, organisations, and even government agencies have gobbled up 1,072 acres (57 percent) of the 1,879-acre flood flow zones in Dhaka metropolitan areas in this decade.

Detailed Area Plan (DAP) was issued in 2010, the core city lost 3,440 acres out of 9,556 acres of flood flow zones, water retention areas, and water bodies till 2019, said Prof Adil Mohammed Khan, general secretary of the BIP.

Syeda Rizwana Hasan, chief executive of Bangladesh Environmental Lawyers Association (Bela), said apart from the flood flow zones, Dhaka has lost almost all 50 of its canals that played a crucial role in its drainage.

Despite orders from the Apex Court, not a single canal has been recovered from the clutches of the grabbers. Land records have mostly been illegally tampered, resulting in private titles on canal lands, she said

RECOMMENDATIONS

Dr Iftekharuzzaman said the two city corporations should be given the responsibility as civic organisations, and they should be the ones responsible for monitoring the work that is under the jurisdiction of Wasa.

He believes the responsibility of complete drainage management and the maintenance of sewerage, canals, and culverts, should be given to a single body. He suggested necessary amendments to the law for that to

Iqbal Habib, joint secretary of Bangladesh Paribesh Andolon, said the idea of handing over the job to the two city corporations would only be fruitful if certain conditions are fulfilled. All the manpower and equipment of

the Wasa's drainage division will have to be under the city corporations.

Rajuk will have to engage the city corporations in the action plan and its implementation in line with the Detailed Area Plan (DAP). And there should be a law for this.

The water bodies and canals which are owned by the deputy commissioner's office will have to be leased out to the city corporations for their management.

Besides, the BWDB also will have to set up pumps according to the plan of the city corporations. A gazette notification will have to be issued so that BWDB does its job through a separate department coordinating with city corporations.

Finally, an integrated master plan will have to be taken to solve the problem and it will have to be executed properly, Habib concluded.

Expressing guarded optimism, Syeda Rizwana Hasan said, "The city corporations are overburdened and have not delivered as per legal mandates.'

She added, "Instead of merely changing the regulatory authority, I would suggest that the National River Protection Commission be given a coordinating role and guide the restoration process to be undertaken by respective agencies in a coordinated manner.

UN rights office says Blake shooting was 'excessive'

The UN human rights office yesterday said that the images of the shooting of Black man Jacob Blake in Wisconsin appeared to show that the police officer had used "excessive" force that was likely discriminatory in nature.

Sunday's shooting, captured on video, showed Blake was shot in the back by a white police officer as three of his young children watched. The footage has gone viral and set off angry protests.

From the images available that we've seen at this point, the police appear to have used force against Jacob Blake that would seem to be excessive," Rupert Colville said at a virtual briefing in Geneva, saying the use of force did not appear to comply with international standards.

Covid danger

At the same event, Prof Meerjady Sabrina Flora, additional director general of the DGHS, said, "Although there are limitations in measuring the situation-based cases in hospital settings, an analysis of symptomatic and asymptomatic cases indicate that transmission rates have fallen in some areas while increased in many.

"If measures like social distancing and the use of masks are not ensured, it will not be long before transmission increases," she added.

Prof Iqbal said "misleading remarks" from the government will only worsen the situation.

"We heard similar comments in March when the pandemic had not yet turned serious... Now such comments may turn the situation more complex," said the biochemistry professor who is also a member of the National Technical Advisory Committee (NTAC) on Covid-19.

"We took the wrong track at the outset. And such comments are proof that we are still not on the right track." The leader of the pro-Awami

League association of physicians also observed that respiratory infections in patients are more severe nowadays. "Patients are needing more oxygen

support now than they did 10 days ago. The number of patients requiring IČU support is also increasing.

"Those who are saying Covid-19 transmission has reduced or is under control are not saying things based on

Renowned virologist Prof Nazrul Islam, also a member of the NTAC, said there is no evidence suggesting that the outbreak has been contained.

"The positivity rate has been falling over the last few days. However, it cannot be said right now that the transmission has reduced. We have to observe one more week... If the transmission rate continues to go down for two consecutive weeks, we might say the transmission will stay that way [in the future]," he told The Daily Star.

Prof Dr Rashid-E-Mahbub, former oresident of Bangladesh Medical Association (BMA), also thinks there is no basis for the minister's statement.

"A smaller percentage of people are testing positive these days. But we are not testing en masse," he said.

The situation could be assessed if antigen or antibody based rapid tests were done in the communities.

"There is no scientific basis behind claims that the transmission has reduced," he said, adding, "If we want to understand the level of transmission, we have to survey the people en masse."

He warned of bitter outcomes if the government chose to reopen everything and health rules are

"And I don't see any sign of people obeying the rules," he added.

Earliest Memories

envenuto Cellini from the Italian Renaissance was an artist and a sculptor, but he is remembered for his autobiography. In it he relates the following story. When he was five, he and his father witnessed a rare scene on a winter's night: a small lizard, called a salamander, had entered their room's fireplace and was glowing in the dark. Watching this, his father suddenly boxed him in the ear. The shocked boy howled in

His father then hugged him, explaining that now the boy would remember this rare and unusual sight

Childhood memories are often like that: we only remember things because something shocking or startling happened. My earliest childhood memories are no exception. Neither profound nor important, they were strange or shocking in some way. Take the calf that remains vivid

after all these years. We lived in a sprawling home including a barn for the cows, chickens and ducks. One day in the barn, a cow gave birth to a pretty calf. Like any five-year-old, I was delighted.

But some days later, much to my dismay, the calf died. It was quickly taken away. Surprisingly, it returned the next day. It had been stuffed. Why? I learned that the cow would stop giving milk if she discovered her baby was dead. So I watched every morning as the stuffed calf was brought in front of her mother where it stood with splayed legs while its mother was milked. After milking it was hidden

Not a profound event, but I can still see the stuffed calf in my mind's eye and wonder how its mother was

My next memory is about being naive at six and getting into trouble.

We had a Pye record changer and hundreds of 78 RPM records, each containing one song. You stacked up a dozen records on the spindle and the changer played them in a row. This was a source of great joy for me.

An older, distant cousin came to visit for a few days. I showed him the record changer and he was hooked. One day, after breakfast, he selected twelve records for playing. Engaged in conversation with me, he placed them on a chair. Then he inadvertently sat on the chair. All twelve broke with a horrible cracking sound. After overcomzing the shock he talked me into hiding the accident. However, my parents found out soon enough, and as his accomplice I got into trouble.

My third memory – at five – is about taking an initiative and facing the consequences.

We had a kerosene powered refrigerator. It broke in the middle of summer. The repairman came and worked all day. I watched with great interest, very impressed by his ability. But in the heat, he dehydrated and fell sick. My grandmother gave him salt water to drink. This worked like magic - he was fully revived and energized.

Not comprehending the dehydration part, I thought that a large glass of salt water could also fill me with energy. So I made one and gulped it down. Within a few minutes I was sick with diarrhoea. My family was amused by my misadventure, but I suffered.

In childhood, just like now, every day brings many events. Most recede with time, but some stand out. For me, these events stay like milepost markers on the hazy road to growing

Zoo physician and deputy curator Dr Md Shahadat Hossain said, "The habit of animals has

He said before the pandemic, 2,000 people visited the zoo on average per day but now there are around 500 visitors a day. If the situation is normal, the number of

visitors will increase, he added. Tisha Bhattacharjya, founder of Society of Rise for Paws & Claws, said, "The zoo should limit the number of visitors it allows as several animals are still in the process of delivery or carrying their babies. A crowded environment may cause problems for them."

"Those animals are accustomed to breeding in the forest in their favorable environment. At this time, they like to avoid people or noise.

Unprecedented waterlogging cripples life in Barishal city

Kirtankhola overflows during high tide; road condition gets worse

SUSHANTA GHOSH, Barishal

Barishal has been experiencing unprecedented waterlogging for over a week due to tidal surge from the river Kirtankhola, causing immense suffering to city-dwellers.

Most of the city areas go under water during the high tide while the low-lying areas remain waterlogged always, said the residents. The Kirtankhola has been flowing

above danger level, said Md Masum, assistant engineer of Bangladesh Water Development Board, Barishal. On August 20, its water went up to 52cm crossing the level, he added.

"We have not recorded such a measurement for the last 20 years," said the official.

About 1 lakh slum dwellers living near the river and at least 50,000 people in the low-lying areas are the worst affected. Many are struggling to make ends meet, said locals.

Manabendra Batabeyal from College Raw area said he never saw such a situation in his 80 years of life. During the high tide, his area now goes three to four feet under water,

Nasim, a pickup driver from the city's Kalijira, told The Daily Star, "At esent, we have to move from one place to another by boat."

Anowar Hossain, a grocer at Palashpur, said valuable items worth around Tk 50,000 of his shop were grabbed or filled with solid waste. badly damaged.

During a recent visit, this correspondent found low-lying areas like Amanatganj, Palashpur, Stadium, Sadar Road, and Port Road went almost four feet under water. Around 12 people living in those areas said they have never witnessed such waterlogging.

They blamed the authorities' failure for the situation.

Family comes under pressure from neighbours

In Arshad Hasan's 100 square feet apartment at Mirpur section-11's Bihari camp, there's barely enough room for his family of four.

Yet, the family houses two-and-a-half dozen cats within that space, earning a reputation as something of a kitten sanctuary. What started with only two cats some four years ago, has now ballooned into around 30.

"Anytime we come across a stray cat that's ill or too weak to survive, we bring it home and nurture it to full health, said Rahila Anzum Khushbu, Arshad's daughter. "Our neighbours also call for our help any time they see a struggling

It's hard to walk inside the apartment without risking stepping over one of the cats. When this correspondent went to visit the family recently, he saw Arshad cooped up on a table laid out for boutique work, with cats everywhere around him.

There were a few on the table, a few under the chair, some more under the table, and a couple others on top of Arshad's body. Right beside the table, a few more were eating rice and fish from a bowl, while a couple more were resting around a brick enclosure set up at the

corner of the flat as a restroom for them.

At another corner, a bunch of prescription bottles could be seen. Asked, Arshad said, "We keep medicines to help with the primary treatment of the cats. We also keep antibiotics. When needed, we

take them to a veterinary hospital." Arshad said the family visits Gulistan's Fulbaria Veterinary Hospital at least once or twice a month.

"We have to spend around Tk 300 daily to take care of our cats. We need at least two-kg rice and one-and-a-half kg fish to feed them six times every day," Khushboo

said she couldn't pursue a master's degree due to financial troubles. Asked why they spend so much for the cats, she simply said they are bonded with the animals with love and can't stop taking care of them. The family doesn't exactly keep the cats

Finishing her honours back in 2017, she

forever though. If anyone expresses interest to care for a cat, they cross-check their personal info before letting them take the one they desire.

However, "There are neighbours around the area who see the cats as nothing but a nuisance. Among them are two women who regularly harass our family. They

The situation only got worse with the coronavirus pandemic. As news began to spread that the virus can be spread by pets, another set of locals started pressurising the family to release the cats.

The situation took a turn for the worst when two of the cats were beaten to death. All of this prompted some neighbours to release their pets, some of which found their way to Arshad's home.

Despite the pressure, the family held on.

We do this out of our love for cats, and we intend to keep taking care of them in spite of any obstacle thrown at us," Khushboo said.

Barishal city was once blessed with numerous ponds that could contain additional water, said Suvangker Chakrabary, secretary of Bangladesh Paribesh Andolon, Barishal unit. Most of them do not exist now due to a lack of maintenance and encroachment, he said.

Talking to this newspaper, Tariqul Haque, former chief engineer of Barishal City Corporation, suggested re-excavation of those water bodies including the canals to improve drainage system.

Contacted, BCC Executive Engineer Md Anisuzzaman said adequate fund is needed to improve the overall situation.

"Last year, we sent a proposal of a development project costing Tk 2,615 crore to the LGRD ministry to restore all 43 canals and their

beautification, but the authorities did not approve it," he said.

"Now, we will try to clean those water bodies with our own fund so that the city's waterlogging problem is resolved to some extent," said the BCC official.

CONDITION OF CITY STREETS **WORSENS**

Waterlogging has rendered most city roads unusable, as bitumen has broken down from the surface of the roads, causing numerous potholes. The situation is easily noticeable whenever the waters clear to make the roads visible.

Kawnia Road, Amanatganj Road, Taltoli Road, Bandh Road, Lakutia Road and Port Road were found in dilapidated condition.

According to BCC authorities, the city has 593km roads in 30 wards; of them, only 267km is bitumen-surfaced and the rest is brick-surfaced.

are now in good condition, which outside amid the situation. include Sadar Road, Hospital Road, Swa Road and Bazar Road.

According to locals, Taltali Road, Rupatoli Road, BSCIC Road and Lakutia Road are bearing the brunt of the situation.

Khijir Ali, an auto-rickshaw driver from Palashpur, said he has to avoid many roads and eventually can't earn enough money. "In the last one week, my income has halved from the usual Tk 500," he

Martuza Abedin, councillor of ward-2, said the city roads got damaged previously and the tidal water made the condition worse.

Executive Engineer Anisuzzaman said the LGRD ministry sent back another proposal of a Tk 1,100 crore road development project at the beginning of this year. "Although we corrected it and reduced cost to Tk 683 crore, it is yet to be approved," he said.

BCC Chief Engineer Nurul Islam said, "We will start repairing some roads, after the rainy weather ends. This year's incessant rain halted the Dilip Roy (60) from Bhatikhana work for a long time, he added.

TURMOIL IN CONGRESS IN INDIA

Loyalists promoted, dissenters snubbed

Days after saying she had no ill-will against 23 Congress veterans who wrote her a letter that lurched the party into turmoil, Sonia Gandhi has taken the first steps to keep the so-called dissidents in check.

Jairam Ramesh, a senior leader who was not in the dissenting group, has been appointed chief whip of the Congress.

Gandhi has also formed a committee in the Rajya Sabha with Congress party's treasurer and her political advisor Ahmed Patel and another loyalist KC Venugopal to deal with issues that may come up in the Rajya Sabha.

This new committee will effectively sideline and keep under check the Leader of Opposition Ghulam Nabi Azad and Deputy Leader Anand Sharma, sources said. Both the leaders had played a critical role in writing the letter and were instrumental in ensuring not many Rajya Sabha leaders come out in support of Sonia Gandhi.

To show this is not being done exclusively to side-line the dissenters, Sonia Gandhi has appointed a similar committee in the Lok Sabha, with Gaurav Gogoi as the Deputy Leader and Ravneet Singh Bittu as a whip. Both leaders are believed to be close supporters of the Gandhi family.

Sonia Gandhi has also ensured other letter-writers like Manish Tewari and Shashi Tharoor in the Lok Sabha are ignored, sources said. Both Tiwari and Tharoor are excellent orators and have lost out because of being signatories, they added.

> With this decision, the days of leaders like Ghulam Nabi Azad and Anand Sharma appear to be numbered as the leaders of the Congress party in the Rajya Sabha but top aides say Sonia Gandhi will wait for the monsoon season to end before ordering a change.

At a stormy meeting on Monday, the group of Congress veterans had found themselves

targeted for sending the letter calling for sweeping reforms, fair internal elections and a "full-time, visible leadership" that they sent to Sonia Gandhi, who took over as interim chief after her son Rahul Gandhi's resignation last year.

But after sharp attacks, accusations and sparring, the meeting ended on a conciliatory note with Sonia Gandhi saying all was forgiven. The party endorsed the Gandhi leadership. Sonia Gandhi would continue as interim Congress chief until an All India Congress Committee (AICC) meeting to be called in six months, the party said. The Congress also decided to set up a committee to examine the grievances in the letter.

WHO vaccine plan in chaos as govts go it alone

The World Health Organization will next week receive a raft of pledges of support for its plan for Covid-19 vaccines for all.

But the agency has already had to scale back its ambition.

The United States, Japan, Britain and the European Union have struck their own deals to secure millions of Covid-19 vaccine doses for their citizens, ignoring the UN body's warnings that "vaccine nationalism" will squeeze supplies.

If other countries that can afford it pursue a similar approach, the WHO's strategy for fighting the coronavirus pandemic globally and equitably risks coming undone, experts warn.

"If that were to happen, it's fairly clear that there would be insufficient volumes of vaccine available for any other countries, particularly in the first six to nine months," said Alex Harris, head of global policy at the Wellcome Trust health charity.

Countries wishing to be part of the WHO initiative, dubbed COVAX, must submit expressions of interest by Monday.

More than 170 countries, including Canada, Norway, South Korea and Britain, have submitted non-binding expressions of interest to participate in the scheme, which the WHO has touted as the only global initiative to ensure COVID-19 vaccines are available worldwide to rich and poor countries alike.

It has signed up nine COVID-19 vaccine candidates and set out plans to obtain and deliver 2 billion doses by the end of 2021 across countries

But it has struggled to get wealthier countries on board in full beyond pledges of funding and warm words about donating surplus vaccines.

China 'destabilising' Pacific Says pentagon chief a day after vowing not to 'cede an inch';

Beijing says US risking soldiers' lives as military tensions boil

US Defense Secretary Mark Esper yesterday accused China "destabilising" the Pacific region on a whistle-stop trip to the tiny island nation of Palau as military tensions grow between the world's two largest

The visit, which lasted barely three hours, comes as Washington attempts to counter Beijing's efforts to gain influence in the sparsely populated but strategically important Pacific island nations.

Esper said the United States and Palau shared values of freedom "where all countries respect the rules and norms for peace and prosperity of all nations".

This is especially important today, as we continue work alongside our allies and partners to protect that international system that is under threat from China and its ongoing destabilising activities in the region,"



War of words raged between the superpowers on Thursday when Esper rowed not to "cede an inch" in the Pacific and China replied by warning Washington that it was risking soldiers' lives.

Both are at loggerheads over issues from technology and human rights to Chinese military activities in the disputed South China Sea, with each accusing the other of deliberately provocative behavior.

In the latest US move against China ahead of November's presidential election, Washington on Wednesday

blacklisted 24 Chinese companies and targeted individuals over construction and military actions in the busy South China Sea waterway.

On Thursday, a US Navy warship carried out a routine operation near the Paracel Islands in the South China Sea, something frequently criticized by Beijing as threatening its sovereignty.

Esper said the ruling Chinese Communist Party (CCP) wanted Beijing to project power globally via its military.

"We're not going to cede this region, an inch of ground if you will, to another country, any other country."

In Beijing, China's Defense Ministry shot back at "certain US politicians" it said were damaging Sino-US military ties in the run-up to the November election for their own selfish gain, even seeking to create military clashes.

"This kind of behavior puts the lives of frontline officers and soldiers on both sides at risk," it said.

India, with the most infections in Asia, has posted the highest single-day increase worldwide every day since Aug. 7. More than 2.4 million students are set to take tests next week for admission to medical and engineering schools, which the federal government has declined to defer, despite growing pressure from students and opposition parties.

Warning sirens sounded before dawn in Israeli communities near the border as the pre-dawn air strikes and shelling prompted Hamas to launch a salvo of six rockets in

The Palestinian Islamist group, which has controlled Gaza since 2007, said the rockets were a "direct response to the escalation by the Israeli occupier".

in reprisal, targeting "additional Hamas military targets" in Gaza, including "weapons manufacturing site", the military said. Israel has bombed Gaza almost daily

since August 6, in response to the airborne incendiary devices and, less frequently, rockets launched across the border.

In response, Israel has been to tighten a blockade on Gaza. It has banned Gaza fishermen from going to sea and closed its goods crossing with the territory, prompting the closure of Gaza's sole power plant for want of fuel.

Floods kill 23 in Karachi

Pakistan's flooded financial capital of Karachi was plunged into chaos yesterday with power cuts, streets under water and cellphone outages caused by heavy rain as authorities said at least 23 people had been killed in downpours the previous day.

Record torrential rainfall flooded major city streets and damaged homes and other buildings on Thursday, with more rain expected.

The provincial government declared a public holiday to avoid residents having to commute on Friday with Chundrigar Road, home to the central bank, stock exchange and head offices of several banks, flooded.

The Chief Minister of Sindh province, Murad Ali Shah, ordered schools be used to accommodate displaced families, whose homes had been damaged or were unreachable.

WHO to review alert rules after criticism Says Covid contacts should be tested,

regardless of symptoms

The WHO said Thursday it was setting up a committee to consider changing the rules on declaring an international health emergency, following criticism of its Covid-19 pandemic response.

The World Health Organization declared a public health emergency of international concern (PHEIC) over the new coronavirus on January 30 -- at which time the respiratory disease had infected fewer than 100 people outside China, and claimed no lives beyond its borders. But under the current International Health Regulations (IHR) governing

preparedness and response for health emergencies, there are no lower, intermediate levels of alarm beneath a full PHEIC, either on a global or

The WHO has faced accusations -- notably from Washington -- of mishandling the pandemic, and waiting too long to sound the alarm, WHO experts had met on January 22 and 23, but at that point did not

conclude that the outbreak merited the high state of alert of a full PHEIC. WHO chief Adhanom Ghebreyesus told a virtual press conference on Thursday that the Covid-19 pandemic had been an "acid test" for countries as well as for the IHR. Now the WHO will set up a review committee into the global regulations to see whether any changes should be made, Tedros said.

The world health body reiterated its advice on Thursday that resources permitting, people exposed to coronavirus should be tested even if they do not show immediate symptoms of infection, reports Reuters.

The comments come after the US Centers for Disease Control and Prevention (CDC) said this week that people exposed to Covid-19 but not symptomatic may not need to be tested, surprising doctors and politicians and prompting accusations the guidance was politically motivated.

Maria Van Kerkhove, a WHO epidemiologist, said the UN agency recommended suspected cases and their contacts be tested, if possible, but the focus should be on people displaying signs of infection.





Last week Anila Torun, junior project supervisor of the Gabtoli Subterranean Tunnel for Cattle Rehabilitation, took a selfie with a cow.

This is all fine because

people like Ms Torun, who live inside Gabtoli bus stand, always take pictures with cows and trucks as an excuse to not show up to work. It's easy to say they got run over or casually mutilated by a runaway bull/truck. Gabtoli is known for being the place with the second highest cowrelated human casualties after India.

While Ms Torun's selfie was perfectly framed to show her new dental surgery from Thailand, it also showed part of the Tk 210 crore project to build the tunnel. This revolutionary tunnel is designed to make it easier for cattle to cross the road by going under the road. The road is a very dangerous 20-feet wide portion where police stop trucks to exchange friendly little

notes asking how the fam is doing at home. Many cattle have been psychologically injured while crossing this road.

Showing the project was a no-no, or rather a 'Nyet' because it is being funded by Russian donors who process 'uplifting energising spirits', whatever that is. Why the nyet, then?

Abu Share Ryuz, Head Data Consultant for the cattle crossing project, shared with us that he doesn't really know because no one shares with him. "I'm just a guy who makes

Ms Torun gave a press briefing later to apologise for her indiscriminate selfie-taking. The real reason is to avoid the 'evil eye' from neighbouring nations.

Addicts rejoice as narcotics' prices stabilise after Covid-22 supply crunch

Grass sellers condemn jailing of fellows implicated for selling pills

Drug addicts in the capital smoked a sigh of relief as prices of their favourite narcotics began to fall, thanks to some stabilisation in the supply chain which was disrupted following the outbreak of Covid-22.

"First of all, I only smoke dry leaves. I am not even a drug addict," said an addict when asked about the prices.


"Look, grass is not really a drug. It's more of a mood stabiliser," he added when prodded some more to speak on the prices.

With not much progress in conversation with members of addicts anonymous, this correspondent decided to try and reach famous drug lord and now owner of a bus to make his deliveries, Buslam, to learn a little of their pandemic woes.

"They killed a lot of us during this lockdown. Can you please write about that instead of our prices, which are low by the way?" Buslam, visibly fuming said.

"My beef isn't with the grass, but more with the pill. That is concerning. This is just for relaxation. Why isn't the crackdown targeting more of that?" he added.

Buslam's comment on deaths is valid. The numbers show that 35 people had been killed so far in "shootouts" till July 26. Not just that, many are languishing in jail over false cases



over the pill.

"We are respectable farmers, selling grass and do not believe in this chemically manufactured pill."

Professional Smoker E Gaza pointed out that a lot more needs to be done than just killing drug dealers.

"This eulogising of killing drug dealers needs to stop. This war against drug is wrong. Just look at our prison system. It's about punishment and not rehabilitation. That needs to change. This baying for blood is symptomatic of a bigger problem in our society," he said while smoking.

The more E Gaza consumed, the more complex his thoughts became.

"We need to look way back into our history. We, as a people, have always been subjugated. If it wasn't the Aryans, it was the Mughals, the Brits...it was always somebody and maybe that's something that has become inherent in us. We want to conquer drugs, instead of taxing it," he said.

At the mention of tax, an official from the international board of revenue appeared on the scene and proceeded to institute a tax on drugs.

"It's like black money at the end of the day. And that's kind of what the country runs on. Please don't ask any questions about black money," he said before disappearing.

As for the supply situation, which was the original point of the article, it's pretty stable,



Virus loses all power inside buses

Cancellations of JSC-JDC exams

Finally, some respite for students

FTER almost five months of postponement of classes and uncertainty regarding the schedule of school examinations, this year's Junior School Certificate (JSC), Primary Education Completion Examination (PECE) and their equivalent exams have finally been cancelled. Moreover, Prime Minister Sheikh Hasina has suggested that students might be promoted without having to sit for class final tests. We welcome this move, which would certainly bring some respite to anxious students worried about finishing their syllabuses and performing well in the highly competitive exams, with schools closed for the better part of the year due to the pandemic.

Exams are nerve-wracking even during non-Covid times. The pandemic has exposed our students to further mental and emotional vulnerabilities, as they are stuck at home for long periods of time with no interaction with their peers, worrying about an uncertain future. Compelling them to sit for exams for which they were unprepared for would have been cruel, to say the least, and we appreciate that officials have now been asked to devise alternative evaluation methods for promotions for all grades. We believe this is an opportune moment for the education sector to come up with methods of assessments that don't rely on rote memorisation but rather promote critical thinking among students, and enable them to engage analytically with knowledge gained from their textbooks, and indeed, the outside world. The latter ought to be a prequisite of education, whether or not there is a pandemic.

The education ministry and primary and mass education ministry have extended the closure of educational institutions until October 3, following recommendations by the National Technical Advisory Committee on Covid-19 This, too, is a necessary move to ensure the safety of students and their families and to keep the transmission of Covid-19 in check. However, this prolonged closure will further negatively impact students who lack access to digital devices, TVs and radios and hence cannot reap the benefits of alternative programmes introduced by the government since the onset of Covid-19. The ministries must address this digital divide urgently or risk mass dropouts, particularly as poor families, struggling to tide over the pandemic, put their children to work or marry their daughters off. As a result of the cancellation of the PECE, it was also announced that the government will not provide any scholarship to over one lakh students of primary schools and madrassas across the country that are offered on the basis of these results. We feel this decision could also push students from disadvantaged backgrounds out of education, and we urge the government to come up with alternative methods to assess the needs of students and grant scholarships to the most deprived candidates.

Moreover, the fate of HSC students still hang in the balance, and they risk losing a year if the Covid situation does not improve in the near future. If the situation prolongs for much longer, the ministry can consider opting for predictive grades based on previous class exams. At any rate, it should explore all possibilities while engaging with experts as well as students on how to best mitigate the

Rural women lead the way

THE global economic slowdown that resulted from the pandemic has affected multiple industries and led to mass unemployment at home and abroad. We hope such initiatives get all the support they need in carrying out their activities so that they can be replicated across the nation and empower women in impoverished communities.

The 'legacy' of crossfire

DESH has inherited many legacies by virtue of its long history as a constituent of a larger geographical entity, of which it was a part till not very long ago. Some of them make us proud, some we

would rather shun. But one common trait of most people of South Asia is the propensity to hide behind abhorrent legacies of the past to hide our failings as well as our incapacity or unwillingness to change the status quo, and instead blame the past regimes for one's shortcomings. We have the most recent example of "legacy" being cited as the reason why we are witnessing instances of crossfire.

The issue of crossfire killings has come into national focus more acutely after the preplanned murder of Major Sinha. But extrajudicial deaths are not recent phenomena. We have been witnessing this practice for a long time. But when some of our leaders resort to blame games and citing the past as an excuse, what they expose is a selective memory (or selective amnesia if you like), basking in the self-serving feeling of satisfaction that it is the predecessor and not them, who is the villain of the piece.

We prefer to blame this legacy because that perhaps suits our purpose no matter how blatantly obvious those practices may be in the present. We still blame the "bloody Brits" for many ills but do nothing to change the rules, practices or traditions we have inherited. Every regime, irrespective of the party in power,

has blamed its predecessor for all the wrong policies and for all the evils that were happening in the country. However, not only were those policies not done away with—they were generally made even more stringent by adding more draconian features. In recent times, the floor of the parliament was used to root for crossfire as a way to resolve law and order issues. The number of deaths since the start of the anti-narcotics drive suggests that as an expedient, crossfire may have come to be accepted as a tactical norm.

policies have been steadfastly continued with. Operation Clean Heart may have been a well-intentioned undertaking—to arrest the rising incidence of crime and lawlessness and recover illegal weapons, but at the end of the day, at least 58 people were dead, allegedly killed by the security forces, and about 10,000 arrested. The Act of 2003 to indemnify the killings was declared illegal by the High Court. In similar vein, the Rakkhi Bahini was given indemnity in 1974. As we have stated before, one hears critical and discordant notes only when a ruling follow the tactics of the gun and narcotics runners; doing that degrades them to the level of injustice of these elements. But even more than that, resorting to such extrajudicial means, where the police become the judge, jury and executioner, denigrates the legal system and the court, and as Albert Camus has said, it mutilates justice. Such police actions also betray a lack of confidence in the judicial system. And if it becomes a common trick of police trade, it often becomes a weapon of extortion and fear wielded by some errant police officials.

The latest example of the blamethe-past inclination is a minister's frank admission that crossfire deaths are illegal—being a lawyer, he couldn't say otherwise—but he quickly added that it is a legacy the Awami League has inherited. He also, somewhat ruefully, acknowledged that bad legacies take a long time to purge. Indeed, legacies, particularly bad ones, are like the second layer of human skin, the dermis, which is impossible to peel off. But one would have thought that a decade was long enough a time to get rid of a practice for which the country has had to face severe internal and international criticisms.

The most unfortunate aspect of governance in Bangladesh is that although there have been changes in government from time to time, the bad party cadre has the misfortune of falling victim, as was the case of Arzu Mian, a Bangladesh Chhatra League leader, who was allegedly killed in a "gunfight' with Rab in August 2015. And it was an AL MP who reportedly claimed that "Arzu was murdered" and said, "the government could not function depending on Rab, which was formed during the BNP-Jamaat-e-Islami coalition government.

The country today is caught between crossfire and self-defence. Although one does not have any issue with the security forces resorting to genuine self-defence, the narrative of self-defence has been so overused that it no longer accords legality to the killings; the official statements following such deaths are too repetitive to satisfy one's credulity. The law enforcing agencies can ill afford to

No society can endure a situation where law keepers break the law. While the government is justified in undertaking drives to arrest a deteriorating law and order problem, it cannot justify the extrajudicial actions resorted to by the police. One wonders if trade in yaba and other narcotics have reduced in the two years of the drive, despite the nearly 400

Extrajudicial methods have both national and international repercussions, apart from the deleterious effect on the rule of law. And the lawmakers, instead of blaming the baggage of the past, should do away with those instead. Is there the political will to do so?

Epidemics, economics, and externalities



OVID-19 and its damage continue to leave a trail of devastation around the world. Millions of businesses have closed, with many having no realistic prospect of reopening. Millions of people have lost their jobs.

Millions are without health care. Some families are suffering from food insecurity for the first time. While the well-to-do can manage by using their savings, those who live from paycheck to paycheck, or hand to mouth, are suffering unfathomable

The pandemic also poses an almost impossible problem for traditional economic thinking. Most economists believe that the price mechanism will

resources from being allocated efficiently. Consider the decision whether or not to wear a face mask. In the absence of a pandemic, the demand for and supply of masks reflect the benefit and cost of producing them. Mask wearers will be protected from harmful substances in the air, but will incur costs: inconvenience, some discomfort, a possible loss of physical attractiveness, and of course the price of the mask. The market will equate the benefit and the cost, and scarce resources will be used in adequate amounts.

But this is not the case when externalities exist, as with Covid-19. Today, wearing a mask will deliver many benefits beyond those to the individual mask wearer. If the wearer is infected, the mask will prevent transmission of the coronavirus to friends, and further to friends of friends.

Here, the market fails, because the benefit of wearing a mask is far higher than what a single individual would

has so far been one of the most successful in the United States in terms of infection and mortality rates. By contrast, governors of other, mostly southern, states refused to listen to scientists and health experts, and thus did not mandate mask wearing or enforce shelter-in-place orders and social distancing guidelines.

Similar externalities, or technological diseconomies, exist with respect to the environment. If a firm freely disposes of a large amount of sewage or air pollutants, then it is not paying the cost of the harm that its discharges or emissions will cause. The company is thus producing the substances in far greater quantities than a comparison of social cost and social benefit would deem adequate.

Yet, US President Donald Trump's neglect and dismantling of environmental regulations encourages such behaviour, because it enables many firms to avoid the cost of external diseconomies and impose additional hazards on society. Environmental deregulation assumes



allocate resources efficiently, if not equitably, and that competition will maximise national income. But this assumes, crucially, that the activities of individuals or firms do not directly affect those of other agents, except through price signals in the market that indicate the scarcity of a product.

Economists refer to these effects as "externalities," and divide them into external economies and diseconomies, depending on whether they are positive or negative. Such externalities prevent

estimate for themselves. National or municipal governments must therefore intervene and make it mandatory for all residents to wear one.

By requiring everyone to wear a mask, rather than leaving the decision to personal choice, a community can better protect itself from the substantial ravages and suffering caused by Covid-19. I live in Connecticut, where the state's governor and his pandemic task force have responded appropriately and done a good job of containing the virus. One can only assume that Trump and those like him are unable to regard others as entitled to comparable

concern and respect as those in their wealthy, rarefied circles.

But we can turn for inspiration to Guido Calabresi, the US Circuit Court Judge and Professor Emeritus at Yale Law School who, along with the late Nobel laureate economist Ronald Coase, laid the foundations of the interdisciplinary "law and economics" approach. Calabresi highlighted the importance of social justice and the serious impact of sudden income fluctuations on people involved in accidents—very similar to what many are experiencing during the current pandemic.

In his book The Future of Law and Economics, Calabresi explores a new approach that incorporates externalities into consumption. In particular, he argues that a legal system which reflects people's compassion toward one another may help to create a more equitable society.

Calabresi's idea is especially welcome and enlightening at a time when too many leaders are neglecting the struggles and pain of their fellow citizens. Perhaps close study of Calabresi's argument and propagation of his ideas among policymakers would contribute to fostering a much-needed sense of social solidarity in a world where the selfabsorption of some is a threat to all.

Destroyed, but not defeated

The freedom fighters who fought till the end in August 1971



T is said that in times of peace, sons bury their fathers, but in war, it is the fathers who bury their sons. On August 29, 1971, the Pakistani army caught Bodiul Alam (Bodi), Shafi Imam (Rumi), Abdul Halim Chowdhury (Jewel) and Magfar

Ahmed Chowdhury (Azad) in Dhaka city. They were the members of a guerrilla unit of Mukti Bahini.

Rumi's parents and Azad's mother witnessed the extremely distressing scenes of the capture of their sons. Blood poured out of Azad's nose and mouth as the Pakistani soldiers beat him up mercilessly in front of his mother. Eminent musician Altaf Mahmud was also captured by the Pakistani army at the dawn of August 30. Before his family members, the Pakistani soldiers hit him hard with rifle butts. The blow broke one of his front teeth. Sharp strokes of the bayonet caused a cut on his forehead and the skin started hanging over his eyebrows. Rumi and Azad never returned to their mothers; neither did Bodi and Jewel. Altaf Mahmud's wife and daughter never saw him again.

From June 1971, Bengali guerrillas started conducting operations in the heart of Dhaka city. As they were locals of Dhaka, they knew the city very well. Most of them were students and trained in Sector 2, which was under the command of the then Lieutenant Colonel Khaled Mosharraf. Their operations had multiple aims—to let the world know that the situation in Bangladesh, especially in Dhaka, was far from stable, to unnerve and demoralise the Pakistani army, and to instill hope and courage in the Bengali population eager to see the independence of Bangladesh. Habibul Alam, Kazi Kamaluddin, Qamrul Huq (Shawpon), Ali Ahmed Ziauddin, Mofazzal Hosen Chowdhury (Maya), Golam Dastagir Gazi, AFMA Harris, Fateh Ali Chowdhury, Masud Sadique (Chullu), Pulu, Mukhtar and some other guerrillas took part in several daring operations in Dhaka from

Bodi showed extraordinary courage in some important guerrilla actions. On August 19, some guerrillas used two boats for a reconnaissance of Siddhirgani power station in Narayanganj. One of these boats bumped into a Pakistani army patrol boat. When the guerrillas were challenged by the Pakistani soldiers, Bodi quickly fired his Sten gun on the soldiers, emptying the whole magazine. Because of this rapid burst of fire by Bodi, the Pakistani soldiers could not retaliate much and with the exception of Jewel, the freedom fighters remained unhurt. On August 29, Bodi was the first to be arrested by the Pakistani army from a friend's house around 11 am. It is likely that Bodi was arrested after a tip-off. Otherwise, the Pakistani army had no other way of knowing he was a freedom fighter and that he would be in that specific house at that

Bodi was tortured brutally by the Pakistani army into giving them information about the other guerrillas, their arms and ammunition, and their hideouts. After the gruesome torture, Bodi disclosed the names of Chullu and Samad. Both of them were soon arrested. From Samad, the army figured out the association of Altaf Mahmud with the guerrillas. Altaf Mahmud, a much-loved musician who achieved enormous fame after composing the tune of the iconic song Amar Bhai er Rokte Rangano Ekushey February, was very supportive of the guerrillas. Taking huge risks, he kept two steel trunks filled with arms and ammunition to be used by the freedom fighters in his house in Rajarbagh.

The trunks were buried under a lemon tree in the backyard. The Pakistani army made Altaf Mahmud dig out those trunks. Weapons and explosives were also hidden in an underground storage in the kitchen of the house of Habibul Alam in Dilu Road. Breaking the concrete slabs of the kitchen floor, the army collected those arms and ammunitions too. On August 29, Kazi Kamal and Shawpon narrowly escaped being captured during the army raids. Kazi and Jewel were in Azad's house in Moghbazar on that night. Three fingers of Jewel's left hand were still bandaged as they were badly injured their house had also been raided last night.

ten days ago during the guerrillas' exchange of He just departed silently. On that morning, fire with the Pakistani army near Siddhirganj power station. Seeing the bandage on Jewel's hand, a Pakistani military officer twisted his injured fingers forcefully. Jewel screamed in terrible pain. Kazi instantly jumped on the army officer and snatched the officer's submachine gun. Then, he opened fire on the stunned Pakistani soldiers and ran away from

Shawpon managed to hide himself

guerrillas Zia and Fateh also went to that house to inform Rumi of the danger. But it was too late.

Rumi joined the Liberation War in the middle of June. He was one of the specially trained guerrillas of Sector 2. During the operation in Dhanmondi on August 25, when the car carrying guerrillas was chased by Pakistani military vehicles, using his Sten gun butt, Rumi smashed the back windshield

inside the haystack near a cowshed when the Pakistani army surrounded his house in Malibagh. The soldiers searched the place thoroughly, but Shawpon was very lucky that maybe after seeing the cows, they did not go near the haystack. Jahanara Imam wrote in Ekattorer Dinguli that early in the morning of August 30, Shawpon came to their house in Elephant Road. When Jahanara Imam informed him of the Pakistani army's raids and asked him to go to a safe place immediately, Shawpon was so distraught that he could not even tell Rumi's mother that

of the car of his own accord and opened fire on the military vehicle. Bullets fired by Rumi did not miss the driver and the jeep crashed into a lamp post. In 1971, Rumi was only 20 and a freshman in university. Because of the treachery of one or more local collaborators of the Pakistani army, these freedom fighters and talented individuals, who were deeply committed to liberating their motherland, were captured by the occupying Pakistani forces at the end of August 1971.

Although the guerrilla activity in Dhaka city suffered a major setback because of the capture of some skilled guerrillas and the loss of a large amount of arms and ammunition, the guerrillas did not get demoralised. Soon, new guerrilla groups from Sector 2, equipped with better arms and ammunition, entered Dhaka and from October 1971, guerrilla operations started to rock the capital again. In Sector 2, the then Major ATM Hyder put in a great deal of effort into training the young civilians to become skillful guerrillas. Major Hyder was a former officer of the Special Services Group (SSG), the elite commando unit of the Pakistan army. His specialised knowledge about commando-type guerrilla warfare and the dedication and determination of the young men contributed to the creation of daring guerrilla units.

Quoting Mao Tse Tung, Khaled Mosharraf once said to the young men aspiring to become freedom fighters that no government wants an alive guerrilla. Humayun Ahmed's important novel Aguner Parashmoni is based on the guerrilla activity in Dhaka in 1971. The novel ends with saying that as the dawn is breaking, the fireflies are not seen anymore. The fireflies are not needed. These sentences symbolically suggest the lack of interest among many people in independent Bangladesh in remembering the invaluable contributions of the freedom fighters in 1971. Do the majority members of the new generation even know the names of the young guerrillas of our Liberation War? Are they able to recognise one of those valiant guerrillas if their photographs are shown to

Failure to distinguish between real heroes and pseudo-heroes only serves to create an intellectual vacuum and historical ignorance in society. Rumi, Bodi, Jewel, Azad, Altaf Mahmud and many other freedom fighters were killed in 1971, but they were far from defeated. Although they did not live to see freedom, the glory of their courage and sacrifice will last forever. Let those fearless freedom fighters stand as examples to all of us. Let their courage and love for the motherland inspire the people of this



Come again? How are voters going to figure what the party stands for? This looks less like the re-election of a leader in a Western democracy than the near-total Brendan Buck on what support in yesteryear's cult-like autocracies, like Iraq's Saddam Hussein or North Korea' cult-like embrace of Trump, the convention provided a platform to some speakers who seem nuttier than a fruitcake. The Associated Press reports that "anti-abortion activist Abby Johnson, one of the speakers... advocated for 'household voting' in which each household is given a single vote, and said that, if differences arise, women should defer to their husbands." Good luck on winning suburban women's vote with that. Johnson has also said she would be fine with police

Kim Il-Sung. This mindless, mass kowtowing brings to mind a North Korean children's book I read many years ago where I was assured that when Kim Il-Sung visited a farm, overjoyed hens laid bigger eggs.

This year's Republican electoral efforts abound in absurdities. Along with the

older because "statistically, my brown son is more likely to commit a violent offence over my white sons." Another speaker, elementary school teacher Rebecca Friedrichs, argued that "public schools groom kids for sexual predators like Epstein and Ghislaine Maxwell, his longtime companion... by teaching them

basic sex education."

Some of the invited guests are no less bizarre. Marjorie Taylor Greene, a Republican congressional nominee from Georgia, was an invitee to the White House to attend Trump's acceptance speech. She supports the cockamamie QAnon conspiracy theory, which centres around an anonymous high government official called Q, who shares information about an anti-Trump "deep state" tied to satanism and child sex trafficking.

"She has also made a series of racist, anti-Semitic and Islamophobic comments, according to AP. Trump describes her as a "future Republican Star." God help Republicans, and God help us.

An unsurprising and inevitable fallout of the Trump cult has been the spread of one his worst attributes—his shameless mendacity. Take the lies about the Democratic National Convention spread by the right-wing echo chamber. Now, twisting the truth to nearbreaking point to make your side look good is a hallowed quadrennial American political exercise. What's remarkable here is how often they are making statements that are demonstrably false.

Take the canard that the Democratic National Convention had dropped "One nation, under God," from the pledge of allegiance. The claim was initially shared on Facebook by former US Republican senatorial candidate Peggy Hubbard, getting 1,000 likes. Trump joined in merrily. In a total of 30 council events, the reference to God was indeed removed—in just two events. On the national stage, "One nation under God" was mentioned on all four days.

Right-wing radio titan Rush Limbaugh also made the outrageous claim that Democratic presidential candidate former Vice President Joe Biden's widely admired acceptance speech was faked. Although nearly three dozen journalists, a small camera crew, several Secret

Service agents and many campaign staffers witnessed Biden's acceptance speech in the Chase Center in Wilmington, Delaware, Limbaugh claimed the whole thing was a fraud concocted by stitched-together edited clips. This despite Biden delivering the speech in front of reporters from ABC, The Washington Post, The New York Times, The Wall Street Journal and CNN, among others.

The important point, however, is that Trump is not the cause, but a florid manifestation of the long-term rot in the Republican Party. A decades-long veteran of the right-leaning think tank American Enterprise Institute, political analyst Norm Ornstein, along with centre-left Brookings Institution analyst Thomas Mann, wrote a scathing critique of the Republican Party in 2012, long before Trump was on the political horizon: "It is ideologically extreme, scornful of compromise; unmoved by conventional understanding of facts, evidence and science; and dismissive of the legitimacy of its political opposition."

Writing recently in The Atlantic magazine, Ornstein pines for a resurrected Republican Party that is "very conservative, but not radical. It would believe in limited government, but a government run by professionals, respecting data and science... It would believe in genuine fiscal discipline. It would try to apply free-market approaches to solving difficult problems, such as climate change. It would... insist that those in office adhere to high ethical standards." Then he delivered the coup de grace: "Sadly, even if Donald Trump is defeated in November, there is no sign that such a party will return anytime soon. But restoring the Republican Party to its traditional values is absolutely essential to preserve the core of our system of governance."





The door is filled with spiderwebs,


The ants are creeping on the wall,

A Book, a Bookstore, a City and the Aftermath

During the long lockdown in early 2020, I took much anticipated present; a rediscovery stock of my shelvedunread books. A mint-green through random stimulations in the present. hardback covered book-spine caught my eye;A Little Princess by Frances Hodgson Burnett. Almost always, I know the provenance of my books. Who? Where? When? Whom? Was it bought or gifted? Full-price or bargain-buy? On this book I drew a blank. In 2019, my sister had handed it over saying it belonged to me. It must have emerged from some carton of books that had travelled the globe with the family; got lost, then found by me during the 2020

On 29th May 2020, I opened the book and read the following inscription:

To Raana Ahmad

Pappa

Paris 17.5.'57 A clear blue and white sticker states:

W.H. Smith & Son English & French Books

248 Rue de Rivoli PARIS I do not recall ever having read this book.

Sixty-three years after being gifted this book by my father on my birthday on 17th May, I started reading Little Princess in May 2020. In hand was not a treasure found in the attic but its equivalent. Enhanced by the patina of age, I was reuniting with a precious item of immense personal value and considerable historical

W.H. Smith & Son, "the largest English bookshop in Paris" in the "City of Light" opened its doors on the elegant Rue de Rivoli in 1903. It was a regular source of children's books for us living in Paris in the mid-1950s. Birthdays and good report card results merited books as gifts in those days. Purchases were sugared by a climb to the upstairs English Tearoom which offered a full traditional tea service: egg and cucumber finger sandwiches, scones with clotted cream and marmalade; also fruit and chocolate cakes. Those childhood taste-bud memories remain fixed in one's mind and tongue. Over following decades, WH Smith ("Son" dropped out) continued being a lure for a "peeping person" to browse books and more often than not a visit upstairs.


Hemingway's A Moveable Feastis my current re-read for its heartfelt passages of devotion to Paris; including the unforgettable lines Hadley, Hemingway's wife marks: "There are so many sorts of hunger...Memory is hunger."My copy was bought on 12.09.97 notes the WHSmith sticker.I was once again living in Paris in the late 1990s. Mentioning to the salesperson my childhood association with this historical store brimming with beckoning books, I was presented with a "Carte de Fidelite" granting me 5% discount on purchases. My cup of wistful nostalgia was complete. I was told that many global customers return with such stories, now accompanied by their children and grandchildren. I had my daughter in tow.Only I was told that the English Tearoom had shut down sometime in the 1980s. Disappointment set in. The tea treat was part of the past and

To my utter delight, while researching this write-up, I took note that in 2016 the British Tearoom on the first floor had reopened, sponsored by Twinings of London. My "bucket list" in post-pandemic travel includes literary retail therapy downstairs and then culinary indulgence upstairs; while taking in the food with a view over the Tuileries gardens, the front facing landscape of the Louvre Museum.

Following reading A Little Princess and its personal Parisian association, I read My Life in France (1961) by Julia Child, the autobiography by the American celebrity chef whose books and television presentations on French cuisine became trademarks of her culinary expertise. I had bought this book few years back at W.H. Smith on Rue de Rivoli. With considerable amusement, I read of Julia's exasperation: "I've had it! I'm going to learn to speak this language, come hell or high water!...I signed up for a class at Berlitz...Paul, (husband and fluent in French) made up sentences to help my pronunciation: for the rolling French "r' s and extended "u" s, he had me repeat the phrase "Le serrurier sur la Rue de Rivoli" (""he locksmith on the Rue de Rivoli") over and over." Julia Child evolved into the consummate Francophile. An American cinema adaptation Julia and Jule was made in 2009 with Meryl Streep cast as the ebullient and efficient Julia

Frances Hodgson Burnett (1849-1924) was a British-born novelist and playwright who moved to United States as a teenager. She gained lasting success writing for children: Little Lord Fauntleroy (1885), A Little Princess (1905) and Secret Garden (1911). Although she had never been to India, the last two novels have Indian links and characters in the narrative. Once I Googled the author, I was taken aback to learn that A Little Princess was first adapted to screen as a silent film in 1917. The Hollywood child sweetheart Shirley Temple played Sarah Crewe in the 1939 "talkie" cinematic version of A Little Princess. In the 1970s, it was screened by the BBC as a mini-series; as well as a British-American production in the 1980s. The 1990s saw an American adaptation, a Filipino productionas well as a Russian book-to-screen adaptation of this ever-green children's book. A Little Princess endured sufficient appeal for a Japanese drama television series in 2009. To my utter amazement, it is available on YouTube from 5th March 2020. Her literary classics have been on offer for over a century - from silent film screening to YouTube.

Sara Crewe "Little Missus," a seven-year old English girl accompanied by her doting father arrives in London at "Miss Minchin, Select Seminary for Young Ladies." "Big Missus" had died in British India at Sara's birth.The duo had sailed from Bombay to this place. Since "the climate of India was very bad for children, and as soon as possible they were sent away from it generally to England and to school...She was



to have a pretty bedroom and sitting room of her own; she was to have a pony and a carriage, and a maid to take the place of the ayah who had been her nurse in India." Miss Minchin sensing financial credentials in the Crewes' dress and demeanour; upfront pampers but underneath resents Sara. "Sara had always been an annoying puzzle to her, because severity never made her cry or look frightened. making no complaint or outward sign of rebellion."An introspective child, she becomes "Mama" to lonely motherless four year old Lottie. Sara befriends Ermengarde St. John, "... she took

fancy to fat, slow, little Miss St. John." Sara's otherfriend Becky is the over-worked scullery maid, a fourteen-year old girl "but so stunted in growth." Sara's closest friend and confidante is her doll Emily. Mature and resilient beyond her tender years, Sara seeks to maintain composure to combat lonely turmoil, rigid regulations and hostile surroundings. Escapism is her inner narrative in adversity; retreating to a make-believe world; leaving this world to live in another sphere where in her father's eyes she remains "A Little Princess."

The turning point in Sara's life comes when

her father goes bankrupt in a diamond mine scam in India and dies of "jungle fever." She is now eleven years old. Her new status is revealed to her by Miss Minchin: "I tell you that you are quite alone in the world...unless I choose to keep you here out of charity." A bare, cold attic becomes Sara's room. No longer a student, she is now a servant. When Sara becomes "One of the Populace" as the chapter is titled; despite her physical and emotional upheaval, a survival mentality prods her: "Her way of doing it was to "pretend" and "suppose" with all the strength that was left in her... And once or twice she thought it almost made her more cold and hungry instead of less so."

An attic window opening introduces her to her neighbour, an Indian turbaned "lascar" Ram Das who lives in the attic room "The Other Side of the Wall." He is appalled at the child's misery. "The Magic" is instigated by Das and his English Saheb. Warm bedding, food, firewood and flowers appear in her room. Lo and behold, the narrative takes an even happier turn when Ram's employer is none other than her father's dear English friend from India who had also invested in the diamond mine. Only, there was no bankruptcy and Mr. Carrisford had been on the search for Sara who is the inheritor of a large fortune. Her imaginary role of "A Little Princess" becomes reality. "Once upon a time" could easily have been prefixed at the start of the story. And true to any fairy tale; Sara lives "happily ever after" as "A Little Princess." Any eight-year old would have been happy with its reading.

A unique literary experience has been measured some six decades later. The association between the book and its reader is enduring and textured; meaningfully layered with insight into human qualities, foibles and frailties. In these insecure times, do we not fall into moments of angst and despair? In the most unpromising of situations, there still lies the unexpectedness of the power of kindness, the offering of warmth and wisdom. In times of turmoil, internal and external; does not reading of choice offer a causeway to reflection, a hopeful window of escape? Here is a short read but replete with reflective thoughts and lasting takeaways. In the words of Zadie Smith, "Happiness is not an absolute value. It is a state of comparison.

Was A Little Princess a popular children's book recommended by the sales staff at W.H. Smith & Son? Was the Indian element influential in its selection? Did my father see it on display in the shop window? A biibliophile, had he read an article about the book and thought it would be an appropriate gift? Or did the book title simply appeal to him? I will never know. Pappa passed away in 1986.

FUTURE OF G2P IN BANGLADESH: THE CASE OF SOCIAL PROTECTION SYSTEM

The Daily Star in association with Policy Research Institute (PRI) of Bangladesh organised an online discussion titled "Future of G2P in Bangladesh: The case of social protection system" on August 06, 2020. Here we publish a summary of the discussion.



Dr Ahsan H Mansur, Executive Director, Policy Research Institute of Bangladesh (PRI)

Many social protection programmes which are operating under different ministries need to be consolidated; otherwise, there will be multiplication of the same process. Thus, reaching the deserving beneficiaries will not be possible. We must ensure that we select the beneficiaries who deserve to be supported by the programmes the most.

Currently the Bangladesh government runs more than 150 social protection programmes under more than 20 ministries/divisions that creates inefficiency and mis-targeting. Global experience suggests that a single authority is generally most desirable in administering the social protection (SP) system because the database involves issues of quality control, maintenance, classification, across geographic regions and social groups, updating through addition of new beneficiaries and deletion of ineligible ones, after reviewing new applications for support and other information. A dedicated data bank (may be under a separate Division within the main ministry) with data specialists is required to maintain and upgrade the massive databases. NID operations should be moved to the central database and made accessible to all relevant government agencies or eligible institutions. Equal access for all service providers on a competitive basis is a doctrine that should always be protected to ensure quality and enhance efficiency.

Government agencies engaged in commercial operations must operate on equal terms with private sector operators. This principle of even playing field is sometimes violated, giving exceptional privileges to some companies and consequently putting other companies in the same market at a disadvantage. There should also be no discrimination based on the ownership of companies by foreign and domestic entities.



Md Azizul Alam, Additional Secretary, Finance Division, Ministry of Finance

Since 2019, all major cash transfer programmes have been brought under G2P programmes. 70 percent of the social protection budget are under the cash transfer

programmes. The government has declared a few cash transfer programmes under the purview of 20 stimulus packages, and the resource allocation for the overall stimulus, mostly through the banking channel, is almost four percent of GDP. A big portion of this budget is also allocated to enhance and expand social protection programmes. One such programme is designed to give 2,500 taka per month to 50 lakh unemployed people. 38 lakh of these beneficiaries have already been provided with the stimulus through Electronic Fund Transfer (EFT). Bangladesh Bank's Bangladesh Electronic Funds Transfer Network (BEFTN) infrastructure was used to execute this programme. The current daily EFT capacity of BEFTN is about ten lakh, which may be doubled if run on two shifts. Monthly, we may need about three to four million EFTs.

In the previous fiscal year, one crore EFTs were made to beneficiaries under G2P operations. 46 lakh beneficiaries have been brought under the G2P programme. There are two types of programmes for the three major social welfare programmes, which include the distribution of allowances to the elderly, widows, and the disabled. One is for existing beneficiaries, and the other is for those who are newly enrolled.

G2P is an MIS-integrated electronic payment system; every department has its own MIS. When their MIS is formed, the databases that are created are interchangeable and can inter-cross. Therefore, the data from the 2,500 COVID-19 allowances that were to be provided to five million families was crosschecked with the data from other databases for pension, national savings deposit, old-age allowance, and widow allowance. At the back end, the G2P system provides electronic facilities that allow for integration with different national databases and help rectify and update the selection process.



Debdulal Roy, **Executive Director** (Programming), Bangladesh Bank

After National Payment Switch Bangladesh (NPSB) and MFS become intertwined, users will have access to financing through NPSB, even without EFT. NPSB, with the current setup, can make 220 transactions per second. If the capacity of the EFT-based system is insufficient, Bangladesh Bank can adjust this with the NPSB-based system to process the transactions faster.

If all customers could access their finances whenever necessary and at convenient places, a cashless payment method could be introduced. A uniform QR code can be provided so that anyone can access it to make a transaction. However, this method needs proper promotion. Moreover, if the transaction process requires a fee, the fee needs to be reduced so that the method can be utilised by younger people (students) and people living below the poverty line or in rural areas. The government is trying to introduce an interoperable digital transaction platform under the initiative of the ICT Ministry, which can allow the social safety net funds to be readily accessible to the general population.

The national household database should be organised with the help of Bangladesh Bureau of Statistics (BBS) to provide access to uniform data to all relevant agencies. Linking NBR's taxation or bank account information with the data can also help find the right beneficiaries and the amount of fund needed for a beneficiary.



Dr Shahadat Khan, Founder and CEO SureCash

The two most important things to consider are the beneficiary selection and the payment process. G2P payments are digital now and a payment platform is already available. All we need now is a reliable beneficiary database. But data collection, data management, and data processing are quite different from the payment of benefits. If we look at the architecture of G2P, the disbursements will be made by the relevant ministries and we understand data collection is a weak point for our country.

We usually think that financial service operators will do the work of data collection but G2P architecture says otherwise. There is a lot of work to be done in terms of data collection, data filtering, and data management by the government and local government officials who will be selecting the beneficiaries. There is also scope for collaboration here. After this comes beneficiary selection and then after collecting enough information, the MFIs open the beneficiaries' e-KYC accounts. The disbursement process that follows is a bit easier compared to the beneficiary selection and updating processes.

Through collective efforts along with ministries and other stakeholders, the responsible agency can check if there is duplication of beneficiaries or double dipping of benefits by recipients.



Kamal Quadir, CEO, bKash

A lot of work is being done for G2P payment. The current crisis would have been exceedingly difficult to tackle without the support of e-KYC. Even a few months back, MFIs could not open accounts digitally and the proactive policy support from the central bank in this matter is highly appreciated. MFIs need to focus more on the NID issue. Even after many years since the introduction of NIDs and the pandemic which struck Bangladesh, there are a lot of debates about whether enough people have NIDs. According to the Secretary of Finance, 110 million people have their NIDs, which is a large number. Therefore, we must make maximum usage of this infrastructure.

Sometimes the customers face inconveniences when the government agencies inform them about using certain services without considering their choices and convenience. Thus, we need to look into this issue.

Lastly, it is important to share the practitioners' experience whenever policy decisions are being made. Although our resources are increasing, most of the time we do not know where to find the proper resources. This is why we come up with solutions that make things more complicated.



Abedur Rahman Sikder, Deputy Managing Director (DMD), Dutch Bangla Bank Limited (DBBL)

We need to consider two parts of G2P. The first is the selection of the right beneficiaries which is quite challenging. The payment solution providers are usually not directly involved with this part. Our involvement comes during the payment process and when opening accounts where we must ensure the KYC procedure. After the selection of beneficiaries, the responsibility of making e-KYC falls on the payment solution providers. This payment can be through MFS, through the large agent banking network in our country, or through banks.

The costs must be considered as well. Through mobile banking, this cost can be a bit more sometimes and that is why for G2P, the authorities should look into other channels such as agent banking or bank accounts.

We hope that within the next financial year, all payments associated with various social security programmes will be made digitally. The stakeholders should equally promote agent banking accounts and bank accounts along with MFS since there are cost variations among these channels. This will provide the beneficiaries to choose from suitable options.



Md Shafayet Alam, Executive Director,

There are mainly three challenges to G2P. Firstly, the organisations providing allowances must want to adopt it. Next, they must have the ability to implement it. And, lastly, these organisations must be able to provide complete transparency throughout the whole process. As an MFS provider, Nagad works with the distribution channels. It is our job is to ensure that the remitted amount reaches the customer safely and they can use it conveniently. But the beneficiary selection process is not the job of MFIs. This is the responsibility of the allowance providing government organisations. The ultimate goal of the MFS providers is to get closer to a situation where the need for physical It is possible to conduct daily transactions by maintaining social distancing through MFS, especially if the service providers are dispersed. This will also help reduce the crowding that is still happening at banks. However, data authenticity is an issue because there can be cases where a person may not possess a mobile phone and/or NID and request the local representative to conduct transactions on his/her behalf. In such a scenario, manual intervention can play a part. No matter how much technology we bring in forward linkage, someone is selecting the ultimate beneficiaries and during that selection, we face the problems associated with the lack of honesty and authenticity. To resolve this, the local representatives can be brought under a disbursement channel. The agents who recruit these local representatives can be incentivised to provide authentic data and prevent malpractices. This may encourage local representatives or those involved in data collection at core levels to give authentic data, due to the commercial benefits involved.

Besides, technologies such as blockchain can be used to prevent trust manipulation since data is usually dispersed and therefore maintaining the authenticity will require such strong implementations.



Mohammad Ismail, Additional Secretary (Budget, Program and Assessment) and Additional Secretary (Institution and Disability), Social Welfare Ministry

There are some root level problems due to which our success rate is low in G2P expansion despite our efforts. Firstly, we are unable to motivate the union (local level) social workers who implement projects at the field level. Secondly, according to our estimates, around 10 to 15 percent of the people do not have mobile phones. The mentally disabled people who meet the age requirement, still rely on their guardians. We have created a categorical database of 19 lakh such people whom we give Suborno card, through which they obtain 450 taka per month.

The cards for widows, aged people, etc., that exist at the field level are misused. Cases arise where the actual beneficiaries do not get their money whereas the money is withdrawn by people whom the authorities are unable to trace.

There are very few banks which provide allowances every three months tend to keep the money for a year and

especially women, in both urban and rural areas, and farmers and other people in such occupations, through MFS. We can utilise e-KYC for providing these services as well. The effectiveness, efficiency, and transparency of all these services, including data preparation and selection, must be ensured from the beginning. BBS can help in this regard. Inclusive lists can be prepared by involving the local administration and the local NGOs. The overall efficiency will increase if we can bring everyone under MFS.



Khondoker Shakhawat Ali, Founder, Knowledge Alliance and Emeritus Fellow, Unnayan Shamannay

The main objective here is proper utilisation of public money while implementing the social safety net programme. There are both social and technical aspects of such objectives. We need to create a balance between these two to ensure transparency and accountability, otherwise government's initiatives will not reach the right people, no matter how much money we spend on these programmes. Our objective of alleviating poverty will eventually fail.

There are mainly three stakeholders here: designers and supervisors—they are the government bodies and the regulators; implementers—service providing organisations such as banks and MFIs; and the beneficiarieswhose interest should receive the highest

Improvement of the social protection system is a governmental prerogative, whereas money transfer concerns are determined by the market dynamics of service quality. Governance and compliance issues are important in maintaining the balance of the two. We understand that platforms such as Rocket are a single bankowned service, bKash is a subsidiary of a bank, SureCash is a technology provider for banks that offers the service, and Nagad is a service offered by Bangladesh Post Office. This gives us four different models in the MFS sector. However, all must work under the common MFS regulation under the purview of Bangladesh Bank to ensure compliance and governance; otherwise the interest of the beneficiaries will be grossly compromised.



Dr M. A. Razzaque, Research Director, Policy Research Institute of Bangladesh (PRI)

In the case of social security, despite having goodwill, we face the problem of selection error. We plan to support 50 lakh families during the COVID-19 crisis, but what is the basis of targeting specifically 50 lakh families? This programme of reaching 50 lakh families will only exist temporarily for one year and hence, will not be part of the social security structure. All the attention and manpower that will go behind this programme will give us no lasting



benefits in the future.

Dr Bazlul Haque Khondker, Director, Policy Research Institute of Bangladesh

The most important ministry working in the field of social security is the Ministry of Social Welfare. Many issues and challenges, particularly a problem with motivation, exist within this ministry because the personnel probably feel that G2P poses a threat to their jobs.

Even though a database of 19 lakh persons have already been created, a total of 92 lakh beneficiaries need to be covered, so a further 73 lakh persons should be added to the database for the expansion of the G2P. This will be difficult to accomplish in one to two years. Therefore, mitigating the challenges within the Ministry of Social Welfare is crucial. The government has stated that by 2025, all elderly eligible citizens will be given an old-age pension, which will effectively approach a universal pension system for all Bangladeshi citizens. This means that the ministry's work will increase drastically and managing the increased workload will be a

significant challenge. Clear information is required on the exact costs incurred in money transfers for the SP system which is now valued at 2.9 percent of GDP. Besides, letting customers choose which operator works best for them will create competition which, in turn, will give them more benefits.

RECOMMENDATIONS

A. Beneficiary Selection

- > Improvise issues related to data collection, data filtering and data management from the very beginning
- > Utilise technology along with other sources of information to determine the eligible beneficiaries accurately – that is, who should be brought under social safety net programmes and who should be
- A national household database should be established with the help of Bangladesh Bureau of Statistics and other government and local government institutions. All SP transfer providers should have real time access to the same national data bank as well.

B. Social Protection System

- > Bringing all social security programmes under a single network and administration should be the ultimate objective
- Although MOF is taking a lead role at the development stage, once the system starts operating, all issues related to G2P should rest with one ministry or agency within the Ministry of Social Welfare
- > Provide clear information on the costs incurred in money transfers

C. DFS (Digitise Financial System)

- > Promote agent banking and traditional bank accounts alongside MFS so that the beneficiaries can choose the channels that are convenient for them
- > Ensure equal access to all MFS operators on a competitive basis
- > Provide loan assistance to small entrepreneurs through MFS; utilise e-KYC here
- > Emphasise on making cash withdrawals from banks and other service providers easier, especially for the aged, widowed, and disabled people, while strengthening proper safeguards

MFS accounts can be integrated with ATMs and bank accounts very easily, within two to three months as the MFS operators are technically sound. However, challenges to this approach include: whether the concerned ministries are interested to implement it; the need for all stakeholders to work at the same pace, as this will help eliminate the risk of misunderstandings; and eliminating the perception that MFS operators take high service charge mostly for their own gains.

The efforts required and the stages and players involved in providing instant services to customers are huge. The MFS operators must pay retailers, distributors and other associates as well as pay fees to BTRC for these transactions.

Putin says Russian police force ready to help Belarus leader

Russian President Vladimir Putin said on Thursday the Kremlin has set up a reserve police force to support Belarusian leader Alexander Lukashenko but it would not be used unless the unrest there got out of control, Interfax news agency

Putin said Russia saw no need for now to use Russian forces in Belarus over the political crisis that followed a disputed Aug. 9 presidential election. Moscow felt the situation was normalising, the RIA news agency reported.

The former Soviet republic was plunged into turmoil following the election, which the opposition says was rigged to ensure that Lukashenko's 26-year rule was extended further.

Security forces have beaten protesters in the street and arrested thousands in a bid to stamp out mass demonstrations and strikes. Lukashenko denies electoral fraud.

"We have of course certain obligations towards Belarus, and the question Lukashenko raised was whether we would provide the necessary help," Putin said.

"I told him Russia would fulfil all its obligations. Alexander Grigorivich (Lukashenko) asked me to create a reserve police force and I have done that. But we agreed this would not be used unless the situation got out of control."

Maria Kolesnikova on Thursday was the latest opposition figure to be questioned by state investigators in a criminal case against a Coordination Council formed last week with the stated aim of negotiating a peaceful transfer of power.

Australia PM 'open' to repatriating NZ mosque gunman

Canberra is open to the idea of New Zealand sending the Australian-born gunman behind the Christchurch mosque massacre back home to serve his life sentence, Prime Minister Scott Morrison said yesterday.

White supremacist Brenton Tarrant was sentenced to life without parole on Thursday for the attacks on two mosques last year that killed 51 Muslim worshippers.

Soon after the punishment was handed down, New Zealand Deputy Prime Minister Winston Peters said Tarrant, 29, should be transferred to the Australian prison system.

"The Islamic community and all of New Zealand has already suffered enough without having to pay astronomical prison costs to keep him do the right thing by them," he said.

safe in our prison system," Peters said. Australia's Morrison said he had received no request to transfer Tarrant but he was prepared to talk about the prospect with his New Zealand counterpart Jacinda Ardern.

"Whether he is held in Australia or New Zealand, look we're open to that discussion," he told Seven News television.

That obviously has a lot of implications, these sorts of decisions. The prime minister of New Zealand and I will talk about those issues."

He said the wishes of survivors and bereaved family members would be paramount in any decision on Tarrant's future.

Tarrant, a former gym instructor from the rural New South Wales town of Grafton, moved to New Zealand in 2017 and immediately started planning an attack on the country's Muslim community.

Government documents show it is costing around NZ\$4,900 (US\$3,240) per day to keep Tarrant behind bars, compared to NZ\$302 for a regular prisoner.

The documents say he is "likely to have needs and present risk at a level of severity beyond any" managed in New Zealand before.

Tarrant has already caused issues for prison authorities, when a letter he wrote from jail was posted on the extremist website 4Chan in August last year.

In it, Tarrant praised British fascist Oswald Mosley and warned "there is a

Lawyers at Tarrant's sentencing this week revealed that in a pre-sentencing interview in April he said he had renounced his racist views and felt remorse for the attacks.

Investigators looking for MP Shahid's brother

Md Golam Mostafa, accountant of the recruiting agency, was arrested on August 20 in a case filed by several trafficking victims with Motijheel Police Station on July 7.

Mostafa on August 24 gave confessional statement to Dhaka Metropolitan Magistrate Masud Ur Rahman under section 164 of the Code of Criminal Procedure.

Speaking to The Daily Star yesterday, CID Deputy Inspector General Imtiaz Ahmed said, "We have found important information and got names of some persons involved in trafficking people into Kuwait. We are now analysing the information and

verifying those people's involvement." Imtiaz, however, refused to disclose the identities of the suspects.

Requesting anonymity, a top CID official said they were looking for Kazi Badrul's whereabouts.

"As Kazi Badrul's name has already surfaced in a confessional statement, we will bring trafficking charges against him," he added.

According to court sources, Mostafa in the confessional statement said he used to send people to Kuwait through Job Bank International as per directives of Kazi Badrul. These people were later received by Kazi Papul's agency Marafie Kuwaitia in Kuwait.

Mostafa said he had joined the

recruiting agency as an accountant in 2012. He said brokers used to persuade people to give money to them to have a better job abroad with good salary. But their dream for a better future would be shattered as soon as they would not get those jobs.

Mostafa claimed that one Taiveb used to frequent the recruiting agency to oversee the trafficking process, but he never met any fortune seekers.

The accountant further said he used to complete the ticketing and visa procedures of sending people to Kuwait through a recruiting agency named "Best Travel" in the capital's Fakirapool area. One Monir of the agency used to complete the other

processes, according to court sources. Besides depositing the collected money into the bank accounts of Kazi Papul and Kazi Badrul, Mostafa used to hand them cash amounts.

Mostafa said Kazi Badrul went into hiding after the Kuwaiti law enforcers and the government conducted drives at his brother's agency in Kuwait.

Mentioning that he was unaware of the human trafficking activities, Mostafa apologised for what he did for the recruiting agency, said court sources citing his confessional statement.

This newspaper could not reach Kazi Badrul for comments as his phone was found switched off.

The taskforce on Wednesday sent a letter to the posts and telecommunications ministry to this effect, officials said.

Goldman pays Malaysia \$2.5b as part of 1MDB deal

Goldman Sachs has paid Malaysia \$2.5 billion as part of a settlement over the US investment bank's role in the multi-billion-dollar 1MDB scandal, officials said vesterday.

The agreement, which has a total value of \$3.9 billion, was announced last month after lengthy negotiations. Billions of dollars were looted from sovereign wealth fund 1 Malaysia

Development Berhad in a fraud that involved former prime minister Najib Razak and his cronies. The cash plundered from state coffers bankrolled a global spending spree, and was used to buy everything

from artwork, to real estate and a

Goldman's role came under scrutiny over bond issues totalling \$6.5 billion it helped arrange for the investment vehicle, with Malaysia claiming large amounts were misappropriated during the process.

The settlement comprises a payment of \$2.5 billion to Malaysia and a guarantee that at least \$1.4 billion in assets acquired with misappropriated funds would be recovered.

A spokesman for Malaysia's finance ministry confirmed the cash part of the settlement "has been paid by Goldman Sachs and received via an escrow account" on Γhursday.

Bloomberg News reported the funds will be used to repay outstanding debts of 1MDB, citing a person familiar with the matter.

AFC Cup likely to be cancelled



Bangladesh champions Bashundhara Kings' journey in their debut AFC Cup campaign might be over after just a single match as the Asian Football Confederation (AFC) might be

forced to cancel the competition due to the aggravation of Covid-19 in host countries.

Bashundhara Kings took pole position in Group E with a 5-1 thrashing of TC Sports of Maldives in their opening fixture on March 11, but the Bangladesh giants' campaign was stalled immediately as coronavirus spread throughout the continent, forcing the continental body to reschedule the remaining group matches of the competition at centralised venues in September and

The Group E matches were rescheduled from October 23 in Maldives with two Maldivian sides along with and Chennai City of India and Bashundhara Kings the four teams. Vietnam, Bahrain, Kuwait and Jordan were the other four confirmed centralised venues, but no member nation has vet shown interest to be hosts for the four remaining groups.

With this issue in mind and the rising number of coronavirus cases in some of the host nations, the AFC is planning to cancel this edition altogether. The continental body has already cancelled its draw ceremony and it is believed that a decision of cancellation of the competition will come within a

week following analysis by the AFC bodies on the basis of recommendations by the competitions committee.

A Bangladesh Football Federation official, on condition of anonymity, said that cancellation is on the cards.

"There hasn't been any decision made yet as the internal bodies of AFC are analysing the situation. The coronavirus situation in host countries is a concern for the AFC. There are also the matters of air-travel and quarantine period in those countries. Hence it looks likely that the competition may not go ahead," said the official.

Mentionable here is the fact that AFC has already postponed the remaining rounds of the 2022 World Cup and 2023 Asian Cup joint qualifiers, which were originally scheduled for June this year and later deferred to October-November window, to

However, Bashundhara Kings are not taking their foot off the gas as yet as they are eyeing the domestic circuit and a probable friendly match with a foreign team. The team has already started its camp after completing Covid-19 tests of players and officials.

"We haven't been informed anything regarding cancellation officially, but we know there are issues with hosting of a few groups," Bashundhara Kings chairman Imrul Hasan told The Daily Star yesterday. "AFC Cup was our priority, but we have the domestic season to look forward to and we might play a friendly match with a foreign

"We feel very blessed to have been able to play the game of doubles for so long. We are grateful to have had the opportunities in the beginning of the year to play and say our goodbyes to the fans. Flood deals a heavy blow to fish farmers

The sector incurred Tk 479.85cr loss in last few months, says govt report

STAR REPORT

The fisheries sector has suffered a loss of about Tk 479.85 crore due to heavy rains and floods, according to a report by the fisheries department.

Ponds, lakes and fish farms on around 17,000 hectares of land have been inundated in 208 upazilas of 36 districts, said the report released recently.

Nearly 6,000 tonnes of fish fry were washed away,

directly affecting around 72,000 farmers. During the recent new moon and depression in the Bay of Bengal, swollen rivers in Patuakhali washed away

around 1,000 tonnes of fish from 7,280 ponds and other Between August 19 and 22, the rivers flowed about 68

cm over the safety mark in some places of the district. The fishing industry and fish farmers were also hit by cyclone Ampan on May 20 when fish worth Tk 24.57 crore

got washed away. Al Mamun, 48, a fish farmer at Char Jamuna village of Rangabali upazila, said his fish farm on five acres of land

have been inundated and ruined about 15 days ago. He added that he was just trying to recover from the losses caused by Ampan.

Shrimp farmers in Bagerhat said they have suffered more in recent weeks than during cyclone Amphan.

In the last few days, incessant rains and tidal waters have

251 lives lost in floods in last 2 months

A total of 251 people died in 33 floodhit districts in the last two months, said a report by the National Health Crisis Management Unit of the health

Majority 210 of the dead were drowned, according to the report which has compiled these deaths between June 30 and August 27.

Among others, 13 died from lightning strikes, 25 from snake bites, one for diarrhea, and two others of wound. According to the report, a total of 57.301 people fell sick in differen disease including diarrhea, skin disease, inflammation of the eye, tracheal inflammation.

Of them, the highest 57,301 suffered from diarrhea.

As of the end of July, around 37 percent of the country's total area has been flooded, according to Prof AKM Saiful Islam of Buet's Institute of Water and Flood Management.

People of low-lying areas were the worst affected victims of this natural disaster. Many of them were waterlogged for over a



Scientists develop injectable robots



Scientists have created an army of microscopic four-legged robots too small to see with the naked eye that walk when stimulated by a laser and could be injected into the body through hypodermic needles, a study said Wednesday.

Microscopic robotics are seen as having an array of potential uses, particularly in medicine, and US researchers said the new robots offer "the potential to explore biological environments"

One of the main challenges in the development of these cell-sized robots has been combining control circuitry and moving parts in such a small

The robots described in the journal Nature are less than 0.1 millimetre wide -- around the width of a human hair -- and have four legs that are powered by on-board solar cells.

Biden threat to 'American Dream'

Says Trump as he accepts GOP nomination for second term

AFP, Washington

President Donald Trump tore into his election challenger Joe Biden as a threat to the "American Dream" in a bruising speech on Thursday night accepting the Republican nomination for a second term against a backdrop of racial tensions and the deadly coronavirus pandemic.



The former celebrity real estate developer spoke at a grandiose event staged at the White House -- the first time a president has ever held a party convention at the executive mansion -- and followed up with a vast fireworks display on the National Mall.

In his 70-minute address, Trump went after "weak" Biden as hard as he could, attacking him by name dozens of times in an attempt to define the veteran centrist former vice president, who leads in polls ahead of the November 3 election, as a radical leftist.

"No one will be safe in Biden's America," he said.

"This election will decide whether we save the American Dream," Trump said, rejecting Biden's main campaign slogan about saving America's soul.

"He's the destroyer of America's jobs and given the chance, he'll be the destroyer of American greatness.' The relentless verbal assault contrasted with Biden's
