Amphetamine Smuggling

Banned chemical brought from India by road, sent abroad by air

A group of chemical traders in Chennai are found to be the kingpins of amphetamine smuggling from India through Dhaka, according to an investigation by the Department of Narcotics Control.

About a year ago, the unscrupulous traders started to use Bangladesh as a smuggling route and ship the banned chemical to several destinations, mostly in Australia and Malaysia, under false

declaration and without the knowledge of courier companies.

Amphetamine could be processed into yaba and sold to addicts in the countries where the crazy pills of Myanmar have started to get popular. Bangladesh banned import of this chemical and its use in the production of cold medicine in February 2017. India also has banned its export, say

The Chennai-based group linked up with some chemical importers at Mitford medicine hub to run the smuggling smoothly for a year, until a package of 12.32kg amphetamine powder was seized from the cargo

village area of Hazrat Shahjalal International Airport on September 9. The Mitford allies were being paid handsomely by the drug racket upon every successful shipment of couriers, found narcotics officials

The contraband was brought to Dhaka by land "every three days" and sent to different countries -- each consignment containing 12 to 20 kilogrammes of amphetamine powder.

Kamalapur station may shift northward

Bangladesh Railway and the metro rail authorities have agreed to a new plan which requires shifting of Kamalapur Station Plaza to a nearby location to make space for extending the MRT-6 line up to Kamalapur from Motijheel. The existing plaza will be demolished

nd a similar one will be built north of it as per the new plan that will turn the station into a true transport hub, Railways Minister Nurul Islam Sujan told The Daily Star after a meeting between the two sides yesterday. Prime Minister Sheikh Hasina will make

the final decision in this regard as the existing plaza, an iconic structure, has to be demolished to implement the new plan, he mentioned.

"The metro rail authorities [Dhaka Mass Transit Company Limited] agreed to the new plan proposed by Kajima Corporation [a Japanese company]. We also accepted the plan, subject to the prime minister's approval," he said.

Seeking anonymity, a railway official, who attended the meeting, said the station plaza has to be shifted 130 metres north of its current location to implement the new



"If the existing plan is implemented, the station will be completely shadowed by the MRT-6 [Mass Rapid Transit] structure. There is no option but to shift the station because even if the existing plan is modified, the station will be partially shadowed by the MRT-6 structure," the official pointed out.

Officials of Kajima Corporation, which is leading the Kamalapur Multimodal Transport Hub (MmTH) Sub Working Group, placed the new plan at yesterday's meeting at Rail Bhaban.

The BR and the DMTCL, the implementing authority of the country's first metro rail, have been in a dispute over extension of the MRT-6 line from Motijheel

Hasina also said there should be proper management to ensure there is no waste as the vaccine is a "sensitive" drug.

On November 5, the government signed a trilateral memorandum of understanding (MoU) with Serum Institute of India (SII) and Bangladesh's

SMART NID FOR EXPATRIATES

EC sending staff to 40 countries

Tk 100cr set aside for this

The Election Commission will send its officials to 40 countries to hand smart NID cards to the Bangladeshis living there.

The work in this regard will start once the Covid-19 situation improves and the EC plans to deliver the cards in Malaysia, Saudi Arabia, the UAE, Kuwait and the UK in the first phase.

Tk 100 crore was set aside for the work from the funds of Identification System for Enhancing Access to Services (phase-II) Project, which will be implemented from this December to November 2025 spending Tk

Phase-II of the IDEA project was approved at the meeting of the Executive Committee of the National Economic Council yesterday. After the weekly Ecnec meeting, Planning Commission member Abul Kalam Azad said the new project had been undertaken as the tenure of the first phase of the IDEA project would expire in December. He said the EC would send its teams to 40 countries which host the

largest number of Bangladeshis to include their names in the voter list and provide them with NID cards. He also said the EC teams would work in coordination with the

respective embassies under the new project. Talking to The Daily Star yesterday evening, IDEA Project Director Brig

Gen Mohammed Saidul Islam said they planned to spend Tk 2.5 crore for the work in each country on average.

"But we will need more than Tk 2.5 crore for some large countries as we will need to send several teams at the registration points there," he said.

While the government taken steps to ensure victims gender-based violence such as rape can go to local-level bodies for remedy,



these initiatives largely fall flat because of little action and

In 2014, the women and children affairs ministry formed a Nari Nirjaton Protirodh Committee (NNPC) in every union with the aim of combating the scourge of child

marriage and violence against women in the country. The role of the committee, headed by the union parishad chairman, is to create awareness about genderbased violence and child marriage by holding a wardbased monthly meeting, according to a gazette published on May 11, 2015.

Each committee also includes three female and three male UP members nominated by the UP chairman, one teacher nominated by the UNO, one community police, one local NGO representative, one imam, and one Nikah

The ministry also formed an NNPC in every upazila and district, where the UNO and the DC respectively are the heads of the committee. At the union level, these committees are supposed to

Slum fire ravaged everything they had

Rahmat Mia, 23, lives in a tin-shed room with a monthly rent of Tk 3,500 with his wife, mother, sister and niece in

Rahmat was struggling to make ends meet and had two months' worth of rent pending.

While he was already worried about how to run his family in the days ahead, the horrific fire at the slum on Monday night burnt everything to ashes.

Rahmat's family was able to save their lives but all their belongings were

The fire broke out around 11:45pm, gutting 72 houses and 26 shops.

Rakib Islam, 15, sustained burn injuries from the fire. The boy, who works as a labourer, has been undergoing treatment at Sheikh Hasina National Institute of Burn and Plastic Surgery around 2:00am since yesterday with 25 percent burns.

Firefighters suspect the fire began from an electric short circuit, while locals say it originated in a shop.

During a visit to the slum yesterday, Rahmat was found searching for anything that could be salvaged from his burnt possessions.

Describing how he came to know about the fire, Rahmat said it occurred after they all had fallen asleep following dinner at 10:00pm. They woke up to people shouting and then saw the fire right next to their house.

Rahmat said ever since they came to the slum 16 years back from their village home in Narsingdhi due to struggles, their home had burnt down twice, rendering them helpless and in financial ruins.

"Ten years ago, our house was first burnt. We struggled very hard to save money and buy household items. But now, everything is gone again!" he said with grief.

Like Rahmat, every victim has their own story to tell.

Beauty Rani Chandra was seen crying as she looked at the wreckage inside her home. All the belongings of her oneyear-old family, include her wedding attire, were burnt to ashes.

Her husband Dulal Chandra said that though his income dropped due to pandemic, he managed to save some money even after family expenses and house rent.

He saved Tk 40,000 to pay off a Tk 1

However, the money and his wife's gold were destroyed in the fire. "With everything else, our dreams of our future have also been destroyed. I do not know how will I be debt free," he said.

Shilpi Begum, another resident of the slum, said she lived there for ten years with her husband and two children. The fire reduced my 10-year savings to ashes," she wailed.

She and other victims of the fire sought help from the government and from those who are financially well off.

Over the year, at least 600kg was smuggled out of Bangladesh after its arrival from India. One kg of the powder sold at Tk 1 crore.

The DNC learnt all this while probing a case filed over the seizure in September and after arresting 13 people, including six staffers of a courier service. So far the investigators found the

six were unaware that the courier service was being used for smuggling the contraband as they don't have the capacity to detect it. All of them already secured bail last month. Seven other arrestees -- Abul Kalam

Azad alias Bunty, a chemical trader in the capital's Mitford Hospital area, Junayed Ibne Siddiqui, and Bunty's associates Rezaul Haque Bablu, Nazrul Islam, Babul Mazumdar, Md Mazed and Md Bappi -- are now in jail.

Junayed, who is from Chandpur, met Chennai-based chemical trader Habib Master in Bahrain in 2018. In the Gulf country, he was running the real-estate business of his father-inlaw, who passed away the previous

Junayed later met Bunty and Indian nationals Rajkhan and Satish and their operations began.

Apart from the railways minister, Salman F Rahman, private industry and investment adviser to the PM; Salim Reza, secretary at the railways ministry; Md Shamsuzzman, director general of the BR; and MAN Siddique, managing director of the DMTCL, attended the meeting.

DISPUTE OVER EXISTING PLAN

The latest development comes two weeks after the Sub Working Group formed by the Japanese government provided Bangladesh with an alternative plan for extending the MRT-6 line up to Kamalapur.

The group said the existing design would seriously hamper the prospect of turning the country's premier railway station into a true transport hub.

It sent a letter to the railways secretary in the first week of November, giving details of its alternative plan, ministry sources said.

Besides, the Japanese ministry of land, infrastructure, transport and tourism wrote to the Public Private Partnership Authority of Bangladesh, saying the alternative plan of the sub-working group would bring down costs, compared to that under the existing plan.

The Kamalapur hub is going to be established under public-private partnership model with governmentto-government initiative between Bangladesh and Japan. The MRT-6 line was initially

designed as an elevated line from Uttara to Motijheel. Later, a skywalk was planned to connect the line with Kamalapur Railway Station. Last year, the DMTCL planned to stretch the MRT-6 line directly to the

railway station following the PM's directive. Bangladesh Railway opposed Kamalapur MmTH.

Railway officials said they were not against the extension of MRT-6 line up to Kamalapur, but the DMTCL's current design would upset their MmTH plan. They had asked the DMTCL to modify its blueprint.

The DMTCL sought help of the Prime Minister's Office in resolving the issue. The DMTCL plan was given the go-ahead at a meeting with PM's Principal Secretary Ahmad Kaikaus in the chair on September 3.

The meeting also directed the railways ministry to take immediate steps to allow setting up of MRT-6 station and a scissors crossing at Kamalapur Railway Station. YESTERDAY'S DECISION

The railways minister said that as per the existing plan, the railway station will be shadowed by the elevated structure of MRT-6 and the loop line that allows trains to change direction. "We had reservations about the plan.

Kajima also expressed its reservations. As per the new plan, the loop line (scissors crossing for trains to change direction) would not go towards the station, rather it would go in a different direction.

"We have taken the decision at today's meeting. If the prime minister agrees to the plan, we will move forward with it.

"Once the design-related problem is solved, we will sign a MoU [memorandum of understanding] with Kajima for establishing the hub," the minister mentioned.

He further said they have to shift the Inland Container Depot from Kamalapur to Dirasram in Gazipur, and a development project proposal has already been prepared to that effect.

Despite repeated attempts, MAN Siddique, MD of the DMTCL, could not be reached for comments over his mobile phone yesterday evening.

The picks underline an emphasis on professionals whom Biden already knows well, in contrast to the Trump White House where officials were often picked without having traditional background for the job or proved incompatible and departed in acrimony.

Biden and Vice President-elect Kamala Harris were expected to formally introduce their appointments in Wilmington, Delaware yesterday. **DWINDLING OPTIONS** The president, meanwhile, has largely

Singapore deports 15 Bangladeshis over social media posts 'inciting violence'

Singapore has deported 15 Bangladeshis over social media posts that incited violence or encouraged communal unrest in response to recent terror attacks in France, officials said yesterday.

"We will need to modernise and enhance the database and server as the number of people and voters are increasing every day. Although the target of distributing smart NID cards was initially set at nine crore, we now have around 10.98 crore voters," said

Abul Kalam said the major operations of the project include production and personalisation of smart cards.

"We've placed a recommendation at the meeting that the NID services be brought under the revenue budget, instead of keeping it under any project," he said.

Meanwhile, Planning Division Senior Secretary Ashadul Islam said the government was planning to bring all data registration activities, including NID registration, birth and death registration, and the registration activities carried out by Directorate General of Family Planning under a single entity.

The five-year-long first phase of the IDEA project was launched in 2011, aiming at establishing a secure, accurate and reliable national identification system in Bangladesh.

During the first phase, the commission is supposed to have personalised and supplied NID cards to about nine crore voters up to upazila level. However, it has so far personalised and supplied 6.5 crore cards till date, said EC officials.

After missing four deadlines, the first phase of the project is now set to be completed next month. Its cost has risen to Tk 1,696 crore, up from the primary budget of Tk 1,379 crore.

DAP threatens 70pc natural waterbodies

Architects, urban planners slam proposed mega plan for Dhaka

Despite LGRD Minister Tajul Islam's assurance at a press conference last Sunday that Dhaka will be transformed into a modern and liveable city, the proposed Detailed Area Plan (DAP) for the capital is facing severe criticism from architects and urban planners.

At a press conference yesterday, members of Institute of Architects Bangladesh (IAB) spoke at length about the flaws in the DAP draft, which has been formulated by consulting firms Sheltech and DDC under a work order by Rajdhani Unnayan Katripakkha (Rajuk).

Implementation of this draft will result in seventy percent of natural waterbodies disappearing, architects warned, adding that flood flow zones will be severely hindered under this plan

"There is a clear point in the Terms of Reference for preparation of the DAP, which mentions demarcating rivers, canals, water bodies, water retention and catchment areas based on surveys done during the British and Pakistani eras and mouja maps," said Jalal Ahmed, president of IAB.

"The draft DAP has ignored this point, and proposed a modification in the classification of flood flow zones," he said. Flood flow zones are areas which typically remain dry, but store water

during rainy season. These are essential to prevent waterlogging in the city. "The draft DAP proposes two separate terms for the current zones -primary waterbody and general waterbody. This draft mentions allowing construction (conditionally) on the general waterbodies, which will be severely detrimental to the city and its people," said Jalal Ahmed.

Eight years on, survivors still cry

Police yesterday barred the victims of Tazreen Fashions factory fire from going to Gono Bhaban, on the eighth anniversary of the tragedy where at least 113 workers were killed and 172 injured as fire wrecked the garments factory in November 2012.

The workers -- injured in the deadly fire - were marching to see the prime minister to press home their three-point demand.

They had been staging a sit-in in front of Jatiya Press Club in Dhaka for more than two months, day and night, demanding proper compensation and treatment.

The workers were barred by the law enforcers around 12:15pm. When they faced the barricade, they started to protest there and shouted slogans in favour of their demands.

Rehana Akhter, an injured worker, told reporters that four of her family members died in the deadly fire.

Cases against 'Golden Monir'

Rab calls on NBR, BRTA, CID for investigation

Rapid Action Battalion (Rab) yesterday sent letters to three separate agencies to investigate the irregularities and wealth of Monir Hossain, also known as Golden Monir.

Those three agencies are National Board of Revenue (NBR), Bangladesh Road Transport Authority (BRTA) and Criminal Investigation Department (CID).

Lt Col Ashique Billah, legal and media wing director of Rab headquarters, confirmed the development to The Daily Star.

"We have sent the letters to BRTA to check documents of his vehicle, CID to check money laundering issues and NBR to check whether he evaded tax. We would provide all necessary legal assistance to the agencies if they need any, said the media wing director.

Meanwhile, the investigation of the three cases filed against Monir were transferred to the Detective Branch (DB) of police yesterday, Parvez Islam, officer-in-charge of Badda Police Station, told The Daily Star.

Rapid Action Battalion filed the three cases under the Special Powers Act, Narcotics Control Act and Arms Act with Badda Police Station on November 22.

Never-ending wait for justice

Perpetrators of rape, violence thrive amid perpetual legal proceedings, activists say

On February 12, 2018, a Tangail court -- in just 14 days -- sentenced four men to death and another to seven years' imprisonment for raping and murdering law student Rupa Khatun on a moving bus.

Many praised the quick trial, which is regarded as a milestone for the Women and Children Repression Prevention Tribunal.

"Around three years has passed, and proceedings are still ongoing at the High Court. I don't know when this'll end and whether we'll get justice. I don't know anyone at the HC and couldn't get any update about the case," said Rupa's brother Hafizur Rahman Pramanik, in a press conference at Jatiya Press Club yesterday.

Amrai Pari Paribarik Nirjaton Protirodh Jote (We Can) and Nari Nirapotta Jote, a platform working for women's safety, organised the conference.

Ramzan Hossain, father of Suraiya Akter Risha -- who was knifed on a footbridge by her stalker Obaidul on August 24, 2016 in the capital's Kakrail -- also shared a similar experience, as Obaidul received death

penalty and Tk 50,000 fine in August last year, but proceedings are still ongoing at

Ramzan could hardly speak a few sentences and broke into tears.

The two platforms organised the conference to present a nine-point demand to stop violence against women (VAW) and children, and ensure speedy trial of VAW cases. Of the nine points, two were that VAW cases should be settled in 180 days, and the HC must settle such cases on a priority basis within the prescribed time.

The other demands include ensuring proper security, necessary treatment and compensation for survivors, children and their families during trial proceedings; modernising and sensitising the process of taking witnesses in VAW cases; ensuring necessary policies and actions by the government to execute the 2009 High Court guideline to prevent sexual harassment; making the Domestic Violence (Prevention and Protection) Act 2020 successful; adopting a zero-tolerance policy

Investigate forced marriage between 85-year-old man and minor: HC

The High Court vesterday directed authorities to conduct an inquiry into the reported incident of forced marriage of an 85-year-old man and 11-year-old girl in Jamalpur and to submit the probe report to this court on November 29.

According to a news report published in the daily Samakal on November 21, local influentials of Bairapara village under Dewanganj upazila in Jamalpur on November 18 forced 85-year-old Mohir Uddin and 11-year-old girl to marry each other. They also tortured the elderly man at an arbitration, as his grandson Mihir Uddin allegedly raped the girl, the report said.

The HC asked the DC and superintendent of police in Jamalpur and OC of Dewanganj Police Station to conduct the inquiry and provide victims with protection. The bench of Justice FRM Nazmul Ahasan and Justice Shahed Nuruddin came up with the suo moto order after Deputy Attorney General Abdullah Al Mahmud Bashar placed the newspaper report before the judges.

ATTACK ON HASINA'S MOTORCADE

SC clears way to resume trial

The Appellate Division of the Supreme Court vesterday upheld a High Court verdict that cleared the way for a lower court to resume trial proceedings of a case filed over the attack on motorcade of the then opposition leader and now Prime Minister Sheikh Hasina in Satkhira in 2002.

A four-member bench of the Appellate Division headed by Chief Justice Syed Mahmud Hossain came up with the order after dismissing a petition filed by Rakibur Rahman, an accused in the case, challenging the HC verdict. On October 8, an HC bench led by Justice Mustafa Zaman Islam

cleared the way for the lower court concerned to resume the case's trial proceedings. Following the petition filed by Rakib, another HC bench on August 23,

2017 stayed the proceedings and issued a rule asking the state why the trial proceedings against Rakib should not be scrapped. In the petition, Rakib claimed that he was 10 years old when the incident took place in 2002 and therefore, the trial proceedings of the case

filed under the Penal Code against him cannot be run. During hearing on the petition, Rakib's lawyer AM Mahbub Uddin Khokon told the court that the trial proceedings against his client (Rakib) could take place under the Child Act, 2013 as he was a minor at the time

of bomb attack Meanwhile, Additional Attorney General SM Munir argued that Rakib was 32 years old during the incident as per the FIR. He did not inform the trial court that he was 10 years old during the time and therefore there is no legal bar to run the trial against him.

Convict Abu Naser refused bail

The apex court, however, ordered the authorities concerned of Chattogram jail to admit him to Chattogram Medical College Hospital for his treatment, if it is necessary, and to send him back to the jail after completion of

A four-member bench headed by Chief Justice Syed Mahmud Hossain came up with the order after hearing a petition filed by Chowdhury seeking bail on health ground.

Lawyer Nozrul Islam Chowdhury appeared for him while Attorney General AM Amin Uddin represented the

Ghulam Rabbani, a former Korean Export Processing Zone managing director and a former aide-de-camp of Bangabandhu, was shot in the throat by criminals at Muradpur in Chattogram on his way to the KEPZ on April

Thirteen days later, Rabbani, who also had been a vital prosecution witness in both the Bangabandhu murder and the jail killing cases, succumbed to his injuries at Bumrungrad Hospital in Bangkok.

Rabbani was reportedly killed following a conflict between him and a few of his colleagues at the KEPZ over his appointment as its MD, and termination of two employees of the KEPZ before and after his appointment.

Abu Naser and one Md Selim, two convicts of the case, were sent to jail on their surrender before a Chattogram court on December 15, 2016.

62 fined for not wearing masks in **Barishal**

Barishal Administration yesterday fined 62 people Tk 11,200 in total for not wearing masks in the city, to check the ongoing Covid-19 pandemic.

Three mobile courts took the action in drives from morning to afternoon at various important points of the city including Bibir Pukur, Sadar Road and Chawkbazar areas, said officials.

The fined people include pedestrians, rickshawpullers, and three-wheeler drivers as they did not wear masks at that time.

Magistrate Executive Subrata Kumar spokesperson of the district administration, said the campaign was aimed at making people aware of the coronavirus pandemic. He assured of continuing such drives

She also had been working at the factory at that time. The only reason she is alive now as she jumped out from the factory building when the fire broke out.

Another injured worker, Jorina, told The Daily Star, "I have been participating in the demonstration here for around two months. I jumped from the building's third floor when the fire broke out in the factory. Now I am living with a broken leg, with no compensation for it."

Meanwhile in Savar, survivors, family members and labour leaders yesterday demanded capital punishment for those responsible for the fire, reports our correspondent.

"We could do nothing except sit in front of the burning building and watch the workers die. This was not an accident -- it was a systemic murder," they said.

Taslima Akhter, president of Bangladesh Garment Shramik Samhati, said, "There has not been a single conviction for any of the RMG disasters where garment workers died. This impunity cannot go on. The negligence of the government as well as the garments owners' association must also be investigated."

On November 24, 2012, fire broke out

at Tazreen Fashions Limited, a garments factory in Ashulia, some 35km from Dhaka

When the workers attempted to leave the building, the management locked it from the outside. Some 113 workers were killed in the fire. Many jumped through the windows of the building to save their

Two cases were filed with Ashulia Police Station against the factory owner and others. Police submitted charge sheets in both the cases against 13 people, including the factory owner Delwar Hossain, in September 2015.

The cases are currently under trial at the Additional Sessions Judge Court-1 in Dhaka. Tazreen's managing director Delwar Hossain is out of jail on bail.

Rakib Hassan Shohag, president of Garment Workers Tailors League (Savar, Ashulia unit), said most of the time witnesses remain absent on hearing dates.

Yesterday, the victims urged the government to build a hospital and a dormitory for survivors on the land where the factory is located. They also placed wreaths in front of the factory in remembrance of those who lost their lives in the incident.

60 shanties gutted in fire at Mohammadpur

Sixty shanties were gutted after a fire broke out yesterday at Jahuri Mahalla slum in the capital's Mohammadpur area.

The fire originated at the slum around 4:15pm. On information, ten firefighting units rushed to the spot and doused it around 5:45pm, said Shahjadi Sultana, duty officer of Fire Service Headquarters Control Room.

The cause of the fire could not be known immediately, she said. No casualty was reported.

Shanto, employee of a private firm who lives nearby, said the fire originated in the middle of the slum.

He said the slum is known to locals as "Pora Bosti", as there were several fire incidents before.

"Much of the information and statements in the plan are not supported by solid research, or they did not disclose whatever research was done," said IAB architects.

The draft also incorrectly cites the Dhaka Metropolitan Building Rules-2008 Construction "obstructive", said the architects. "The 2008 rule dictates that every building must have some specific amount of open space to allow sunlight and wind to pass through for healthy ventilation," said Nasir.



Prices of vegetables remain high in the local markets of the district as local growers cannot cultivate early varieties of winter vegetables timely this year due to bad weather. Because of continuous heavy

rains and floods during the peak season, cultivation of early winter vegetables has been delayed in Pirojpur, said farmers, adding that they were also badly affected by the bad weather.

The actions, or lack thereof, of the Eklashpur NNPC in Begumganj of Noakhali is a prime

The committee remained non-functional before the horrific September 2 gang rape and torture of a woman in Joykrishnapur village of Eklashpur union, video footage of which went viral on social media in the first week of October, triggering a firestorm of protest.

The victim did not go to the committee as she knew nothing about it in the absence of its activities. She rather went to UP member Moazzem Hossain days after the incident, seeking his help to get justice but to no avail.

"I went into hiding after the incident, and I was not being able to walk after the severe torture and beating. Still, one of my sisters and I managed to go to his house and narrated the torture I endured," she told The Daily Star recently.

"But he did not believe me, rather he told me that those boys were not that bad and that I might have done something wrong.

The head of Eklashpur NNPC and UP Chairman Khalilur Rahman couldn't be reached as he is currently sick. Moazzem has been in jail since his arrest on October 6.

Md Shihab Uddin, member secretary of the committee, said they first sat in October after the incident. He admitted that the committee had, until then, been inactive.

Begumganj UNO Shamsun Nahar, however, claimed all six of the UP committees in the upazila, including Eklashpur, hold such meetings and send their agendas regularly.

Asked how she got the agendas when

no meetings were held in Eklashpur, for instance, the UNO said there were no separate meetings on incidents of violence against women and of child marriage. "When the six UPs hold joint meetings, these issues are raised there.

The death of 14-year-old Nurnahar of

Kauljani union in Tangail due to marital rape on October 25 revealed that the Kauljani NNPC had no visible activities to stop child

Bellal Hossain, member secretary of the committee, said they weren't informed about the early marriage of Nurnahar.

He said the committee hadn't held any meeting or awareness programme this year or maintained a record relating to child

There have been multiple instances where rape survivors and victims of gender-based violence did not receive any remedy from these committees.

Even, Anna Begum, a member of Jhanpa UP of Manirampur upazila in Jashore, was allegedly beaten with the sandal of the head of her committee in August last year, when she asked for an Eid bonus. She was expelled

from the committee. Contacted, the committee head, UP chairperson Shamsul Haque Montu refuted the allegation, saying the woman was of 'immoral character and she used to be

involved in sex work earlier." MONITORING NEEDED

According to the latest report of Ain o Salish Kendra (ASK), at least 975 rapes, 208 gang rapes, and 43 murders after rape occurred across the country in the first nine months of

Despite being armed with various laws, the fight against gender-based violence still remains an uphill challenge. The NNPCs have a major role to play in this regard at the grassroots level, experts said.

They stressed monitoring NNPC activities in order to make these more functional and accountable.

Shaheen Anam, executive director of Manusher Jonno Foundation, said there has to be a strict monitoring mechanism so that these committees can be held accountable for their activities.

She referred to how in the Eklashpur gang rape and other incidents of violence against women, the media and rights bodies played an active role in helping survivors get access to remedies.

"But is it possible in every case? The system must be working and every committee must be held accountable for their actions."

A project of ASK has been providing gender awareness and sensitivity training to NNPC members and advocating for lawful mediation in the five most violence-prone districts, since 2017.

Khaleda Khanom, team leader of the project, ASTHA: Strengthening Access to Multi-Sectoral Public Services for GBV Survivors in Bangladesh, said most of these committees were inactive before the rights

body started working with them.
"The members of the committees didn't know about their roles. We found most of the people went to the UP chairman and members to report the violent incidents, and they would do both lawful and unlawful mediation in rape or severe injury cases," she said.

"In rape incidents, they would also never maintain confidentiality, which affects the survivors. In the case of severe domestic violence incidents, they would often try to mitigate the issue by sending the victims back to their husbands, without ensuring fruitful measures so that these incidents aren't Contacted, Dr Abul Hossain, project

director of the multi-sectoral programme on violence against women at the women and children affairs ministry, said they don't usually review the activities after publishing

"However, we often tell the DCs to monitor it. The minister and secretaries also urge them to reactivate their activities," he said.

Attack on Ichhachhara Punjee

Separate land commission urged for plain land indigenous communities

At least ten non-government organizations, campaigning for land and human rights of marginalised population, called on the government to protect indigenous communities living in Ichhachhara Punjee of Kulaura upazila.

They made the call on Saturday while visiting Ichhachhara Punjee (village) where indigenous communities came under attack on November 9 over possession of a betel leaf garden belonging to an indigenous family at Katabari Paan Jum (betel leaf garden).

In order to promptly settle land disputes of indigenous communities living on plain land across the country, the organisations also urged the government to take immediate steps for creating a separate land commission for plain land indigenous communities.

The members of the rights organisations also met with Moulvibazar deputy commissioner (DC) and Kulaura upazila nirbahi officer (UNO) on Sunday.

Association for Land Reform and development (ALRD) representative and Programme Officer (Law) AKM Bulbul Ahmed said the land commission for plain land indigenous communities should be comprised of members of the communities and there should be a law that bans the transfer of land from indigenous people to non-indigenous people.



Abdul Karim Chowdhury, general secretary of Sylhet unit of Bangladesh Paribesh Andolan (Bapa), said the role of indigenous people in protecting forest, bio-diversity and environment is undeniable and a threat to their existence could easily be defined as a threat to natural forest and wildlife.

Manusher Jonno Foundation Senior Program Manager Evelina Chakma, Coordinator of Indigenous Environment Movement of Bapa in Sylhet division Father Joseph Gomes OMI, KUBRAJ General Secretary Flora Babbly Talang, Nizera Kori central activist Mizanur Rahman, Bapa Habiganj unit General Secretary Tafazzal Sohel, Bapa organiser in Moulvibazar ASM Saleh, Bangladesh Environmental Lawyers Association's Sylhet unit activist Al Amin Sarder, Bangladesh Legal Aid and Services Trust's Sylhet district Programme Officer Satyajit Kumar Das and Dr Ali Ahsan Chowdhury also spoke, among others, at Ichhachhara Punjee.

Evelina Chakma said, "I witnessed the problem faced by the indigenous people after visiting the spot."

The administration needs to make sure should take strict action against violators of that these issues are handled properly and

the media needs to cover the issues with due importance, she added.

Moulvibazar DC Mir Nahid Ahsan said the representatives of the rights organisations praised the steps taken by the administration over the attack on indigenous communities at Ichhachhara Punjee.

He also said the issue was discussed at the district's law and order meeting and a case was already filed over the attack and vandalism at the village.

On the night of November 9, several hours after Kulaura upazila administration in a raid evicted illegal occupants from a betel leaf garden belonging to an indigenous family at Katabari Paan Jum, a church was ransacked and at least one person sustained injury during an attack on Ichhachhara Khasi village.

Around 50 to 60 men armed with local weapons, led by Rafiq Ali, who had been evicted from the garden several hours earlier, first vandalised a grocery store owned by one Lal Mia around 7:00pm and they later ransacked the nearby church too, locals said, adding that when the attackers started to throw stones at houses up on the hills, at least one person was hurt while running to safety.

3 arrested in rape cases in 2 districts

Three people were arrested in two rape cases in Magura and Jashore on Monday night.

In Magura, Rab held two people on charges of gang-raping a 42-yearold woman, a mother of three, on Monday night.

However, the Rab officials did not disclose the arrestees' identities for the sake of investigation.

The victim's family members said they are inhabitants of a village in Jhenidah's Shailakupa. The village is situated in a bordering area of Jhenidah and Magura.

The victim along with her husband used to stay in a makeshift tent near a paddy field at night in Jagla village of Magura Sadar upazila to carry the harvested paddy to its owner's house on their horse cart.

During the paddy cultivation season every year, they normally do this work and get paddy or money

Around 1:00am on Sunday, five unidentified criminals attacked them with sharp weapons.

The criminals tied the victim's husband to a tree and gang-raped the woman at knifepoint. They also looted Tk 5,000 before leaving the scene.

Hearing their screams, locals later rushed there and rescued the couple.

The victim later filed a case against five unknown criminals with Magura Sadar Police Station, said Joynul Abedin, officer-in-charge of the

On Monday night, Rab arrested two people from Baittapara Bazar in Magura Sadar upazila over their alleged involvement in the incident. They were being interrogated, said Lt Col Sarwar Hossain, company commander of Rab-6 in Jashore.

In another incident, police picked up a man from Jashore's Keshabpur on Monday night over the rape of a housewife

The arrestee is Abu Sayed, 33, of Bhaina village of the same upazila.

Police said both the victim and the accused are neighbours. On Sunday night, Sayed asked the 35-yearold victim to go with him to bring medicine from a village doctor.

He then took the woman to nearby Dangir Beel and raped her with the help of some of his associates.

The victim lodged a case with Keshabpur Police Station accusing Sayed and three others.

The other accused -- Sirajul Islam, 33, Jasim Uddin, 32, and Siddiqur Rahman, 30, -- are residents of other villages in the same upazila.

Police were conducting drives to arrest the other accused, said Jasim Uddin, OC of Keshabpur Police

"People see our profession as demeaning, but we do it to buy food. I am trying to make sure women in this profession are not left hungry, and their children will not have to do this work," Rina Akter told BBC.

Rina runs a daily drop-in shelter for sex workers in Gopibagh. Floating sex workers who work at night can come to this shelter in the morning to bathe, eat, rest and get treatment for sexually transmitted diseases.

Rima Sultana Rimu is an 18-year old peace activist, and a member of Young Women Leaders for Peace in Cox's Bazar.

This programme -- part of the Global Network of Women Peacebuilders funded by United Nations Women -- aims to empower young women from conflict-affected countries to be leaders and agents of

Rima responded to the Rohingya refugee crisis in her community by advocating for gender-responsive humanitarian action.

She organises gender-sensitive, age appropriate literacy and numeracy classes for Rohingya refugees, and for women and girls in the community who lack access to education.

"I am determined to bring gender equality to Bangladesh. I believe in the power of women and girls to fight for our rights. We will succeed," she said while talking to BBC.

Journo Kajol gets HC bail

issued a rule asking the authorities concerned of the government to explain why Kajol should not be granted bail in the case.

In the petition, Kajol said he is ill and the section of the law under which he has been implicated is not applicable to him as he did not defame anybody.

After hearing the petition, the HC bench yesterday granted permanent bail to Kajol.

The HC bench also asked the investigation officer of the cases lodged against Kajol with Hazaribagh and Kamrangirchar police stations whether he has taken permission from the Cyber Tribunal to probe the cases after 75 days of filing the cases.

The investigation officer and the Cyber Tribunal have been ordered to submit separate reports to the HC by December 15.

The HC bench passed the order after Kajol's lawyer Jyotirmoy told the court that the investigations of the two cases are illegal as the probes had to be concluded within 75 days of filing

The investigation officer has not completed investigations of the cases in 75 days, which is a violation of the relevant provision of the law,

Deputy Attorney General Sarwar Hossain Bappi represented the state during the virtual hearing on the bail petition.

On August 24, Judge KM Emrul Kayesh of the Metropolitan Sessions Judge's Court of Dhaka refused to grant bail to Kajol in the case filed under the Digital Security Act.

Dhaka Metropolitan Magistrate Dhiman Chandra Mondol rejected his bail petition in the case on June 24.

Two other cases under the Digital Security Act were filed against Kajol on March 10 and 11 with Hazaribagh and Kamrangirchar police stations.

Fifty-three days following his disappearance after leaving his office in the capital's Hatirpool, Kajol was found by Border Guard Bangladesh in Benapole on May 3.

He was then arrested, initially on charges of trespassing, but was granted bail after being produced before a Iashore court.

Later, he was shown held under section 54 of the Code of Criminal Procedure (CrPC) after police informed the court that three more cases against Kajol were pending with different police stations in the capital.

The court then sent him to Jashore

The world is still engulfed in the unprecedented health crisis which has shattered economies, infected almost 58.9 million people and left nearly 1.4 million dead.

Russia's Sputnik V coronavirus vaccine is 95 percent effective according to a second interim analysis of clinical trial data, its developers said yesterday.

The two-dose vaccine will be available on international markets for less than \$10 (8.40 euros) per dose, they said, and will be free for Russian citizens.

It can be stored at between two and eight degrees Celsius (between 35.6 and 46.4 degrees Fahrenheit), they said, instead of the temperatures below freezing required for some other vaccines.

AstraZeneca and Oxford University on Monday said their drug had proved on average 70 percent effective at stopping the virus after trying it on 23,000 people, days after tests of two other drugs suggested they were more than 90 percent effective.

The French head of AstraZeneca

says in an interview with AFP that three billion doses of the vaccine will be made available in 2021 at cost -around 2.50 euros (\$3) per dose.

The European Union has struck a deal for up to 160 million doses of US firm Moderna's Covid-19 vaccine candidate, the head of the European Commission said yesterday, taking the EU's potential stock of Covid-19 shots to nearly 2 billion.

Last week, Moderna said its experimental vaccine was 94.5 percent effective in preventing Covid-19, based on interim data from a latestage clinical trial.

Indian Prime Minister Narendra Modi warned yesterday that any Covid-19 vaccine could lead to side-effects in some people, as even popular medicines do, and that the government would only go by science in finalising one for the country.

The comments came ahead of the possible launch of the Oxford-AstraZeneca vaccine by early next year in India

While World Health Organization Director-General Tedros Adhanom Ghebreyesus hailed the latest batch of results as light at the end of the "long dark tunnel", he cautioned that the world had to ensure drugs were

QANTAS VACCINE RULE

Australia's Qantas announced that international travellers will need to be vaccinated against Covid-19 to fly, becoming the first airline to suggest rules could become common across the industry. Chief executive Alan Joyce said the

carrier would implement the measure once a vaccine was made available to the public. Certainly, for international visitors

Following Qantas' announcement, Australian Health Minister Greg Hunt said "no final decision" had yet been taken on how to proceed when vaccines are available, but indicated vaccination or a strict two-week quarantine would be a condition for entry.

'We would expect that people coming to Australia whilst Covid-19 is a significant disease in the world will either be vaccinated or they will isolate," he said.

Australia's Victoria state announced its last coronavirus patient had been cleared of Covid-19 -- a major milestone for what had been the epicentre of the country's second wave.

But in China, where the virus was first detected late last year, hundreds of flights at Shanghai's Pudong International Airport were cancelled after a small cluster of cases in the city was linked to several cargo handlers.

And officials in Hong Kong ramped up already tight social distancing measures following a local spike in infections, shuttering bars, pubs, party rooms and nightclubs. All live performances and dancing have also been banned.

ANTONY BLINKEN: Secretary of State Joe Biden nominated his longtime adviser Antony Blinken to be secretary of state. Blinken, 58, served as deputy secretary of state and deputy national security adviser during the Obama administration and has close ties with Biden. He is widely viewed as a pragmatic

centrist on foreign policy who has supported past American interventions and is well respected by some Republicans.

ALEJANDRO MAYORKAS: Homeland Security Biden announced the nomination of Alejandro Mayorkas, who served under Barack Obama as deputy secretary of Homeland Security and director of the Citizenship and Immigration Services. If confirmed by the Senate, Mayorkas, who turns 61 on Tuesday, would be the first Hispanic, and immigrant, to lead DHS. Born in Havana, Cuba, Mayorkas came to the United States as a political refugee with his family when he was a child.



AVRIL HAINES: Director of National Intelligence Haines, 51, was the first woman to serve as Deputy Director of the CIA, a position she held from 2013 to 2015. If confirmed, she will be the first woman to oversee the 17 agencies that make up the nation's intelligence community. Biden's team are also vetting Representative Deb

Haaland for the interior Secretary Post. She'd be the first Native American cabinet secretary.

JANET YELLEN: Treasury Secretary Biden has chosen former Federal Reserve Chair Janet Yellen to serve as treasury secretary, a pivotal role in which she would help shape and direct his economic policies at a perilous time, according to a person familiar with the transition plans. Yellen, who is widely admired in the financial world, would be the first woman to lead the Treasury Department.



LINDA THOMAS-GREENFIELD: Ambassador

Joe Biden's pick to be the next US ambassador to the United Nations, if confirmed by the Senate, would be the most experienced diplomat of the six people named by Biden for top national

security positions on Monday. Linda Thomas-Greenfield is a 35year veteran of the State Department who served as ambassador to Liberia, director general of the foreign service and top diplomat for Africa before being forced out during the early months of the Trump administration. Biden plans to elevate the position of UN ambassador to Cabinet level.

JOHN KERRY: Climate Envoy

John Kerry, one of the leading architects of the Paris climate agreement, is getting one more chance to lead the fight against climate change after Biden named the former secretary of state as climate envoy for national security. It's a sign of how the incoming administration is heeding warnings that natural disasters from global warming will weaken US defense and spur conflicts around the globe. Unlike others, this role doesn't need Senate confirmation.

JAKE SULLIVAN: National Security Adviser

Biden will appoint Jake Sullivan to be his national security adviser. Sullivan, who at 43 will be one of the youngest national security advisers in history, was a top aide to former secretary of state Hillary Clinton before becoming then-vice president Biden's national security adviser.

Poorest must not be trampled: WHO

With Covid-19 vaccines on the horizon, the planet's poorest must not be trampled as countries scramble to get their hands on them, the World Health Organization said Monday.

WHO director-general Tedros Adhanom Ghebreyesus said the latest batch of promising results from final-phase candidate vaccine trials showed there was light at the end of the "long dark tunnel" of the coronavirus pandemic.

But he said the world had to ensure they were distributed fairly across the globe. "Every government rightly wants to do

everything it can to protect its people," Tedros told a virtual press conference.

"But there is now a real risk that the poorest and most vulnerable will be trampled in the stampede for vaccines."

AstraZeneca and Oxford University said their prospective vaccine had proved on average 70 percent effective at stopping the virus after trying it on 23,000 people, days after tests of two other candidate vaccines suggested they had more than 90 percent effectiveness.



"With the latest positive news from vaccine trials, the light at the end of this long dark tunnel is growing brighter. There is now real hope that vaccines in combination with other tried and tested public health measures, will help to end the pandemic," said Tedros.

"The significance of this scientific achievement cannot be overstated. No vaccines in history have been developed as rapidly as united front was punctured by Angela Merkel who these. The scientific community has set a new voiced concern about slow progress.

Anticipating the huge demand for any approved vaccine, the WHO has helped create the so-called Covax facility to ensure equitable distribution. Tedros said 187 countries were now on board.

The international vaccine procurement pool aims to lay its hands on two billion doses of safe and effective vaccines by the end of next year.

However, it is struggling to raise the funds needed to provide for the 92 low-income countries and other economies that quickly signed up.

Tedros said \$4.3 billion was needed immediately to support the mass procurement and delivery of Covid-19 vaccines, tests and treatments, while a further \$23.8 billion would be needed in 2021.

"The real question is not whether the world can afford to share Covid-19 vaccines and other tools; it's whether it can afford not to," said Tedros.

Leaders at the virtual G20 summit said Sunday they would "spare no effort" to ensure fair distribution of coronavirus vaccines, but the

Biden pushes new approach to EU ties

President-elect Joe Biden spoke with the heads of the European Union institutions and Nato on Monday in a round of calls seen as part of his efforts to repair tattered transatlantic

Biden "underscored his commitment to deepen and revitalize the US-EU relationship," a statement from his office said after a call with Ursula von der Leven, the head of the European Commission.

In a marked difference in tone from US President Donald Trump, branded the EU a "foe" and accused it of ripping off the US in trade, Biden expressed his hope that the two sides would "cooperate on common challenges."

Von der Leyen sounded upbeat and optimistic.

"Great to speak with President-elect JoeBiden,' von der Leven tweeted. "It is a new beginning for the EU-US global partnership ... working together can shape the global agenda based on cooperation, multilateralism, solidarity and shared values," she

Biden has already spoken to a host of European leaders bilaterally, including German Chancellor Angela Merkel, French President Emmanuel Macron and British Prime Minister Boris Johnson.

Both Biden, and his nominated secretary of state, Antony Blinken, have both criticised Brexit, a key concern of EU, and have expressed concern about the impact on peace on the divided island of Ireland.

Biden also spoke to the head of the transatlantic Nato defence alliance, Jens Stoltenberg, telling him of the "United States' enduring commitment to Nato - including its bedrock principle of collective defence under Article 5." Article 5 is a mutual defence clause which holds that an attack on one Nato member is an attack on the whole

ASTRAZENECA-OXFORD VACCINE

'Half-dose' method intrigues experts

Evidence suggesting an initial half dose of the vaccine being developed by drugs firm AstraZeneca and the University of Oxford is more effective than a full dose is counterintuitive, and even took the researchers by surprise. Why would less be better than more when it comes to triggering an

Andrew Pollard, the director of the Oxford Vaccine Group, described the findings from the Phase 3 clinical trial as "intriguing".

They showed that the vaccine had an efficacy of 62 percent among the people given two full doses a month apart. But this rose to 90 percent for another group who received a half-dose first and then a full dose after a month.

Sarah Gilbert, professor at Oxford's Nuffield Department of Medicine,

said the better result with a smaller initial dose could be because this better "mimics what happens in a real infection". Essentially a vaccine uses a safe method to trick the immune system into believing it is dealing with a dangerous infection, triggering an immune

response and an immune memory that can activate if the body comes across the real pathogen. The Astra/Oxford vaccine employs what is known as a "viral vector",

using engineered viruses to deliver genetic cargo into cells, giving them instructions on how to fight SARS-CoV-2. The strategy uses the transporting virus as a "Trojan Horse"

The head of AstraZeneca in France, Olivier Nataf, in an interview with AFP called the development an opportunity cause it will require fewer doses to vaccinate more people. He also said the vaccine offers 100 percent protection against the occurrence of severe forms of illness and hospitalisations. Finally, he said, there is greater simplicity in storage, transport, handling, under normal refrigeration conditions of 2 to 8 degrees. And the price of the vaccine is less than most of its rivals: around 2.50 euros (\$3) per dose.

Darwin notebooks 'stolen' from Cambridge University

Two of Charles Darwin's notebooks containing his pioneering ideas on evolution and his famous "Tree of Life" sketch are missing, believed stolen, the Cambridge University Library said yesterday. The British scientist filled the leather notebooks in 1837 after returning from his voyage on the HMS Beagle. The library said they were worth millions of pounds. In one book, he drew a diagram showing several possibilities for the evolution of a species and later published a more developed illustration in his 1859 book

"On the Origin of Species". The University of Cambridge's vast library first listed the notebooks as missing in 2001. They were long believed to have been incorrectly filed within the building, which contains around 10 million books, maps and manuscripts and has one of the world's most significant Darwin archives. However a major search this year -the largest in the library's history -- failed to turn up the notebooks.

Pope, for first time, says **Uighurs are 'persecuted'**

In a new book, Pope Francis for the first time calls China's Muslim Uighurs a "persecuted" people, something human rights activists have been urging him to do for years. "I think often of persecuted peoples: the Rohingya, the poor Uighurs, the Yazidi," he said in a section where he also talks about persecuted Christians in Islamic countries. In the wide-ranging "Let Us Dream: The Path to A Better Future," Francis also says the Covid-19 pandemic should spur governments to consider permanently

establishing a universal basic income. In the book, a 150-page collaboration with his English-language biographer, Austen Ivereigh, Francis speaks of economic, social and political changes he says are needed to address inequalities after the pandemic ends. It goes on sale on Dec. 1.

Pakistan behind Kashmir attack, India tells UNSC India on Monday told the main UN Security

Council powers that it feels pressure to hit back at Pakistan after accusing its neighbour of arming four militants shot dead in a gun battle last week, diplomats who attended a special meeting said. Prime Minister Narendra Modi has said the four were plotting "to wreak major havor" with an attack aiming to disrupt local elections in the disputed territory of Kashmir starting this week. A top Indian foreign ministry official handed over a dossier to envoys from the Security Council permanent members -- the United States, France, Britain, Russia and China -- which it said showed Pakistan involvement in the militant operation. India said the four were planning the "biggest" attack since a suicide bomber killed 40 Indian paramilitaries in Kashmir in February 2019.

Aussie PM lams pressure of US-Sino rivalry

Australia has hit out at "needlessly" worsening relations with China, with the country's prime minister appealing for smaller nations not to be caught in the crossfire of Sino-US rivalry.

Prime Minister Scott Morrison decried mounting Chinese pressure and rejected the portrayal of Australia as a US lapdog, saying it was wrong and "needlessly deteriorates relationships" in an online speech to a London forum late Monday. Morrison insisted Australia wanted "mutually beneficial" relations

with both its largest trading partner and the United States, while having the right to pursue its own interests independent of both. In recent months, Canberra's relationship with Beijing has gone from

In a nod to the incoming administration of US president-elect Joe Biden, Morrison also insisted countries like Australia should not be asked to pick sides as Washington and Beijing duke it out for influence.

"Greater latitude will be required from the world's largest powers to accommodate the individual interests of their partners and allies. We all need a bit more room to move," Morrison told the UK Policy Exchange.

During the last four years, US President Donald Trump has taken a confrontational approach, trying to rally allies to counter China's rising influence, something critics say risks creating a Cold War-style standoff between two competing power blocs.

Ethiopia war in 'decisive phase'

Fear for civilians grows as Tigray leader tells PM his people 'ready to die' resisted calls for mediation and insists and reportedly killed hundreds and

International pressure mounted yesterday on the warring parties in northern Ethiopia to cease fighting and protect civilians in Tigray, whose leaders Prime Minister Abiy Ahmed has given a deadline to surrender.

The UN Security Council was to convene its first meeting on Tigray later yesterday, where forces loyal to the region's ruling party have been battling Ethiopian soldiers for nearly three weeks, sparking a refugee exodus, civilian deaths and fears of broader instability in the Horn of Africa.

Abiy, last year's Nobel Peace Prize winner, ordered troops, tanks and warplanes into Tigray on November 4 in response to an alleged attack on federal military camps by the Tigray People's Liberation Front (TPLF).

The army says it has encircled Mekele, the regional capital, ahead of a threatened all-out assault.

the conflict has reached a decisive final stage, on Sunday gave the TPLF 72 hours to surrender -- an ultimatum rejected by the dissident region's leader, who says his people are "ready to die" for the homeland.



The prospect of a devastating bombardment of Mekele, a city of half a million people and a refuge for many more fleeing the conflict, has alarmed rights groups who warn such an attack on a civilian centre could contravene international law.

forced many more to flee within Tigray, though the true extent of death and displacement is not yet known. A communications blackout and

The TPLF on Monday said it routed an army battalion and claimed responsibility for a rocket attack on Bahir Dar, the capital of Amhara region to the south of Tigray, whose local forces are fighting alongside Ethiopian troops. The government said that "a large number of Tigray militia and special forces are surrendering" following the

issuance of Abiy's 72-hour ultimatum. Long-running tensions between Addis Ababa and the TPLF, which dominated Ethiopia for nearly three decades before Abiy came to power in 2018, boiled over in September when Tigray proceeded with regional elections in defiance of the federal government, which declared the vote illegal.

Former Tazreen workers deserve fair recompense

Why do they still have to agitate for what they are rightfully owed?

■ HAT former workers of Tazreen Fashions Limited would have to agitate for fair compensation even after eight years since a fire ravaged the factory, killing over 117 workers and permanently disabling many others, is a damning indictment of the true state of Bangladesh's apparel industry. While the authorities shamelessly advertise the success of this industry, about 45 workers have been silently and helplessly protesting on the sidewalks outside the National Press Club for 70 days now. They wouldn't leave the premises until their demands of dignified compensation, rehabilitation and justice are met. These demands are by no means unfair, nor impracticable, yet beyond a cursory visit by the representatives of BGMEA and the Department of Inspection for Factories and Establishments (DIFE), nothing has been done to address their grievances.

The apathy with which their demands have been treated is not surprising, given how often it happens to victims of workplace accidents and mass layoffs in Bangladesh. But this tactic of totally refusing to acknowledge them, without so much as a meaningful contact from the authorities, boggles the mind. Why has no one reached out to negotiate their terms? Can a government simply ignore the existence of a section of its citizens? Is it some unholy test of their endurance? The workers say, of the 173 injured workers listed for compensation, only 45 got some kind of financial support. The number is far less than the official count of workers said to have received compensation—and the amount received is a pittance at best. Although labour activists have long demanded that the compensation for permanently disabled workers be equal to their lifetime's earnings, as per the Bangladesh Labour Act, the amount of compensation is only Tk 1 lakh in case of death, and Tk 1.25 lakh in case of permanent disability—one of the lowest in the world

It is high time the legal provisions for compensation for deceased and injured workers were reformed in line with the gravity of their loss. Many of the former Tazreen workers were the sole bread earners of their family, and they have been living a miserable life since the accident, unable to find work or retain their jobs for long because of their invalidity. Those "lucky" enough to have received some compensation saw it wither away, as is only natural, while those who caused their sufferings through their negligence or complicit silence are being let off the hook. This cannot go on any longer. The government must take the responsibility of these workers and ensure they receive proper compensation, rehabilitation and medical treatment. And those responsible for their sufferings must be brought to book.

Antibiotics losing efficacy

Random and indiscriminate use should be checked

NE wonders whether we are looking at an impending health crisis, with the most effective medicine that we have known to fight bacteria of various classifications well-nigh becoming ineffective due to their random and indiscriminate use. It has been more so during the Covid-19 pandemic, which saw increased consumption of antibiotics as a quick fix against a hitherto unknown virus. It is feared that most of the nearly one crore people in Bangladesh who had suffered illnesses that mimicked Covid-19, took antibiotics and other drugs. One wonders what we might face in the future if 17 antibiotics are losing their efficacy against the 10 types of illnesses caused by bacterial infection. In future, we will have been left with only three drugs to fight bacterial diseases. These fears are based on extensive studies carried out by specialists and specialised institutions.

The health ministry and relevant administrations should explore the reasons for the situation coming to such a pass. They must take heed of the findings of the National Technical Advisory Committee on Covid-19 and ensure that all protocols related to the treatment of the pandemic are followed. One of the reasons for the quantum rise in the use of antibiotics is the violation of this protocol. Also, there is much to be said about quality of the drugs; as usual, lack of monitoring and failure to ensure the production standards in pharmaceutical industries have led to lower quality drugs entering the market. It is essential also to take measures to stop antibiotics from entering the food chain, which is happening due to non-therapeutic use of antibiotics for fattening up animals. It is time to consider banning over-the-counter sale of antibiotics. More than any other country, we believe, we have more people who are disposed to self-medication. There is also the practice of not finishing antibiotic courses that has contributed to resistance to antibiotics.

This matter demands immediate attention. Otherwise, the fear of the chairman of Pharmacology at BSMMU—that we might not have any drugs left to treat bacterial infections in future because all the known bacteria have acquired resistance against extant antibiotics—may come true.

16 DAYS OF ACTIVISM AGAINST GENDER-BASED VIOLENCE

Why is it so difficult for Bangladeshi women to get justice?

N 2015, Salma's husband and his parents held her down and poured nitric acid down her throat because they wanted more than the Tk 100,000 (USD 1,100) that her parents had already paid in dowry. For months since the wedding, her father-in-law had beat her repeatedly, demanding more. Salma went to stay with her parents to escape the abuse. But when villagers started gossiping about her broken marriage, her parents told her to return to her in-laws. When she said she was being physically abused, they told her "you just need to endure." Now, she is fed through a tube in her stomach.

Salma's story is disturbingly common in Bangladesh, where over 70 percent of married women and girls have faced some form of intimate partner abuse, about half of whom say their partners physically assaulted them. But the majority of women never told anyone about this abuse and only three percent take legal action.

In many cases like Salma's, survivors seeking help are turned away—by family, community, and the police—and can be in even more danger when forced to return to their abuser. When Salma tried to escape the violence, she was met with stigma and—with only a handful of government-run shelters in the country

and limited access to support services—she had nowhere else to go.

Salma has fought for a legal remedy for over five years now, but to little avail. Her father, meanwhile, had a stroke and the family cannot afford to continue pursuing justice. The public prosecutor bringing the case told her that her inlaws were paying more bribes so she women and girls seeking legal recourse never have to give up.

The 16 Days of Activism is an annual international campaign in which governments and activists come together to address violence against women and girls. It runs from November 25, the International Day for the Elimination of Violence against Women, until December

"should pay more money." "That is how you will get justice," he told her. He too, of course, requested bribes, she said.

Every time they go to court to find out the status of the case, court officials, police and the prosecutor all ask for "tea and snacks costs," Salma said. Now she says she is telling her father, "You have been going to the courts for the last five years and nothing is happening. Let's just give up."

But there are concrete actions the the Bangladesh government and donor governments can take now—during the 16 days of activism against genderbased violence—so that Salma and other 10, Human Rights Day.

The Bangladesh government should work with concerned donor governments, activists and the UN to conduct an audit of currently available shelters, disseminate this information, and commit to opening at least one shelter in each of Bangladesh's 67 districts by 2025. Shelters should remove restrictions that limit their accessibility, such as requiring court orders to stay there or restricting the presence of children. No woman or girl should ever have to "just endure" violence because there is nowhere else to go.

The law ministry should immediately

create an independent commission to appoint public prosecutors to ensure their independence. Donor governments like the US that are involved in justice reform should ensure that training for public prosecutors and police emphasises working with victims of gender-based violence and consider joint training for prosecutors and investigating officers to improve coordination on cases of gender-based violence.

As Salma described, as cases go on for years, justice officials frequently demand bribes, making it more and more difficult to continue to pursue justice. This problem is exacerbated by a lack of transparency and accessibility of case information, given Bangladesh's 3.7 million-case backlog. Without a centralised filing system, cases get lost and survivors are forced to pay bribes to get court officials to find their case information and move cases forward. The German government led an impressive justice audit in Bangladesh and would be well-placed to spearhead a project to move case files into a centralised online filing system-genderbased violence cases would be a good place to start.

The Bangladesh government should ensure that legal aid is reaching women and girls in need and that they are aware of their rights. Last year, the national legal aid services organisation distributed funds to 2.5 times more men than women.

The law commission drafted a witness protection law nearly a decade ago—it should be passed into law in consultation with Bangladeshi women's rights organisations, and donor governments should support the implementation of a witness protection programme.

Violence against women and girls is so pervasive in Bangladesh, it is sometimes dismissed as unsolvable. For these 16 days of activism, the government and donors should listen to activists who are offering workable solutions.

Championing women's empowerment in a time of crisis

ANGLADESH has come a long way in its fight for women's advancement. The government has prioritised promoting gender equality and women's empowerment as a key development agenda and has undertaken several policy and programmatic measures consistent with its goals. Consequently, Bangladesh has made commendable progress over the past decade and leads South Asia on closing the gender gap in areas such as women's economic participation, educational attainment, health and political empowerment.

Women's empowerment has also been a prime focus of the tripartite partnership between the Government of Bangladesh, UNDP and Sweden. Over the years, we are proud to have supported the government in a range of efforts that helped Bangladesh move forward, from expanding gender-sensitive social protection to countering violence against women and girls.

But challenges remain. Traditional gender roles still prevail. Only about 36 percent of Bangladesh's women participate in the labour market. An estimated nine out of 10 working women are in the informal economy and have less savings and access to social protection than men. Many are burdened with unpaid care and domestic work.

The Covid-19 pandemic is exacerbating these challenges. The hard-fought gains for women's empowerment are under threat. Females have been disproportionately impacted when countries announced national lockdowns to contain the pandemic. A UN survey highlights that, in Bangladesh, about 25 percent of female respondents reported losing informal jobs, while another 24 percent saw decreased working hours. Overall, they also received less support compared to men.

In addition to the loss of livelihoods, Covid-19 is affecting human development for women and girls. For example, they are likely to experience more food insecurity than males in the same household. While domestic work increased for both women and men during lockdowns, the burden of unpaid childcare work falls substantially on mothers and female caretakers. At the same time, the lockdown cut off access to critical health services for women. including a major drop in institutionally assisted deliveries. In Bangladesh, ongoing school closures also affect nearly three million ultra-poor, including primary school children enrolled in government school-feeding programmes. The fall in household incomes along with missed meals can also accelerate risks of school dropouts for girls that, in turn, can lead

to child marriage, with further increased health, educational, economic and gender-based violence risks.

Furthermore, the sharp increase in gender-based violence during the pandemic is a great source of concern. This is a global phenomenon, which the UN Secretary General describes as a pandemic within a pandemic. In Bangladesh, surveys documented nearly an increase of 70 percent in reported incidents of violence against women and girls in March and April 2020 compared to the same time last year. Many were unable to escape the violence during the lockdown while access to legal recourse and urgent protection measures were cut short. More worryingly, perpetrators of gender-based violence often get away without serious punitive action. This is despite Bangladesh's main laws on violence against women stipulating that

Despite these worrying trends, there are

During the pandemic, about 200 destitute women trained in tailoring turned to making WHO-compliant masks and supplied these to local markets and neighbouring districts. They have so far sold more than 67,000 masks, using their skills to provide for themselves and their families while serving a bigger purpose of protecting communities.

Programmes like SWAPNO highlight that the role of social protection should not only be limited to providing relief. They can provide a path to more sustainable and equitable economic and social development. This year also marks the entering of the final phase of its national action plan to build "a society without violence against women and children by 2025."

Bangladesh. The stimulus packages and direct economic relief can help somewhat, but these will bypass a sizeable chunk of the needy. I have been in touch with three families who live in three areas of Bangladesh—Dhaka, Sylhet and Jamalpur—to track the economic and health impacts of the disruptions during the last eight months. What my interactions with them reveal is that pre-existing health conditions and their lack of savings have adversely affected them and their ability to earn a living. One of them has become a dependent and the other two have come back to Dhaka, putting their future plans on hold until the pandemic recedes and true economic recovery takes place.

I, along with many others who have worked on poverty elimination, have voiced the need to support poor families during times of crises such as natural disasters, economic slowdowns and sickness of the principal bread-earner. With no safety net and zero net worth, a single crop failure or morbidity of the head of the household can push a family, which is inching its way up the income ladder, back to square one.

dreamer. We can accept his proposal to "use ideas, data and analysis to help fight global poverty", but many like me consider that to "think that poverty might one day be gone" could be a little too audacious and out of touch with the harsh realities of the lives of our poor, today.

Coming back to the families who live near the poverty line, consider Anima, who has been working in Dhaka, taking care of out a subsistence living. They have no adequate resources for healthcare and every episode of illness has taken a toll on Anima and her daughters. She herself has a bad liver condition as well as high blood pressure. Her medicines cost Tk 2,100 per month, which she pays out of her salary, but one of her daughters has a serious illness for which she was divorced by her husband, who was unable to support her or defray the cost of her

middle-class suburb, and sent her children to study at madrasahs, paying for their education from her meagre income. Her daughters, as they were reaching puberty, were enrolled in a residential programme with a madrasah and received good educations. One of them, Urmi, is married and the other, Arifa, is a teacher at a madrasah.

However, Ashura herself is paying for her years of hard work and neglect

of her health conditions, and suffers from serious diabetic conditions as well as a failing kidney. Although she managed to save a sizeable chunk from her salary while working abroad with a Bangladeshi diplomat in Bhutan and European countries, she has fallen victim to the greed of her relatives, who borrowed from her but failed to return the loan during her times of need. She was working in Dhaka with one of the families

she has been associated with since her young age. Recently, once the lockdown began, she had to take early retirement after a brief period of hospitalisation with unpaid bills, and temporarily moved to Netrokona to be near her sister. Her daughters are very close to her, but they are unlikely to be able to support her medical treatment. Any serious episode of diabetic outburst or kidney failure might be catastrophic for her (after finishing this article, I was informed that Ashura sadly passed away on November 22 due to kidney failure).

The youngest of this group, Azim, has been in and out of different jobs since he moved to Dhaka from his birthplace in a small village in Golapganj thana, 20 miles from Sylhet municipality. He was born in a lower-middle-income family but the death of his father at an early age pushed all siblings, seven brothers and three sisters, into severe economic uncertainties, and they had to start fending for themselves. He received very little formal education but managed to learn how to read and perform simple arithmetic on his own. Azim, a young and energetic man who is now in his thirties, has tried his hand in the RMG sector, small-scale business, domestic work as well as rural entrepreneurship. He is able to pick up any trade, but poor luck and the fickleness of small business fortune has prevented him from getting out of the cycle of poverty and destitution. He is saving to launch his next business enterprise as a vendor in the bustling bazaar of Sylhet town, but he has to weigh his prospects of success given his limited capital. He says, "If nothing else works, I will become a caretaker for this family."

Ashura, another middle-aged woman in my study group, is a model mother who got married early, after she moved to Dhaka from Mymensingh to make a living. Her husband died, leaving her with three young children, a boy and two girls, to raise on her own resources. They lived in one of the slums of Dhaka and she worked as a domestic help in Lalmatia, a

Investing in a feminist peace

pandemic, public life in much of the world has largely ground to a halt. For the two billion people living in conflict-affected

however, there has been no lull in violence and upheaval. Some of the world's conflicts have even escalated or been reignited during the crisis, dealing devastating new blows to infrastructure and healthcare systems that were only beginning to be rebuilt. Globally, we continue to invest far more in the tools of war than in the foundations of peace.

Of course, some are working for peace. On March 23, at the outset of the pandemic, United Nations Secretary-General Antonio Guterres called for a global ceasefire, in order to enable countries to focus on the Covid-19 crisis and allow humanitarian organisations to reach vulnerable populations. More than 100 women's organisations from Iraq, Libya, Palestine, Syria and Yemen quickly joined the appeal with a joint statement advocating a broad Covid-19 truce, which could form the basis for a lasting peace.

It should come as no surprise that women were among the first to support the call for a ceasefire. This month, governments and civil society came together to mark 20 years since UN Security Council Resolution 1325 first

recognised women's pivotal roles on the frontlines of peace-building efforts.

It is women—including young women-who do much of the painstaking, long-term work that underpin high-profile formal agreements, which are still often reached in talks that exclude them. For example, in Syria, women have passage of humanitarian aid, worked in field hospitals and schools, distributed food and medicine, and documented human rights violations. In South Sudan, women have mediated and resolved tribal disputes to prevent conflicts from escalating to violence.

Women also spearhead the critical work of campaigning for peace, including through education programmes, which teach young people that conflict is never inevitable. Feminist organisations have long called for nuclear disarmament, arms control, and the reallocation of funds from the military to social investments.

These appeals are essential. But they have gone unanswered. So has the UN's call for a Covid-19 ceasefire: according to the Norwegian Refugee Council, in the two months following Guterres's appeal, armed conflict in 19 countries displaced at least 661,000 people. Unless we listen to women, and shift our investments from war toward peace, the devastation will continue.

Last year, global military expenditure reached USD 1.9 trillion, following the largest annual increase in a decade. In the last quarter-century—since the landmark Beijing Declaration

can be met. It means education for our children, health systems that function, a fair and unbiased justice system, food on the table in every home, an empowered, recognised, appreciated, and fully compensated community of women, and a lot more."

We should be spending our money not on tools of destruction, but on a kind of "feminist peace" that upholds basic economic and social rights for all. This means guaranteeing broad social protections and delivering vital services, such as health care, childcare, and education. The provision of such services has been proven to reduce conflict-fueling inequality.

The pandemic has highlighted the critical importance of other services as well. For example, shelters for survivors of gender-based violence have faced

lockdowns, and need more funding to meet it. In addition, governments should be ensuring adequate supplies of medical and personal protective equipment, which have often run out during the pandemic, even in the world's richest countries.

A feminist peace also means that everyone's voice is heard, with all groups included fully and meaningfully in the decisions that affect their lives. Here, women's organisations have a vital role to play, helping women and other marginalised groups gain access to decision-making arenas and giving them the resources and confidence to participate.

But, again, more funding is needed. Bilateral aid to women's organisations in fragile or conflict-affected countries averaged USD 96 million per year in 2017-18—a mere 0.005 percent of global military expenditure.

For all the devastation it has caused, the Covid-19 crisis also represents a generational opportunity to build more inclusive economies and societies, free of the scourge of violent conflict. A concerted effort to demilitarise our world and build a feminist peacebeginning with a global ceasefire, and followed by a comprehensive reappraisal of how we allocate our resources—must be central to this vision.





With head coach Jamie Day away from the team, the men in red and green have been training under assistant coach Stuart Watkiss over the last three days following a 72-hour quarantine at the team hotel. Yesterday they had nearly one-and-a-half hour's training with the ball and a 30-minute gym session in a quest to getting fitter for the

Bangladesh played two FIFA international friendlies against Nepal before flying for Doha on November 19, but they lacked fitness, cohesion and energy in those two matches, the first of which they won 2-0 before playing out a goalless draw in the second match.

"The main objective [of this practice match] is to get in shape and get some organisation of the team, going into the Qatar game. Obviously we are focusing on full fitness and emphasising on hard working game with organisation and structure of the team. There is no expectation on the result [from the warm-up match]; if we work hard and have good possession of the ball, we will win the game," goalkeeping coach Les Cleeveley said.

A Bangladesh Football Federation statement said that yesterday's practice session focused on activation, passing practice, short games, game training and set-plays and that all players and officials were motivated to perform their level best for today's match.

It has been learnt that Watkiss may field almost the same playing eleven that started against Nepal, with Mahbubur Rahman Sufil and Sohel Rana likely to come in place of Suman Reza and Nabib Newaj Jibon.

Jibon, however, has already recovered from a knee injury which he sustained during the second match against Nepal in Dhaka and he is scheduled to fly to Doha today. "I was in full bed rest in the last six days and took medicine which physio Andre Joan suggested me. Now there is no pain on my knee. Joan, having discussed the matter with Jamie Day, asked me to join with the team for training, said Jibon, who is hoping to play against Qatar with only nine days remaining for the game

The pitfalls between beauty and duty

The tragic demise of a young cricketer because he could not quite crack it at the highest level brought to mind the forays of an all-time great -- former Australia skipper Steve Waugh's journey earlier this year through India with a camera to rediscover the joys of cricket, the love that keeps an entire population

agog.
Waugh said with all the illfeeling surrounding the infamous Sandpapergate scandal in Cape Town in 2018, when Australia and the wider cricketing world were shocked by the team's leadership decided to indulge in balltampering, he just wanted to do a "feel-good" project that he was "passionate about".

Among many others, Waugh came across a three-year-old Instagram batting sensation, a 100-year-old playing the game and was inspired by blind and differently abled players.

The joys that were captured by the lens of one of the greatest captains in the game's history were mostly of people playing the game at the informal, non-professional level.

But if we train the camera on the other end of the spectrum, will the images be the same?

The death of Sajibul Islam Sajib, a member of the 2018 Bangladesh Under-19 World Cup squad who died by suicide on November 15, reminds us of the dark side of the cutthroat demands of modern-day professional cricket.

Sajib was reportedly suffering mentally after not being considered for a competition. His tragic story may have grabbed headlines, but we do not know the number of young men who are battling depression and hopelessness after failing to make the highest level in a sport that they have loved from childhood.

The feel-good factor seen in Waugh's photos, where the simple love and enjoyment of the game is all that mattered, seems to start diminishing the higher up the professional ladder the player climbs. Appetite for success takes over from the thirst for joy when hopefuls enter a structure, where the line between failure and success is all too well-defined.

Every aspiring cricketer wants more wealth, which made the to be the best and soon wind up headlines for all the wrong reasons.

That ticket to Europa was provided by Antonio Conte's men finishing third in their group in the Champions League last season, behind Dortmund and Barcelona.

On the other hand, Real Madrid have never failed to reach the last 16. Real will be hoping that Eden Hazard can conjure some magic for them, while Inter's hopes will bank squarely on the performance of Romelu Lukaku, the fourth deadliest striker in 2020 with 29 goals. Elsewhere, a tough test awaits Liverpool against last season's semifinalists, Atalanta, as Jurgen Klopp finds himself without a large number of first-choice players but the positive news is the return of Mohamed Salah, who recovered from Covid-19 and can join a formidable attack with in-form Diogo Jota, Sadio Mane and Roberto Firmino.

The task should be simpler for reigning champions Bayern Munich, who will aim to continue re-writing the history books by extending their record run of consecutive Champions League wins to 15 against RB Salzburg. The Bavarians have been perfect with three wins out of three.


