Amphan still taking its toll

6 months after the cyclone, villages in Satkhira, Khulna remain inundated as WDB yet to repair damaged embankments

Thirty-seven villages in Pratapnagar and Sriula unions of Satkhira's Assasuni upazila went under water when Cyclone Amphan broke major river embankments at several points in May this year.

Both the unions remain largely submerged, six months on, due to the breaches in the Kopotakkho and the Kholpetua river embankments.

Communications with the upazila headquarters have been cut off since then as tidal surges forcing through the breaches continue to keep the two unions inundated.


People are suffering from a lack of sanitation as well as an acute shortage of drinking water as all sources of potable water have been submerged in the brackish river water.

Amir Ali Sheikh of Tipna village in Pratapnagar told The Daily Star that these past six months have been "horrible" and he had not experienced anything like this in the last 40 years.

"When the first tidal surge hit after the embankments broke, the water rushed through the breaches and swept away everything. Some water receded at low tide, but there was no longer a liveable environment," said 68-year-old Amir Ali, describing the events of May 20.

"Up until last week, I received only 20kg rice from the union council, nothing else," Amir Ali said.

RUSSIA'S VACCINE
WHO wants
to see clinical,
trial data

The World Health Organization needs to see clinical data and information of good manufacturing practice to be able to evaluate Russia's Sputnik V coronavirus vaccine, WHO assistant director general Mariangela Simao said on Friday.

Russia's Sputnik V vaccine is more than 90 percent effective, a representative of the health ministry said this month, citing data collated from vaccinations of the public rather than from an ongoing trial.

Sputnik V's developers have touted it as easier to store than some alternatives and at less than \$10 (8.38 euros) per dose the cheapest among frontrunners in a global race to develop a vaccine.

Russia's military has started a mass coronavirus vaccination campaign which aims to inoculate more than 400,000 servicemen, Defence Minister Sergei Shoigu announced.

RAIL BRIDGE OVER JAMUNA PM to lay foundation stone today

Prime Minister Sheikh Hasina would lay the foundation stone of Bangabandhu Sheikh Mujib Railway Bridge over the Jamuna today.

Once built, the dual-gauge double-track bridge would be the largest dedicated rail bridge in the country.

According to rail officials, the bridge would be usable from August 2024 and would enhance the connection between the capital and western region.

Sheikh Hasina attend the event virtually from her official residence the Gono Bhaban whereas Railways Minister Nurul Islam Sujan would preside over the programme in Sirajganj.

The 4.8km-long bridge will be built some 300 metres upstream of the Bangabandhu Bridge which has a single rail line.

In December 2016, the authorities approved the bridge project at a cost of Tk 9,734 crore and the project was scheduled to be completed within December 2023.

The project cost has gone up to Tk 16,781 crore from Tk 9,734 crore and the current deadline is December 2025.

Japan would provide lion share of the project cost as soft loan.

Costs of two main work packages saw a huge rise after the detailed design was made in September 2018.

Besides, costs of land acquisition, land

SECOND COMMODITY EXCHANGE PROTOCOL WITH USSR

Bangladesh and USSR sign the second commodity exchange protocol at the State Guest House in Dhaka today. The protocol is in accordance with the Bangladesh-Soviet trade agreement of

March, 1972.

Under the protocol Bangladesh would export to the Soviet Union raw jute (20,000 tonnes), jute goods (hessian two crore

metres and sacks one lakh piece), tea (1,000-2,000 tonnes), goat

skins (one lakh pieces), spices (Tk 1,00,000), towels and sheets (Tk 3,00,000) and miscellaneous items (Tk 8,00,000).

The imports from the USSR would be kerosene, pig iron,

steel billets, zinc ingots, cotton, ingot moulds, rolls, machinery

Melting mountain ice reveals ancient artefacts

An archaeological survey of an ice patch in Norway's Jotunheimen mountains has led to a haul of ancient artefacts.

The survey, which was conducted on the Langfonne ice patch in 2014 and 2016, discovered Iron Age scaring sticks used in reindeer hunting, reindeer antlers, a 3,300-year-old shoe from the Bronze Age, and 68 arrows.

The report's authors have hailed the discovery of the arrows as the earliest ice finds in northern Europe.

Global warming has caused the ice patch to retreat by more than 70 percent over the past two decades, the study found.

"With the ice now retreating due to climate change, the evidence for ancient hunting at Langfonne is reappearing from what is in essence a frozen archive," said Lars Pilø, the study's lead author and an archaeologist from the Innlandet County Council.

Pump worker
dies after co-
worker sets
him alight

A filling station worker died of his burns at a city hospital early yesterday, four days after he was set on fire allegedly by one of his co-workers.

Riad Hossain, 20, breathed his last at Sheikh Hasina National Institute of Burn and Plastic Surgery around 12:30am, his father Farid Mia said.

A student of Siddheswari College in the capital, the youth took the part-time job a few months ago with a monthly salary of Tk 5,000 to support his family.

He sustained 40 percent burns to his body on Tuesday after another worker Mahmudul Hasan

4 killed in Gopalganj bus crash

At least four people were killed and 20 others injured when a bus hit a rickshaw-van on Gopalganj-Pirojpur highway before crashing into a canal in Malekbazar area of Tungipara yesterday morning.

Of the four, Akamuddin Mollah, 50, and Krishna Kitonia, 32, of Tungipara upazila, and Sanjat Dhar, 40, of Muksudpur upazila, were in the rickshaw-van and Thanda Khan, 50, of Bagerhat's Chitalmari upazila, was the helper of the bus.

"The bus of Dola Paribahan, coming from Pirojpur, hit the rickshaw-van and fell into a roadside canal upside down, breaking the railing of a culvert. Four people, including the van puller, died at the scene and 20
