# File case against 30 washing plants

High Court directs DoE

The High Court yesterday directed the Department of Environment (DoE) to lodge a case against 30 washing plants in Keraniganj area within 30 days, for polluting the water of river Buriganga in the area.

The 30 factories in question are -- Ahmed Hossain, Amena, Sun Moon, Eden, Bismillah, Lotus, Global, Rubel, Anushka, Sotota, Chanchal, Abdur Rob, Dhaka, Ajan, New Sahara, Dohar, Relative, New Nasha, Unique, Mow, Setu, Quality, Joena, Kalam, Water Colour, Par Joar, GM, Cumilla, Achhia and Lily water plants.

During hearing a writ petition, the HC ordered the authorities concerned of the government to stop dumping waste into Buriganga.

The authorities concerned and local representatives have been directed to monitor the situation so that no one can dump waste into Buriganga and to take appropriate legal action if any individual or organisation pollutes its water and environment.

# UNDOCUMENTED IN BAHRAIN 30,000 workers get regularised

An estimated 30,000 undocumented Bangladeshi migrant workers became regularised in Bahrain under an amnesty programme of the Gulf country's government that ended on December 31 last year.

Under the programme declared on April 2 last year, most Bangladeshi workers availed "flexi permit" from Bahrain government's Labour Market Regulatory Authority (LMRA) to get work opportunity there, said an official at the Bangladesh embassy in Manama.

However, a small number of the workers returned home after being regularised without paying a fine, he said.

Unlike other Arab countries, migrant workers' situation in Bahrain is comparatively better, considering the authorities allow foreign workers to live and work without any local sponsorship. In contrast, local sponsorship is mandatory under the existing "kafala system" to avail job in countries like Saudi Arabia and United Arab Emirates.

In Bahrain, to avail such work permit without local sponsor, a foreign worker has to get "flexi permit" after being registered with the LMRA.

Sheikh Mohammed Tauhidul Islam, labour welfare counsellor at the Bangladesh embassy in Manama, said a worker who obtains the permit has to pay a monthly fee of 30 Bahraini Dinar or about Tk 6,700 to the authorities.

Besides, the worker needs to pay a small amount of annual fee to maintain the legal status, he said via a WhatsApp call yesterday.

The amnesty was declared for all undocumented foreign workers living in the Gulf country, he added.

# Roads ministry forms committee to set toll

The roads, transport, and bridges ministry yesterday formed a 16-member committee to finalise the toll for Dhaka-Mawa-Bhanga Expressway after Roads and Highways Department (RHD) has placed a proposal in this regard.

As per the RHD's proposal, a private car and bus have to pay Tk 278 and Tk 999 respectively for using the first expressway in the country, excluding the toll he or she has to pay for Padma Bridge, now under construction.

Led by Abu Sayed Sheikh, an additional secretary of Road Transport and Highway Division, the 16-member committee was asked to submit its report within 25 working days, Fahmida Haque Khan, deputy secretary (toll and axle) of the division, said.

The committee will have representatives of transport associations, finance ministry, RHD, Consumer Association of Bangladesh

Before the committee's formation, Sabuj Uddin Khan, additional chief engineer (Dhaka zone) of RHD, placed the toll proposal before the stakeholders meeting

# 464 died, 513 injured in last month: report

At least 464 people were killed and 513 were injured in 402 road accidents throughout the country in December last year, according to a report by Road Safety Foundation.

According to the Road Safety Foundation, 124 accidents (30.84 percent) occurred on highways; 129 (32.08 percent) occurred on regional roads; and 104 (25.87 percent) incidents occurred on local roads, said a press release yesterday.

Of them, 147 were killed in 138 motorcycle accidents, the press release said.

Meanwhile, a total of 17 people died in five waterway accidents, while another 19 died and four were injured in railway accidents.

According to the report, most of the accidents took place in Dhaka division. A total of 138 people died in 117 road crashes in the region.

The report was prepared by aggregating information from seven daily newspapers, five online portals and several electronic media outlets.

Unfit vehicles, reckless driving, unskilled drivers and violation of traffic rules are among the reasons behind the accidents, the report said.

# Mir Nasir gets SC bail

The Appellate Division of the Supreme Court yesterday granted bail to BNP leader and former state minister for civil aviation Mir Mohammad Nasiruddin in a corruption case in which he was sentenced to 13 years' imprisonment.

A three-member bench of the Appellate Division headed by Chief Justice Syed Mahmud Hossain granted the bail on the ground of ongoing Covid-19 situation, following a bail petition filed by Mir Nasir.

Lawyers M Asaduzzaman and Md Ruhul Quddus Kazal appeared for Nasir while Anti-Corruption Commission's lawyer Khurshid Alam Khan

# Youth held in Dhaka for blackmailing Indian girl

He used to disseminate child pornography online, says CTTC

Around seven months back, an Indian girl from Kanpur met a Bangladeshi youth through a dating app.

They eventually became good friends and shared their messenger IDs. As their relationship became stronger, he even managed to convince the girl to share her personal photos and videos with him.

After a while, they had a fallout. The youth then started blackmailing her and threatened to leak those contents on social media unless she gives him 2.50 lakh rupees.

He asked her to deposit the money in a Bangladeshi private bank account at its Dakkhinkhan branch in the capital.

Distressed, she contacted the Cyber Terrorism Investigation Team of Counter Terrorism and Transnational Crime (CTTC) of Bangladesh through their Facebook messenger. She explained her situation and provided her social media ID to the cyber cops.

With that, the cyber police managed to get the youth's mobile number. Tracking it, police arrested the youth -- KM Mirazul Azam (28) -- from his residence on Atish Dipankar Road in Mugda area on December 29.

Law enforcers also seized a mobile phone of Mirazul, a private university student, and found that he used various social media IDs to disseminate child pornography.

"The accused used to contact, collect, store and supply pornographic

# HC grants bail to accused UP member

The High Court yesterday granted bail to a union parishad member in a case filed for gang-rape and torture of a woman in Noakhali's Begumganj in September last year.

The HC bench of Justice M Enayetur Rahim and Justice Md Mostafizur Rahman passed the order following a bail petition filed by the accused -- Moazzam Hossain alias "Sohag Member".

Deputy Attorney General Sarwar Hossain Bappi vehemently opposed the bail petition during its virtual hearing.

Moazzem's lawyer Md Oziullah told The Daily Star that the HC granted bail to his client as he has been in Noakhali jail for three months although the maximum punishment for his alleged offence -- of negligence in discharging responsibility as a public representative -- is six months' imprisonment.

# Towards a jam-free Sylhet

SCC removes hawkers, non-motorised vehicles from some roads; 1,070 vendors moved to market

After an immensely stressful year for people everywhere, Sylhet City Corporation's resolution for the new year is simple -- make life simpler for its citizens.

As the city is growing fast, the city corporation had initiated a project to expand road-width, along with plans to construct new footpaths some years ago, but traffic congestion and hawkers occupying footpaths kept setting it back.

To avert the situation this year, SCC, in association with Sylhet Metropolitan Police (SMP), has planned to make its major roads hawker-free, as well as prohibiting non-motorised vehicles in

some congested roads.

Mayor Ariful Haque Choudhury said, "It's been years since we're trying to keep the city roads free from hawkers and traffic congestion. Finally, with the help of SMP, we're being able to do so."

Md Nisharul Islam, commissioner of SMP, added, "The presence of hawkers in Sylhet's streets create great suffering for citizens. We will ensure that they do not get to sit on these roads anymore. As the SCC has ordered rickshaws off some city roads, we'll help them enforce this decision too."

The roads include -- Chowhatta to Taltala via Zindabazar and Bandarbarzar, Kean Bridge and its adjacent area,
