## DEATH OF APPRENTICE LAWYER Police refuse to record case against DB men

Relatives of apprentice lawyer Rejaul Karim Reja, who died in a prison cell of a Barishal hospital, yesterday alleged that Kotwali police did not record a murder case against three members of Detective Brach of police. A DB team detained

Rejaul at a tea stall near his home on Barishal city's

Hamid Khan Sarak around 8:00pm on December 29 when he was having tea, said his brother-in-law Abdul Barek Hawlader.

The DB that night filed a drugs case against the 30-year-old apprentice lawyer with Kotwali Police Station and handed him over to police, he added.

A local court sent him to jail the following day. On January 1, he was admitted to Sher-e-Bangla Medical College Hospital.

He passed away on Saturday night. Yesterday, Barishal Metropolitan Police Commissioner Md Shahabuddin Khan asked Rejaul's father, wife and Barek to meet him at his office.

The three met the BMP commissioner around noon. The commissioner listened to them separately and asked them to talk to the Kotwali OC over filing a murder case in this regard.

Barek said Kotwali OC Nurul Islam refused to record the case arguing that he could not do so as the apprentice lawyer passed away in the hospital's prison cell.

Rejaul's family was preparing the

draft of a case to be filed with a local court today in this regard. Sub-Inspector DB Mohiuddin Mahi and two other members of DB would be accused in the

case, Barek added. Rejaul told his wife at the hospital that he was brutally tortured by Mohiuddin, said family members.

**Rejaul Karim Reja** Despite repeated attempts, this correspondent could not reach the BMP commissioner, the deputy commissioner (DB), the Kotwali OĆ and SI Mohiuddin over the phone for comments.

The protesters said Rezaul was a very bright student. He wanted to take over the responsibility of his hard-up family, but he was "killed" after being picked up by the DB police.

They demanded trial of SI Mohiuddin over the alleged murder. They also warned of announcing tougher agitation programmes if their demand was not met.

## Bangladesh okays it for emergency use

last night said he has yet to formally receive the NOC.

The developments come after India on Sunday banned export of the vaccine for two months to make sure emergency local demands are met.

As many people here expressed concerns that the shots might not arrive on time, the Bangladesh government yesterday said the ban would not affect the import of Covishield.

"The deal was done on the basis of discussions at the highest level, between Bangladesh Prime Minister Sheikh Hasina and Indian Premier Narendra Modi. So, no ban will be applicable for us. There is no reason for us to worry," said Foreign Minister AK Abdul Momen referring to a correspondence with the Indian Ministry of External Affairs.

"The vaccine will arrive on time. It will come towards the end of this month ... India and Bangladesh will get the Serum vaccines at the same time," he told reporters at a briefing at the Foreign Service Academy.

The Serum Institute on Sunday said it intends to concentrate on meeting India's own immediate demand for two months before exporting it to other countries.

Health Minister Zahid Maleque and Secretary Abdul Mannan of the health ministry yesterday told reporters that the ban would not affect Bangladesh's contract.

Bangladesh is supposed to get 50 lakh doses of Covishield every month for the first six months as per the agreement.

### 24 more die, 910 test positive for Covid

The health directorate reported that 910 people were infected with the novel coronavirus in the 24 hours ending 8:00am yesterday.

This was below 1,000 new cases for the third consecutive day. The previous day, 835 people tested

positive for the viral infection while the number was 684 on Saturday, according to a press release of the Directorate General of Health Services.

With yesterday's cases, the total number of confirmed cases rose to 5,16,929.

Meanwhile, 24 people died from Covid-19 in those 24 hours.

The death toll reached 7,650 and the death rate was 1.48 percent.

Against yesterday's 12,096 tests, the positivity rate was 7.52 percent and the overall positivity rate 15.80 percent.

In the same 24-hour period, 917 Covid-19 patients recovered from their illnesses.

With this, the number of recoveries stood at 4,61,515 and the recovery rate at 89.28 percent.

Among the 24 deceased, 18 were males.

One of them was aged under 10, one petween 41 and 50, eight were aged between 51 and 60, and 14 were above 60 years, added the release.

### Two men get death for rape, murder of girl

A Madaripur court yesterday sentenced two people to death for killing a sevenyear-old girl after rape on November 27, 2012.

The convicts are Mahmudul Hasan alias Madhu, 32, and Milon Mollah, 30, of Sreenadi village of Madaripur Sadar upazila.

Moslem Ali Akhand, public prosecutor of Women and Children Repression Prevention Tribunal in Madaripur, said Judge Dilruba Sultana of the court delivered the verdict in presence of the convicts.

The court also fined Tk 1 lakh each. According to the case statement, Rabia Akhter Riya, daughter of Gaus Napti of Kotbari Sreenadi area under Sadar Upazila, was killed after rape by criminals in a bush in the afternoon on November 27, 2012, while she was returning home from her coaching centre.

She was a class-II student.

The next day, the victim's father filed a case against some unknown people with Sadar Police Station.

After investigation, Fayakuzzaman, then sub-inspector of Sadar Police Station, submitted a charge sheet against Mahmud and Milon on February 3, 2013.

After examining witnesses and evidence, the judge found the two guilty and pronounced the verdict against the two.

Earlier, the investigation officer seized PK Halder's two flats and six acres of immovable properties following a court order last month.

According to the case statement, PK Halder has immovable property worth about Tk 187.78 crore. Of the amount, he has investment about Tk 123.54 crore in Lipro International.

He purchased 589 decimals of land for Tk 1 crore in Mymensingh.

In the enquiry, the ACC found that there is about Tk 67.35 crore investment in eight companies.

Besides, documents show he has Tk 32.25 crore worth of moveable property, reads the FIR.

The total amount of his moveable property stands at Tk 99.61 crore, which he amassed directly and indirectly using others' names, said the FIR.

According to Canadian media reports, Halder is now in Toronto. He is a director of P&L Hal Holding Inc, a Canadian corporation.

The three other NBFIs from which PK Halder allegedly misappropriated crores of taka are: International Leasing and Financial Services Limited (ILFSL), FAS Finance and Investment, and Bangladesh Industrial Finance Company.

that, "The vaccine has been granted emergency authorisation by the Indian regulator on Sunday, but on the condition that Serum Institute doesn't export the shots to ensure that vulnerable populations in India are protected.

"We can only give the vaccines to the government of India at the moment," he said, adding that the decision was also made to prevent hoarding

Poonawalla further said the "company also has been barred from selling the vaccine in the private market".

Besides, Serum was planning to give 200 to 300 million doses to COVAX by December 2021, said the AP report.

auditor to find out the total amount of money embezzled from the BIFC by Proshanta Kumar Halder, also known as PK Halder, and his cohorts in the last five years.

The petitioner alleged that the then BIFC board of directors led by PK Halder embezzled around Tk 500 crore from the BIFC, and another Tk 1,000 crore was plundered by sanctioning loans to several companies.

In the full text of its order, the HC said, "For the case in hand, the general managers who were in charge of overseeing the activities of the financial institutions from the year 2002 to date should be made answerable for causing the disaster in the financial sector."

"Although this court is wellcompetent to draw the attention of the Anti-Corruption Commission to initiate a primary enquiry against the aforesaid persons, I opt to refrain from passing such orders/directives for now with an expectation that the governor of Bangladesh Bank shall look into the matter for the greater interest of the nation in order to dismantle the prowess and ill-plans of the offenders so that no further public money is purloined by the crooked businessmen in collaboration with the unscrupulous Bangladesh Bank officials," Justice Khurshid noted.

The HC bench appointed Justice Moveenul Islam Chowdhury, a retired judge of the Supreme Court, at the hearing.

# Erfan Salim cleared of charges

"It was a guest bedroom, not Erfan's personal bedroom. Because this is a political family, a variety of guests, political leaders-workers, and community residents enter this room to have personal meetings with Erfan Salim," read the report.

"Erfan Salim finished his BBA degree in 2010 from Canada's Hudson University. In order to destroy his political career, and ruin his social standing, one or more people planted the gun in the bedroom with dishonest motives -- however no proof of their identity could be obtained.

"We also could not find proof of Erfan owning or publicly brandishing illegal weapons, or of him being involved in any criminal activities."

The deputy police commissioner of Lalbagh zone, Biplob Bijoy Talukdar, was asked why they thought the arms and illegal devices recovered from Erfan's residence did not belong to him. He replied, "I can only tell you that we investigated the matter and we submitted the final report based on our findings."

In their final report, the police, however, did not mention about the rest of the alarming discoveries made by the Rab in Erfan's residence and office.

In the FIR, Rab DAD Kaiyum wrote, "We entered a room called the 'control found an air gun leaning against the wall beside the wardrobe. In addition, in the bottom shelf of the wardrobe we found two black daggers, one of which was 11 inches long while the other was 11.4 inches long. We also found one 8.5 inches long 'Chinese' cleaver, which had a black blade and a green hilt. The hilt itself was 18.7 inch."

He wrote that while raiding the building, they found 38 black walkietalkies, one pair of handcuffs and one drone camera.

Several other findings were not included in the FIR, but were seen by reporters of this newspaper during the raid on the 15th floor of Madina Ashik Tower. Those included surgical tape, devices for intercepting radio frequencies, thick rope and a single large bone, which was believed to be that of a human although no forensic tests have been conducted yet.

Lt Col Ashique Billah, media wing director of Rab, had told journalists on record back then that the 15th floor of the tower was used as a torture cell.

"During our preliminary interrogation of Erfan Salim, we learned about this torture cell," he had said.

During the raid, Executive Magistrate Sarwoer Alam had told our correspondents, "Erfan used to torture
