# TRUMP impeached again

US politicians charge president with inciting deadly riots at the US Capitol; his ouster unlikely in Senate trial

A bipartisan majority of lawmakers in the House of Representatives yesterday voted to impeach Donald Trump seven days from the end of his term, assuring he becomes the first US president to be impeached twice.

With nearly all votes counted, the number supporting impeachment on the single charge of "incitement of insurrection" for Trump's role in whipping up a violent mob surpassed 217, the majority threshold out of 433 current House members. At least 10 Republicans joined the Democrats.

But it appeared unlikely that the extraordinarily swift impeachment would lead to Trump's ouster before the Republican president's four-year term ends and Democratic President-elect Joe Biden is inaugurated on Jan 20. The Senate's Republican majority leader, Mitch McConnell, rejected Democratic calls to convene the Senate in emergency session to begin an immediate impeachment trial,

according to a spokesman.

The House voted on a single article of impeachment - a formal charge - accusing Trump of "incitement of insurrection," focused upon an incendiary speech he delivered to thousands of supporters shortly before the pro-Trump mob rampaged (Carietal Theorem 1997).

Trump mob rampaged through the Capitol. The mob disrupted the formal certification of Biden's victory over Trump in the Nov. 3 election, sent lawmakers into hiding and left five people dead, including a police officer.

During his speech, Trump repeated false claims that the election was fraudulent and exhorted supporters to march on the Capitol.

Yesterday, before the vote, Trump broke his silence from the White House only to issue a brief statement insisting on his opposition to violence.

"In light of reports of more demonstrations, I urge that there must be no violence, no lawbreaking and no vandalism of any kind. That is not what I stand for," he said.

# Govt mulls allowing human trial

The government may allow human trial of three vaccine candidates in the country to enhance the possibility of getting more Covid vaccines, say officials.

Health Secretary Abdul Mannan told The Daily Star yesterday that allowing clinical trial of vaccine candidates is part of the government's initiatives to find more sources of vaccines.

"If any vaccine producer gives us detailed [research] data, we will make decisions based on that...," he noted.

Now three foreign companies are moving ahead with their plans to run last-stage human trial of their vaccine candidates in Bangladesh. They are India's Bharat Biotech, and China's Anhui Zhifei Longcom Biologic Pharmacy and the Institute of Medical Biology Chinese Academy of Medical Sciences.

Besides, Bangladeshi company Globe Biotech Ltd will submit to Bangladesh SEE PAGE 2 COL 3

# Confusion reigns over vaccine price

Govt, Beximco restate Bangladesh will get the Covid-19 jabs at the same price as in India

As confusion continues over the price of Oxford-AstraZeneca coronavirus vaccine, the government and the Beximco Pharmaceuticals Ltd have reiterated that Bangladesh will get the vaccine at the same price India is paying.

Health Minister Zahid Maleque said there was no scope for deviating from the tripartite agreement signed between the government, the Serum Institute of India (SII) and its local partner Beximco.

Beximco Pharmaceuticals Managing Director Nazmul Hassan Papon said Bangladesh would not pay a single cent more than India for the shots branded Covishield. "Many countries, not one or two, will produce vaccines. If one country charges more, we will try to go for another country. We have that option."

They made the comments while talking to The Daily Star after Reuters ran a report on Monday that SII would sell the AstraZeneca coronavirus vaccine to Bangladesh at \$4 a dose, "about 47 percent more than India will pay for its inoculation campaign".

# US military leaders issue rare warning

The US military's Joint Chiefs of Staff, the uniformed leaders of the military branches, on Tuesday put out a rare message to service members saying the violent riots last week were an assault on America's constitutional process and against the law.

The joint message broke nearly a week of silence by the military leaders after the assault on the Capitol by supporters of President Donald Trump sent lawmakers into hiding and left five people dead.

# HC calls it 'naked interference'

Govt cannot even recommend withdrawal of graft cases, observes the top court

The government attempt to get a corruption case withdrawn in Sylhet is a "naked interference" into the affairs of the Anti-Corruption Commission, observed the High Court.

The government can neither withdraw nor recommend the withdrawal of any corruption cases filed and moved by the ACC.

The HC bench of Justice M Enayetur Rahim and Justice Md Mostafizur Rahman in the full text of the verdict on a revision petition filed by the ACC on the issue said the law does not allow the government to do so.

However, the bench said the government could make requests to the ACC on such matters but it was up to the independent body whether to entertain them.

# Pompeo's remarks irresponsible

Foreign ministry says refuting claim Al-Qaeda carried out attacks in Bangladesh

Dhaka has termed Washington's remarks linking terrorist group Al-Qaeda with Bangladesh irresponsible and unfounded.

In a statement on January 12 on the US state department's website, US Secretary of State Mike Pompeo said, "Imagine too the potential to completely upend fragile places with an established Al-Qaida presence like Libya, Yemen, and the Maghreb, or increase turmoil in places like Bangladesh, where Al-Qaida cells have carried out attacks.

In response, the Ministry of Foreign Affairs issued a statement yesterday strongly rejecting Pompeo's comments as "irresponsible". There is no evidence of any presence of Al-Qaeda in Bangladesh, it said.

Such irresponsible comments by a senior leader is very unfortunate and unacceptable," the foreign ministry

Bangladesh, under the leadership of Prime Minister Sheikh Hasina, maintains a "Zero Tolerance" policy against all forms of terrorism and violent extremism, and has been undertaking all possible measures and actions to address the menace, it said.

"If any such claim could be substantiated with evidence, the government of Bangladesh would be happy to take necessary measures

# Trump impeached again

"I call on all Americans to help ease tensions and calm tempers. Thank You."

With a large presence of riflecarrying National Guard troops inside and outside the Capitol, an emotional debate unfolded in the same House chamber where lawmakers crouched under chairs and donned gas masks on Jan. 6 as rioters clashed with police officers outside the doors.

"The president of the United States incited this insurrection, this armed rebellion against our common country," House Speaker Nancy Pelosi, a Democrat, said on the House floor. "He must go. He is a clear and present danger to the nation that we all love."

Democratic congressman Julian Castro, a former presidential candidate, called Trump "the most dangerous man to ever occupy the Oval Office." Congresswoman Maxine accused Trump of wanting civil war and fellow Democrat Jim McGovern said the president "instigated an attempted

coup." No US president ever has been removed from office through impeachment. Three - Trump in 2019, Bill Clinton in 1998 and Andrew Johnson in 1868 - were impeached by the House but acquitted by the

Some Republicans argued that the impeachment drive was a rush to judgment that bypassed the customary deliberative process such as hearings and called on Democrats to abandon the effort for the sake of national unity

"I am not choosing a side, I'm choosing truth," Republican Jamie Herrera Beutler said in announcing her support for impeachment, drawing applause from Democrats. "It's the only way to defeat fear."

In a break from standard procedure, Republican House leaders refrained from urging their members to vote against impeachment, calling the vote a matter of individual conscience.

Under the US Constitution, impeachment in the House triggers a trial in the Senate. A two-thirds majority would be needed to convict and remove Trump, meaning at least 17 Republicans in the 100-member chamber would have to join the Democrats.

McConnell has said no trial could begin until the Senate was scheduled to be back in regular session on Jan. 19, one day before Biden's inauguration. The trial would proceed in the Senate even after Trump leaves office. A source said earlier yesterday that the Republican Senate leadership had discussed whether to initiate a trial as early as Friday.

McConnell said in a memo to his fellow Republicans he has not made a final decision on how he will vote on impeachment in the Senate.

No Republican senators have said they would vote to convict. Two have called on Trump to resign.

The FBI has warned of armed protests planned for Washington and all 50 U.S. state capitals ahead of Biden's inauguration. Trump on Wednesday urged his followers to remain peaceful, saying in a statement, "I urge that there must be NO violence, NO lawbreaking and NO vandalism of any kind. On November 19, 2014, the ACC filed the petition with the HC challenging a Sylhet court's order of January 26, 2012, that granted a government prayer to withdraw a corruption case against Md Abdul Kashem, chairman Number-4 Borodal Uttar Union in Tahirpur upazila, and two others

The Sylhet court also exempted the accused from the case proceedings.

The case was filed with Tahirpur Police Station on April 5, 2007, against the accused in connection with embezzling 17 bundles of corrugated iron sheets meant for government relief to the poor. The sheets were worth Tk

On February 11, 2011, the home ministry recommended withdrawal of government

reportedly recommended withdrawal of over 7,000 criminal cases filed before the Awami League assumed power. In the full verdict, the HC said,

"Such an endeavour [having the case withdrawn] on the part of the government can be regarded as a naked interference in the affairs of an independent body like the commission.

"Because section 3(2) of the Act of 2004 [ACC Act] postulates in clear terms that the Anti-Corruption Commission shall be an independent and impartial

noticed that as per mandate of section 10(4) of the Act of 1958 [Criminal Law Amendment Act], the Anti-Corruption Commission is the only authorised body to withdraw from the prosecution against any person either generally or in respect of any one or more offences under the Act of 2004 or the Act of 1958," it said. "Thus, it is patent that the

government has nothing to do in respect of withdrawal of a case filed under the Act of 2004 or the Act of 1958. Be that as it may, if the government wants to withdraw a case pending before the Court of Special Judge, in that event it can only make a request or express its pious wish to the commission and if the government makes such a request, the commission is free to decide indifferently whether it would consider such request or proposal of the government or not," the HC judges

Khurshid Alam Khan, the ACC lawyer, told The Daily Star that it is the established provision of the law that the government cannot withdraw any corruption case filed or moved by the ACC and even it cannot recommend for their withdrawal.

The HC in the full text clearly interpreted the law in detail, he added. Deputy Attorney General Sarwar

Hossain Bappi refused to make any comment on the HC observation.

# Confusion reigns over vaccine price

government placed firm orders for over six crore doses, according to Indian median reports.

Serum, which stockpiled 50 million doses of the vaccine in India, has signed an initial deal to sell 11 million of the shots to the Indian government for 200 rupees (\$2.72) per dose, said the Reuters

Serum is the world's largest vaccine producer by volume.

Following the Reuters report, Bangladesh Finance Minister AHM Mustafa Kamal faced questions from the media about Bangladesh paying more.

"I am not aware whether the price is higher [for Bangladesh]. If India produced [the vaccine], then their production cost will understandably be less ... When they would sell it, they would add their expenditure with the profit," he said.

"We cannot expect that we will get [the vaccine] at the price same as their production cost. But we will look into at what price vaccines are being sold in the international market. We will try to control the price at which we will get the "Many countries, not one or two, will

produce vaccines. If one country charges more, we will try to go for another country. We have that option," Mustafa Kamal said. Following the Reuters report and the statement of the finance minister, The

Daily Star contacted the health minister

and the Beximco authorities. "We will speak as per our agreement. We will get it [the vaccines] at the same price the Indian authorities purchased from Serum Institute of India. So if India gets the vaccines at prices lower than what has been fixed for us, we will also

get the vaccines at lower prices," Zahid Maleque said.

"If India buys the shots at prices lower than us, then it is a good news for us. We will then get more shots from Serum,

The health minister insisted that there was no room for confusion over the prices. "Everything will be done according to the agreement. The lower the price is, the more we will get."

Asked whether the contract will be made public, he said the agreement was signed publicly and claimed that everything written on the papers had already been made public. "The agreement does not have any hidden

The tripartite agreement between the government, Serum and Beximco was signed on November 5 last year to purchase three crore shots of Oxford raccine from Serum at \$4 per shot. The government has recently said the

first instalment of 50 lakh doses would arrive on January 25 and the vaccination would start in the first week of next month. Each jab, however, will cost the government \$5 as it will have to

pay Beximco in service charges and for transporting the vaccines to the government vaccination centres. Contacted, Nazmul Hassan Papon

said Bangladesh government would get the vaccine at the same price India is paying and that there was no reason to "Bangladesh is purchasing the vaccine at \$4 per shot, but it's a tentative price.

But if India purchases the vaccine at a lower price, Serum will also reduce the price accordingly for us. "As per the agreement, there is a guarantee that Serum will give us the

vaccine at the same price it sells to India. There is no room for deviation [from it]. 'We will not pay a single cent more [than India]," Papon said.

"Since we are yet to receive the first installment of vaccines, it would be too early to make any comment on what would be the final price. Because India bought each shot at 200 rupees in the first phase and it might go up to 250 rupees," he added.

Earlier in the month, the health minister, the health secretary and the Beximco MD insisted that Bangladesh would get the vaccine at the same price as Indian government. BEXIMCO TO SELL VACCINES AT

PRIVATE MARKET The drug-maker will import 10 lakh doses from SII for private distribution. Beximco is buying each dose at \$8 from

"Among the doses, various pharmaceuticals companies have already ordered for eight lakh doses," Papon told

He said they would sell the vaccine after the commencement of government's mass vaccination programme.

Beximco Chief Operating Officer Rabbur Reza said the price of the vaccine in the private market was yet to be decided.

After arrival of the vaccine, the Directorate General of Drug Administration will fix the price, he said. He also said Beximco had already sent a proposal to Serum for purchasing

another 20 lakh doses. Contacted, DGDA Director General Maj Gen Md Mahbubur Rahman said the price of the vaccine to be sold in the private market would be finalised under government regulation.

Meanwhile, the authorities of Bangabandhu Sheikh Mujib Medical University (BSMMU) and Anhui Zhifei Longcom Biologic Pharmacy are working to finalise a plan to run laststage human trial of the Chinese firm's vaccine candidate. The two sides last week agreed to run the trial.

Prof Kanak Kanti Barua, vice chancellor of the BSMMU, told The Daily Star recently, "We have replied to them [Anhui Zhifei]. We will run the trial... It will require time to complete the procedures.

Besides, the Institute of Medical Biology Chinese Academy of Medical Sciences is planning to run last-stage human trial through a private research organisation in Bangladesh, a health official told this newspaper, seeking

Bangladesh has so far confirmed purchase of Covid vaccines from two sources. Three crore doses of Oxford-AstraZeneca vaccines will come from Serum Institute of India (SII) and another 6.8 crore shots from global

Recently, the COVAX, co-led by WHO, GÁVI, CEPI, offered four lakh doses of Pfizer vaccine to Bangladesh to vaccinate its frontline workers. The Pfizer vaccine needs to be stored at minus 70 degrees Celsius while the SII vaccine can be kept at 2-8 degrees

Talking to this newspaper yesterday, Health Minister Zahid Maleque said, "We will take Pfizer vaccine. We have enough storage capacity for that."

Earlier on Monday, Prof ABM Khurshid Alam, director general at the Directorate General of Health Services (DGHS), said the government was exploring the existing storage capacity to that end. According to health ministry

officials, the government is also thinking about allowing private companies to import Covid vaccines to sell those in the domestic market. 'SELECT RIGHT VACCINE' Experts have called for prompt

exploration of sources of those vaccines, which will give the Bangladeshi population herd immunity for a long time and are cost-effective and compatible with the country's cold chain infrastructure. At a recent discussion, a number

of experts said it is uncertain how long the vaccines approved so far will give immunity. Besides, if the novel coronavirus mutates regularly like the influenza virus, there may a need for regular vaccination.

There should be two vaccination goals -- one is to reduce mortality and morbidity, and the other is to gain herd immunity, they said.

vaccinate 26 crore people aged above 50. It will help reduce the number of deaths. We should also take such a strategy for now. In the future, we may get single-dose vaccines that may provide lifelong immunity," said Prof Md Savedur Rahman, chairman at the BSMMU's pharmacology department.

"Some of the vaccine candidates which are at the second stage of human trial are single-dose and suitable for our existing cold chain. Those can even be stored in normal temperature in the country," he told this newspaper

Sayedur said Bangladeshi researchers should get in touch with those vaccine inventors to be part of their research.

He also mentioned that Bangladesh allows human trial of vaccine candidates, it may have three advantages -- priority in getting vaccines, preferential pricing and technology transfer.

If any delay occurs in making decisions on such trial, it will happen not because of the scientific community, but due to other players in the decision-making process, noted Sayedur, also a member of BMRC's Ethical Review Committee.

According to the Ney York Times Coronavirus Vaccine Tracker, eight vaccines, including that of Pfizer-BioNTech, Moderna and Oxford-AstraZeneca, have so far been approved by the US, the UK and several other countries for emergency use.

Besides, 20 vaccine candidates are at the final stage of human trial and another 21 at the second stage.

#### Baul singer Rita Dewan granted ad interim bail

A Dhaka tribunal yesterday granted ad interim bail to Baul singer Rita Dewan in connection with a case filed for 'hurting religious sentiment" under the Digital Security Act.

Dhaka Cyber Tribunal Judge Mohammad Ash Sams Joglul Hossain granted bail to Rita till January 27 after she was produced before the court, seeking bail in the case, Shamim Al Mamun, bench assistant of the tribunal, told The Daily Star.

The tribunal on December 2 last vear issued arrest warrants against Rita, Shahjahan Kabir and Iqbal Hossain, accepting the probe report of the case. The report was filed by the

Police Bureau of Investigation. Shahjahan is now behind bars, while Iqbal is on the run, the

prosecution said. On February 2 last year, lawyer mrul Hasan filed the case against Rita with the cyber tribunal. There were three other cases filed against Rita in Dhaka, Chattogram and Jhenidah,

said Rita's lawyer Abdullah Al Noman. The Jhenidah case was dismissed by the district court, but the Dhaka court accepted the case filed by Imrul and issued an arrest warrant on December

A hearing for the other DSA case filed in Dhaka's Chief Metropolitan Magistrate Court will be held tomorrow, and the court will decide whether or not to accept the case, her

lawyer said. This means even though Rita received ad interim bail in one case yesterday, she will still need to get bail

in two other cases. The probe report details that Rita was doing a "Pala Gaan" session with fellow artiste Shah Alam Sarkar, where the topic being debated was "Living Beings versus The Greatest". The event was held on the night of December 10, 2019, at Shahjahan's house in

Tangail's Kalihati upazila. Shahjahan and Iqbal had uploaded Rita's songs to their YouTube channels,

according to the case documents.

On February 1 last year. complainant Imrul was at home when he came across the video on social media. "The complainant was extremely

angry and hurt," said the PBI report.

'And upon finding no way out, the

complainant went to Kadamtali Police Station to file the case.' The complainant alleged that Rita was making "derogatory comments"

about religion. The PBI report "investigated the matter" and wrote in their report, 'Upon investigating videos of Rita's songs, we have found evidence of the crime. The words she chose to debate this issue hurt the religious sentiment of the audience.

Following the filing of the lawsuit, Rita, along with her two daughters, had posted another video on social media apologising for "causing hurt".

#### France court probes minister for conflict of interest

Subsequent blast injures six

A mechanic was killed and at least six were injured in an air conditioner explosion and another subsequent blast in a high-rise at the capital's Gulshan yesterday.

The deceased -- Azizul Haque (35) -was working at the AC chiller plant on the roof of a 14-storey commercial building "Empori Financial Centre", said fire service.

The explosion took place around 1:45pm on the roof, caused another blast in the UAE visa processing centre on the ground floor, said Abul Kalam Azad, senior station officer of Baridhara Fire Station.

He said they have to find out whether it was another AC explosion that also caused a fire, said the fire official.

The injured, whose identities could not be known immediately, were receiving treatment at a nearby hospital, said police and fire officials.

The explosions shattered the building's glass, damaged the furniture the visa processing centre's wall.

# Citizens, cops wary of further violence

The furious clash between activists of two councillor candidates at Mogoltuli Mogpukur Par area in the port city on Tuesday evening has made both the city dwellers and law enforcing agencies worried over further clashes in different areas ahead of polls day.

Their worry is mainly over the Awami League (AL)-backed councillor candidates and their rival candidates from AL who did not get party support in different wards.

A man identified as Azgar Ali Babul (52), was shot dead and another was hit by a bullet during a gunfight between activists of Nazrul Islam Bahadur, an AL-backed councilor candidate in Chattogram City Corporation (CCC) ward-28, and that of former councilor of the ward Abdul Quader, a Jubo League leader who failed to get party support for candidacy, on Tuesday Police and local sources said both the deceased and injured men were activists of Bahadur.

A joint team of police and Rapid Action Battalion during a drive on Tuesday night detained 26 people including Quader following the clash, said Sadip Kumar Das, officer-in-charge of Double Mooring Police Station

Sources in the area said the clash on Tuesday ensued over removing posters of Quader by some of Nazrul's activists on Monday evening. Quader lodged a complaint with the Returning Officer (RO) against Nazrul's men over removal of his posters on Tuesday morning, said sources in the RO office.

The clash erupted on Tuesday evening when both the candidates went to same area for campaigning, said locals.

# Rab arrests 'bitcoin trader mastermind'

Rab arrested 29-year-old Raihan Hossain, an alleged mastermind behind an illegal bitcoin operation on Tuesday night. In a special drive, members of Rab-1

arrested Raihan from Gazipur last Tuesday. Col Tofail Mostofa Sarwar, additional director general (operation) of Rab, disclosed the arrest and spoke about Raihan's activities yesterday, while talking with a group of reporters at the elite force's

headquarters in the capital's Uttara. Rab recovered 19 fake national identity cards, 22 SIM cards, Tk 1,275 and USD 25 in cash, a computer, three mobile phones, three fake invoice books, a trade license, a TIN certificate, a recording microphone, a camera, a router, a headphone, a modem, and four check books of different banks from Raihan's possession.

Sarwar said Raihan has been involved in "online sourcing business" for the last eight

Rab officials said he became involved in illegally earning through bitcoin with the help of a Pakistani national named Sayed.

Now, he has around 250 bitcoin accounts. He used to buy bitcoin after hacking credit cards. So far, Raihan has swindled over 30 thousand US dollars by monitoring local and foreign online bank accounts

using different smart devices. Col Sarwar said that they have found transaction history of USD 35 lakh in Raihan's account in just one month. Meanwhile, about Tk 35 lakh was found in one of his bank accounts, he said.

Raihan, the alleged mastermind behind online bitcoin trading and fraud, has recently bought an Audi worth Tk 1.8 crore, said the Rab high official.

Raihan has been stealing from ordinary people by colluding with Pakistani, Nigerian and Russian smugglers, credit card hackers and illegal smugglers through bitcoins, according to Rab officials.

He would use the banner of a fake company named MRH Software Development to lure people.

Col Sarwar further said that they are working to trace another racket of bitcoin trading, and illegal bitcoins will not be allowed to take root in Bangladesh.

# Want to see boats plying Rupnagar canal: Mayor Atiq

# CHATTOGRAM CITY POLLS Rebel candidates a headache for AL

Failing to get support from Awami League, the ruling party's rebel councilor candidates are desperately trying to get the support of BNP-Jamaat to win the election race of Chattogram City Corporation (CCC) polls scheduled for January 27, sources in Awami League and an intelligence report of police

Anxious of the prospect of losing the mayoral race due to division of voters following rebel councilor candidates' leaning into BNP-Jamaat, the AL high command is desperately trying to neutralise its rebel candidates and work united in favour of party-supported candidates in the local body polls, sources in AL said.

Admitting that the party is facing problems due to rebel candidates in the CCC elections, AL joint general secretary Mahbubul Alam Hanif told The Daily Star that the party's vote bank and voters are divided in elections, due to presence of rebel candidates.

"It becomes difficult for party-backed candidates in the mayoral and councilor posts. That's why we are working hard so that rebel candidates leave the election field and work in favour of party-supported candidates," he told The Daily Star.

Although he admitted that they are finding it difficult to manage rebel candidates, Hanif said whenever the party high-ups talk with them, the rebel candidates assure them verbally that they will not stay in the election field.

"But the reality is different," Hanif also

Asked whether AL's "rebel" candidates are trying to get support of BNP-Jamaat, Hanif said, "We are careful so that BNP-Jamaat voters cannot ride on the shoulders of rebel councillor candidates of AL, and come to the polling stations paving the way for BNP candidates to win in the election," he also said.

AL party insiders said several meetings had taken place at the residence of ALnominated mayoral candidate Rezaul Karim Chowdhury where senior leaders of AL in Dhaka and Chattogram were present to resolve the rebel issue and the party's internal feuds ahead of the polls.

Former minister and AL presidium member Engineer Mosharraf Hossain and Mahbubul Alam Hanif were present in an emergency meeting. The party's central leaders warned to take tougher organisational action if rebel candidates do not leave the election race and work in favour of party-backed candidates.

Despite the warning, rebel candidates are yet to step down from the election race. Due to the situation, election campaigning of AL is also being disrupted, according to

A field-level intelligence report of police recently also said AL's rebel candidates are trying to get support from BNP-Jamaat to win the election race.

In the report, it was also apprehended that clash and violence might take place among rebel candidates before election, as well as polling day. This newspaper has a copy of the report,

that states details of current political unrest in two blocks of Chattogram AL, pointing to some serious issues. According to the report, AL-nominated

councillor candidates and rebel candidates will be desperate to collect votes for themselves on polling day, leaving AL mayoral candidate Rezaul Karim Chowdhury alone in the election battle.

Due to severe rift and feud within the party, violence may also break out before or on election day.

Sources said former councillors of 13 wards failed to get party nomination for election. of them, 12 are contesting the election independently. Only in ward-13, former ward commissioner Mohammed Hossen Hiran withdrew his candidacy.

The report stated that the 12 rebel candidates for ward councilor are followers of Chattogram city unit AL's General Secretary AJM Nasir Uddin, adding that immediate-past mayor of CCC AJM Nasir has been doing his best to make his followers win, which will go against mayoral candidate Rezaul.

According to AL insiders, a rift is prevailing between Deputy Education Minister Mohibul Hasan Chowdury Nowfel and AJM Nasir. On Tuesday night, a clash between two councillor candidates - AL-backed Nazrul Islam Bahadur and AL rebel candidate and former councillor Abdul Quader -- left one person dead and another with bullet wounds.

Several people were injured in five prior clashes surrounding the election.

Party sources said activists and leaders backed by AJM Nasir were frustrated as Nasir did not get the party ticket for mayoral post of CCC. His followers believe that Nowfel is responsible for that.

Apart from that, a number of followers of late Mohiuddin Chowdhury, father of Nowfel, got party tickets to contest ward councilor posts. As a result, leaders and

# VC, wife leave HSTU campus in the dark

The vice-chancellor of Hajee Mohammad Danesh Science and Technology University (HSTU) left the campus on Wednesday dawn, allegedly in fear after some job seekers in presence of high officials of the university allegedly mounted pressure on him to finalise a recruitment before the end of his tenure on January 31.

Dr Abul Kashem and his wife left the campus at around 3:40am Wednesday by his official vehicle.

All of this unfolded in presence of the university's treasurer Dr Bidhan Chandra Haldar and registrar Dr Fazlul Haq, the VC told the Daily Star over the phone.

The jobseekers allegedly confined the VC and his wife for seven hours. He said the jobseekers stormed his official residence at the campus on Tuesday morning. Around 30 people got inside his residence and mounted pressure on him to finalise the human resources recruitment, but the VC turned them down as he could not do so.

Later, raged jobseekers cut off the power line of his official residence at around 3:30pm Thursday. "I was in complete darkness for hours and without water," he told the newspaper.

Till 9:30pm, the situation continued, he said.

Informed, a police team rushed to the campus and kept monitoring the situation. Mithun Sarkar, ASP of Dinajpur Sadar circle, said, adding police personnel were deployed to keep the situation calm.

"I left the campus as I was feeling unsafe there," said the VC over the

They don't want to be the patron of drug and teenage gangs.

Mahabubul Alam, BNP-nominated councillor candidate for Chandgaon, said, "It is true that everyone wants to get vote from all political parts to win the race. We have no connection with Jamaat now but Jamaat voters may cast vote in the election. Now the question is if they cast votes, who get those votes," he added.

Contacted, AJM Nasir Uddin, AL Chattogram city unit general secretary and member secretary of AL election management committee for CCC polls, said the party is strict in its decision of taking stern action against rebel candidates. "If one wants to stay in the party, they must follow its decision," he said.

Despite repeated attempts, Rezaul was not available over phone for comments.

## Citizens, cops

AL insiders said Nazrul, a follower of late AL leader ABM Mohiuddin Chowdhury, was a councillor of the ward between 2010 and 2015 while Quader, a follower of former CCC mayor AJM Nasir Uddin, was elected councilor in the polls held in 2015.

Both of them tried to get party backing this time but Nazrul succeeded, they said, adding that Quader was adamant to vie in the polls, defying party decision.

Locals apprehended more clashes in the area between followers of two in days to come.

"We afraid to go out of home," said a local of Mogoltuli area preferring anonymity. "Gunfight between activists of two rival candidates might have killed an innocent passerby.'

"The more polls day is coming closer, the higher the tension is between rival candidates," said another local.

Meanwhile, law enforcing agencies are also worried over the tensions. Sources in police said they were not too worried about tensions between BNP-backed councillor candidates and AL-backed candidates, rather they were worried over issues between AL-backed candidates and their rival candidates from the party.

A total of 12 former ward councillors who did not get support from AL are vying in the polls defying party decision.

Law-enforcing agencies are anxious of violence in those wards, particularly ward-14 (Lalkhanbazar), ward-33 (Firingibazar), ward-28 Pathantuli) and ward-12 (Saraipara).

Contacted, CMP Commissioner Saleh Mohammad Tanvir said police and law enforcers were alert to thwart any untoward situation in the city

"We will maintain law and order situation at any cost," he said.

In the third phase, the person takes part in extremist activities and in the fourth, they become extremists. In the final stage, they carry out violent extremist activities.

One young woman who was about to surrender went abroad to study. But her family did not know that she returned to the country as part of a militant group. Now, after returning to normal life, an initiative is being taken for her to finish her studies. In this manner, some are being given cows for farming, while others are given power trailer

Col Sarwar said, "We have considered what can be done other than handing over those involved in extremism to the law. It is difficult to solve this problem by knocking them down only through campaigns.

# Concrete wall on market land!

Local influential continues the construction work blocking way of 28 shops of the market

Our Correspondent, Patuakhali

A local influential man continued constructing a concrete wall occupying front side of a market, erected on a private land, near Kalaiya Launch Terminal in Baufal upazila.

Due to the illegal construction work entrance to at least 28 shops have been completely blocked, causing financial losses to the shop owners as they are unable to open their shops.

Several workers, engaged in the construction work, said AKM Farid Mollah, younger brother of local ruling party Lawmaker ASM Feroz is constructing the wall.

During a visit to the area on Saturday, this correspondent found that some workers were constructing a wall in the front of Haji Shahid Market, owned by one Shahid Alam.

While talking to this correspondent Shahid said he owned 65 decimals of the land on the west side of the launch terminal, while Delwara Runu, wife of Lawmaker ASM Firoz, possesses another 65 decimals of land on the opposite side.

In 2013, he built a 375-foot-long market beside the government road that connects the launch terminal, he said, adding that there are a total of 28 shops, including groceries, hardware, medicine and fruit shops, in the market.

Besides, there is another shop on the land owned by the lawmaker's wife on the east side of the terminal

Shahid alleged that Farid started erecting the wall in front of the market blocking way of all the shops in his market on last Thursday.

Shahid said they are not dared to protest the illegal act as Farid belongs to a local influential family.

One of the traders, seeking anonymity, said one can clearly see that the wall is of no use but to obstruct the way to the only market in the area.

They have another eight-foot land on the west side of the road, he said, adding that he is constructing the wall on that land.

Baufal Upazila Nirbahi Officer (UNO) Zakir Hossain said it is totally wrong to obstruct other people's movement by building concrete wall just beside a government road.

# Their request went unheeded for 47 years!

Before every public election in Joychondi union of Kulaura upazila over the last 47 years, many contenders made the promise.

But after the elections were over, none of the winners lived up to the promise of replacing the makeshift bamboo bridge, over the Gogalichhara river, with a proper concrete one.

The 30-metre-long rickety bridge is the only means of communications with the upazila headquarters for around 12 thousand inhabitants of Abutalipur, Mithupur, Rampasha and Begmanpur villages in Joychondi union.

With no more than a metre in width and without any handrail on its sides, the bridge becomes extremely risky especially during the monsoon when its uneven platform gets slippery and the rising current below flows with an enormous force.

During a visit recently, villagers including children, women and the elderly were seen risking their lives while passing each other on the narrow rundown bridge.

Abutalipur village resident Bashir Mia, aged 60, said, "We've been suffering for the last 47 years, since I was a child."

He also said the villagers turned in petitions for a bridge on numerous occasions to offices concerned in the union as well as in the upazila, but their appeal has gone unheeded all these years.

Arab Mia of the same village has four cows and he has to consult the upazila livestock office on the other side of the river quite frequently.

But while crossing the unsafe bridge, he cannot help but think of falling down in the river, he said.

A permanent bridge is urgently needed on the river to ensure safety of everyone -especially children, women, the elderly and those who require emergency medical care at hospitals in the upazila town.

The number of service seekers at Mithupur Community Clinic drops significantly during the wet season when the bamboo bridge becomes highly hazardous for crossing, said Kamal Ahmed, a community healthcare provider at the

Sutrisna Rani Sarkar, head teacher of Journalist Abdul Ahad, a resident of Rahmat Mia Government Primary School,

observed that dropout rate of students from the four villages by the bridge is higher than that in surrounding areas and a permanent bridge would help overturn the scenario.

'We went to every office concerned for a bridge and we get lots of promises from candidates when the election comes. But we never got the bridge," said Bimal Das, a member of a local ward.

Joychondi Union Parishad Chairman Kamar Uddin Ahmed said that he raised the demand in vain for a proper bridge at the spot several times during the monthly coordination meeting of Kulaura Upazila Parishad.

Asked, Kulaura Upazila Nirbahi Officer ATM Farhad Chowdhury said he was not aware of the situation, but he would take necessary steps after visiting the area.

#### **Hunt for cockpit tapes** after Indonesia jet crash

Bad weather forced scores of divers to temporarily suspend their hunt for a crashed Indonesian jet's cockpit voice recorder yesterday, as investigators worked to read critical details on a flight data device that had already been salvaged. The two "black boxes" could supply key clues as to why the Sriwijaya Air Boeing 737-500 plunged about 3,000 metres in less than a minute before slamming into the Java Sea soon after take-off on Saturday, taking with it 62 people. Divers just off the coast of Jakarta had hauled the data recorder to the surface Tuesday, with the hunt now focused on finding a voice recorder on the wreckage-littered seabed. So far authorities have been unable to explain why the 26-yearold plane crashed just four minutes after setting off from Jakarta, bound for Pontianak city on Borneo island, a 90-minute flight away.

#### Forest loss 'hotspots' bigger than Germany: WWF

More than 43 million hectares of forest -- an area bigger than Germany -- have been lost in a little over a decade in just a handful of deforestation hotspots, conservation organisation WWF said yesterday. Swathes of forest continue to be flattened each year -- mainly due to industrial-scale agriculture -- as biodiversity-rich areas are cleared to create space for livestock and crops. Analysis by WWF found that just 29 sites across South America, Africa and South East Asia were responsible for more than half of the global forest loss. The Brazilian Amazon and Cerrado, the Bolivian Amazon, Paraguay, Argentina, Madagascar, along with Sumatra and Borneo in Indonesia and Malaysia were among the worst affected, it said. Forests are an enormous carbon sink, together with other vegetation and soil sucking up roughly a third of all the carbon pollution humans produce annually. Yet they continue to disappear rapidly, threatening irreparable losses to Earth's crucial biodiversity.

#### Thousands arrested in South Africa for not wearing masks

South African police have arrested more than 7,000 people caught without face masks in public since the end of December, the government said yesterday. Officials made face coverings mandatory in May last year at the same time as they gradually eased movement restrictions imposed in March to stem coronavirus infections. Police Minister Bheki Cele said more than 20,000 people had been arrested or fined since December 29 for breaching the new rules, including 7,455 people detained for not wearing face masks.

#### **Dynasty politics major cause** of social corruption: Modi



Indian Prime Minister Narendra Modi has called upon the youth of the country to contribute selflessly and constructively in politics. Speaking at the valedictory function of the ond National Youth Parliament Festiva yesterday, Modi remarked that politics is a big medium to bring about meaningful change and like every other field, presence of youth is critical in politics also. He called upon the youth to root out dynastic system. Dynasty politics gives rise to incapability and dictatorship in a democratic setup as these dynasts work towards saving the politics of their family and the family in politics, he said. # US suffers worst day of pandemic

Sees a record 4,470 deaths in 24 hours; Chinese province of 37m declares 'emergency'

The United States has endured its worst day of the pandemic, with three Americans dying every minute, as China took decisive steps yesterday to stamp out a tiny coronavirus outbreak.

Global infections have soared past 91 million, and the spikes have forced governments around the world to reimpose restrictions such as unpopular and economically painful lockdowns, including in Europe which is battling a devastating second wave.

The United States is the worst-hit nation, logging a record 4,470 deaths in 24 hours on Tuesday, as it reeled from a winter surge in infections that has overwhelmed hospitals and clinics in many areas even as vaccines are rolled out.

"It's most definitely the darkest period of my entire career," said Kari McGuire, a palliative care supervisor at the St Mary hospital in Apple Valley, a small rural town in California.

"I've personally had to watch people that I know, that I care for, watch their loved ones die. It's been very difficult.'

Coronavirus patients at the overstretched hospital were crammed into hallways, makeshift ICU beds and

even the pediatric ward. McGuire said there were "astronomical numbers" of Covid-19 deaths -- the United States accounts for a fifth of the world's almost two million coronavirus fatalities.

Authorities on Tuesday announced that starting January 26, all travelers entering the United States by air will need a negative Covid-19 test before departure.

Japan was set to expand a coronavirus state of emergency on Wednesday beyond greater Tokyo to seven more regions to counter a surge in cases.

While Japan's outbreak remains comparatively small, with around 4,100 deaths overall, medics say hospitals are under heavy strain from the spikes in the worstaffected areas.

Governments worldwide are racing to acquire and deliver vaccines to help end the Covid-19 crisis, though the World Health Organization has warned that coverage is not expected to be wide enough for population-level immunity this year.

One of the Chinese-developed vaccines, CoronaVac, demonstrated a 50 percent efficacy following tests in Brazil, the organization in charge of its production in the South American country said Tuesday.

While that figure is much lower than the Moderna and Pfizer-BioNTech vaccines, Indonesia -- one of the world's most populous nations -- has given it the green light and kicked off a mass inoculation drive with it on Wednesday. President Joko Widodo became Indonesia's first recipient of that shot on live television.

While criticism and fears over slow vaccine rollouts are growing in North America and Europe, there was some positive news Tuesday when the European Union started the approval process for the Oxford-AstraZeneca shot.



#### Iran new 'home base' of al-Qaeda

Alleges Pompeo

Outgoing US Secretary of State Mike Pompeo alleged Tuesday that arch-enemy Iran has become a new "home base" for al-Qaeda, surpassing Afghanistan or Pakistan, an assertion mocked by Tehran and questioned by experts.

"Al-Qaeda has a new home base. It is the Islamic Republic of Iran," Pompeo said in a speech at the National Press Club.

"I would say Iran is indeed the new Afghanistan - as the key geographic hub for Al-Qaeda -- but it's

actually worse. "Unlike in Afghanistan, when al-Qaeda was hiding in the mountains, al-Qaeda today is operating under the hard shell of the Iranian

regime's protection.' Pompeo urged more international pressure, calling the alleged alliance a "massive force for evil all over the world."

But he announced sanctions on individuals and a \$7 million reward for information on an al-Qaeda member he said was believed to be in Iran identified both as Muhammad Abbatay or Abd al-Rahman al-Maghrebi.

Iran, a Shia clerical state, is ideologically opposed both to al-Qaeda and the Islamic State group, extreme Sunni movements that are predominantly Arab, and has fought on

fronts abroad against both. Iranian Foreign Minister Mohammad Javad Zarif said that Pompeo "is pathetically ending his disastrous career with more warmongering lies."

# Israel kills 57 in Syria in deadliest attack since 2018

Israeli raids targeting arms depots and military positions in eastern Syria killed at least 57 pro-regime fighters, in the deadliest such strikes since 2018, a war monitor said yesterday.

The Israeli air force carried out more than 18 strikes against multiple targets in an area stretching from the eastern town of Deir Ezzor to the Iraqi border, the Syrian Observatory for Human Rights

The overnight raids killed fourteen Syrian soldiers and 27 foreign militia fighters whose nationalities were not immediately known, the Britain-based monitoring group said. The monitor couldn't verify the 16 other people killed.

They wounded at least 37 others.

Paramilitaries belonging to the Lebanese Hezbollah movement and the Fatimid Brigade, which is made up of pro-Iranian Afghan fighters, operate in the region, the Observatory said.

Days before the strikes, the Fatimid Brigade transported a consignment of Iranian-manufactured weapons to eastern Syria from neighbouring Iraq. They were stored in the region targeted

yesterday, the monitor said. The Israeli military did not immediately comment.

The latest raids came hours after separate strikes near the Iraqi border killed at least 12 Iran-backed militia fighters on Tuesday.

The Observatory said it could not

identify the warplanes responsible for the earlier strikes. It is less than a week since the last wave of Israeli strikes in Syria.

On January 7, Israel targeted positions in the south and in the southern outskirts of Damascus, killing three pro-Iran fighters.

Israel routinely carries out raids in Syria, mostly against targets linked to Iran in what it says is a bid to prevent its arch foe from : consolidating a foothold on its northern

Observers have warned that Donald Trump and Israel could up the ante against Iran and its regional allies in the dying days of the US president's tenure.

# **EXCERPTS FROM THE INTERVIEW OF** DR. MOHAMMED FARASHUDDIN AN ACADEMICIAN'S PURSUIT OF EXCELLENCE

During the last few decades, Bangladesh has made notable progress in the education sector across all levels. While the country has reached near-universal net primary enrollment rate, it has also made the tertiary education accessible, resulting in increasing enrollment in colleges, universities, and polytechnic institutes. One of the key drivers in achieving this change has been the support from the private sector actors, especially in establishing private universities and polytechnic institutes during the nineties.

As of 2019, according to the World Bank, 45% of the tertiary education enrollments have been in the private sector tertiary education institutions. Besides, the enhanced world-class curriculum offered by some of these institutions has helped shape a strong workforce for this fast-growing economy. One of the visionaries who has played a significant role in promoting tertiary level education in Bangladesh in the private sector is the founder of East West University, Dr. Mohammed Farashuddin. The aim was simple, "To provide quality education at an affordable cost in Bangladesh," as stated on the university's website.

To know more about what motivated the erudite scholar to resist the temptation of a comfortable life abroad and return to his motherland to work towards promoting education, we caught up with him on the second episode of Preronar Kotha.

"My education was like a religion to my mother. And my father used to think that education is imperative for contributing to the building of the nation", said the academician at the beginning of the interview.

Encouragement from his teachers greatly influenced his lifelong pursuit of education. While discussing his motivations, he shared an anecdote from his high school days, "I used to respect our headmaster Mr. Suruj Ali a lot, even though some people were afraid of him. On our second day at school, he took our English class. There, he asked a very tough question, and I answered that from the last bench. He asked some more questions, and I answered them as well. He then brought me forward to the first bench, where the class toppers used to sit."

In 1966, he joined the elite erstwhile Civil Service of Pakistan (CSP) and worked in the field administration as Sub-divisional Officer (SDO). After the liberation war in 1971, he got appointed as the Private Secretary of the Father of the Nation Bangabandhu Sheikh Mujibur Rahman, where he worked very close to him and oversaw the socio-economic and cultural advancement, formulation, planning, and implementation of the pro poor and anti-poverty economic policies of the war ravaged country.

In 1975, he went to Boston University, USA to pursue his Masters and PhD. His perseverance, hard work and focus helped him earn his PhD within 3 years 9 months, while most people take much longer than that, Economics has always fascinated him and the intriguing concept of cost-benefit analysis which he researched as part of his PhD work has later helped him in every aspect of his professional career.

Later on, despite being engaged in full-time professional commitment in his roles in the public and development

sectors including the United Nations, Dr. Farashuddin never gave up on his passion for education and teaching: "I have worked in three countries. Anywhere I went, I tried to find out if I could teach a subject there." Even today, at this age, Dr. Farashuddin loves and enjoys teaching and interacting with the young talented minds.

His dream to contribute to the education sector has made him establish East West University, the third-largest private university in Bangladesh, with the aim to disseminate knowledge and education and develop human capital. Dr. Farashuddin has always been outspoken and tough in making the right decisions. He mentioned that his ability to make tough decisions enabled him to make some positive changes in this professional life.

As the Governor of the Bangladesh Bank, he has implemented his learnings and knowledge and executed some rigorous decisions to address the issues of corporate governance. "Directors used to default loans from their own banks, political people used to sit on the director's board. I put

In order to encourage and attract talented officials to Bangladesh Bank, Dr. Farashuddin did one more thing, "Those who joined Bangladesh Bank with four first-class degrees would get four increments, which would ultimately make their net salary a lucrative amount."

As an academician, he believes that our education system in Bangladesh needs some major changes to reduce inequality and to build a better value system. He emphasized the importance of community-based schooling for children. "We need area based or community-based schools. Students need to interact with and go to school with children from their own locality. Uniforms and food will be the same for everyone. Currently in Bangladesh, there are only a few schools, few colleges and few higher educational institutes which are good, if we have locality based schooling and everyone is provided the same education, there won't be education/learning divide".

The devotion to give back to the country and community where he was brought up made Dr. Farashuddin leave a lucrative and rewarding career in the USA after his PhD and return to his motherland. This sacrifice and patriotism stand as an inspiration to our younger generation. He mentioned during the interview.

"I believe that if we Bangladeshis do not stick with each other, if we do not help each other, then we can't take the country to the highest level. This is why I came back."

While conversing, he even added, "If I had Aladdin's lamp, I would change the way our students think. I want them to engage in creative thinking. I feel inspired when I talk to students who came back to Bangladesh to give something back to the country."



#### **BOOK REVIEW: NON-FICTION**

# Shashi Tharoor Looks Through A Glass Darkly, For Democracy

#### FAKRUL ALAM

This is a must-read book for anyone worried about the vulnerability of democracy in our time and the rise of authoritarian governments everywhere. It is an apt reminder of the importance of democratic alternatives to totalitarian tendencies masquerading under populism. Surely, the dire consequences of tampering with democracy's fundamental principles should be disturbing anyone concerned even a bit about human civilisation. The phenomenon of Donald Trump, Vladimir Putin, Jair Bolsonaro, Viktor Orban, Recep Tayyip Erdogan—all "strong" men marring democracy—though depressing, is worth reflecting on.

In The Battle of Belonging: of Nationalism, Patriotism and What It Means to Be Indian (Aleph Book Company, 2020), Shashi Tharoor mentions these democracy-threatening leaders (he dubs them "oxymoronically" as constituting a "Nationalist international"), as well as ideal ones we can continue to seek guidance from, while ruminating about the state of democracy in his nation. As the inside cover flap informs us, he is (in his third term) "the longest serving member of the Lok Sabha" from his Kerala constituency, winner of India's Sahitya Akademi award, debater par excellence (watch him speak on YouTube at the Oxford Union debate, "Britain Does Owe India Reparations"), a former Under Secretary-General of the UN, and a State Minister in the last Congress government. The book under review is only the most recent of his other widely-read and thought-provoking titles.


Tharoor's is a learned and up-to-date work—it has 492 footnotes and a bibliography 25 pages long in addition to many in-text references to happenings only some months old at this time. He has read extensively and thought at length about the crisis imperiling democracy in his country. Seeing Trumpintoxicated demonstrators storm Capitol Hill, Tharoor would have surely linked CNN images of the rabid mob assaulting the citadel of American democracy to Indian media images of recent times— Kashmiris paralysed by the security "lockdown" and the communications "blackout" imposed on Jammu and Kashmir in 2019, or working-class Indians and immigrant labourers stranded everywhere after the Coronavirus lockdown enforced by India's central government in March 2020.

On the one hand, The Battle of Belonging is a paean to an India heir to "a rich and diverse and plural civilization". This is the India that Tagore, Gandhi, Ambedkar (three

of Tharoor's heroes) and others envisaged in their different ways. This was an India that was a herald of parliamentary government, of "liberal constitutionalism", and a vibrant even if not always perfect postcolonial democracy, of democratic pluralism, and the kind of civic nationalism where diverse peoples of different origins, religions, languages, classes and castes kept overcoming all sorts of odds in their bid for integration. On the other hand, as far as Tharoor is concerned, is present-day India where democracy is being undermined by a majoritarian rule that has been taking advantage of democratic norms only to subvert them. He sees in his India today the nurturing of the cult of the strong man-ruler, "ethno-

sense of belonging, not just to a physical country called India, but to the idea that it represented in the world." Tharoor's passion does make him insistent and repetitive at times, but he has a mission to persuade his Indian readers through this book. He absolves himself on this point with a sentence worth quoting—"As I never tire of pointing out, the fundamental DNA of India, then, is of one land embracing many."

And why should I, a Bangladeshi, value his book? Bangladeshi nationalism is central to my thinking, but I see it as part of a quartet, along with socialism, democracy, and secularism—all embodied in our 1972 constitution. From what I can deduce from his book, his vision

religious nationalism" in ferment, and people being cajoled for devious purposes through surreptitious use of new media channels.

Tharoor writes with passion, urgency, and learning. His 410 pages of text is in very readable and often eloquent prose; however, he wears his learning with ease and wit. He illustrates his concerns and his convictions with impressive writerly skills and telling examples from world history. He has, obviously, a phenomenal memory and a gift for apposite quotes. Most important, he writes about his country entirely as a patriot; as he tells us in his Prologue, although he has "spent a lifetime acquiring and embodying a cosmopolitan, even globalist, sensibility", his father had passed on to him "a passionate of India is not dissimilar. Also, like Indians, Bangladeshis can lay claim to a heritage that has evolved out of "a shared history". Like him, we should be wary of, and vocal against, encroachments on basic human rights in our country every which way we can and articulate our concerns as best as we are able to from where we are. Finally, like him too, let us look forward to the optimal functioning of "pluralist democracy," operating "under the rule of law" in our beloved country.

# The Fall of A Great America

In a near-perfect echo of today's world, Nobel Prize-winning Elfriede Jelinek's On the Royal Road: The Bergher King (Seagull Books, 2020) is stuffed breathless with metaphors, innuendoes, and anecdotes as it satirises US President Donald Trump.

The foremost of these lies hidden in the title itself—the play follows the journey of an unnamed land after its petulant and destructive new "King" has just been voted into power; but the "Bergher" in the subtitle refers both to the German word, bürger, for "citizens", and to the US President infamous for his plump, garish, golden-orange aesthetic. Such is the nature of Jelinek's humour, translated from the German by Gitta Honegger. The things they write of are funny because they critique the obvious and the discomforting—the fact that the people "cast their vote, but don't know who they voted for, even though they did it themselves," for

Jelinek finished writing the script three weeks after Trump was elected President on November 8, 2016. By the time Honegger began writing her Introduction to the English translation in September 2019, wheels were turning on Trump's impeachment inquiry. The text, therefore, evolved almost at par with the pace of life under Trump's rule, which, as the play recounts, has included everything from word vomit on Twitter to tax fraud, displays of aggression, sexual predation, denial of truth, and individuals being stripped of finances, citizenship, and human dignity. In one of the most relatable instances, Jelinek writes, "Everyone has his own facts and everyone else also has his facts, but different ones. Of course, they are not the same, but both are true. Thus everybody has a weapon against everybody." At the centre of this storm brewed by misinformation stands the golf-loving, gold-loving King, who insists, "Only i tell the truth, i alone, i have been legitimized, here is my king's id which has been forged for a

long time, but now no longer, now it's the real

To control all this chaos, Jelinek presents the play entirely in the form of a monologue, delivered by a blind seer in the Bergher King's court. This seer is a manifestation of Tiresias of Oedipus Rex, who foretold Oedipus' destiny. Here, though, the seer-narrator is a woman—that creature that both Trump and his predecessors of classic literature so loved to silence, and she is also Ms Piggy of The Muppet

Jelinek can be examined to reveal harrowing truths about a world endangered by voice given to the blind, i.e. the world of January 6, 2021, when hundreds of Trump supporters stormed the US Capitol to challenge a free and fair election after being incited by his speech.

Jelinek's play was published before the breach of the Capitol, but in a fitting warning against the power of hate speech, it begins with a reminder that, "In the Beginning Was the Word", that "[e]verything has happened





Show—as fitting a soothsayer for a cartoonish King as can be.

Seasoned readers will notice how the play engages with Greek myths and the philosophies of Heidegger and Girard to reveal the ironies and failures of our modern existence, buoyed and weighed down by capitalism, neighbourly competition, and the violence it all brews. For many, however, the rambling sentences and absence of a plot and chapters can be difficult to digest. But if one can find the time, each and every word by

already, but isn't over yet." In the pages that follow, the play reveals unflinchingly how complicit everyone has been in the entire spectacle of the Trump presidency. And because Jelinek never actually names the country nor the leader, it becomes a raw and scary tale of power left unchecked which can apply anywhere in the world.

# Sweet, Sour, and Savoury: A Post-Partition Tale

There are few pleasures in the life of a Bangali that come close to the sheer delight of basking in the rare but sweet Sun on a winter morning on the balcony, accompanied by the aroma of a cup of tea, sweetened with milk and sugar, while you immerse yourself in a book that won't spoil the harmony of this experience. Bhaswati Ghosh's debut novel Victory Colony, 1950 (Yoda Press, 2020) fills this role quite well.

Amala is a young refugee whose parents were the victims of communal riots in East Pakistan after the Partition. She also loses her only brother soon after arriving in Kolkata. When Amala is being escorted to one of the refugee camps, we meet Manas, a sensible young man from an educated, upper class Kolkata family.

The strength that imbues Amala gives the novel its heart. She is the symbol of the refugees' endurance in the face of constant struggle for survival. Manas's perspective on the influx of refugees to his city sounds like the voice of conscience. If Amala represents the refugees from the East, Manas can be read as the bright side of Kolkata which has opened its doors to welcome the stranded.

Manas's attraction for Amala is easily felt from the beginning of the novel and the progression of their relationship does not come as much of a surprise. Through their bond, the novel aims to symbolise the harmonious existence of the refugees and their culture in Kolkata.

As an instrument of storytelling, the novel is delightful in its reliance on Bangalis' love for food, which has not been done before. From Chitra Mashi's macher jhol and fried fritters to the moments when Amala and Manas share a pack of murimakha in the refugee camp, it effortlessly penetrates the personal and cultural spaces with food.

In fact, reading Victory Colony, 1950 at

times feels like a trip to my maternal aunt's place. The probability that the trip will end badly is slim to none, it is filled to the brim with affection and warmth, and not an hour goes by when my palate is not treated with a delicacy. (I hope my mother doesn't read this, or she will certainly yell—keno, toke ami khete dei na? One of the great things about this novel is that it has no shortage of doting *mashis*.

While the book spends considerable time in detailing Manas's aristocratic home, however, it dwells surprisingly little on the existential crisis of the refugees. Nor does it aim to portray a complete picture of how the people of Kolkata responded to this huge influx to their city. We see Manas's enthusiasm in helping the refugees but he is a college educated member of an aristocratic family. The confrontation of the local zamindar with the residents of the Bijoy Nagar (Victory Colony) cannot be taken as representative of the response by the general people of Kolkata across classes and communities.

Over the recent years, we have seen Donald Trump and his supporters' reaction to Mexican immigrants pouring in from America's southern border. In our own backyard, we have been reluctant to share our resources with Rohingya refugees who have narrowly fled the grasp of death. Unlike Manas and his group of volunteers, the incessant buzz here is—when will they go away?

As an antidote, Victory Colony, 1950 makes a case for finding hope and resilience when life throws its harshest weather at you—the cold and foggy early hours of the morning making way for the glimmering, warm rays of the Sun.

## Police officials are not above the law

Higher authorities cannot absolve themselves of responsibility for corruption of those under them

E must applaud the recent observation from the High Court which stated that "a handful corrupt police officials who have been tasked with the duty to protect and preserve the life of innocent people of this country became errant...", asking "how will the general people repose faith on the police force and find the police station as their safe place to register their grievance?" This observation was made in reference to the wrongful arrest and incarceration of Md Arman, who spent five years in jail for a crime he didn't commit.

What is important to note here is that the HC did not just limit its observation to the errant police officials in question. It added, "...their higher authority has miserably failed to hold these corrupt, defiant police officials accountable for which they cannot absolve their responsibility", specifically stating that in the case of Arman, the IGP in question "cannot skirt around his responsibility on such a planned, deliberate and wrongful act".

While the observations were delivered as part of the 39page full text verdict on Md Arman's unlawful incarceration, we hope that the implications for the police force will go far beyond this one case. The HC has clearly outlined a fundamental issue that is rotting the Bangladesh Police from within, and fast depleting public trust and confidence in our nation's law enforcers—a blatant abuse of power that allows certain police officials to hold themselves above the law, even while "enforcing" it, and use their influence to engage in corrupt and unscrupulous activities. And although the HC has pointed out that this does not mean the entire police force is to blame, it is clear that we can also no longer shift the blame onto rogue officials without acknowledging the failure of the higher authorities to hold these officials to account. As long as they choose to look away, they too are complicit in these crimes.

It is no secret that arbitrary arrest and detention, along with custodial torture, is a common occurrence in Bangladesh. As recently as January 3, police were accused of the custodial torture and subsequent death of 30-yearold law student Rejaul Karim Reja in Barisal. The stereotype of the violent, corrupt police officer from Bangladesh is of great concern, not just for the higher authorities of the police force but also for the government and the entire nation. At this point, simply taking disciplinary action is not enough. There must be a cultural shift from within the police force itself that expels such abusive and immoral practices from within, and all such corrupt officials must be tried for breaking the laws that they are meant to uphold. Without radical change, it is the marginalised citizens of this country like Md Arman who will continue to suffer and have their human rights violated, with little recourse to

## Community initiative for building roads commendable

But why doesn't the union parishad have funds for such development work?

T is encouraging to see what people can achieve when they join hands to make a difference in their own lives and communities. As reported in The Daily Star on January 13, around 700 inhabitants—around 500 men and 200 women—of Netrakona's Kalmakanda upazila have been working voluntarily to build a new road which, once completed, will reduce the sufferings of around 15,000 villagers. The volunteers hope that they will complete the work of the 4.5-kilometre road within a week, which is

Reportedly, building a road through these villages has been a long-time demand of the residents but it could not be done due to financial constraints of the union parishad. According to the local union parishad chairman, with their limited budget it is not even possible to repair the roads, and building new ones is just impossible.

It is easily understandable what happens when there is no proper road in a village. It is not only that communications with the nearby villages and towns get hampered, the villagers also cannot have their basic rights ensured. Education of children becomes very difficult as schools and colleges are usually situated miles away. It gets particularly difficult for girls to continue their education after the primary level if the schools are far away and the road communication is not good enough. And getting healthcare at upazila health complexes or nearby hospitals during emergency situations also becomes a challenge. Moreover, people's sufferings increase during monsoon, especially when they have to transport their agricultural produce or other goods to the nearby bazars.

While we commend such a community initiative to build the much-needed road in Netrakona, we also wonder why the local union parishad does not have funds to build the road. According to the union parishad chairman who inspired the villagers to build the road on their own, his appeals to the upazila parishad and local administration for building a new road through the villages have fallen on deaf ears. The authorities concerned must give an explanation regarding this. Finally, we hope the new road will bring better days for the people in the eight villages in Netrakona.

one such incident. But that wasn't the end of it. The postincident scenario is turning out to be more pathetic.

First, a section of people reached the conclusion that the victim and her family were responsible for this. Why did she go to her friend's residence? Why did her mother allow her to go there? Social media has been flooded by such types of questions. For many, the rape was a foregone conclusion. They also raised questions about the dress of the girl, her intention to go to her friend's house, and her "love affair" with the boy, thus conveniently shifting the blame onto the victim herself. In short, she created the situation that led to her eventual murder.

Unfortunately, our society is accustomed to blaming a rape victim whether she belongs to the lower class, the middle class or the upper class. Maybe this mentality is a new phenomenon, or maybe it has been going on for long. It's hard to determine since there was no social media in the past that could give us unfettered access to the deepest reaches of people's minds. But social media has certainly brought this to the fore, and its impact has been far-reaching as more people seem to be influenced by this toxic

Several factors are responsible for the growing trend of victim blaming. When a "responsible" person or institute in our society expresses such mentality, it influences others. Recently, a lawmaker, while delivering his speech in parliament, blamed women's attire and their "freedom of movement" for the growing incidence of rapes. It met no strong protest either inside or outside the parliament. The question is, how much impact does a comment like this from a lawmaker have on our society? A more pertinent question is, what do such remarks and the fact that they meet no significant resistance tell us about the entire society?

The role of police in such cases has long been a thorny issue. Police are often seen to spread unfair claims and insinuations centring the victim. Then the gossip mill goes into overdrive, spreading these insinuations far and wide. In case of the Kalabagan rape victim, police have adopted almost a similar approach. A short summary of what police said would be that she was not raped. Rather, everything happened through mutual

understanding. It appears police were rather quick to conclude that it was consensual sex.

After the incident, the accused, Dihan, took the girl, who was suffering heavy bleeding, to hospital and said she was 19 years old although, in reality, she was 17 years and three months old. When the girl was dying, Dihan could sense that she would have to be presented as being above 18. Police picked it up and mentioned the girl's age as 19 in their case statement. Even when the victim's mother showed a certificate proving she was indeed 17, police refused to correct it and instead gave priority to Dihan's statement. The mother brought this allegation against the police. The law enforcement agency members reasoned that they had collected her age from hospital documents. But hospital authorities only recorded it based on Dihan's statement without any verification.

There is no chance to get the victim's version of the story as she is no more. But attempts are being made to justify the crime by pushing forward the theory of "mutual understanding", so much so that it would appear as if the victim gave consent to her own murder.

The fact of the matter will be known after a fair investigation. The irony is, police will conduct that investigation. If police have made those comments based on assumptions or bias before the actual investigation, it already constitutes a breach of trust. This is a fate that many victims of various crimes have to suffer

Dihan's father has recently retired from his government service. Some media outlets have reported that he owns a huge amount of wealth. Everybody knows how much salary a sub-registrar gets. Most of them are allegedly involved with corruption and irregularities. This is applicable not just for sub-registrars, but all so for many bureaucrats. As per information from the foreign minister, those who laundered money and bought houses in the Begumpara of Canada are either former or incumbent bureaucrats. So, irregularities and corruption have become an integral part of the society. And it got institutionalised due to lack of good governance.

Now, it seems the society is facing the consequences. When a young person gains access to unlimited money and luxurious cars provided by their guardian's illegal income, it is bound to have a negative impact on them. # We must do more to protect our children from sexual abuse

HAT comes to your mind when you hear the term "school"? You think of a space where children go to learn and develop their skills. A place where children learn to grow intellectually and emotionally, make friends, create beautiful memories, and feel safe. We do not think of it as a place where children might undergo horrifying experiences that can leave a life-long psychological scar on them.

Incidents of mental and physical abuse of children at the hands of their teachers and schoolmates occur all the time at educational institutions globally. Child abuse has become a global concern as it has damaging consequences for both the children and society. The violence subjects the children to unimaginable pain and humiliation, which affects their learning process and negatively impacts their personalities and prospects.

According to the Center for Global Development, a total of approximately 400,000 girls across 10 countries were reported to have experienced sexual abuse in schools in the year between March 2019 and March 2020. Often teachers are the perpetrators of sexual harassment. For example, according to PISA for Development, one in eight boys and girls in Senegal and Zambia have been reported to be harassed by a teacher or staff member within a month.

The Demographic and Health Surveys (DHS) programme conducted a survey among numerous countries where they asked women whether they had been sexually abused by a teacher when they were in school. The survey found that over 10 million women in India, 6 million in the Democratic Republic of the Congo, and 3 million in Nigeria were sexually abused when they were in

The worst part of the situation is that most of the time, teachers are not held accountable for sexual harassment and abuse of children. Moreover, the Center for Global Development has also found that many countries do not even have a

code of conduct for teachers that would typically ban sexual abuse or harassment of students. As a result, children lose their trust in adults and law enforcement, and it can permanently impact them. It also forces them to drop out of school, affecting their education and leading to a segment of the generation to remain uneducated and unable to contribute to the development of the economy.

In recent times, Bangladesh has also witnessed a rise in the number of child abuse cases. According to research by Bangladesh Shishu Adhikar Forum (BSAF), 571 children were raped or gangraped, and 87 kids were sexually harassed in 2018. In 2019, 164 children were raped or gang-raped, whereas 27 kids were sexually harassed between January and March last year. However, according to Ain o Salish Kendra (ASK), the actual number of children abused every year is much higher. As a matter of fact, many incidents are not reported to the local authorities or any authorities at all.

The abuse is taking place on both genders but more on girls than boys. However, according to a United Nations study in 2013, definitions of violence, harassment, and abuse are not consistent globally. This further deepens the problem.

Violence against children is preventable and must not be tolerated. Children have the right to be in a safe school environment where they will be able to learn to the best of their ability. Every child has the right to go to school without fearing their teachers or schoolmates. To address this, an organisation named Darkness to Light provides a training called "Stewards of Children" to address sexual abuse of children. Stewards of Children uses real people and real stories to represent how children can be protected. The training provides in-depth information and skills development on various topics. The training is designed to help people recognise and report child abuse. It also

teaches ways in which bystanders can protect children from sexual abuse, what constitutes healthy and inappropriate touch for children, how to talk to children about protecting themselves from sexual abuse, etc.

A framework consisting of five steps has been created to protect children and prevent child sexual abuse. The first is to learn the facts. If we do not understand child abuse, then we cannot end it. Secondly, we have to create a safe environment to reduce abuse risks. Over 80 percent of sexual abuse cases occur in isolated, one-on-one situations. Thirdly, we must openly talk about the issue. Talking freely breaks down barriers and reduces the stigma associated with sexual abuse. By talking openly about our bodies, sex, and boundaries, we can encourage children to share. Fourthly, we need to recognise the signs of child abuse. Signs of abuse are not always obvious. Emotional and behavioural changes can be noticed. Lastly, it is our responsibility to react appropriately to suspicion, disclosure, or discovery of abuse. Only 4 to 5 percent of all sexual abuse reports are false; the rest are real.

Very few schools in Bangladesh have proper child protection policies and training in place to safeguard the students. Only a handful have strict child protection policies and training requirements. Schools should conduct child protection training every year. All the faculty, admin and support staff, including the gardeners, canteen staff, guards, and technicians, should participate in it.

If all schools take such initiatives, it can prevent child abuse in educational institutions significantly. The violence is preventable and proper initiatives and knowledge can tackle the issue and provide a safe environment for the children and the youth to learn and grow. Child abuse can happen anywhere, and as adults, we must do everything we can to prevent it.

**I** the headlines of your newspapers? If one were to run a quiz to see how well the readers of The Daily Star stack up against each other, the question that is BADIUZZAMAN BAY most likely to be at the top of the list

would be about the name that appeared most in the headlines of our central pages over the last week. The answer may surprise you: Abdul Quader Mirza, a local Awami League leader and incumbent mayor of Basurhat municipality in Companiganj, Noakhali. He grabbed headlines for seven consecutive days starting from January 7 in the front or back pages of The Daily Star, exceeding the number of appearances by his party chief, who usually has this place of honour when it comes to headlines or placement of new items in national newspapers.

I drop this little statistical truth bomb merely to illustrate the curious case of Quader Mirza, who has sparked a political firestorm with his shatya bachan (or truth telling) in the run-up to the second phase of municipality elections due on January 16. A two-time mayor of Basurhat, Quader Mirza is now up for re-election. But since declaring his manifesto on December 31, he has been seemingly on a warpath against his own party. In comments made in public meetings and to journalists, he let off a dizzying drumbeat of criticism, grievances and warnings, directed not just at the who's who in greater Noakhali politics but also the central leadership.

What makes his case so curious is that he is also the younger brother of Awami League General Secretary Obaidul Quader, an obvious source of discomfort for the party rank and file. Although he claims that he merely meant to talk about corruption and irregularities in regional politics—not about national political issues—the remarks speak for themselves. Before we go into the broader implications of this issue, here's a motley assortment of Mirza's most contentious comments.

"There are some sycophants involved with greater Noakhali politics who claim the BNP's fort in Noakhali and Laxmipur has been demolished under the leadership of certain

leaders," Quader Mirza is heard saying in a video clip of his December 31 speech that later went viral. "If there is a fair election, our MPs, except for the ones in three or four constituencies in greater Noakhali, will not even find a door to escape. That's the truth.' On another occasion, he said, "Bangabandhu liberated the country to establish people's right to food and vote. The right to food has been established, but we have not yet been able to establish the right to vote." He, therefore, wants to ensure a fair election on January 16. He also claims there is a conspiracy afoot to rig the election against him and even to kill him, a claim he repeated several times over the week, saying he had received death threats for his bold assertions. Some local Awami League leaders also brought in illegal firearms to thwart his re-election bid, he alleged.

Without citing any name, he also talked about what leaders are like these days. "Leaders are those who burn people in broad daylight. Leaders are those who loot crores of taka through tender manipulation. Leaders are those who take Tk 5 lakh in exchange for jobs of police and primary teachers. Leaders are those who take Tk 3 lakh from a poor peon in exchange for his job," he said. In his lengthy diatribes, Mirza spared no one—local Awami League leaders, MPs, administrative higher-ups including deputy commissioner (DC) and superintendent of police (SP), and even national leaders and former ministers. He spoke passionately about the crisis in leadership, sometimes with facts to back him. Thus he painted a landscape that is utterly chaotic, where morality is a moving target.

He also spoke of his trust in the prime minister's leadership but points to those who surround her. He said, "Sheikh Hasina wants fruits (results) in elections. But in their eagerness they would uproot the whole tree for her. Some people in the administration are doing it to destroy her image." Sycophants and corrupt people are misguiding the prime minister and even bypassing her directives, he claimed. He urged her to take stern action against party leaders if they are found involved in corruption, drug abuse or scandals involving women.

As extraordinary as these accusations and insinuations are, his observations about his own elder brother came as icing on the cake. Initially, he appeared appreciative of his brother's achievements. But later he was coy on the subject, and on January 10, following

a thinly-veiled threat from the former, he became quite vocal. He alleged that Obaidul Quader had acted as a major barrier to his emergence as a national leader. "In my student life, I wanted to study in Dhaka. But he advised me to study in Chattogram because he feared that I would emerge as a bigger leader than him. Obaidul Quader did not let us move ahead," he said.

He added: "Before the national elections, Obaidul Quader promised to arrange jobs for eligible people in every household. But where are the jobs?" he asked. He expressed further resentment at a rally on January 12, saying, "In the presence of one of his domestic helps, he said I am a self-proclaimed mayoral candidate, and that I am not a party man. Now you people tell me whether I am a selfproclaimed candidate... This is an insult." Whether there is any truth to his statement about his brother is immaterial to our discussion, but it does have the unexpected outcome of hitherto-suppressed sibling rivalry playing out on the big screen.

There is a lot to take away from Quader Mirza's bold, relentless shatya bachan mission, which he launched apparently after having survived a tumour surgery. Such allegations

about electoral fraud, voter suppression and widespread crimes and corruption with the connivance of ruling party leaders and loyalists usually come from opposition parties, and are roundly rejected by those in power. But coming from an "inside" man, not least one with decades of experience in grassroots politics, these acquire a veneer of credibility difficult to dismiss offhand. Allegations become revelations then, offering a window into the true state of politics in Bangladesh. While Quader Mirza appears paranoid at times and may have his own motive for turning on opponents so near to the election (after all, he equivocated on his own role in the picture he paints), he is certainly not the first politician to publicly challenge party interests/narratives. Nor is the reaction he received from party colleagues totally unexpected.

One may recall the fate of former Awami League minister and two-time MP Abdul Latif Siddiqui, who in September 2014 was widely criticised for his remarks about Muslim pilgrimage and certain Islamic organisations. Afraid to be judged unfavourably by its devout Muslim base, the party sacked him

from his ministerial post. Further back in time, one may also recall the dramatic removal of then-President Badruddoza Chowdhury in June 2002 following an uproar over his refusal to pay a visit to BNP founder Ziaur Rahman's grave on his death anniversary. In the not-so-short history of our democracy, we have seen many such instances of once-loyal party leaders and loyalists,

decorated freedom fighters and even justices seeing the short end of the stick for their apparent revolts against authority or party narratives.

Will Quader Mirza meet the same fate? We don't know. One thing is certain that there is still no tolerance for diversity of opinion within our so-called democratic parties, which view any reformist pushback as insubordination and therefore deserving of

To be frank, I'm not interested in the allegations Quader Mirza brought specifically against certain leaders. It's his word against theirs. But many of his comments do confirm what we already know about political crimes and corruption in Bangladesh. Awami League leaders often talk about the infiltration of outsiders leading to divisions and opportunism within the party, giving it a bad rap in the process. But seldom do they talk about how these developments may be the outcome of its own lack of discipline and intraparty democracy as well as its ideological flexibility. A recent Prothom Alo report, citing data from the police headquarters about complaints filed with police stations across the country, shows an uptick in six crimes since the start of the pandemic. These are: rape, mugging, extortion, causing panic/terror, property grabbing, and cattle theft. If past trends hold, it can be assumed that criminals enjoying the protection of local ruling party leaders have been involved in many of these cases. Quader Mirza has added only three more to the list: election violence, tender manipulation and recruitment scandals. What's surprising about it is that he chose to

Many have praised his courage. Many, especially party stalwarts, lambasted him for being hypocritical ("biting the hand that feeds him"). But for a party ruling the country as long as it has, Awami League will surely benefit from taking a page out of the book of the Communist Party of China which every now and then rejuvenates itself by exorcising corrupt party leaders and officials. Cleaning up malfeasance within party ranks, instead of punishing those who blow the whistle or demand reforms, is not just the right thing to do. It will also boost its image in the long run.



Interestingly, geoscientists' interpretation and predictions often lead to resource discoveries. About 150 years ago, British geologist Robert Mallet, while inaugurating the first Indian coal mine at Ranigani in West Bengal, predicted that coal deposits of a similar kind would one day be found under the plain land

that the reserve is very significant and commercially viable. A rough calculation would suggest

that production of a million ton of ore annually (the same level of production capacity in Maddhapara hard rock mine as well as in Barapukuria coal mine) would run the mine for about 100 years. However, the database on which the above estimate is made has been considered inadequate, and there are suggestions that further wells should be drilled to more accurately delimit and define the extent and reserves of the ore body.

The overall magnetic survey results have shown that in addition to the magnetic high at Alihat area, there are positive magnetic anomalies in a few more places of Hakimpur upazila and surrounding areas. This raises hope that a similar iron ore body may be encountered nearby if these areas are tested by drilling. A cluster of iron ore bodies in close proximity would make the economy of mining iron ore more feasible and profitable.

Geological predictions The magnetite ore samples that

were extracted from the discovered borehole are crystalline, dense, heavy and hard with alternating black and white crystalline bands. It is in total contrast to the soft soil of Bangladesh beneath which it hides. This does not puzzle the geologists who are acquainted with the geological

proven right when GSB discovered the first coal reserve in Bangladesh plain at Barapukuria, Dinajpur in 1985. In independent Bangladesh in 1980s, renowned geologist Dr F.H. Khan reasoned and named the Dinajpur-Rangpur area as "Dinajpur Shield". He predicted that metallic mineral deposits were likely to be found beneath this area because shield areas are a habitat of metallic deposits as seen in the vast terrains of Orissa-Bihar to the west and other parts of very large Indian Shield. It took a new generation of geologists to prove Dr Khan's prediction right by the Dinajpur discovery in 2020.

In fact, the hard, dense, crystalline rocks found beneath only a few hundred metres in Dinajpur are the oldest rocks in Bangladesh—between 1,000 and over 3,000 million years old. These rocks formed from extremely hot and dense magmatic liquid, cooled and pressurised at the very early years of the Earth's history. These are hard, crystalline igneous and metamorphic rocks as found beneath the Dinajpur-Rangpur area. The remaining part of Bangladesh is made up of much younger and soft sedimentary rocks with the present deltaic Bangladesh only less than three million years old.

A prudent forward move required There have been reports that a further evaluation of the discovered iron ore in Dinajpur will be handled by a different hard rock production and is more governmental agency—the Barapukuria coal mine company. But this coal mining company has little to do with mineral or hard rock geology or mining. Furthermore, the Barapukuria coal mine has its own challenge to tackle to continue coal production after the present production ends in the central part of the mine, and with the expiry of the present contract with the Chinese mining company in about a year. On the other hand, Maddhapara Granite Mining Company Limited, also in Dinajpur, is managing the granite

suited to taking over management of the iron ore body in question. In any case, a foreign consultant is supposed to be engaged for the evaluation and mining feasibility study of the iron

However, the evaluation of the iron ore reserve by the GSB is not completed. It would be wise to let GSB continue its own evaluation of the discovered iron ore to reach a more mature and complete stage. We should know enough of a resource base before we engage a foreign company

to evaluate and mine it. That will give us more power in a negotiating table with a third party. A well-thoughtout policy with respect to natural resource exploitation is important to safeguard the national interest, even if it means a slower pace of action. Bangladesh's track record on natural resource exploration and exploitation shows that national interests have been undermined in several cases in the past.



# **DEVOTEE OF MUSIC**

Kumar Bishwajit has been a prominent figure in the music industry of Bangladesh. Throughout his career, he has made numerous hit songs which have carved a place in the minds of listeners. In this interview with Rafi Hossain, the renowned musician opens up about how he made a song in tribute to the father of our nation, Bangabandhu, and how he began his musical journey.

Rafi Hossain: Welcome to Uncensored with Rafi Hossain. Today, we are joined by a special guest, Kumar Bishwajit. Thank you for joining us today. Kumar Bishwajit: Thank you for having me, Rafi Bhai. I am very happy to be here.

Rafi: You recently made a song in tribute to Bangabandhu in celebration of his 100th birthday. What inspired you to do so?

Kumar: I consider myself very fortunate to have been able to witness the fight for the freedom of Bangladesh. I was not old enough to fight for liberation, but I was old enough to understand what was going on. I was around seven or eight years old, and I had seen a lot of the war. With us reaching the fiftieth anniversary of our independence, I felt that I should also celebrate the man who led us to that independence. I'm blessed to sing about Bangabandhu. We are all grateful to him for what he has done for us. Without his contributions, we would not be able to call ourselves Bangladeshi. The song that I made about

everything nowadays. (laughs). Honestly, I do not try too hard to take care of my appearance as I am more focused on conveying myself through my music. I think that when it comes to music, looks do not matter.

Rafi: When you were young, did you decide that you would pursue music as a career?

**Kumar:** I think that to be a musician, you must be born with a God-gifted talent. There are a lot of people in the world who are very interested to be musicians, but without that gift, it is very difficult to actually make it. Without the help of God, I would not have been able to come this far. I grew up in a very musical atmosphere, and in my family, singing or listening to music was always encouraged. That made me fall in love with music. When a teacher would come to teach my sisters music, I would stand close enough to hear, and try to pick up the songs that he was teaching. After he would leave, I would sing the songs, and it would shock my sisters, as I had managed to pick it up by

called Rhythm-77. After I left Feelings, the band broke up and then James started a new band under the same name.

Rafi: You were very close to Ayub Bachchu. What do you think of him as a musician?

Kumar: I have known Bachchu for a long time. We grew up in the same locality and were always very close. I made him join Feelings, and he also played using my guitar for a while. We both had very strict families that were not very eager to let us pursue music as a career, so we were both very close. Even when we moved to Dhaka after forming the band, we lived in the same house. As a musician, he was very dedicated. He would listen to a lot of music and try to pick it up. We would listen to popular instrumentals, and we would pick them up and cover them. Bachchu would always practise until he got it perfect. He had a dream, and he turned it into a reality. I think his contributions to music are proof of his love and dedication to music. Someone like Ayub Bachchu is very rare, and we do not know when someone of his calibre will

Rafi: Are you hopeful for the future of the industry? **Kumar:** I think that there will be good artists coming out, but to be good artists, the artists need to have passion and dedication. If they do it just for money and fame, they will not be able to make good music. When I started, I had to struggle, and at the end, with my dedication to music, all the struggle proved to be worth it. Now, I am proud to say that I have been working with music for almost thirty-eight years, and it is my main profession. But, it was not an easy road to be a musician. To actually make it in music, you need to make sure the songs you create are of top quality. Doing covers of songs is fine, but without original content. it is impossible to be a professional musician. If you make good songs, it will reach people. Another important thing an artist needs to remember is that they must make songs which people will remember and something that they can sing onstage with people singing along. If you have a thousand songs but people only remember four, something is not right. It is much better to have only two songs, but people completely remember both. To make songs, you have to make things you enjoy yourself.

Rafi: Do you have any message for the readers? Kumar: I hope everyone will stay well, healthy and safe, and work to better themselves this new year.

I am eager to present it to her. Rafi: Even after so long, how have you kept yourself in such good shape? It seems like you do not age. What is your secret?

Kumar: I am a bit worried about that. Maybe it is because of all the formalin that is mixed in

# Two new frontrunners to pick up pace baton

One of the most demanding and risky disciplines in cricket is pace bowling because even promising fast bowlers with all requisite attributes can fade away or suffer debilitating injuries without proper

The Bangladesh team management is considering creating a culture with emphasis on pace bowling, much like India has over the last five years or so and are now reaping the benefits.

Head coach Russell Domingo had also pressed the issue and is now looking forward to preparing a good group of fast bowlers in all three formats, both home and abroad.

Two young seamers who have caught the eye with recent performances and were called up for the Tigers' preliminary squads are left-arm seamer Shoriful Islam and right arm quickie Hasan Mahmud.

Young Shoriful showed his talent and aggression during Bangladesh's ICC Under-19 World Cup-winning campaign last year, where the youngster impressed with a consistent line and length.

The six feet three inches tall pacer uses his height well and performed well during the Bangabandhu T20 Cup last year, picking up sixteen wickets in 10 games for Gazi Group Chattogram.

Shoriful was rewarded with selection to Bangladesh's 24-member preliminary ODI squad for the upcoming three-match ODI series against the West Indies.

According to prominent pace bowling coach Sarwar Imran, it will be important that young Shoriful work on his inswing

thrive in the international circuit for a long

"Obviously, he is a bright prospect for Bangladesh but for left-arm seamers it's very important to be able to get the ball into the right-handers. He can take the ball away from the right-handers but at times you can become predictable in international cricket.

"If you look at [former Sri Lanka pacer] Chaminda Vaas, he used to bowl at a pace of 130kmph but still became one of the best left-arm seamers in world cricket because of his ability to move the ball both ways. Shoriful needs to work on this aspect as he has got all the attributes to become better in the coming days," Imran told The Daily Star.

Another young quick, Mahmud, was named in both the ODI and Test preliminary squads after he showed his ability to bowl at a good pace.

Mahmud, who made his T20I debut against Zimbabwe last year, has a great chance to make his ODI and Test debut in the upcoming home series against the West Indies. Imran said Mahmud could become the biggest prospect for the Bangladesh pace bowling department if handled properly.

"Mahmud has a very smooth action and can bang it into the deck hard. He can bowl at a very good pace, around 140kmph, and such quick bowlers are always handy in Tests and ODIs. He is still in his early 20s, so it's important for the management to make sure he isn't over-bowled and his workload management is maintained. I am very hopeful about Mahmud as he can be the next big thing in the pace-bowling department for Bangladesh in the coming days," he said.

# Faridpur man bounces back even after losing both arms

SUZIT KUMAR DAS

Even after losing both his arms in an accident, Kamrul Sheikh, 34, used the sheer power of will and determination to bounce back and change his

A resident of Faridpur's Sadar upazila, Kamrul is married with two children - a son and a daughter.

From a poverty-stricken family, he was only able to complete primary education, after which he began working to support his family. He would sometimes worker as a carpenter, sometimes a rickshaw-puller, an electrician, or a day-labourer.

On August 15, 2018, while working as an electrician at the district's Khaleq Bazar area, Kamrul was electrocuted and lost both his arms in the accident

"I climbed up an electric pole and set my ladder near the electric wires. I was repairing a faulty line. That is about as much as I can remember. When I regained my senses, I found myself on a hospital bed," said Kamrul.

From a local hospital, he was shifted to the burn unit of Dhaka Medical College and Hospital (DMCH), where he underwent treatment for around a month and half.

"Both my arms were badly damaged. They had to be amputated within three days of my admission [to DMCH]," Kamrul said.

"After the accident, my entire family was in financial trouble. The West Zone Power Distribution Company gave me Tk 2 lakh as compensation. I bought four rickshaws with that money and rented them out.

"But the income was not sufficient and I was getting worried. One day, a friend of mine, Lutfar Khalasi, suggested that I meet a man named Jashim, who, like me, does not have either of his arms but runs a shop himself." Kamrul met Jashim and learned some techniques to work. "I sold my

four rickshaws and opened up a grocery shop -- Zihad Varieties Store -- in

## Bangladeshi averts it thru' pollution plea

In a rare case, a Bangladeshi man with asthma has prevented a deportation bid by the French authorities, arguing that he risked a severe deterioration in his condition, and possibly premature death, due to the dangerous levels of pollution in Bangladesh.

In a ruling believed to be the first of its kind in France, the appeals court in Bordeaux overturned an expulsion order against the 40-year-old man, reported The Guardian Tuesday.

"To my knowledge, this is the first time a French court has applied the environment as one of its criteria in such a case," the unnamed man's lawyer, Ludovic Rivière, said. "It decided my client's life would be endangered by the air quality in Bangladesh."

Yale and Columbia universities' Environmental Performance Index ranks Bangladesh 179th in the world for air quality in 2020, while the concentration of fine particles in the air is six times the World Health Organization's recommended maximum.

# Wasa MD asked to inform HC about steps, plans

Sewers Linked to Buriganga

The High Court yesterday asked Dhaka Wasa to submit a report on what has been done to implement a 2011 order to stop dumping sewage in the Buriganga river.

The Water Supply and Sewerage Authority (Wasa) was ordered by the court 10 years ago to seal off the drains and sewer pipes linked to the river.

The HC yesterday directed Dhaka Wasa Managing Director Tagsem A Khan to submit a report on what steps had been taken and what plans had been made to the court through swearing by an affidavit by January 21.

The HC bench of Justice Gobinda Chandra Tagore and Justice Mohammad Ullah passed the order during hearing a pending writ petition filed by rights organisation Human Rights and Peace for Bangladesh (HRPB) in May 2010, seeking necessary directives to seal of the drains and sewerage lines connected to the Buriganga and to save it

Yesterday, the HC bench observed that Dhaka Wasa was very slow in implementing the 2011 directives.

At this pace, the directives will not be implemented and the pollution of the Buriganga will not stop, the HC bench

Earlier in the day, the MD of Dhaka Wasa submitted a compliance report to the HC through his lawyer Umme Salma, saying that the Wasa has sealed off several unauthorised sewerage lines in some areas of the capital, including Kalabagan and Palashi, and has handed over the responsibility of the canals to the city corporations.

Writ petitioner's lawyer Manzill Murshid told the HC
