

A second lease of life for little Ahad

Orphaned at birth and adopted by rickshaw-van puller, boy overcomes heart ailment, Covid-19 with help from M'singh volunteers

Ahad from Jamalpur lost his father before his birth and mother during delivery. When none was found to take care of the seven-year-old, another couple came forward to adopt him.

The boy found a new home of rickshaw-van puller Md Nazim Uddin and Ripa Akter who took him to their Charpara Kopikhet residence in Mymensingh city.

The couple amid their financial constraint started raising him and got him admitted to class two in a local government primary school. "We want him to be educated," said Nazim. At one stage, the couple discovered that he had a heart problem.

At that time, the couple had no children. Now, they have two -- Ahad and a five-year-old daughter.

In May last year, when shutdown caused by Covid-19 pandemic began to cripple the financial condition of the country's low- and low-middle class people, the couple fell in severe crisis.

At that time, a group of volunteers found them during their door-to-door distribution of food for the people in need. Then the activists came to know from the couple about Ahad's heart problem.

Two years ago, the couple had taken him to Mymensingh Medical College

Hospital and National Heart Foundation in Dhaka. But they could not afford the amount required for the treatment, said Nazim Uddin.

Since then Ahad had been left untreated, said the family.

The volunteers led by Ali Yusuf took the charge of Ahad's treatment and made a post on social media urging people to financially support Ahad in June.

People responded well and Tk 2,80,000 was collected within a week and Ahad's treatment started, said Ali, also a poet and printing businessman.

"We were ready for Ahad's treatment in June. As the boy tested coronavirus positive, the process delayed. We took him to Dhaka Shishu Hospital in October and did necessary tests," said Md Ashraf Uddin, another volunteer.

"He was admitted there under Dr Khalifa Mahmud Tarik in December and was operated on on January 4 this year," he said, adding that now he is doing well.

Now, Ahad has got a new hope to live. The satisfaction is beyond expression, said Nazmul Ahmed Didar, another activist. But the volunteers gave the total credit to those who gave the boy financial support.

Expressing gratitude to the volunteers and those who have come forward with helping hands, an emotion gripped Nazim said they will keep the service in their memories forever.

the exhibition and hoped it would encourage people to know more about Bangabandhu.

"We all know about the contributions of Bangabandhu in attaining the independence of Bangladesh but many of the new generation do not know about his contributions as a statesman," he added.

"When Bangabandhu was freed from prison in Pakistan and returned to the war-torn country, there was no administrative structure; roads, schools and colleges were all in disarray. He then took up the challenge of rebuilding Bangladesh and in a very short period of time took various steps to revive the country's economy," the mayor said.

Rajesh Kumar Raina, assistant high commissioner of India, Khulna, presided over the inaugural ceremony.

He said after independence of Bangladesh, Bangabandhu not only focused on the people of his country but also concentrated on building a bridge between the neighbouring countries. He also emphasised on the special bond between India and Bangladesh.

Among others, Vice Chancellor of Khulna University Mohammad Fayek Uzzaman and District Council Chairman Sheikh Harunur Rashid were present.

one of the investigation team members was present at the protest.

She said, "On January 11, 2020, Lakingme was taken to Cumilla by Ataullah and later on she was converted and married to him at a registrar's office. If OC Pradeep Kumar Das [now accused of killing Maj Sinha] of Teknaf Police Station would have recorded the case of Lakingme's father Lala Aung Chakma, she could have been rescued."

According to her, although Lala managed to file a case with Cox's Bazar Women and Children Repression Tribunal on January 27 that year, the PBI negligently investigated the case. And after 11 months and six days, Lakingme's body was found in a Cox's Bazar hospital morgue.

Prof Titil also demanded that she was abducted, forcibly converted and married at 14 years of age, which means she was raped. The family must get justice and the accused must be held accountable for this.

"Besides, the law enforcers must investigate whether she killed herself or was murdered because we have found many examples that she was instigated to take her own life," Prof Titil added.

"Lakingme's family must be given protection since they are feeling insecure, and they must be given compensation. Also, a departmental inquiry into PBI's negligence must be carried out and

punishment must be ensured for those involved in certificate forgery, forced conversion and marriage of the minor," she added.

She also expressed concern over maintenance and guardianship of Lakingme's child.

Expressing solidarity with the protest, Prof Dr Robayet Ferdous of Dhaka University said there are "many Lakingmes" who had to endure such cruelty.

Lakingme became the victim of identity politics and all this was done in an attempt to destroy her Chakma identity, he added.

Rina Roy, director of Manusher Jonno Foundation, said 1,627 girl children and women were raped in the past year. "But we have not seen any reflection of this in the judiciary."

"Marriage of a 14-year-old girl is not acceptable in any way and it amounts to rape and coercion. We are demanding justice for Lakingme," she added.

Sanjeeb Drong, president of Bangladesh Adivasi Forum, presided over the protest.

No citizen of this beloved state deserves such cruel state like Lakingme, he said. "We want to see this state as more sensitive and more democratic; we demand a humane Bangladesh."

Advocate Rafiq Ahmed Siraji of ALRD; Maithen Promila, member of Adivasi Forum and Lakingme's lawyer Md Mohiuddin also joined the protest. Moderated by Shahnaz Sumi, deputy director of BNPS.

Councillor candidates are also conducting their campaigns every day.

Apart from the mayoral post, candidates are vying for 41 general seats and 15 reserved seats for women under councillor posts.

A total of 14 executive magistrates have been deployed by Election Commission to maintain electoral code of conduct, said Mohammad Hasanuzzaman, returning officer of CCC polls, adding that the magistrates have already fined many people in different areas for violating the code of conduct.
