Two people were killed in road accidents in two districts on Wednesday, according to reports from our correspondents.

Our Patuakhali correspondent reports, a ruck driver was killed as the truck loaded with rods fell into a ditch in Barguna's Patharghata upazila at night.

The accident took place near Abdus Salam Ideal Madrasa in Patharghata Municipality. The deceased was identified as Abu Bakar (30), said Patharghata Police Station Officer-in-Charge Md Shahabuddin.

Abu Bakar's assistant Naeem said the accident happened while the vehicle was being loaded with rods in Kakchira area. The trucker died on the spot.

Our Dinajpur correspondent adds, a truck hit a motorcycle from the opposite direction on Dinajpur-Gobindaganj regional highway at Laxmipur village in Phulbari upazila, leaving the biker dead.

Lebu Islam (25) from Stationpara in Phulbari died on the spot, said Phulbari Police Station OC Fakhrul Islam.

# UK stands by Bangladesh | Road accidents | Govt served legal notice | Duping jobseekers not to reopen schools

A Supreme Court lawyer has served a legal notice on the government, requesting it not to reopen the educational institutions until the ongoing Covid-19 pandemic is completely over.

Khandaker Hasan Shaharyar sent the legal notice to the authorities concerned of the government on January 27 also urging them to take necessary steps to provide 100 percent online classes to the students through using digital system during the pandemic.

He also appealed the government to cancel its decision to reopen the institutions in February. Citing the legal notice, Shaharyar told The Daily Star yesterday that if the academic institutions are reopened now the students' health will be at risk as the Covid-19 pandemic is yet to end.

He said he will move a writ petition before the High Court for necessary orders if the government reopens the academic institutions in this situation. Earlier on January 11, another legal notice was served on the government requesting it to reopen all the educational institutions including the

schools and colleges across the country from January 16. Lawyer Faruque Alamgir Chowdhury sent the legal notice on behalf of Abdul Kaiyum Sarkar, principle of Vawal Mirzapore Public School and College, to the education secretary and director general of the directorate of education for taking steps to reopen academic institutions from January 16.

Citing the legal notice, Faruque told The Daily Star that the educational institutions of the country have remained closed since March last year due to ongoing Covid-19 pandemic situation hampering the study of the students. The shutdown of the institutions was extended for 11 times so far and therefore, lakhs of students are facing adverse impact.

In the first week of January, one of the accused, Bokul, sent the job offer letters to Ali and asked him to verify those if there is any confusion.

Ali verified it with the company's website and deemed

"Actually, it's a fake website made by the fraudsters." Such company doesn't exist," the PBI Chief said.

On January 19, Bokul sent a visa approval list and visa copy to Ali's WhatsApp. It showed that one of them got approval for a study visa.

"Ali told Bokul that they wanted employment visa... so why did they issue study visa? Bokul told him that they can change it again and it will not be a problem," explained

'Ali then instantly wrote to Ireland Embassy in New Delhi, India through email. In reply the embassy said these visas are not genuine," Banaj Kumar said, adding that the fraudsters could not think that Ali would go to such lengths to verify the visa.

Ali then filed a case over human trafficking and fraudulence with Hatirjheel Police Station.

PBI arrested Shahin and Bokul near Dutch Bangla Bank in Motijheel while Galib was picked up at Gulshan area.

Raiding Shahed's office in Banani, they seized 13 passports including the victims' ones along with two laptops, cheque books, seals, fake job offer letters, police clearance forms and bio-data of the job-seekers.

The PBI Chief said they are trying to arrest Shahed.

EVM VANDALISM: BNP-SUPPORTED **COUNCILLOR CANDIDATE ON 1-DAY REMAND** 

A Chattogram court yesterday placed a BNP-supported councillor candidate for CCC election on one-day remand, in connection with vandalising two Electronic Voting Machines (EVM) inside a polling station at Patharghata area on Wednesday.

The court of Additional Chief Metropolitan Magistrate Mohiuddin persons were also made accused in the Murad placed Mohammed Ismail Bali on

remand, after police produced him before court, with 10-day remand prayer, said Assistant Commissioner (Prosecution) Shahabuddin Ahmed of Chattogram Metropolitan Police. Bali was immediate past councillor of Ward-34.

Earlier, AL and BNP supporters locked into a clash inside Patharghata City Corporation Girls' High School polling centre, where the EVM machines were vandalised at one point. After the incident, voting was suspended at the station. Later, police detained Bali.

Following the incident, Md Shahjahan, the station's assistant presiding officer, filed a case, accusing Bali and 24 others with Kotwali Police Station on Wednesday night. He was then shown arrested in the case, said Nezam Uddin, OC of the station.

Analysing the hospital's CCTV footage, Anisul was seen being dragged into a soundproof room by several staffers and thrown to the ground by six employees during the admission procedure.

Two employees dressed in blue garbs held his leg and two others hit him with their elbows. Anisul's hands were tied behind his back with a piece of cloth.

There were no doctors in the soundproof room at the time, police said.

On November 10, Anisul's father Faijuddin Ahmed filed a case with Adabor Police Station, accusing 15 people, including five hospital shareholders and directors, for murdering his 35-year-old son.

Police have so far arrested thirteen people, including three directors, in connection with the case. The three directors are Dr Md Niaz Morshed, Dr Abdullah Al Mamun and Fatema Khatun Moyna.

The six accused who gave confessional

statements are marketing manager Arif Mahmud Joy, pharmacist Tanvir Hasan, kitchen chef Masud Khan, and ward staff Asim Chandra Pal, Tanif Mollah and Sajib Chowdhury.

Earlier, expressing distrust over the police investigation, psychiatrists demanded a judicial probe into the officer's death and arrest of their colleague NIMH Registrar Dr Abdullah Al Mamun.

Police claimed that the doctor had referred Anisul from NIMH to Mind Aid, as he received 20 percent commission for such

Dr Mamun also ran a private practice at the facility, for which he was paid separately, said police, adding that several other doctors of NIMH and other government hospitals were also maintaining private practices at Mind Aid and referred patients there.

The other directors -- Sakhawat Hossain, and Sazzad Amin -- are still on the run.

Meanwhile, Law Minister Anisul Huq yesterday told parliament that some "aggrieved" journalists publish "incorrect" news over public hassles while availing services regarding the national identity card.

Anisul Huq, in-charge of the Election Commission Secretariat in the House, in reply to a lawmaker's question, said there are some mistakes in the NID cards due to lack of required number of skilled and technical manpower as per demand.
