India Farmers' Protests

Fresh clashes raise tensions

Delhi cop hurt; Congress MP Tharoor, 6 journos sued for 'seditious' tweets

Clashes erupted yesterday between hundreds of opponents and supporters of a major farmers protest that has disrupted the Indian capital for more than eight weeks.

At least one farmer was seen brandishing a sword during the latest unrest to overshadow two months of protests against the liberalisation of farm produce markets. Police fired tear gas and baton charged rival groups to separate them at Singhu border.

Tensions have been building around the farmers' camps since Republic Day on Tuesday, when a tractor rally turned into a citywide rampage which left one farmer

dead and nearly 400 police injured.

thousands of extra police and paramilitaries in Delhi and around the camps since then. One small camp has been closed, as have many roads around the protest sites.

Some local groups have said the farmers should leave. Farmer leaders nave insisted their action will go on.

"When we don't have any land left, when we are unable to cultivate any crops, we are going to die anyway," said Bhagwant Singh, a 53-year-old farmer at

"At least if we die here protesting, we will be martyrs. We will fight and die for the rights of the people of this country."

It has so far been a smooth process, from the government purchasing the vaccine, piloting it and transporting it to the district level.

Healthcare officials of different districts also told The Daily Star correspondents that they did not have any issue so far in storing the vaccine.


But some The Daily Star talked with said they were behind schedule in training volunteers at the district, city corporation and upazilla levels.

Contacted, Dr Shamsul Haque Mridha, member secretary of the National Vaccination Campaign committee of the DGHS, told The Daily Star yesterday, "Training and orientation of volunteers in all upazilas will be started on Saturday. It will be completed everywhere within days. We have time for this."

Asked about the delay, he said, "In fact, we had to change our plan after receiving the vaccines form the Indian government as a gift. We had no plan to run piloting in five hospitals in Dhaka. We have to change our plan considering circumstances.

PMO gives go-ahead

A railway official said the station plaza has to be shifted 130 metres northward from its current location to implement the new plan.

After that meeting where both sides agreed to the new plan, Railways Minister Nurul Islam Sujan told reporters that the existing plaza will be demolished and a similar one will be built to the north as per the new plan that will turn the station into a "true transport hub".

He, however, had said Prime Minister Sheikh Hasina would make the final decision in this regard as the existing plaza, an iconic structure, has to be demolished to implement the new The BR and the DMTCL, the

implementing authority of the country's first metro rail, were locked in a dispute over the extension design plan of the MRT-6 line.

The MRT-6 line was initially designed as an elevated line from Uttara to Motijheel. In 2019, the DMTCL planned to stretch the MRT-6 line directly to the railway station following a PM directive.

Although the BR did not oppose the extension, it contested the DMTCL design for the extension, saying that it would frustrate the BR's plan to turn the Kamalapur station into an MmTH.

The station, in its current location, would be completely covered by the MRT-6 structure if the DMTCL design is implemented. There would no option

but to shift the station because even if the existing plan is modified the station will be partially covered by the MRT-6 structure, the BR officials argued.

Even the Japanese ministry of land, infrastructure, transport and tourism wrote to the Public Private Partnership Authority of Bangladesh to change the proposed design.

In the meeting between DMTCL and the BR, Japan's Kajima corporation -which is leading the Kamalapur MmTH Sub Working Group -- proposed a modification to the design of the MRT-6 structure, to which both parties agreed, BR officials said.

Papul, also the managing director and CEO of Marafie Kuwaitia Group He was accused of human trafficking, bribing Kuwaiti officials with millions of dollars to recruit Bangladeshi workers and get contracts for his company, money laundering, fraud related to employment of workers in his company,

and violating the residence law. The others sentenced on Thursday include Kuwait's interior ministry's Assistant Under-Secretary Maj Gen Mazen Al-Jarrah, and Nawaf Al-Mutairi, Hassan Al-Khader and Papul's associate Mohammad Rashidul Islam, a Bangladeshi.

Quoting Arabic newspaper Al Qabas, The Times reported that Papul is estimated to have obtained KD5 million in assets in Kuwait. During investigations, all his bank accounts and that of his company were frozen.

According to sources in Kuwait, Papul went to Kuwait in 1989 as a worker and eventually started working as a recruitment broker and later established companies. He ran four companies involved in providing cleaners through government contracts in Kuwait, employing 9,000 workers.

According to witness accounts in the case against Papul, he was part of an "organised gang" made up of two Kuwaitis and Papul. They used a company to recruit workers from Bangladesh by fraudulent means in exchange for payments ranging between KD2,500 and KD2,700 for each, The Times reported.

The trio occupied sensitive positions in three major companies that brought over 20,000 Bangladeshi workers to Kuwait in exchange for more than KD50 million. Although the company was closed due to legal violations, the workers landed in Kuwait to discover their visas were fake. They were forcibly

Some Bangladeshis, who worked as Kuwait correspondents for media outlets in Bangladesh, told The Daily Star that they faced unlawful deportation for reporting on misdeeds of Papul. Papul acted behind the deportation, they alleged.

Times reported during investigations since June last year, evidence was uncovered that Papul extorted the workers, intentionally hid information and bribed some Kuwaiti officials to facilitate unlawful issuance

Initially, Papul denied all the charges against him and his links to the criminal activities, but a search by the Kuwaiti authorities of his residence and companies produced documents revealing his crimes. He then admitted to offering gifts and assisting his friends in "several agencies" who in turn helped Papul complete the company's

transactions, according to the report. During interrogation, reportedly confessed to have provided KD1.1 million by cheque to an official at the Ministry of Interior, one million dinars in cash to another official, in addition to "bags" of millions of dinars in cash to a third official, Kuwaiti media

heard testimonies from scores of Bangladeshi workers who had been brought into Kuwait by the accused, from Bangladesh, for money. This trading in work visas allowed him to siphon off money to the United States for laundering. transferred Papul suspicious

> Against this backdrop, questions have arisen as to who is the respective authority, how long it will take to inform the matter to the Speaker and how long the MP will be paid in monthly salaries and other benefits from the government exchequer.

According to the accounts section of parliament, an MP now gets over Tk 1,73,000 per month in pay and perks, meaning Papul received more than Tk 14 lakh since his arrest in Kuwait.

Speaking on the issue, Transparency International Bangladesh Executive Director Dr Iftekharuzzaman told The Daily Star that if the government or the Jatiya Sangsad avoids taking prompt actions, it will only add to the embarrassment caused to the nation by the MP's sentencing.

"Initiatives should be taken immediately to contact the relevant authorities in Kuwait to collect relevant official papers so as to take action against the MP, including cancelling his membership of parliament, as per the constitutional provisions," he said.

"Moreover, the Kuwaiti action should be treated as only the first step in this episode. He and his associates should be brought to justice under the Bangladeshi laws, under which both money laundering and human trafficking are serious crimes," he also

Iftekharuzzaman also said any government inaction at this stage would be a message that there are elements within the government and parliament who are determined to sabotage the prime minister's zero tolerance pledge against corruption.

BANGABANDHU'S BIRTH CENTENARY

Momen invites new US secy of state to visit Bangladesh

Foreign Minister AK Abdul Momen has invited new US Secretary of State Antony John Blinken to visit Bangladesh and attend the celebrations of the Birth Centenary of the Father of the Nation and the Golden Jubilee of the country's independence.

He wrote a letter of congratulation to Blinken, whose nomination as the Secretary of State has been confirmed by the ÚS Senate on Tuesday, just more than a week after President Joe Biden took office, the Ministry of Foreign Affairs said in a statement.

In the letter, Momen underscored that such a visit of the US Secretary of State would further strengthen the multifaceted bilateral relations, and would also provide Blinken an overview of the "miraculous development" Bangladesh has achieved under the visionary leadership of Prime Minister Sheikh Hasina.

He expressed his disposition to work closely with his US counterpart to achieve the two friendly countries' common goals of peace, development, and security for all.

Terming the Bangladesh-US relations as a unique partnership, Momen stressed upon Bangladesh's willingness to work with the new US Administration to further strengthen the ties, address common challenges, and to build on the progress and prosperity that has been achieved.

He also expected that the new US administration will deport Rashed Chowdhury, the fugitive killer of the Father of the Nation Bangabandhu Sheikh Mujibur Rahman, in the spirit of ensuring justice and rule of law.

Momen further thanked the United States for the strong political support and humanitarian assistance provided for the Rohingyas and expected that Joe Biden's administration would work more proactively in the international efforts to resolve the crisis through the safe and sustainable return of the displaced Rohingyas to their ancestral land in Myanmar.

Opining that Bangladesh can be lucrative destination for new US investment, he stated the Bangladesh government's keenness to have wider ŪS cooperation in the economic arena, especially in the form of trade liberalisation and foreign direct

investment. Bangladesh being the present Chair of the 48-member Climate Vulnerable Forum, Momen expressed deep satisfaction about the return of the US to the Paris Agreement, and hoped that the two countries would work closely to save the planet for the future generation.

The results will be published after coordinating 75 percent of the SSC and 25 percent of JSC-JDC results, Education Minister Dipu Moni told the media earlier.

All 1,365,789 candidates under 11 educational boards will become successful in the exams.

As per the previous laws, there is, however, no provision to publish the results of HSC and equivalent exams without holding tests. On January 24, three separate amendment bills were passed in the parliament, paving the way for publishing results without holding a public exam during a pandemic, epidemic, and act of God.

The bills are the Intermediate and Secondary Education (Amendment) Bill- 2021, the Bangladesh Vocational Education Board (Amendment) Bill-2021, and the Bangladesh Madrasah Education Board (Amendment) Bill-

The amendments have been incorporated in the Intermediate and Secondary Education Ordinance-1961, Bangladesh Vocational Education Board Act-2018, and Bangladesh Madrasah Education Board Act-2020.
