## Tunisians protest against 'police state'

Hundreds of young people took to the streets of the Tunisian capital on Saturday to protest against police repression and demand the release of demonstrators detained in recent days. The protesters marched from Tunis's central Human Rights Square to Habib Bourguiba Avenue, trying

to make their way to the interior ministry, an AFP reporter said, but security forces blocked their path.

Denouncing what they say is police repression and government corruption, some demonstrators held signs that read, "Police everywhere, justice nowhere."

Some threw plastic water bottles at security forces, while others chanted

slogans including "Down with police rule" and "Release the nation's sons (from detention)".

Mired in a political and economic crisis worsened by the Covid-19 pandemic, Tunisia has been rocked this month by a wave of social unrest, a decade after Arab Spring protests ousted the autocratic regime of Zine El Abidine Ben Ali.

## 50 lakh shots

Hussain Md Moinul Ahsan, civil surgeon of Dhaka district, told The Daily Star yesterday.

Talking to this correspondent, Mohammad Imtiaz, civil surgeon of Narayanganj district, also said his district was yet to get any vaccine.

After 567 people were administered vaccines during the pilot vaccination in Dhaka's five hospitals, the Directorate General of Health Services (DGHS) has kept the rest of the 20 lakh vaccines likely for the three districts, said the officials.

As the countrywide inoculation will start on February 7, officials of the Beximco Pharmaceuticals Ltd said they have completed delivering the vaccine to 61 districts yesterday.

Beximco is supplying the vaccines to the government as the sole distributor of Serum Institute of India (SII) in the country under a tripartite contract. The company will supply a total of three crore doses of vaccines under the agreement.

"We have completed our delivery today [yesterday]," Nazmul Hasan Papan, managing director of the pharmaceuticals, told this paper.

About the vaccine distribution plan for Dhaka, Dr Shamsul Alam, member secretary of the national vaccination committee at the DGHS, said, "It cannot be said before we complete the distribution."

The government will provide support to those who have no access to digital device for online registration to be vaccinated, officials said.

In addition to the union digital

centres, the community healthcare providers will help people register online for taking vaccines, said DGHS officials.

"We have thought to organise online registration support in respective rural areas for those who will not be able to register themselves. We will inform [those who registered] about the date for vaccination after at least 10 people will register at a centre," Prof ABM Khurshid Alam, director general of the DGHS, told journalists yesterday.

He added that 15,000 people registered for vaccination across the country as of yesterday morning.

There are around 13,000 community clinics, each of which is run under the supervision of a community healthcare provider (CHCP), according to the DGHS.

"All of the CHCP has tabs and it has been decided to assign them to help those who have no access to digital device," Toufiq Hassan Shawon, medical officer at the MIS, told The Daily Star yesterday.

Meanwhile, the frontline journalists who do not belong to any professional association can be registered if their employer organisations email their lists to the respective offices of the government.

Issuing a circular, the Press Information Department has recently asked to send the lists with the names and ID numbers of journalists to pidprotocol2017@gmail.com.

Similarly, the management information system (MIS) unit of the health directorate has provided another e-mail ID: linedirector@mis.

dhgs.gov.bd to send such lists.

"An organisation should send a list of its employees so that we can include their names in the database of those who registered online easily," said Md Toufiq Hassan Shawon.

He added that solution of the technical issues regarding online registration was underway.

Since the android app for registration has yet to be available on Google Play Store, people can get registered through www.surokkha.gov.bd, officials said, adding that the app will be available in a few days.

Meanwhile, State Minister for Foreign Affairs M Shahriar Alam yesterday told parliament that Hungary has requested Bangladesh for 5,000 shots of Covid-19 vaccine.

Speaking on the thanksgiving motion on the president's speech, he said Bolivia has also requested Bangladesh to provide coronavirus vaccines.

"Hungary has requested us for 5,000 shots of Covid-19 vaccine. We will provide them with vaccine from the stock we have. The prime minister and the ministry of health will decide on Bolivia's request," Shahriar said.

Bangladesh is collecting Oxford-AstraZeneca vaccine produced at the Serum Institute of India. Already 50 lakh shots of the vaccine, purchased by the government, and 20 lakh doses sent as gift by India have arrived in the country.

Another 2.5 crore doses are expected to reach the country in the next five months.

The state minister also called for taking action against those who are spreading rumours about vaccination.

The deceased were identified as Selim Mia, 25, son of Tayeb Ali, Rokshana Begum, 30, wife of Rafiqul Islam, Abdul Mannan, 58, son of late Abdul Hye, Lal Mia, 35, son of late Ketu Mia, and the driver of the vehicle Md Jubed Ali, 25, son of Yusuf Ali -- all hailing from different villages of the adjacent Nalitabari upazila.

All of the deceased and injured were passengers of the auto-rickshaw. Selim Mia, Rokshana Begum driver Md Jubed Ali were killed on the spot.

They were taken to Sherpur General Hospital where Lal Mia and Abdul Mannan succumbed to their injuries, said the OC.

Of the injured persons, Mamun was referred to Mymensingh Medical College Hospital while eight-year-old Rumi Begum, daughter of Rokshana Begum, is undergoing treatment at Sherpur General Hospital, the OC added.

On information, police rushed to the spot and recovered the bodies. Police seized the truck but its driver and helper had managed to flee, said the OC.

A case was lodged with the police station.

Regarding the contributions of the Father of the Nation, Hasina said there had been frantic efforts to erase the name of Bangabandhu from Bangladesh history after August 15, 1975.

"Even they tried to erase the name and contribution of Bangabandhu from the Independence and Language Movement," she said.

Hasina said Ziaur Rahman, HM Ershad, and Khaleda Zia destroyed many archives both at Bangladesh Television and Bangladesh Betar.

She said Bangabandhu wanted to build a country that would be free from poverty and hunger.

"But he could not do that. So, it is our responsibility to finish his unfinished task, and we're taking Bangladesh forward in that direction," she said.

of their departed souls with respect." Siraj said he would not thank President Abdul Hamid because he did not mention late president Ziaur Rahman who is "the proclaimer of the country's independence".

As the treasury bench MPs booed, Siraj said, "I can't thank the president for not talking about bribery, corruption, terrorism, murder and rape in his speech, and for not giving directions in this regard."

"Money launderers remain invisible. Who are their patrons? They are all government-backed [or are] directly involved with the government. From Basic Bank's Abdul Hai Bachchu to today's Prashant Kumar Haldar, [all] are close to the government."

Mentioning the name of independent MP Mohammad Shahid Islam Paplu, who has been jailed by the Kuwaiti government, Siraj said Paplu not only tarnished the image of parliament but also of the country.

"Thousands of crores of taka are being spent in the name of holding elections. What is the point of spending people's money on such mockeries of election?"

Dictatorship and democracy contradict each other, he said, the government has to choose one of

the two paths. "Let's form a Baksal government by shedding the undeclared Baksal approach and false words about democracy. Otherwise, give the country back to the people. Give back people's human rights and freedom."

About President Abdul Hamid, he said, "He is the guardian of the state. The president in his speech mentioned the success of the prime minister. I would also like to thank the prime minister for her measures to eradicate terrorism and militancy. I would like to thank [her] for women's empowerment. But there is no democracy and good governance in the country. People want to hear the truth from the president."

The deputy speaker, pointing at the BNP MP, said, "What you have said about the president is not true. I will check whether those statements can be expunged [from the parliament proceedings]."

He also advised the BNP MP to act democratically himself if he expected others to behave democratically.

Several other MPs on their thanksgiving motion lambasted the BNP, its chairperson Khaleda Zia, and acting chairman Tarique Rahman for having links to militants when they were in power.

hospital, said Dr MA Hamid, the head of burn and plastic surgery department.

SUFFERINGS

The low-income people, especially day labourers, farm workers and rickshaw-pullers, are finding it hard to earn the bare minimum to feed their families.

In Kurigram and Lalmonirhat, those living in the Brahmaputra, Dudhkumar, Teesta and Dharla river basins are among the worst sufferers.

"I have been waiting for passengers for over three hours. But I'm yet to find any as people are staying indoors due to severe cold and dense fog," said 45-year-old Motalab Mia, a rickshaw-puller, in Dada Mor area of Kurigram town.

"We burn straws to keep us warm

as we cannot afford winter clothes," said Afia Bewa, 58, a widow, at Char Gokunda village in Lalmonirhat's Teesta basin area.

Habibur Rahman, chairman of Mogholhat union parishad in Lalmonirhat, said, "I have received around 400 blankets recently from the government. But I need at least 7,000 blankets for the poor in my union."

In Thakurgaon and Panchagarh, many day labourers could not find work due to inclement weather.

"I have been waiting here for hours to find work. But nobody is hiring..." said Shukanu Barman, 50, at an intersection in Thakurgaon town.

But it has faced criticism at home and abroad for how it handled the initial Wuhan outbreak and its lack of transparency.

MORE RESTRICTIONS

With mass vaccination programmes still in their infancy and struggling with supply, unpopular restrictions on business, movement and travel remain among the few options available to governments in their fight against the virus.

Yesterday, France closed its

borders to all non-EU travellers except those on essential trips, and closed big shopping centres, except those selling food; whilst Portuguese citizens will not be able to travel abroad except in "special cases" for two weeks.

The day before, Germany barred most travellers from countries battling the new virus variants that are believed to be more contagious. The decision impacts people from Britain, Ireland, Portugal, Brazil, South Africa, Lesotho and Eswatini.

## Russian police detain

obvious threat of arrest and the protests that his jailing has sparked pose a major challenge for Putin who has dominated the Russian political landscape for over two decades.

In a highly unusual move, police imposed a security lockdown in the heart of the capital yesterday, sealing off streets to pedestrians near the Kremlin, closing metro stations and deploying hundreds of riot police as snow fell.

Yulia, a 40-year-old protester in Moscow, said she had joined

the rallies despite having a panic attack the night before because of worrying about repercussions for taking part.

"I understand that I live in a totally lawless state. In a police state, with no independent courts. In a country ruled by corruption. I would like to live differently," she said.

Police have said the protests were illegal as they had not been authorised and would be broken up. Authorities have said demonstrators could spread Covid-19.

the current EC under Chief Election Commissioner KM Nurul Huda.

In the second letter, they cited a media report that some of the EC officials had embezzled at least Tk 11 crore from the training budget.

The report also mentioned about allegations against 18 people, including the CEC, commissioners and top EC officials, that they took at least Tk 3 crore of the Tk 11 crore.

In the letter, the distinguished citizens said the EC was created as a constitutional body so that it can act independently without any bias.

The EC's constitutional duty is to hold free, fair and acceptable elections. Arranging and giving training to election-related officials is part of the routine duty of election commissioners and EC officials, and for that they get salaries and allowances from the public exchequer, the statement said.

It is an extremely corrupt and heinous deed to take crores of taxpayers' money by creating posts besides the official ones through abuse of power. There have been media reports about the CAG's audit objections regarding this, read the statement.

"In legal terms, taking money twice for the same work is called double dipping. This is unjust, unethical and a serious financial misconduct."

It further mentioned that a smokescreen has been apparently created over constitution of SJC through the Supreme Court in its verdict on the cancellation of 16th amendment to the constitution said: "The decisions of the apex court of the country are final not because they are infallible, but because the decisions are infallible as they are constitutionally final. By the impugned amendment, the removal mechanism of the judges of higher judiciary by the Supreme

Judicial Council has been substituted by the parliamentary removal mechanism.

"Since this amendment in [sic] ultra vires the constitution, the provision prevailing before substitution is restored. The appeal is accordingly dismissed."

The statement also said it is clear through the verdict that SJC is still valid, and the SC has not stayed its verdict that restored SJC.

In yesterday's statement, the eminent citizens said SJC can properly probe the allegations as it can seek evidence, necessary files, record and documents from the EC and other officials.

In their first letter, they said members of the EC under KM Nurul Huda's leadership had indulged in misconduct and irregularities, including that of Tk 2 crore for delivering speeches as "special speakers" at training programmes ahead of the 11th national election and fifth upazila elections.

In response, the CEC on December 24 said the allegations of spending Tk 2 crore on special speakers at training sessions ahead of elections were made on false grounds.

Nurul claimed that the allocation for special speakers for the 11th national election was Tk 1.04 crore and for the fifth upazila election the amount was Tk 47.70 lakh.

According to the rules and regulations, all expenditures were subject to audit and if the audit objections were not settled, all unspent money would be returned to the public exchequer, he mentioned.

"There is no scope for financial irregularities," he said.
